"No Stopping a Determind Driver" By Janice Collins

I've been in two car accidents that were the rollover kind. The first was when my girlfriend Delores and I were travelling near her home on sandy country roads in Colorado.

She hit a rut in the road near a large ditch, causing the car to swerve. We rolled over and the car landed on the embankment. I was not trapped, just tossed around in the car, and I lost my glasses and shoes.

When I couldn't see her, I crawled out of the window on my side and went around the car trying to find her. Her head was sticking out from under the car which was upside down and covering her body.

She was conscious, and asked me not to leave her because it was such a terrifying thing to have happened. Since I could not help her, I left, telling her that I was going for help.

I ran faster than I had ever run before, shoeless and without glasses, to the nearest farm house to make phone calls.

When I got to a house with a fenced yard, the dogs didn't accept me. So I hollered for help. The people heard me and made phone calls, and then took me back to the site.

An ambulance came for Delores and the parents of both of us also came. Fortunately, Delores was in a small depression under the car, and it must have been made when we hit the embankment and rolled over.

She was only bruised, no broken bones or concussion. I was taken to the doctor's just to be checked. We were both about seventeen and the accident didn't deter us from driving. Our parents were calm and didn't want us to feel any worse than we already did.

My second rollover accident involved my car. My husband was taking us Editor to Denver to visit my father who had ulcer surgery.

We hit a slick spot in the paved road, after a rain storm. We slid and rolled the car. The car was totaled.

My husband's finger was badly cut, and he held it in place while we tried to stop the bleeding. We were fortunate that a passerby stopped to take us to the Denver hospital so he could get stitches.

My husband was a very brave person to have handled the situation so well. He was more worried about me instead of himself.

Once again, the accident didn't stop us from driving.

Former state senator Ron Calderon gets 3 1/2 years in prison for accepting bribes



MONTEBELLO - Former state Senator Ron Calderon was sentenced last week to three and a half years in federal prison after pleading guilty to a federal corruption charge, admitting that he accepted tens of thousands of dollars in bribes in exchange for performing official acts as a legislator.

Calderon, 59, of Montebello, received the 42-month sentence last Friday afternoon from United States District Judge Christina A. Snyder, who also ordered the defendant to serve 150 hours of community service.

Calderon pleaded guilty in June to one count of mail fraud through the deprivation of honest services. In a plea agreement filed in this case, Calderon admitted accepting bribe payments from the owner of a Long Beach hospital who wanted a law to remain in effect so he could continue to reap tens of millions of dollars in illicit profits from a health care fraud scheme. Calderon also admitted taking bribes from undercover FBI agents who were posing as independent filmmakers who wanted changes to California's Film Tax Credit program.

Ron Calderon's brother, Tom Calderon, 62, also of Montebello, a former member of the California State Assembly who became a political consultant, was sentenced last month to 10 months in custody for his conviction on a money laundering charge for allowing bribe money earmarked for his brother to be funneled through his company.

"Former Senator [Ron] Calderon repeatedly violated the trust of widening project is still years the voters by taking nearly \$160,000 in bribes in exchange for abusing his position as an elected official," said United States Attorney Eileen M. Decker. "The Calderons are now being punished for their roles in a bribery scheme that involved multiple forms of payments, as well as the attempted concealment of the scheme through money laundering and lies made to residents of his district. Politicians who violate their oaths by selling their offices will be discovered and will be prosecuted."

"Mr. Calderon used the power of the state Senate to dole out favors in exchange for bribe payments and a flashy lifestyle, rather than governing honestly for the people of California," said Deirdre Fike, the Assistant Director in Charge of the FBI's Los Angeles Field Office. "I'm proud of the agents and prosecutors who made this case a success using innovative techniques to uncover a variety of schemes and abject corruption by a state official."

"At the heart of this case are two brothers - one a politician, the other the facilitator - who thought they were above the law and could exchange political favors for bribery payments," stated IRS Criminal Investigation's Acting Special Agent in Charge, Anthony J. Orlando.

Hahn and Napolitano clash over solutions to traffic and homelessness

■ The two L.A. County Supervisorial candidates agreed on major goals, but differed on how to get there.

CERRITOS – The two candidates competing to replace outgoing Los Angeles County Supervisor Don Knabe displayed sharp contrasts on issues of transportation and homelessness during a debate in Cerritos on Tuesday night.

Rep. Janice Hahn (D-San Pedro), a former L.A. city council member, is running against Steve Napolitano, a former mayor of Manhattan Beach and Knabe's senior deputy, for the Fourth Supervisorial District seat.

Hosted by KPCC at Cerritos Library, the nearly 90-minute debate highlighted the differences between Hahn and Napolitano who shared similar goals for L.A. County, but proposed separate paths to get there.

Perhaps the greatest difference arose over transportation and Measure M, the county initiative to instate a permanent half-cent sales tax to raise \$840 million per year to fund transit operations and traffic decongestion efforts.

Hahn offered her support for the measure, while acknowledging it needed oversight to ensure the funds go towards the cities in the Fourth District.

"I'm very upset about the ballot language, but this will provide \$120 billion, create good jobs, and fast track these transit projects,"

Napolitano opposes the measure, citing the 43 cities that have petitioned against the tax proposal.

"This is a city of L.A.-driven measure. It's shortchanging the Fourth District. I'm standing with my cities and voting no on Measure M," he said.

The candidates also addressed homelessness, which increased by 5.7% in L.A. County since 2015.

Napolitano proposed creating private/public partnerships to tackle the issue by increasing more low-income and transitional housing options. He even floated dedicated entirely for homeless services.

non-profits overwhelmed -- we need help to fund these programs," he said.

Hahn agreed that more money should be earmarked for homelessness prevention, offering her support for rapid re-housing and the "Millionaire's Tax," which could raise \$250 million from increasing taxes on wealthy residents of L.A. County.

Both candidates agreed that addressing mental health was also key in the conversations around homelessness.

The tensest moment of the debate came when Hahn was asked to defend reports that her campaign accepted nearly \$440,000 in illegal donations from political action committees, which can only donate \$150,000.

Hahn said she has since paid the money back, calling the excess donations a misunderstanding of campaign financing rules, which did give Hahn's campaign higher fundraising limits on personal donations since Napolitano selffunded his campaign with \$2

"I am not a millionaire so I had to raise every dollar," said Hahn accusing Napolitano of trying to buy a seat on the board of supervisors.

Napolitano maintained that the excess money Hahn collected in the primary helped buoy her campaign.

Nevertheless, Hahn and Napolitano agreed closely on a number of other issues like business-friendly policies and fiscal solvency.

Hahn touted her record the idea of a quarter-cent sales tax brokering contract deals with union workers as a city council member and spoke of her time on the small business committee in

> Napolitano cited the difficulty for businesses to get permits and licenses at the county level, promising to streamline the process, reduce fees, and launch business summit to bring government and the business community together.

Responding to an audience and Halloween parade starting at 6 p.m. education, question about Napolitano doubled down on his call for early childhood education programs as well as expanded arts education county-wide.

"I am supportive of every ballot measure that supports our schools," said Hahn, who proposed pushing for smaller class sizes and investments in before and after-school programs as well as vocational training.

The winner on Nov. 8 will represent nearly two million people in the county's Fourth District, which stretches from the South Bay, down to Long Beach, and up through the Gateway cities like Downey and Norwalk to Diamond Bar.

Construction begins on final segment of I-5 South widening project

LA MIRADA - Caltrans and the Los Angeles County through this location along I-5 Metropolitan Transportation daily. Authority (Metro) on Wednesday began construction on the I-5 Valley View Avenue Interchange Project.

This is the sixth and final project to begin construction on I-5 and will add new carpool and general-purpose lanes in each direction from the Los Angeles County / Orange County Line to the San Gabriel River Freeway (I-

Roughly 170,000 vehicles pass

The project will improve corridor mobility from the county line to I-605, provide congestion relief and improve safety and goods movement.

"This is the final hurdle toward making transportation safer and less congested along this vital stretch of the I-5 South corridor," said Caltrans Director Malcolm Dougherty. "It brings us one step closer toward improving freeway connections for commerce and the local communities."

This project will replace a 60-year-old four-lane bridge with a six-lane overcrossing, while keeping lanes open to traffic. The new bridge will span 1,640 feet and include a railroad bridge to separate local traffic from trains, increasing traffic and pedestrian safety, and eliminating hazards associated with train-vehicle collisions.

The Valley View Avenue Interchange segment is located between the Artesia Boulevard undercrossing to North Fork Coyote Creek, through the cities of Buena Park, La Mirada, Cerritos and Santa Fe Springs.

The Valley View Avenue Interchange project cost is \$631 million and is being funded through a combination of federal, state and local resources.

Construction is anticipated to be complete in late 2019.

MARTIN: How should you vote on the most controversial ballot propositions? I'll tell you.

Prop. 56- Cigarette Tax to Fund Healthcare, Tobacco Use Prevention, Research, and Law Enforcement. Initiative Constitutional Amendment and **Statute**- Prop 56 is a complex and divisive proposition because I can agree with proponents on both sides of the fence on this issue.

I would recommend a "No" vote on Prop. 56 because it would raise the cigarette tax from .87 cents to \$2.87 per pack. Currently California's tobacco tax ranks 37th highest in the country but would jump to eighth 66- Californians to Mend, Not End, the Death Penalty-, also known as "No if passed. Some of the extra money will be dispersed to preventative on Prop 62 and Yes on Prop 66," is leading the campaign in opposition awareness programs, e.g., Medicare and breast cancer, but what about

Net revenues are projected as high as \$1.4 billion by 2017-2018, but this measure is suppose to deter smokers from succumbing to the nicotine cravings so in turn that number is expected to fall over time. Legislatures will be forced to continue to increase the tax in order to make up for loss of revenue annually to afford this measure because implementing law enforcement and collecting the tax will have to come from somewhere.

Trial Requirements Initiative- I would recommend a "Yes" vote on Prop. 57. Gov. Jerry Brown backed this measure in hopes it would lower inmate populations in the outrageously overcrowded California prison system by creating incentives for rehabilitated nonviolent prisoners to remain on their best behavior, ultimately expediting their release. It would also allow a judge to determine whether a juvenile should be tried as an adult which I believe makes the most sense.

Prop. 58- The California Non-English Languages Allowed in Public Education Act (Senate Bill 1174)- A profound "Yes" on Prop. 58, which would repel the borderline-racist Proposition 227 from 1998 and lead the way into the future by allowing multilingualism in public schools throughout California. This is personal to me because as a child, my first language was Spanish.

My grandparents came here from Peru in the late 50s, in a time that was not as accepting toward immigrants and non-English speaking families. My mom and uncles assimilated quickly and quietly into fluent English speakers and successfully lost any form of an accent but maintained bilingual.

After struggling to learn English, I spent my first three years of grade school refusing to answer my grandparents in Spanish because I wanted to perfect my English and extinguish my Hispanic accent.

In the process I forgot how to speak Spanish but held on to the comprehension so I would speak in English to my grandparents and they would reply in Spanish. I didn't want anything to get in the way of my assimilation but I almost forgot the importance of my heritage in the

I hope that if this passes, it would allow kids like myself comfort enough to speak their native language and English both at school and at

Prop. 59-California Overturn of Citizens United Act Advisory Question Dear Editor: (Senate Bill 254)- This one is an easy and definitive "Yes" to Prop. 59, a bill that would call on our elected officials to overturn the controversial Citizens United vs Federal Election Committee. It is a step in the right direction but many more state legislatures need to step forward and take big money out of politics.

Halloween is the celebration of all things scary. For children, this means dressing up as their favorite characters and enjoying tricks and treats. For adults, the celebration often involves alcohol.

Unfortunately, Halloween is also known for having the highest number of child-pedestrian deaths all year and ranks among the worst for holidayrelated DUI crashes and deaths. The California Office of Traffic Safety (OTS) and California Highway Patrol (CHP) are providing tips to trickor-treaters, parents, and partygoers to keep everyone safe this Halloween.

"Halloween should be a time of fun for kids and adults alike," said OTS Director Rhonda Craft. "Some planning ahead, plus extra caution that night, can keep everyone safe on our streets this year."

According to the National Highway Traffic Safety Administration, on Halloween night between 2009 and 2013, 119 people were killed by drunk driving, and 43 percent of all motor vehicle deaths involved drunk driving. The number of deaths among pedestrians ages 5 to 14 is four times higher between 4 and 10 p.m. on Halloween than on any other evening of the year. In 2013, 26 percent of all pedestrian fatalities on Halloween night involved a drunk driver.

"With an increase in the number of children and adults out on Halloween, motorists play a critical role in helping to keep them safe," said CHP Commissioner Joe Farrow. "As a driver, it is important to abide by the rules of the road and remain alert, sober, and free from distraction."

Trick-or-treaters are often too excited and forget about safety, so motorists and parents must be even more aware. Keep these helpful tips in mind when out and about:

Plan your route ahead of time on well-lit streets. Avoid busy streets.

•Choose a costume that makes it easy to walk, see and be seen. Light color costumes are best.

•Select costumes, masks, wigs, or beards made of flame-retardant materials (check the labels). Avoid flimsy, lightweight fabrics and costumes with billowing skirts or loose baggy sleeves.

•A mask may keep kids from seeing well, so make sure they take it off Prop 64, the California Marijuana Legalization Initiative- A resounding before crossing the street. Consider using makeup instead of a mask for

> •It is best to trick-or-treat when it is still light outside, but carry a flashlight so trick-or-treaters can see and drivers can see them.

•Use retro-reflective tape on costumes. Be creative in applying it to make it fun to be seen.

Adults often party on Halloween night, which can lead to drunk and drugged driving, and even dangers fueled by costumes and the excitement of the night. Motorists, partygoers, and hosts should keep these tips in

•Avoid driving through residential areas where trick-or-treaters are likely to be present.

•This is a night to slow down, be extra cautious, and obey all traffic signs and signals. The risk of killing a pedestrian increases with just small increases in speed. A pedestrian is nearly twice as likely to be killed if hit by a car going 30 mph compared to 25 mph.

•Party hosts should have plenty of food on hand for everyone throughout the evening and several non-alcoholic drink choices for the designated drivers. Do not allow anyone to leave if you have any doubts about their ability to drive.



Taxpayers would pay about \$58 per \$100,000 in assessed property value for the bond measure.

"Regardless of circumstances, no one is granted an exemption to commit crimes with impunity. As today's sentence shows, the government will hold accountable those who use fraud and deceit to line their pockets with money, especially when those individuals are serving the California

Calderon admitted participating in a bribery scheme involving two areas of legislation and the hiring of a staffer who was also an undercover FBI agent.

In the first part of the bribery scheme, Calderon took bribes from Michael Drobot, the former owner of Pacific Hospital in Long Beach, which was a major provider of spinal surgeries that were often paid by workers' compensation programs. The spinal surgeries are at the center of a massive healthcare fraud scheme that Drobot orchestrated and to which he previously pleaded guilty. Calderon was not charged in the health care fraud scheme that led to well over \$500 million in fraudulent billings. Drobot, who was described in court papers filed by prosecutors as "a greedy fraudster robbing taxpayer-funded federal programs," was a client of Tom Calderon's political consulting firm.

California law known as the "spinal pass-through" legislation allowed a hospital to pass on to insurance companies the full cost it had paid for medical hardware it used during spinal surgeries. As Drobot admitted in court, his hospital exploited this law, typically by using hardware that had been purchased at highly-inflated prices from companies that Drobot controlled and passing this cost along to insurance providers.

Drobot bribed Ron Calderon so that he would use his public office to preserve this law that helped Drobot maintain a long-running and lucrative healthcare fraud scheme, which included Calderon asking a fellow senator to introduce legislation favorable to Drobot and attempting to recruit other senators to support Drobot.

for Ron Calderon's son, who was hired as a summer file clerk at Pacific Hospital and received a total of \$30,000 over the course of three years, despite the son doing little actual work at the hospital.

In another part of the bribery scheme, Ron Calderon accepted bribes from people he thought were associated with an independent film studio, but who were in fact undercover FBI agents. In exchange for the payments - including \$30,000 in payments to Ron Calderon's daughter for services she never provided - Ron Calderon agreed to support an expansion of a state law that gave tax credits to studios that produced independent films in California.

The Film Tax Credit applied to productions of at least \$1 million, but, in exchange for bribes, Ron Calderon agreed to support new legislation to reduce this threshold to \$750,000, according to the plea agreement.

Ron Calderon took several official actions with respect to reducing the threshold for the Film Tax Credit. Ron Calderon signed a letter on his official Senate letterhead indicating that he would propose legislation lowering the threshold, introduced a "spot bill" he told an undercover agent would be used to propose such legislation, and promised that he would vote in favor of that proposed legislation.

In addition to the payments to his daughter for work she did not do, Middle School, located at 21406 S. Elaine Ave. in Hawaiian Gardens.

Ron Calderon had one of the undercover agents make a \$5,000 payment toward his son's college tuition and a \$25,000 payment to Californians for Diversity, a non-profit entity that Ron Calderon and his brother used to improperly pay themselves.

In a sentencing memorandum filed with the court, prosecutors write that Ron Calderon "sold his vote not just to help pay for the expenses of living beyond his means, but for the more banal and predictable aims of corruption -- fancy luxuries, fancy parties, and fancy people."

The memorandum further argues that a significant term of imprisonment was necessary to send a message to other political officials and the electorate because, without such a sentence, "the trust already eroded by individual detections of corrupt politicians will spread like cancer and threaten the fundamentals of a trusted democracy. It is not hyperbole to insist that nothing less is at stake in defendant's sentencing."

As part of the agreement with the undercover agents, Ron Calderon performed official acts that led to the hiring of another undercover agent as a staffer in his district office at an annual salary of \$45,105.

public by submitting a false Statement of Economic Interest, California Form 700, to the California Fair Political Practices Commission, which failed to disclose the money and other financial benefits defendant he had received from Drobot" and the undercover agents, Ron Calderon admitted in his plea agreement.

Tom Calderon pleaded guilty to money laundering and admitted that he agreed to conceal bribe payments for his brother from the two undercover FBI agents by having the money go through his company, the Calderon Group. Tom Calderon allowed payments to be made to the Calderon Group "to conceal and disguise the fact that the money represented the proceeds of bribery," according to his plea agreement.

The investigation into the Calderons was conducted by the Federal The payments from Drobot came in the form of summer employment Bureau of Investigation and IRS Criminal Investigation. The case was prosecuted by Assistant United States Attorney Mack E. Jenkins of the Public Corruption and Civil Rights Section.

NORWALK - Students across Norwalk-La Mirada Unified's 17 elementary, six middle and three high schools followed safety drills to "Drop, Cover and Hold!" on Oct. 20 as part of the annual Great ShakeOut, a statewide initiative that reminds Californians to prepare for earthquakes.

'One of our District's priorities is to ensure that we provide a safe environment for our students," Superintendent Dr. Hasmik Danielian said. "This includes ensuring our students, teachers, administrators and staff know what to do in the event of an emergency so that we are fully prepared should something happen."

Starting at 10 a.m., Norwalk-La Mirada Unified participated in an earthquake drill as part of the Great ShakeOut.

Leading up to the drill, administrators reinforced emergency procedures with students, including finding appropriate cover to prevent objects from injuring them, where to go for safety and where to find first aid kits in the classroom.

Norwalk-La Mirada Unified staff also reviewed emergency protocols, including procedures to check student and teacher absences, how to handle injuries on campus and what roles each staff member has during preparedness at school, work and home.

"It is important for our students to understand what to do in case of an emergency at school with their peers and also at home with their family," NLMUSD Board of Education President Karen Morrison said. "The Great ShakeOut was a great opportunity to remind our students to be prepared wherever they are."

Norwalk-La Mirada Unified holds fire, earthquake and lockdown drills throughout the school year. Principals send monthly updates that include safety tips to inform parents on what they can do at home to prepare in the event of an emergency.
