## Norwalk man identified as victim in deadly skatepark shooting

NORWALK - The Norwalk Sheriff's Station has identified the 26-year-old man fatally shot at the city's skate park last Saturday night.

Deputies at the Los Angeles County Sheriff's Department say the 26-year-old victim was James Gregory Medrano of Norwalk, according to Deputy Juanita Navarro-Suarez.

Witnesses say they saw Medrano with other people at the skatepark, located just east of the city's arts & sports complex at Norwalk Park on the 12200 block of Sproul Street.

Deputies say Medrano became involved in an argument with another man when that suspect pulled out a handgun and shot Medrano several times in the torso.

He was pronounced dead at the scene, said Deputy Lisa Jensen of the Sheriff's Information Bureau. The shooting was reported to the sheriff's station at 7:59 p.m. on Saturday, Nov. 19.

No other suspect information was available, however, Sheriff's homicide detectives are asking anyone with any information regarding the shooting to call them at (323) 890-5500.

It was 1991. Getting together with the family for Thanksgiving dinner was not something I was looking forward to, having lost my father, whom we called Popi, just two months earlier.

Yet I felt an obligation to my mother and the rest of the family to be there to help alleviate the obvious void that was left in my parent's home.

On holidays before my dad died, the house and neighborhood were filled with sounds of Mexican music blasting from Dad's reel-to-reel tape recorder.

It could play non-stop for 24 hours and sometimes did, often to the annoyance of the neighbors, and always to the frustration of my mother, in spite of being hard of hearing. I could hear the music the minute Saturday - Riverside Municipal Airport, I turned the corner on to their block, though their house was almost at the end of the street.

Popi enjoyed having lots of activity around him, especially since my eldest daughter Yvette made him a great-grandfather, first with Jaime, born in 1986, then with Brandon who was born in 1990.

It amazed me to watch Popi interact with his great-grandchildren in a way that he never could with his own children. I came to realize that becoming a grandparent was God's way of giving parents another chance to get the bonding thing right, if they didn't fare well the first time.

Jaime loved her Popi. The last time she saw him alive she was five years old. She came with her parents to also accepts financial donations year round. This past year alone, more visit with Popi in his bedroom where he lay on a hospital bed. My mom called us to the kitchen to eat. I told

> I walked down the hall to my father's bedroom. There I saw the sweetest sight. Jaime had somehow managed to squeeze through or climb over the hospital bed's metal side guard, and lay on her side facing her Popi. They both smiled at each other as Jaime gently stroked the top of his head.

> Now, the family gathered without Popi, without his lively Mexican or any other kind of music playing. In fact, the only sounds beside our voices were the harsh clattering of the dishes and silverware.

> I didn't know how I was going to get through this strained family gathering. We held hands around the table preparing to say grace.

> Then, with the voice of an angel, Jaime proclaimed, "Popi is so lucky. This is his first Thanksgiving with

Suddenly I felt all the pent up tension leave my body. A smoothing peace washed over me. Someone turned on the radio filling the house with a joyful noise.

Then I knew Jaime was right. And I whispered "Happy Thanksgiving, Popi."

## La Mirada Middle School awarded for inclusiveness

LA MIRADA - Norwalk-La Mirada Unified's Los Coyotes Middle School is being honored with a Golden Bell Award for a student mentoring program, Where Everybody Belongs (WEB), which supports incoming sixth-graders as they transition from elementary to middle school.

WEB connects eighth-graders with new students, making them feel welcomed to the school. Mentors meet before and after school, and during lunch to plan, organize and carry out a series of social and academic activities, including movie nights, Academic Saturday School and Homework Club.

"Earning this award is really exciting because it is not only us, but the past years of WEB leaders as well," Eighth-grade WEB mentor Miseok Kim said. "The leaders were always kind and considerate to the sixth- and seventh-graders."

Miseok immigrated California from South Korea when she was 8 years old. She heard that middle school years were the toughest years for U.S. students.

"I was so worried about entering sixth grade," Miseok said. "But my WEB leader was really patient and answered all of my questions clearly, which left an impression on me. It made the transition so much better for me."

Mentors learn the effectiveness of strong communication and the importance of accepting others, skills that help them adjust when they make the transition from middle to high school.

Prospective mentors apply for the program during spring semester. Once selected, they spend three days at the end of summer training with Los Coyotes WEB coordinators, developing techniques in teamwork and goodwill, as well as examining conflict resolution and anti-bullying strategies.

## **Whittier High senior overcomes** barriers to find academic success

WHITTIER - Some of Whittier High School senior Florencia "Flo" Valenzuela's earliest memories watching addiction consume her drug-dependent parents and having child protective services place her and her younger brother in foster care at 5 years old.

In and out of foster care for several years, Valenzuela at 13 years old found the courage to testify against her parents and avoided having to return to their custody.

Under the guardianship of her older sister, Marcy, Valenzuela has found empowerment and resiliency, flourishing at home and at school. Holding a 3.8 GPA, Valenzuela is an active member of the Associated Student Body, an Academic Mentor to her peers, athlete and community volunteer.

Despite the overwhelming obstacles, Valenzuela has excelled as an academic scholar and community leader and garnering praise from the Children's Defense Fund-California (CDF-CA), which has selected her as a 2016 CDF Beat the Odds Scholarship program honoree. CDF-CA is providing her with a suite of academic and career readiness opportunities – including a \$10,000 scholarship.

"I'm so overwhelmed by the generosity of the Children's Defense Fund and humbled that they would choose me over so many other deserving students," Valenzuela, who is one of five California students to be recognized with the scholarship.

The 17-year-old, who dreams of studying social work or communications at USC, won the scholarship as part of the nonprofit organization's Beat the Odds program, which works to open higher education opportunities for excellence and give back to their communities while overcoming tremendous adversity.

## California Highway Patrol: Freedom of speech and freeways don't mix in L.A.

The California Highway Patrol and local allied agencies, such as the Los Angeles Police Department, were inundated with calls for service on the evening of Nov. 9.

Numerous motorists called 9-1-1 to report that several areas of the US-101, near downtown L.A. were being taken over by large groups of people holding signs and shouting at passing vehicles. Although it's not entirely clear what the purpose of blocking the freeway and freeway ramps was, there was enough indications of political discourse.

The groups became verbally aggressive and physically uncooperative; many demonstrators took a seated position and refused to follow officer's orders. The group's reckless actions endangered thousands of innocent motorists because their path/exit was blocked and were being kept in place against their will for an extended period of time. The group's behavior also caused the response of hundreds of police officers, literally taking them away from their areas of responsibility and delaying emergency service response all over Los Angeles County.

After several hours of Law Enforcement presence and enforcement actions, US-101 was reopened in the early morning hours.

The California Highway Patrol takes pride in being able to safeguard the rights of every citizen, including freedom of speech and freedom to assemble. However, when an assembly changes from peaceful to unlawful, and the actions of some reckless citizens begin to infringe on another person's rights, including endangering them, the CHP will take swift action to restore safety.

As the case Nov. 9 on the 101 freeway proved, enforcement action became necessary due to so many lives being endangered and ultimately, the groups intended message was lost in the chaos.

We encourage everyone in our communities to speak their mind and assemble with other like-minded people, but please do so peacefully and at an appropriate place. We cannot stress enough how dangerous it is for even one pedestrian to walk onto a freeway; we see too many collisions with tragic results as it is already. It should be noted the actions of the group became unlawful as they walked on the freeway and their actions became criminal at the point they began affecting another person's freedom and movement.

The law enforcement community is prepared to respond, prepared to take immediate action and ultimately, prosecute to the full extent of the law any person that knowingly endangers another or infringes on their rights. We are ALL one community and one nation, please keep the peace and respect one another.

### Student protests

On November 15, I was following a thread on Downey's Crime Watch Facebook page regarding Warren High School students walking out of school to protest the election outcome.

To sum up the hundreds of comments people were leaving, many people were against it, stating "those kids shouldn't be protesting, they're only kids, they don't know what they are protesting; they only protested to get the chance to get out of school; it's a waste of taxpayer money for DPD to be escorting them; why pay taxes for public school education if the kids are not learning anything; they shouldn't be ditching school, etc."




