### **Shared Stories: The Ties That Bind**

Frank Novak's story of a rafting trip after a winter of heavy snowfall is a cautionary reminder for those vacationing in the Sierras this summer. Ten people have died so far in Kern and Tulare county rivers this year. Shared Stories is a weekly column featuring articles by participants in a writing class at the Norwalk Senior Center. #### "The Killer Kern" by Frank Novak

In the winter of 2010 - 2011, the Sierras received nearly double the average yearly snow fall. At Donner Summit, made famous by the ill-fated Donner party, the snow level was over 60 ft deep.

By June, the snow melt had swelled streams and rivers up and down the Sierra, and the Kern River was flowing at twice it's normal volume. My three brothers-in-law, my niece, and I had a reservation for a rafting trip.

We had rafted this river before, on a warm day with the river drifting between banks and occasional sandy stretches, dropping around rocks that threw spray into the boats and caused squeals of laughter.

This year, the river was high over the banks, flowing into trees and fields, and in the middle of the river a column of water moved like a freight train over massive rocks that were exposed in normal years. In a portent of thing to come, we were given heavy wetsuits to wear along with the usual life jackets and helmets.

There were four rafts in the group. Our raft shoved off third, going single file down the river. It didn't take long before the second raft in line flipped. We could see it enter a particularly sharp bend in the canyon, and as it rounded a large rock with vertical walls on both sides, the boat was

The six guests and the guide took a long ride in the water. They were in quite a while, but eventually were able to get back in the boat. We didn't think too much about it; we were still having fun.

A little bit later we arrived at the lunch spot. We felt good and ready to eat, but the folks who had been in the water were in a somber mode. Some of guests from that boat had bare feet because their rubber wet suit booties had been sucked off by the current.

They all sat quietly, staring blankly into the distance. They didn't seem By Alex Dominguez much interested in food. The guide of the boat that had flipped walked around talking softly to the other guides.

Eventually, all the folks from that boat loaded into the supply van and headed back to base, done for the day. The rest of us—we still didn't get it.

Just after lunch, it was our turn. Sliding down a chute, paddling to try to keep the boat steer-able while bouncing up into the air, we were suddenly in the water, the boat upside down.

I surfaced six feet away; but the current was relentless and I couldn't get to the boat until our guide reached out with his paddle and pulled me over. We hung to the side, moving fast past another boat that was pulled over at the shore. That guide threw a rope, and only by that means were we able to get our boat out of the powerful center current.



## Local cities promise aid after report reveals drastic spike in homelessness

■ NEW NUMBERS: L.A. County

homelessness went up 23% in 2017 -but twice that much locally.

NORWALK - The Los Angeles Homeless Services Authority (LAHSA) released their results of their annual homeless count for 2017, reporting a 23% increase in people experiencing homelessness

According to the results of the count - which took place in January this year – 57,794 people experience homelessness in LA County on a given night; 46,874 more than the previous year's count.

LA County's Service Planning Area 7 - which includes the cities of Downey and Norwalk – saw a 5,189 person and 50% increase.

Of that number, 3,442 were male and 1,730 female; a 66% and 33% increase respectively.

Only 17 transgender individuals were counted, a 76% decrease from

The bulk of these stats seem to be made up of individuals of Hispanic / Latino descent.

Hispanics / Latinos were the only race within SPA7 to see an increase in population, counted at 3,666 for 71% of the tally - a

White individuals took a far distant second at 885 counted; an 8% decrease from 2016.

While a majority of those counted in SPA7 fell between the ages of 25-54 (52% of the tally and a 20% increase), those aged 18-24 and 55-61 saw huge increases over the last year, at 928 and 719 counted for 160% and 113% increases, respectively.

Veterans were tallied at 155 for a 9% percent increase.

According an official of LAHSA, the skyrocketing cost of housing in LA County - and the inability for wages to keep up with the pace of rent - can be blamed for pushing people out onto the streets.

Specific numbers for the cities yet known and will likely not be available until mid-July, however city officials have already started responding to the currently available results.

## Circulating flyer attacks trash company hoping to win Norwalk's waste contract

NORWALK - A circulating flyer in email has caught the attention of Norwalk residents, calling the integrity of one of the city's potential future waste handler's into question.

The email spreading leans heavily against NASA Services, which is currently contending for a waste hauling contract with

The email attempts to tie the company with several lawsuits and dirty politics in the city of Pico Rivera, however it is uncertain who is behind the spread of the information.

NASA Services has yet to return a call for comment.

According to this email, NASA submitted its bid to the city of Norwalk in 2016. However, NASA was one of several business bumped from contention by HF&F Consultants - who was hired by Norwalk to review the 11 proposals received by the city by several companies - after determining that NASA Services would only bring a 1% savings at too high of a risk for the city.

However, the email continues that the conclusion of a special meeting held on May 6 saw NASA back in the running, selected as one of five finalists for the contract.

Several calls were made to City Manager Mike Egan to confirm this information, however, they were not responded to in time for the publishing of this article.

Mayor Luigi Vernola described it as "political bullshit."

"They want to intimidate me?," said Vernola.

When asked who "They" was, Vernola simply said, "Well, individuals who want to intimidate me to vote a certain way [regarding the disposal contract] I guess." -- Alex Dominguez, staff writer

## Two suspects arrested in Norwalk after bank robbery

NORWALK - Two male suspects were taken into custody last Friday after a short car and foot chase with L.A County Sheriff's deputies near the 15500 block of Fairford Avenue.

According to Cerritos Sheriff's Station Watch Commander Lt. Richard Hernandez, the suspects allegedly held up a branch of the Bank of the West on Carmenita Avenue in Cerritos. A pursuit of the suspects began at the bank, but authorities say the pursuit never made it onto any freeways.

"They drove (west) on Artesia, then north on Bloomfield, and finally west on Alondra Boulevard," said Cerritos Sheriff's Station Sgt. Stephanie Mandujano.

A spike strip was ultimately deployed at the intersection of Norwalk and Alondra boulevards.

"They worked," said Mandujano, who described the two suspects as African-American.

While a part of the car pursuit, Mandujano was not involved in the foot chase, which brought the neighborhood to a halt.

We sat on the warm rocks, gathering our breath, feeling the adrenaline subside. No one talked, but to be honest, none of us wanted to continue.

We had all felt how powerless we could be against the force of the river. But we had no choice nowfor us the only way off the river was to continue down: only a couple more bad rapids to go.

The last rapid was Pinball, a hundred-yard field of boulders snaking down the canyon. It didn't look bad considering where we had been.

We were half way through, controlling the boat and doing well, when from behind a rock appeared a four-foot-deep hole in the swirling

The bow nosed in hard, the guide at the rear of the raft was catapulted down river in a high arc, and we were in the water.

I was completely under, the black bottom of the boat above me, the life jacket pushing me up, pushing my head against the bottom. I tried to work out from underneath, but I was wedged between the edge of the boat and something else, maybe another swimmer.

I pulled with my arms and kicked, but suddenly the suction of an undercurrent pulled me down. It was deep and flowing. Above me, three feet of green water was dimly lit by the sky. I remember thinking, I'm still OK ... but I've been down here a long time.

After I surfaced and spent the next minute sliding down the middle of the river getting face-full after face-full of water from waves standing three feet tall, and after I decided to swim for the shore and was carried down a side channel waiting to pull us out, and after I lay and repeating the same curse word over and over under my breath, not caring what anyone else in the boat thought, and after the long bus ride back to the camp, and the returning of gear, and the mandatory smiles and photos with the guides, and after we had taken inventory of the physical cuts and scrapes, we sat in a restaurant and tried to sort out the psychic damage.

"Now that it's over," one of us said, "I'm glad that it happened."

"Not too many people get that close to drowning and can still talk about it."

In a week which saw me witnessing an over-budget and delayed beautiful Veteran monument dedication, catching up to a suspected bank


robbery chase scene and then that darned email, how could I even think of preparing to cook dinner? Life goes on I guess.

## **HAMILTON:** Congress must reassert itself on use of military force overseas

The Trump Administration, like its predecessors, has shown an apparent appetite for the use of force overseas. The "mother of all bombs" dropped on Syrian troops, saber-rattling toward North Korea, deployments of U.S. forces in 10 or more countries — all of this suggests a growing comfort with the idea of putting our troops in dangerous places.

Politicians on Capitol Hill have noticed this. In particular, senators Jeff Flake of Arizona, a Republican, and Tim Kaine of Virginia, a Democrat, have introduced legislation to authorize the use of military force against ISIS and other terror groups. This is an effort to assert congressional authority and extend Capitol Hill's oversight over the use of force by the White House, something Congress has long neglected. "It's our constitutional duty in Congress to authorize military action," Kaine said at the end of May.

All I can say is, Amen! American soldiers are involved in combat situations in countries all over the globe. We're deploying special operations forces and advising, equipping and training local forces to fight. All too often, these countries' leaders are more concerned with overcoming internal threats than they are with the strategies and values that motivate us to help them.

The argument for all this often comes down to: "We need to do something." Once we're there, the arguments for staying get rolled out: we can't leave without loss of face; we need the leverage more troops provide for negotiation; we'll lose credibility and standing if we withdraw.

But our experience over the years has shown that we don't tip the scales of a war that in most cases has no battlefield solution. We repeatedly get ourselves locked into situations where we must ask ourselves how much bloodshed and destruction we can accept as a result of our entanglement.

The decision to send troops overseas requires clear eyes, hard questions and specific answers. If we are sending our military abroad, our objectives and exit strategies need to be nailed down. Are we engaging in nation- or empire-building? Do we risk being locked into protracted, unending conflicts — we've already spent 15 years in Afghanistan — with minimal progress? Are we inflating the dangers to our national security, as we did when we falsely asserted that Saddam Hussein had weapons of mass destruction?

And when we do intervene, are we avoiding or increasing the suffering of the local people whom we're trying to help? No use of force should go forward without reciprocity — that is to say, capable, committed local leaders who fight corruption and try to provide good governance and protect the values we cherish and

The use of force ultimately comes down to the president — or the president and his top advisors making the decision. This usually happens without sufficient dialogue, consultation, or robust debate beyond the White House. The people the president consults around him are not independent — they hold high office at his pleasure and, from my experience, generally come into the room prepared to reinforce his arguments.

What the president really needs, as LBJ advisor George Reedy famously said, is someone who can tell him to go soak his head. In particular, the people who have to do the fighting and bear the costs need to have a major voice in the use of force, and the best way to ensure that is with the involvement of the Congress.

There are obviously cases where the president needs flexibility. But if we're to put our troops in harm's way, he also needs independent advice and to answer tough questions. I don't see any alternative but the strict, robust and sustained involvement of the Congress.

Deciding on the use of force is the most grave and consequential decision government makes. It is of such import that it should not be made by the president alone, but should be shared with the Congress. Presidents should not get broad authority to use force without limit on geography, objectives, or types of forces. The Founding Fathers had it right: the president is commander in chief, Congress has the authority to declare war. Power over the use of force needs to be shared.

## Caltrans reminds motorists to secure loads before traveling on California roads

#### **SACRAMENTO**

Transporting unsecured loads is unsafe, illegal, and pollutes California's roads and waterways. Caltrans wants motorists and commercial vehicle operators to make sure their load is secure before driving.

Vehicle-related debris can create unsafe conditions for motorists, contributes to litter on highways and could lead to pollution in waterways.

"This is safety, environmental, economic, and aesthetic issue that is 100 percent preventable," Caltrans Director Malcolm Dougherty. "We spent more than \$67 million last year picking up litter and debris. By properly securing your load before you head out, you can help keep our roads clean and safe, and also protect our waterways from being contaminated."

A load is secure when nothing can slide, shift, fall, or sift onto the roadway. Here are some tips on properly securing a load:

- Tie it down. Large or heavy items should be secured with solid straps, rope, bungee cords, or netting. Make sure your tie down materials are appropriate for the weight they are securing and can withstand highway speeds.
- Cover it up. For loose items like grass or tree clippings, a tarp or netting can be used to keep items in place.
- Don't dispose of litter in pick-up beds. Litter in pickup beds can fly out when the vehicle reaches highway speed. Dispose of litter properly.
- Re-check your load. Loads can shift and settle during a trip. If safe to do so, re-check your load during your trip. Tighten straps that may have



loosened and adjust your load if necessary.

Litter and debris can clog stormwater drains and may end up in



## Paging Dr. Frischer...

In my mind, there are two types of people: huggers and non-huggers. Those of you who know me well are aware that I am definitely the former. I hug because I love people and value human contact.

Some people, however, just aren't the cuddly type. Regardless of your touchy-feely preferences, a hug can be an expression of warmth and friendliness, a gesture of love, kindness, sympathy, trust, greeting, or

I believe that it benefits both parties, but is there any scientific explanation or evidence that this is true?

Hugging has been found to trigger several hormones and neurotransmitters: Our skin senses the pressure of touch through a network of tiny nerve endings and communicates this to the brain. This appears to trigger an increase in levels of the hormone oxytocin.

Oxytocin increases levels of the hormones serotonin and dopamine, resulting in greater calm, and reduced depression and anxiety. Low dopamine levels are seen in those with depression and Parkinson's disease.

Oxytocin also causes a decrease in the heart rate and a drop in the stress hormones cortisol and norepinephrine. This can lower blood pressure and stress, and increase feelings of contentment and relaxation.

There's evidence that oxytocin improves immune function and pain tolerance. In a 2015 study, researchers from Carnegie Mellon examined whether hugs could reduce susceptibility to the common cold after being exposed to the virus. Those who felt greater social support and reported receiving frequent hugs were less likely to come down with a cold, or had less severe symptoms.

A 2015 study from King's College in London found that oxytocin has analgesic effects, leading to a reduction in perceived pain intensity.

#### Downey home prices jump 10%

Hugging reduces the levels of circulating cortisol. Lower levels of cortisol allow the mind to calm down and the body to relax. It also helps to decrease cortisol-induced hyperglycemia and diabetes.

Here is one more important finding. Most of us worry about our mortality, particularly as we age. A study published in the journal Psychological Science revealed that hugging and touching reduced that concern. The study showed that even hugging an inanimate object like a teddy bear helped to soothe fears.

In fact, simply imagining hugging a person you love can cause the brain to release serotonin, dopamine, and endorphins, triggering feelings of happiness and joy.

Just between you and me, I had intended to continue hugging on a daily basis regardless of what I found in this research. Hugging triggers a massive release of neurohormones, giving us confidence, strengthening our bonds with one another, building trust, alleviating sadness, tension and anxiety; and bringing us joy and happiness.

Sometimes the simplest treatments are indeed the best!

## La Mirada High woodshop students build, donate garden boxes to local youth shelter

LA MIRADA – La Mirada High School senior Isaac Cantu is vigilant as he stencils the words "Dream Big" along the side of one of four garden boxes that he and three other students made in their woodshop class.

When Cantu and seniors Johnny Granados, Andrew Iabarra and Spencer Collins finish the garden boxes, their hours of craftsmanship will house dozens of plants, flowers, fruits and vegetables to beautify the grounds of the Casa Youth Shelter in Los Alamitos.

"It feels great that the kids at the youth shelter are going to actually use the boxes that we made," Collins said. "Gardening is very meditative and I'm really glad that it's going to provide a useful hobby for these kids

because they don't have much."

The Casa Youth provides temporary shelter and counseling for homeless, runaway abandoned youths in crisis with the ultimate goal of family reunification.

The idea donating garden boxes to the youth shelter originated

from La Mirada High counselor Ila Patterson, who says gardening is a therapeutic hobby for those willing to develop their green thumbs. "These garden boxes are symbolic of what I hope the children will

do while they live at the shelter, since they can grow from counseling support and nurturing," Patterson said. "Just like the plants, the kids will grow and produce amazing results."

Patterson coordinated with the school's woodshop teacher, Ken Yoshioka, to gather student volunteers to build the boxes.

Yoshioka said he jumped at the chance to offer the project to his students because it would both fulfill a philanthropic purpose and allow the students to see that their woodshop abilities can have practical
