Man wounded in drive-by shooting

NORWALK - A 35-year-old Norwalk man was wounded in a drive-by abdomen and was transported to Coast Plaza Hospital in Norwalk by shooting at about 1:50 p.m. Sunday, according to Norwalk Sheriff Watch Commander Sgt. John Haynes.

The shooting occurred near the intersection of Cedarvale Street and Horst Avenue in south Norwalk.

The victim was identified as Randy Vera. He was watering his front yard at the time of the shooting.

Callers to 911 reported hearing 7-8 gunshots. Up to five shots were

reported to have hit the residence; no one inside was hit.

According to Sgt. Haynes, the victim received one gunshot to his

family or friends where it was determined to transfer him to the trauma center at St. Francis Medical Center in Lynwood.

Sgt. Haynes stated that the victim was treated and released. Additionally, Sqt. Haynes stated that it was a suspected gang-related shooting.

I was 23 years old when I decided to abandon my mother, my father, and my siblings. I wanted to run away from my house and all those family reunions that we had almost every other weekend. My main purpose was to find happiness, improve my English, travel, and visit another country for the first time

I wanted to find a good job that would allow me to buy all the things that my parents couldn't afford. But 25 years later, I am still looking for that idea of happiness that I now believe only existed in my mind.

Back in 1979 when I was 10 years old, I think I was a happy kid, but I can't really say it because I don't remember even thinking about it. I grew up with my mom, dad, three brothers, and three sisters in a small house outside of Mexico City. We did not have many material possessions, but my parents always made sure we had food on the table and a roof over our head.

To be honest, at that age I didn't care too much about everything and I didn't know much either. My biggest concern was playing soccer on the street with my friends. My dream was to become a professional soccer player and earn enough money to buy a big house and have a lot of toys and possessions, like the beautiful people in TV commercials with big smiles on their faces who seemed to have everything.

During the first 10 years of my life, the population in Mexico grew so fast that in the decade of the 80's, it became known as the largest populated city in the world. During that time, most of the families had an average of five to seven children and usually the father went out to work while the mother took care of their kids.

There weren't many opportunities in the urban areas because society was growing rapidly. Many people went out to live in the suburbs. In many cases, they lived without having the basic services at all, but people manage to survive.



Even though the community we lived in was considered one of the low-income areas, we didn't mind because at that time we didn't associate having money with being happy. It wasn't until the 70's, when the television became the main source of entertainment for most people, that we realized how poor we were.

During my teenage years I always complained to myself about the conditions we lived in because I could not have what I wanted. Nevertheless, I remember my older brothers telling me that I was the lucky one in the family because I hadn't suffered at all. By the time I was born, our house already had power, running water, and a full bathroom.

One of the questions I disliked the most was when people would ask, "What are you going to be when you grow up?" Most likely it bothered me because I didn't know what to answer.

I recall being next to two of my older sisters when a teacher asked the oldest one the same question. Her response was, "A journalist."

My other sister gave the same answer. So, when it was my turn I also said I wanted to be a journalist even though I didn't know what it was. After that, every time someone asked me, I always gave the same response.

By the time I was 20, I was already on my way to becoming a journalist, although I was still very ignorant about the injustices and inequalities that prevail in most societies. However, I believe that the busy trend of life doesn't allow us to see the whole picture of the problem and in many ways, people remain busy trying to find their own happiness, fulfilling their material needs.

According to Socrates, the Greek philosopher, "Happiness flows not from physical or external conditions such as wealth and power, but from living a life that's right for your soul. If you don't know what's good for your soul, then you will be misled into pursuing happiness based on what's conventional or easy."

Right after I finished college, I came to the United States looking for a stable job that would allow me to have a better life. Ironically, I left my house, my family and friends - all those things that during my first 23 years of existence made my life easier, and I would even say happy, without even realizing it.

English, so I could get a better job and with some money in my pocket, so we would live happily ever after. Twenty-five years later, I never went back to live there and most of my family has never come to visit me.

At the age of 30, I was already living in Los Angeles. I was lucky enough


I promised my family that I would go back in a couple of years speaking

to have a small business, a career, and a house of my own. By then, I asked myself if I was finally happy. My answer was NOT really. Even though I had a beautiful wife and a great son, my thoughts about my family in Mexico never left me.

Nevertheless, it wasn't just the need for my family in Mexico. By the time I reached 40, I was more aware about the injustices and inequalities that exist in almost every single society, including in the richest country in the world. So it was impossible for me to pretend that one day I would find happiness when there is so much pain and suffering all around caused by Mother Nature and by us humans.

Now I am 48 and have concluded that the idea of happiness associated with material possessions, achievements, and pleasures is very relative. I am certain those factors can provide some level of satisfaction, but regarding happiness, real happiness, I'm not sure exactly what that means.

The best thing I can do is try to enjoy the moment I am living now, not in the future, not in the past, but today. Value every day the people and things around me and never stop living without a purpose.

County brings back crash assemblies for teens

LOS ANGELES – In an effort to make roads safer and to get teens to drive safer, County Supervisors Janice Hahn and Sheila Kuehl are providing grants to bring the award-winning In One Instant Teen Safe Driving Program free-ofcharge to their districts' schools.

In One Instant attempts to reach teens on an emotional level, showing them that they have immense power over their own driving decisions and life choices. It also motivates them to promote safe driving behaviors throughout their communities.

The program is designed to be peer-driven. Teens are encouraged to become In One Instant Student Leaders, receiving oversight from a designated school staff member as well as guidance by the In One with one arm/hand. Hold on to Instant team.

School administrators can also implement In One Instant, while involving students in its presentation.

Reminder: During an earthquake, drop and take cover

LOS ANGELES – The recent 3.6 magnitude earthquake that struck near Westwood at 11:20 p.m. on Monday and 7.1 magnitude earthquake near Raboso, Mexico on Tuesday prompted a reminder from Los Angeles County authorities that a catastrophic earthquake could occur at any time.

The County of Los Angeles Chief Executive Office, Office of Emergency Management (OEM) wants to remind all County residents and businesses to take the necessary steps now to prepare for earthquakes and other hazards and threats.

The following are some preparedness tips on what to do during an earthquake, provided by the Office of Emergency Management:

■ If you experience shaking, the recommended actions are to drop under a piece of furniture. Take cover under the piece of furniture by protecting your head and neck the piece of furniture's leg to keep it from shifting or uncovering you until the shaking completely stops.

Never run out of buildings during an earthquake as most people are injured by falling debris as they try to exit buildings during the shaking.

- If you experience shaking and are in a wheelchair or walker, lock your wheels; cover your head and neck area with a pillow or some value of life, with the ballad "I Was type of object that will deflect the debris from falling on to you.
 - When you are in public places, be aware of your surroundings and identify your safe spaces.
 - To receive emergency notifications, register your cellular telephone and landlines at Alert LA County, go to lacounty.gov/ emergency/alert-la.

Also, Los Angeles County residents, renters, and business owners, including persons with disabilities and others with access and functional needs, may call 211 LA County at any time for emergency preparedness information.

Whittier High alumnus returns to inspire students

WHITTIER - William C. Gordon may have graduated from Whittier High School more than 60 years ago, but the philanthropist, attorney and author has never forgotten the school that provided him refuge as a teen nor his commitment to upholding what it means to be a Cardinal with CLASS.

Gordon, a 1955 graduate, returned on Sept. 8 to his alma card and an RSVP is required as mater and the library where he set out his future path, to provide more than 800 students the inspiration to overcome obstacles, succeed and give back to the community - just as

> "My roots are deep in the community, and this library changed my life," Gordon said.

Over the course of the morning, Gordon shared his tale of growing up in a single-parent home, being shoe shiner in downtown Los Angeles as a child, speaking more "Spanglish" than English and finding refuge in the Whittier High library to avoid neighborhood gang members.

"When I was 14 years old, I was in this library when I realized that I needed to make a change – I decided that if I wanted to do well in life, I had to do well in school, and I began to study," he said.

Gordon's audience: Students in Guided Study support and special education classes, English learners or those who simply need motivation.

Gordon described how he worked to become an exceptional student in college prep courses and participated in extracurricular activities, becoming a senator and Associated Student Body president during his senior year. He was also awarded the Cardinal Key, Whittier High's most prized graduation award for students who embody citizenship, leadership, achievement, self-respect and service to the community (CLASS).

In recent years, the Whittier High alumnus has donated dozens of books and more than \$230,000 to the school to fund technology upgrades, campus murals and renovate the library with new furniture, paint and an Alumni Hall of Fame showcase. The facility was dedicated the William C. Gordon Library in 2015.

"His story is empowering because a lot of people didn't believe in him and I feel like he speaks to a lot of us who feel that way," Whittier High School junior Jeanette Peña said. "Willie Gordon is such an inspiration and contributor to the community. He stayed true to his roots and continues to give back to Whittier High School. He is the definition of Cardinal CLASS."

After graduating high school, Gordon earned a bachelor's degree in English from UC Berkeley. He joined the Army and later obtained a law degree from UC Hastings College of Law in San Francisco, becoming a civil litigator and community activist for Latinos with work-related injuries.

At age 60, Gordon began writing mystery novels; he has since published seven books.




