Violence in Norwalk is rising, and officials need to act

COMMENTARY: Violent shootings have made Norwalk unsafe, and it's time for the City Council to act.

NORWALK - In a month where we have seen numerous violent episodes including the wounding manager James Parker, in your of a resident in south Norwalk, the homicide of a man near Excelsion Drive and Pioneer Boulevard, and numerous shooting episodes within our city's boundaries. I felt compelled to address the joint special meeting of the Norwalk City Council along with interim city manager James Parker, public safety director Carlos Ramos, Los Jim Tatreau and liaison Lt. Mike

This was done during the public comment portion of the public I am now a witness (again) in these forum. I was the sole speaker.

Here is the body of that address:

Good evening. I am addressing you tonight as a resident of the City of Norwalk. Many of you and I have sat together in formal and informal situations. Some topics have been deemed "on the record," some have

been deemed "off."

We've shared ideas, thoughts

We've laughed, we've sighed, and we've rubbed our heads for find it. the same reasons. Some of us share even closer ties. We've gone to the same high school, community college and even the same university.

We in Norwalk are dealing with continuing violence including the murder, wounding and senseless shootings in just the last seven

The Council recently took

measures to direct the city in "another direction." However, we cannot rest. We need action now.

I am speaking to the entire city council. This is not the time to await a consensus vote or see what the tendency of your fellow elected officials are.

Additionally, you, interim city expanded role as a public servant, are tasked with the moving forward expeditiously regarding this public safety concern.

People are dying on the streets of Norwalk. It makes no difference if they carry a label, a look or nothing discerning at all.

Will it take a stray bullet going Angeles County Sheriff's Captain into a house, then into a sleeping child or adult to have you take a reactive stance? Be proactive.

> I am not an observer anymore. crimes against my community, our community. Your community.

> Norwalk is not a war zone, yet the sounds of war and it aftermath are now present.

Those sitting in front, like me, are residents. Those sitting besides me, may be visitors or employees. We are all a team.

As a team:

If we do not have the resources,

If we do not have the resolve,

If we cannot find the will, step

For those of you who have never had a loaded weapon pointed at you or who have not heard the sound of a bullet spinning over your head, I hope you never do.

However, I am not one to offer concerns without suggestions.



Bring back the communitybased Sheriff teams. If they exist now, bring them out of their seemingly covert existence. They are needed now.

Find resources. Here is the Homeland Security website on Grants available: https://www.dhs. gov/how-do-i/find-and-applygrants

While we are a predominately Hispanic community immigrant based roots, we no longer have a resident base with just one language defined as "other than English." We need advocates who can reach out to our Philippine, Chinese and other emerging languages in our communities. All Americans don't speak just English as their primary language.

Like some of you who have joined me walking door to door to address resident concerns, add teams of outreach members who actually visit residents when they are home, specifically on Saturdays

Redirect current resources from whatever funds are available.

Redefine our Public Safety Department to what it is, a public city hall ambassador. I do not want

our senior aged or young people who are not law enforcement placed in a situation which clearly now dictates an increase in law enforcement personnel is required. Boots on the ground if that is the language you understand.

Find, allocate, and create funds for safety equipment rebates including: outside lighting, surveillance systems, removal of cover (Large vehicles, overgrown shrubbery).

Upgrade street lighting in those areas deemed too dark.

Confirm and implement the technology for the location of cell phone 911 callers.

This real or perceived delay in responding to emergency calls is unacceptable in this era of smart technology.

Granted, I may be in a position where I can contact any elected official directly or public servant through the bureaucracy of city hall "gate keepers," I assure you, the safety of the residents and visitors of Norwalk is at my highest concern.

Don't ignore those bug bites -- virus risk is real, health officials say

PUBLIC HEALTH: 17 new cases of West Nile virus were reported in Los Angeles County last week.

LOS ANGELES - On Monday, Supervisor Janice Hahn and the Los Angeles County Department of Public Health held a press conference to provide an update on increases in cases of West Nile will deploy 100 teams across the virus, and the continued risk of Zika county to deliver packets to over virus in Los Angeles County.

Public Health will conduct a countywide mosquito-borne disease public health campaign, titled "It's Not Just A Bite" to inform residents about the continued risk of West Nile virus and Zika virus infections and to promote actions people can take to protect from mosquito-borne diseases.

"We can't take it for granted that to eliminate mosquito breeding a mosquito bite is just an annoying itch, because it can make you sick," said Hahn. "It is imperative that we inform our residents about steps that we all can take to really make a difference and prevent mosquitoborne diseases.

"Starting today, Public Health 20,000 local businesses, community buildings, houses of worship and schools with health education materials and easy steps everyone can take to prevent bites," said Barbara Ferrer, PhD, Director of Los Angeles County Department of Public Health.

"Vector control districts have residents, and working tirelessly

sites, but we can't do it alone," Truc Dever, General Manager, Greater Los Angeles County Vector Control District. "Mosquito-borne disease prevention is about shared responsibility, and we all must take action now to eliminate standing water where mosquitoes can breed in our own yards and use approved insect repellents when mosquitoes are present.

Together, we can make LA County mosquito-free and free of

said Jeffrey Gunzenhauser, MD, MPH, Interim Health Officer for Los Angeles County. Last week, 17 new cases of

West Nile virus were reported in Los Angeles County, including three deaths among elderly patients who died due to neuro-invasive West Nile virus infection. The total number of West Nile virus cases and deaths in Los Angeles County this year is 98 cases and six deaths.

To date, no Zika virus infections have been acquired locally in Los Angeles County. However, the Aedes mosquito that can carry and spread Zika is present in some areas of the county posing a risk that infection could occur here.

Anonymous video claims nepotism, dysfunction at City Hall

NORWALK - An anonymous video alleging nepotism in city hiring practices and potential employment qualification manipulation is circulating among city staff as well as members of the City Council.

The video, which was delivered to a Norwalk Patriot freelance reporter, also claims to show a city employee teaching a small child how to play beer pong, supposedly at a Norwalk park site.

Vice Mayor Leonard Shryock, along with council members Jennifer Perez, Tony Ayala and Margarita Rios, confirmed they have viewed the video. Mayor Luigi Vernola canceled a scheduled interview last week, claiming the city attorney recommended he refrain from commenting due to the issue being a personnel matter.

"Public Safety Director Carlos Ramos and Human Resources Director Cathy Thompson are heading an investigation into the contents of the video and its accuracy," Shryock said at last week's Coffee with a Cop

Shryock's concern was the part of the video purportedly showing a young child being instructed in a game of beer pong, where players take turns bouncing ping pong balls into cups of beer.

Shryock went on to say that it was former city manager Mike Egan who made him aware of the video on Sept 6. Two days earlier, the council in a closed-door meeting voted 3-2 to severe its relationship with Egan.

On Sept. 12, council members officially voted 4-0 to fire Egan as city

Asked for an interview Sept. 18 on the steps of City Hall, human resources director Cathy Thompson stated, "I don't want to talk to the press right now." No further comment was given.

The video, received via an anonymous source along with a USB drive and letter, described "How a group of Recreation Leaders and Public Safety Officers have created a culture and atmosphere of reckless behavior..."

The letter states that, "...a former councilman removed the qualification

of needing a college degree to be supervisor." The letter refers to Rosie Lozoya, who was hired as a Recreation

Supervisor despite lacking a bachelor's degree, a requirement for the job, according to the city's official job posting.

Downey faces lawsuit after blocking apartment residents from street parking

PARKING: Responding to complaints, City Council restricted overnight parking on Shellyfield Road to street residents only.

DOWNEY The battle between Downey homeowners and renters over available street parking intensified this week after a property management company promised to sue the City of Downey over its use of preferential parking

The City Council voted in 2015 and again Sept. 12 to create a preferential parking district on Shellyfield Road, between Cecilia and Muller streets, which limited overnight street parking to residents living on Shellyfield.

The district was created in response to a petition from Shellyfield residents, complained that renters from local apartment buildings were taking up benefitting homeowners at the all available street parking.

L'Abri Management Inc., a property management company that operates the nearby 149-unit Stonewood Village apartment complex, said the parking district

"We had hoped the City would give some consideration to renters in the Cecilia, Shellyfield and or your lawn," he said. "On trash Clancy neighborhoods," Ron Kolar, president of L'Abri, wrote in a letter to Downey council members.

was "prejudice against renters and

for homeowners."

"Unfortunately this is not the case. So this is why it is necessary to file a lawsuit."

L'Abri also promised to file court injunction "to keep the City from creating any additional preferential parking district

expense of renters."

One resident of Shellyfield, Oscar Checa, said homeowners are not prejudiced against renters. "What we don't agree with is renters living on others streets coming to park on Shellyfield," he said.

"Most of the cars that did not live there would come and leave trash, beer bottles on the street pickup day they would move your trash cans in front of your driveway so they can park there and you can't get out of your own driveway in the morning or would park so close to the trash cans that the truck could not pick them up."

City Council members discussed the potential litigation in closed session Tuesday.

You must be 50 or older to participate, with eligible seniors able to register for a spouse, adult companion or caretaker under the age of 50. For more information, please call (562) 929-5580.


Tea and fashion show at senior center

I had the ability to take whatever situation I found myself in, do whatever I could to improve it, and be happy and content. I was able to pass this on to George and Jimmy. We were a real cute little family. Always smiling, always happy.

Everyone liked us except Uncle Bert and George's father, Selden. Selden loved George and Jimmy, but he never called me anything but "George's wife."

We were living in the redwoods in Northern California. We were out in the woods. REALLY out in the woods.

We had no water, no electricity, and no plumbing. The three of us, my husband George, my five-yearold son Jimmy, and I were living in a 9' X 12' tent by the sawmill. George had dug a moat around the bottom of the tent so that the almost daily rain would run off and down the hill.

I was doing the cooking for my little family, plus George's father, and his Uncle Bert. The cook stove was a big black cast iron range, fueled by wood, sitting on the ground with a makeshift wood canopy

As long as I was cooking for everyone Uncle Bert bought the groceries. He never took me to the store, just had me make a list. Uncle Bert's attitude toward a woman was that she was a work-horse, not entitled to any appreciation, no matter what she did.

A neighbor stopped by to tell me that there was a makeshift, one-room cabin nearby that was only a little better than the tent. He was a tall man taking huge strides. I didn't care how "little better" it was, I was running to keep up with him.

We arrived at the structure. It was board and batten on the outside, with nothing on the inside, a roughhewn door, with no porch or steps. And, horror of horrors – no window!!

But to say I was thrilled was an understatement. I had brought with me a room-sized rug, our beds, an oil heater, and a travel-trailer-size propane range. I could make a real nice little home for us here. George set about building a table to set against the wall and a bench.

I sent George to fill my 13-gallon propane tank and fuel oil for the heater.

I told George, "I cannot live without a window." He came in with a wind-wing out of an old wrecked car, and said, "Where do you want your window?"

I said, "Right here where I'll be fixing supper. I can

see you walking up from the mill." He immediately cut a hole for it and I had a window.

Uncle Bert didn't see why I wanted a propane range when there was plenty of firewood.

Like the song, "Mama Don't Allow," I felt, "I don't care what Uncle Bert don't allow, I'm gonna have my propane range any old how."

I had a Pillsbury recipe for "No Knead Bread" and was dying to try it. I measured my little oven, side to side, front to back, and top to bottom. There were two shelves in it.

At the one and only store, 15 or 20 miles away, I bought two very small loaf pans - about the size of a ½ slice of bread. These would be good for Jimmy's sandwiches. I also bought two round pans for rolls and two rectangular pans for coffee cakes. With careful planning, these six pans could bake a double recipe of the bread.

George had the stove set up, and as soon as George and Jimmy were out of my way, I started my bread. When they came home, the bread was out of the oven cooling and smelling "heavenly."

From then on, I baked bread at least once a week. If I was not able to bake, and had to buy a loaf of bread, both Gorge and Jimmy acted as if I didn't love them anymore.

My only close neighbor, who lived up on the hill, came and offered to take my now six-yearold Jimmy the 12 miles over the hill to the bridge, where the school bus picked up the students and dropped them off in the afternoon.

She said there may be a time when she could not pick them up. Would I be able to go for them? I said, "Sure." I had never driven alone, but what's so hard about that?

Later on, the other mothers marveled that the first time I had driven alone, I knew what to do when I came up behind a slow-moving logging truck. I had shifted down and crept up the hill behind it.

I had learned something else that first time driving alone. I had introduced myself to the other mothers and said that Jimmy Fluhart is my son.

Two of the mothers said in unison, "You're the one who bakes that bread that is so good that all of our kids are trying to take something good enough to trade him out of his sandwiches."

I didn't say anything in front of the other mothers, but when we got home, I told Jimmy that, "I strive every day to provide you with a wellbalanced lunch, but if you are going to trade away your sandwiches, I'll just stop baking bread and you'll get baker's bread."

He said, "I'm sorry, Mommy, I didn't think about it, but you're right. I won't ever trade away what you send in my lunch."

I said, "That's good, Jimmy," and tried even harder to always bake. When I did and Jimmy came home, he would come dancing across the yard saying, "My mommy's making brea-ed, my

mommy's making brea-ed."

When I baked more often, I tried to give some to my neighbor who took Jimmy to the school bus. I was always rewarded with some eggs and/or something from her garden.

I was always excited when she included some tomatoes. I told her. "There are two things that money can't buy. One is true love. The other is a home-grown tomato." After that she always included tomatoes in her care package.

I had meant the bread as a gift in appreciation of her kindness to me. But I was always so happy to receive her care package.







Rams, Chargers Week 3 recap

RAMS: The Rams and 49ers had a shootout on Thursday night, but in the end LA came out with a 41-39 victory that catapulted them up seven spots in the NFL power rankings.

With the big divisional win under its belt, the (2-1) Rams moved to first in the division and jumped from 19th up to 12th in ESPN's power rankings after its explosive offensive performance.

The Rams are now the highest scoring offense in the league coming into the big Week 4 matchup against the (2-1) Dallas Cowboys.

LA has scored seven more points than the "Greatest Show on Turf" could score through its first three weeks of the 1999 season-- the last time the Rams won the Super Bowl. The 107 points they have scored so far is eight points more than the next best team--Tom Brady's Patriots (99) and is the second most points scored through the first three games in Rams' franchise history.

Todd Gurley scorched San Francisco for 113 yards rushing on 28 carries. Gurley scored two rushing touchdowns and caught another. He now has six losing to the undefeated Kansas City Chiefs, 24-10, at StubHub Center. touchdowns on the season, as many as he scored all of last year.

Gurley will have to figure out how to protect the football moving forward. Although he has only lost one this year, Gurley has already fumbled four times in the first three weeks. He only fumbled the ball five times in his entire pro football career coming into the season.

Jared Goff has proved why the Rams selected him first overall in the 2016 draft all season. Goff had the best game of his young career on Thursday Night Football last week. His near perfect 145.8 quarterback rating says it all.

Goff found Watkins open downfield for two game breaking touchdowns. The second one was costly though as Watkins had to be sidelined for the rest of the game as he underwent the concussion protocol.

Goff threw for 292 yards and 3 touchdowns, completing 22-28 passes, and looked in pro forma. The 6'4 signal caller has been astonishing through the first three games, but the real story is the elevated play by the Rams' offensive

The Rams' O-Line has only allowed 3 sacks all year and have been effective both in pass protection and run blocking.

This Sunday, the Rams face a bipolar Cowboys team in Dallas that is coming off a stellar performance Monday in which they defeated the Cardinals, 28-17.

CHARGERS: The winless Chargers were outmatched again on Sunday,

The (3-0) Chiefs showed why they are considered one of the best teams in the league. Rookie running back Kareem Hunt continued his historic inaugural season becoming the first player in NFL history to ever score three rushing touchdowns on plays of 50 yards or more in their first three professional

As of right now, Hunt is not only in Rookie of the Year discussions but is the frontrunner for MVP. He is on pace for over 2,100 yards and 20 touchdowns rushing and another 720 yards and 10 touchdowns receiving.

Chargers' third year running back, Melvin Gordon rushed 17 times for 79 yards-- an average of 4.6 yards per carry. It was his best performance of the season and was able to find pay dirt early for his only touchdown of the game. He was targeted twice by Philip Rivers but was unable to secure either of the

Rivers had a forgettable performance on Sunday as he was only able to complete 20-of-40 passes for 237 yards, no touchdowns and 3 interceptions. Rivers threw at least two more deplorable attempts that should have been picked off but were dropped by Chief defenders.
