Millions pay excess fees to file taxes online

► Few taxpayers use the Free File system — intended to help moderateand low-income filers — and that benefits companies like Intuit and H&R Block.

WASHINGTON, D.C. - As internet use took off at the turn of the millennium, the Office of Management and Budget asked the Internal Revenue Service to create no-cost electronic tax-filing options for low- and moderateincome taxpayers. The techchallenged agency turned to the online tax-preparation industry for help and soon struck a deal with companies such as Intuit (the maker of TurboTax) and H&R Block, which had organized as a 12-member consortium called the Free File Alliance.

The Free File Alliance agreed to offer tax-prep service to millions of Americans at no charge. In exchange, the IRS pledged to "not compete with the Consortium in providing free, online tax return preparation and filing services to taxpayers."

The arrangement went into effect in 2003 and the IRS and the alliance have kept the framework in place ever since. Today the Free File system appears on track to become permanent. In April, the House voted unanimously to enshrine the provision into law, and the Senate is now considering whether to follow

goal of the program. Free File theoretically allows 70 percent of been filed using the program over the past 16 years, according to the IRS, saving users about \$1.5 billion in fees. Intuit lauds the program as "an example of a public/private partnership that works." And Tim Hugo, executive director of the Free File Alliance, called Free File "a great product," adding, "Free File has changed the market."

But 50 million returns over 16 years represents only about 3 percent of eligible tax returns. By ProPublica's estimate, that suggests U.S. taxpayers eligible for Free File are spending about \$1 billion a year in unnecessary filing fees.

A key reason for the anemic usage, according to experts, is that many taxpayers are unaware of the program. "I don't have an advertising budget," said Hugo, who acknowledged the lack of awareness. He argued that it's the IRS' responsibility to publicize the program. "The companies are already donating the services. It's a philanthropic endeavor."

Critics say low usage is exactly what Intuit, H&R Block and others are seeking. The tax-preparation companies "want the status quo," said Nina Olson, the national taxpayer advocate, whose role is to be the voice of taxpayers inside the IRS. The agreement with the companies not only keeps the federal agency from developing a direct filling option, but also an automated "return-free" option in which the IRS would calculate most individuals' taxes. A 2013 ProPublica investigation found that the industry has successfully lobbied against such a system.

Another reason few taxpayers use Free File is that finding and understanding the options can be confounding. "Trying to navigate the Free File sites," Olson once said in congressional testimony, is "a bit like living in the Wild, Wild West."



If you were driving on Slauson Avenue in the dark in the in the 1970s or 80s, in the city of Vernon, you might be treated to an amazing sight. Just past the chain link fence on the south side of the street, heavy tongs from up high would drop down to pull a glowing rectangular mass, 10 tons of orange steel, out of a high pit.

As the overhead crane lifted the ingot clear and carried it toward the fence, you would feel the heat on your face through the car window.

The crane would trolley along, parallel to the road, with the hot steel hanging upright travelling overhead, the crude until it was lined up with a set of rollers as thick as a man. The crane would bang the hot steel into the rolls and lay it down and above it all the deep rumble sideways, and as it did so crusts of molten metal would get knocked off onto the ground.

Then the rollers would carry the heavy ingot out of sight into the dark bowels of the mill, leaving the pieces of slag to glow on the ground, casting eerie shadows as the metal cooled toward gray.

This was the Bethlehem Steel Plant in Vernon, California, where I had the good fortune to work from 1973 to 1982. I had dropped out of graduate school in 1972. Heartsick over the on-going Vietnam war, and no longer enchanted with the remnants of the 1960s counterculture, I began to work something more "real." The pay wasn't the greatest, and when I heard Bethlehem Steel was hiring, I jumped at the

The Bethlehem Vernon plant was a sprawling affair. Its property stretched almost a half a mile along Slauson between Maywood Avenue and Boyle Street. The plant was a scrap re-melt plant, meaning that new steel was made by melting down scrap metal rather than extracting it from iron ore. Much of the property was open, filled with mountains of scrap metal tended by a few cranes that loaded and unloaded the rail cars.

The heart of the plant was at the north-east corner, on the south side of Slauson and nestled up against the railroad tracks along the Vernon-Huntington Park boundary. Large corrugated-metal sheds, each over one hundred feet wide and a quarter mile long, housed several rolling mills and the three electric furnaces.

The roofs were so high that overhead cranes travelled up and down the bays just under the roof, riding on railroadsized rails that ran along the eaves. When the mills were running there was an incessant clatter: hot steel in the shape of beam-like billets running down roller beds, cranes drive mechanisms of the mills themselves clanking as they turned the heavy mill rollers, of the electric furnaces.

It was into one of these mills that the ingots, rolling out of sight of the gawkers on Slauson Avenue, disappeared. This was the so-called 32-inch Mill, the mill where I worked during most of my years at Bethlehem. The 32-inch Mill was actually a series of two

mills, two cutting machines called "shears," and at the end a pair of cooling beds. These were positioned in a line along one of the long sheds with a lot of space in between. They were connected by conveyor beds made of steel rollers.

A rolling mill in its simplest form is two rollers, one above the other. Hot steel is rolled through these rollers, and is squeezed down as it goes through. Imagine rolling out dough to make spaghetti. Just like dough, the hot steel stretches out and becomes

But the dough we are talking about is steel so hot it glows orange, and at the first mill it is shaped like a large refrigerator. This can't be rolled out to a smaller shape all at once, so the ingot is rolled back and forth through the two steel rollers that are 32 inches in diameter and as wide as a dining room table.

The ingot rolls through one way and is squished slightly. The operator, operating the control levers in a little room over the mill, lowers the top roller down maybe in inch, then reverses the rollers and rolls the ingot back through. After a couple of passes, the ingot is flipped on its side, and rolled back and forth some more. This goes on, until the ingot is reduced to a billet about six inches one a side and almost two hundred feet. long, shooting down the conveyor at thirty miles an hour to the next step in the process.

Studio GalleRoy itself will exhibit a different series of large paintings each month, encouraging the public to attend all three evenings of film and art.

One of the Art fair featured artists is Anthony Cano, a selftaught ceramicist and painter who will exhibit a variety of objects d'art including tile and ceramic sculpture - especially depicting sea life, organic material face-masks, and recycled bottle art. His work emphasizes the natural world and shines a spotlight on the ecological issues of our time.



An interview with state Senate candidate Bob Archuleta

NORWALK – A continuation of an interview with the California Democratic state Senate District 32 candidate Bob Archuleta. An interview with his opponent, Republican Rita Topalian, is scheduled for later this month.

ON PUBLIC SAFETY

Most elected officials cite Public Safety as their primary concerns. What are your concerns regarding the 900,000 plus population of the 32nd district?

"Public safety is going to be right up there at the top of the list...But guess what? One city may have a formula that we can use in another city. That's important in bringing people together."

"[In] the city of Pico Rivera, we're protected by the LA County Sheriff (Department) and their Deputies and I have a great relationship with the LA County Sheriff."

"Of course the other cities, the city of Downey, Montebello, they have their city police. The city of Whittier has their city police. So I've got to deal with them in a different way because shared, "What that may be, of the fact that each city has different procedures, but all don't need to have that out in the under the umbrella of the state of California."

"One of the things I want to make sure, that God forbid, there is an issue, a shooting, an earthquake, whatever it might be, that all these different entities can talk with one another."

"[They should have] all the same radio frequencies that they can talk with one another.'

"They've got to unite their communications, their procedures."

DOWNEY - An automotive crash and subsequent sinkhole late Saturday evening put a damper on Father's Day for Downey residents in and around a Rives Avenue neighborhood.

The crash, which occurred in the 12000 block of Rives Avenue near Brunache Street, happened around 10:15 p.m. after authorities say the driver of an SUV swerved to avoid another vehicle, striking a power pole and shearing a fire hydrant.

The driver was not under the influence of drugs or alcohol, authorities said.

Following the collision, a sinkhole formed and swallowed up the involved SUV. The driver was not inside at the time.

Many of the residents in the immediate area were left without water and electricity until later Sunday, however, it is currently unknown how many people were affected nor what the exact perimeter of the outage was.

One resident, Atanasio Trujillo, 75, returned home from a graduation party around midnight when he discovered what had happened. Trujillo lives just a few houses away on Rives.

Trujillo says that only his power was affected, leaving him without electricity for almost 20 hours. It was enough to upend his Father's Day plans.

"I was supposed to watch the futbol game, the soccer game. We couldn't, no power," said Trujillo.

L.A. County hires IBM to investigate election errors

LOS ANGELES – Los Angeles County has engaged information technology leader IBM Security Services to conduct an independent review and evaluation of the systems and procedures used in the production and printing of voter rosters for the June 5 Statewide Direct Primary Election.

IBM will work with the County's Chief Information Officer and Auditor-Controller to determine the root cause of the printing error and make recommendations for corrective action.

'Our priority is ensuring a thorough and impartial review that is conducted to the highest professional standards," said Chief Executive Officer Sachi A. Hamai. "Working with IBM Security Services, we are confident we will get the critical information needed to prevent this from happening again."

IBM Security Services will complete a full incident assessment and root cause analysis including a forensic review of the systems, procedures and agencies used in preparing and producing precinct rosters for the County's 4,357 voting precincts and more than 5.1 million voters.

The review will also include testing of networks, servers and databases to evaluate any potential vulnerabilities and to assess the effectiveness of security controls, policies and quality control processes.

The review started Monday, June 18, and is expected to take four weeks.


On Election Day, 118,509 voter records were omitted from precinct voter rosters due to a system printing error that affected approximately 12,000 voters, who cast provisional ballots which were processed immediately.

The affected voters also received confirmation by letter, email or automated calls that their ballot was counted and their voter registration status was not affected. No voters were ever removed from voting rolls and their right to vote was never at issue.

Once the root cause of the printing error is determined, the County will issue a report to the Los Angeles County Board of Supervisors and will identify a comprehensive action plan for the Registrar-Recorder/County Clerk to act on the recommendations.











Traumatizing kids is an unspeakable evil

Let's be clear about something: Separating children from families, as the Trump regime is doing to undocumented immigrants, isn't just cruel. It's going to cause irreparable damage to the children involved — and probably to the parents too.

The difference is that developmental trauma — trauma experienced in childhood — is much more difficult to heal that trauma suffered as an adult. Trauma itself can be healed, but it's painful, difficult, and as is often the case in this country, expensive. For many it's simply out of reach.

I suffered childhood trauma. Here's what it's like. I knew from my earliest memories that something in me was not right. I thought it was my fault. I thought I was just born bad.

Trauma is both physical and emotional. My body behaved abnormally, and I didn't understand why.

I was hungry all of the time. I would eat and an hour later, I was hungry again. All day, every day.

I was tired all of the time. I was up until 4 a.m. and then I would sleep at least 10 hours. I couldn't fall asleep earlier even if I tried, and if I attempted to wake up earlier, I'd get a migraine. It interfered with my ability to hold

Worst of all, I got migraines every day for 23 years. Every. Day. It interfered with every part of my life.

Then there was the emotional and behavioral toll. When I was around others, I was panicked. I dealt with it by adopting a number of rather

antisocial and embarrassing strategies to help myself feel more in control. I knew that I was annoying or upsetting or offending those around me while I was doing it, but I couldn't stop.

made me unlikable and unworthy of love. I would try to get close to people, get scared, and then push them away.

All of these things are changing after years of therapy, and only just in the last two months. During most of this time, I did not see myself as a trauma victim. I saw myself as a loser. Lazy. Dysfunctional. A bad person. Unlovable. Wrong. Broken.

Trauma is often invisible to the person suffering it. Your body acts strangely, and you react emotionally to others in ways you can't order to get it is unspeakably evil. understand — and either you don't even know you are doing it, or you don't know why. You can't control it. You think it's your fault and so does everyone around you.

This is what we're doing to these immigrant children. And what I went through is nothing compared to what they're suffering.

I grew up in a wealthy, white, educated family, and I was born a U.S. I thought there was something fundamentally wrong with me that citizen. I was able to get therapy. Most of the children Trump is locking in cages likely won't get that opportunity. Already pediatricians are warning about the lasting damage they're likely to suffer from this cruel treatment.


