Later she might say, I spent a few summer "Man to man, get your hand in someone's face. D them up." In the huddle she would remind us, "Put your foot to the pedal, now step it up," clapping her hands loudly issuing instructions.

I was the point guard and aggressive at guarding others. My outside shot was suspect. I mostly made lay-ups, but my tenacity was unquestionable. I played with burning passion and an insatiable love for the



An American Life

Last week, in Ridgewood, New Jersey, a 92-year-old unsung American patriot lost his battle with congestive heart failure. He had been surrounded by his wife and children and their spouses and their children. He left this vale of tears in his wife's arms, peacefully and with dignity.

His was an American life.

He was born in Newark, New Jersey, during the Roaring '20s, the son of Italian immigrants who had come to America as children. When he was 4 years old, he met a curly-haired little girl in the neighborhood who was just three days older than he. She would become his high school sweetheart and his best friend for 88 years and his wife for the last 70 of them.

In a large public high school, he did not excel in academics, married. but he was a superb athlete; and he had an unquenchable interest in electronics, a subject not taught in the public schools in those days.

His graduation from high school in 1943 was accelerated from June to January because the country was fighting in World War II and it needed the boys to join the effort quickly. Our boy enlisted in the Navy.

Four months after graduation, at age 17, he completed Navy boot camp and was excited about his first assignment on a submarine in the north Atlantic. As he was boarding the submarine at a naval base in Rhode Island, he slipped and fell on a wet dock and broke his right foot. He was hospitalized for two months. The submarine he was about to enter never returned and was never found.

He was then assigned to a destroyer escort, which cruised the Mediterranean and supported Patton's Army in the liberation of Italy. Aboard ship, he excelled in electronics and boxing — always the athlete yet reading about wires and batteries and electrical currents until late in the night.

One day, shortly after the liberation of Naples, the city of his father's birth, he was on leave with his buddies and he saw an old man who resembled his grandfather sitting on a curb stone. The

old man's home had been destroyed by Allied bombing, and the base of the Democratic Party in the 1930s and '40s. But when the old man himself was without shoes.

Our friend resisted the collective wisdom of his buddies and took off his military-issued boots and gave them to the old man. He had his buddies sneak him back aboard ship before his superiors could see him in his stocking feet.

When he was charitable, he hid it.

He returned home to New Jersey in 1946. The little girl had grown up to be a beauty and a brain. During the war, she worked in the Newark Public Library for 17 cents an hour. She borrowed and read a book a week in the 2 1/2 years of our man's involvement in the war.

Two years after he came home, he and that grown-up girl got

His first and only adult job was with the New Jersey Bell Telephone Co. He started out climbing telephone poles, and he went on to install equipment in homes and offices. He soon moved into management and eventually went into teaching his favorite job.

He taught electronics to new employees and colleagues and even to executives who wanted to advance themselves. This was the electronics he had learned in the Navy, supplemented by the electronics that he had taught to himself.

He and his wife had three boys, one of whom followed him into the telephone company and two of whom received scholarships to Ivy League schools. He taught tough lessons to his boys at home - lessons about honesty, humility, self-reliance and teamwork. His favorite one-liner was, "Anything worth doing is worth doing well."

He practiced what he preached. He was a tough taskmaster who demanded much and gave much; and he always forgave. Andrew Napolitano is a senior judicial analyst for Fox News. Always. He was an iron fist inside a velvet glove.

He was the first person in his family to vote Republican, and he took a lot of heat for that. FDR had catered to immigrant families in the big cities, and they formed a healthy part of the

boys came home from Europe and the Pacific and started families and then when Ike ran and many of his soldier and sailor buddies could vote for their former supreme Allied commander, he did so.

Voting Republican in the late '40s and early '50s was anathema in an Italian-American Roman Catholic family in the Northeast. Today it is pretty much the norm.

He would explain to his parents and in-laws and sons that he feared the Democrats would give away the store to stay in office. Though he loved the Navy and respected the police, he was skeptical of government in general, and he loved Jefferson's mantra "that government is best which governs least."

He was a devout Roman Catholic. He loved the New York Yankees, the New York Football Giants and Fox News — and he loved that girl he married, more with each passing day.

In his waning years, his wife sacrificed dearly for him because his tobacco-ravaged heart was unable to do its job alone. Yet modern science and a wife who overlooked nothing added many happy years to his life.

But nature has her rhythms, and they can be unforgiving. There is a time for living and a time for dying. Even God died. After this marvelous man received the Anointing of the Sick and he said a peaceful, loving goodbye, the angels came and brought his soul to heaven.

I knew this man well and loved him with all my heart. He taught me all his values.

His name was Andrew Alexander Napolitano.

He was my father.

Requiescat in pace, Dad.

Let me tell you what forced separation looks like

The recent images of immigrant children in cages are incredibly painful to digest.

Still, many people seem to forget that the U.S. has a long track record of forcibly separating families, whether it was African

Native Americans during colonization, or poor children whose 'unfit" single mothers have lost custody today.

Another common way families are forcibly separated? Juvenile detention. Tens of thousands of teens and pre-teens — most often the

poor and people of color — are locked up in substandard, often privatized penal facilities. Children who go through these forced family separations often wind up experiencing trauma, grief, shame, and dehumanization.

The sad reality is incarceration rates are on the rise alongside economic inequality, and children aren't exempt. Quite often, the only crime these children have committed is that they're from vulnerable families or suffering from mental health issues.

My son and I personally experienced this.

My son became severely depressed around the time he turned 13. I was a single mother teaching as an adjunct, making less than \$20,000 a year, so the treatment he needed wasn't available to

My son got into the criminal "justice" system for the initial petty crime of stealing a pair of sneakers, and he remained there for most of his high school years.

Like so many struggling kids, instead of getting the treatment he desperately needed, he was sent to subpar facilities that made his emotional pain worse. He received no real therapy, and they often refused to give him his required medication or messed it

He began to see himself as a number, as a terrible person. I saw myself the same way, because I knew how the court system saw me — as a poor single mother with no husband and a "criminal"

From the time he was 14 until he was 18, he was transferred to

Americans during slavery, the Japanese during World War II, at least 10 different facilities. I often didn't know where, because I wasn't notified. Despite his chronic depression, he was also put in isolation a number of times — a tactic known to increase mental suffering among adult prisoners.

> At one point, they put him into an adult jail in isolation for at least a month. He was 17 and had just been released from the psych ward that same day. During his once a week phone calls, I could hear the increasing desperation in his voice, as well as the screaming of other adult prisoners in the background.

> As a parent, this experience was devastating and terrorizing. There's no way to describe it. The trauma from that pain is still

> My son is older now, thankfully alive, and doing the hard work of putting his life back together. "Real therapy would have been so helpful," he told me. "So much pain could have been spared."

> 'It really desensitizes people all the way around," he said of his experience. "It makes you value yourself less and others less, too, since other people see you as a nonhuman."

> No human should ever be treated this way. But while we are wounded, we are not broken.

> Social movements are gaining momentum. For example, the immigrant rights movement is growing alongside the Poor People's Economic Human Rights Campaign and other prison liberation movements.

> Separating families due to incarceration, immigration status, mental health, and/or race and class is wrong. If the families impacted by incarceration and other traumas join together with advocates for immigrants, we can create a sea of social change.

> As one of my students recently wrote, "There are more of us than them."





Part 2 of an interview with Rita Topalian

NORWALK – This is part two of my interview with Republican candidate Rita Topalian in the 32nd State Senate special election slated for August 7th.

The homeless.

"Honestly, that is such a difficult problem in the sense that many of these people don't want to do anything different from what they are doing. We've got the mental health issue, that's huge, and we've got the drug issues."

"I'm going to go back to families. Where are the families of these people? Yes, I understand that when you're 18 in America you're an adult and you should be by yourself. We're not going to solve it by what we're doing. You're encapsulating them and putting them into a situation where they're just going to breed more of it."

On the nearly \$350 million gathered for a homeless solution What about those who are unseen. The ones sleeping on a friend's couch, or are underemployed, what can we do to help them?

"First of all, I think they have to be interviewed, they have to be sorted, but not sorted like cattle, that's not what I mean. But if this is mental health, we need someone to sort and find out what the real problems are. Somebody may have just lost a job and can't go home for whatever reason. That's not the same as someone that sits next to you and says there's a dog siting here when there's no dog, or needs another fix. That means five bucks out of your pocket to get another fix."

"So, if you have mental health issues... why not rehab some of these junkie buildings (Referring to closed Metropolitan State Hospital facilities). \$350 million dollars? Take \$2 million dollars and rehab one of these things and make medical rooms."

"But if they don't want help, we can't help them."

"I don't think one answer is going to fit all."

What can you do to curb gun violence in the 32nd State Senate District?

"If someone wants to shoot somebody, there's nothing anybody can do, not even God. So, that's another one of those issues that are difficult. Taking the guns away is not the answer. I believe that as a citizen, we deserve to have guns. And that's left over from the stories I've heard from the genocide (referencing the Armenian genocide during World War I). They take away everybody's guns and the government can do whatever it wants. You don't trust government. (pounding her fist on the table) You should never trust government! Because power goes to everyone's head."

"So, I believe people should have guns.

"As far as what to do, it's the same thing, a societal problem. "I do. As long as there is a good grade level and as long as there Who would pick up a gun and shoot someone. I wouldn't. You wouldn't unless it's self-defense. For children, I would. Again, it's one of those situations.'

Regarding gun control (specifically banning the sales of semi-automatic rifles)

"I know it doesn't sound right. The gun doesn't shoot by itself. Why would someone take a gun and shoot people? Even if you take that gun from that mentality, they're going to find it somewhere else. Even if you don't issue it, they're going to get it on the black market.

"That whole concept (Gun control) doesn't work for me. Um, my biggest fear is taking guns away from the average citizen. If you want to have a gun in your house to protect you and yours, I think you should have a gun.

"I don't have a gun. I would never have a gun personally. But if you want a gun because it makes you feel safer, why not?"

The Gas Tax

"It's got to be repealed.

"These are regressive taxes. They don't affect people like me that much, but they do affect someone trying to keep a family together, make house payments, give their kids some measure of softness, a trip to Disneyland once a year.

"And besides, you know what, if they taxed and they used it for what they say they use it for, then I could say alright. But they don't. Where's all our money going?"

Public servant salaries

"It's crazy. You know what they're argument is? We have to be competitive."

"It's like this district, the 32nd. These are people that are middle income, hard-working, these are people who need their money later on down the line. The government doesn't look at you as a human being anymore. You're a cash cow. And for what?"
