Shared **Stories:** My own best medical advocate

Ready for summer vacation, my parents, two younger sisters and I packed into our 1960's Chevrolet station wagon. Headed about four hundred miles from Illinois to Minnesota to visit relatives, I recalled playing Go Fish, I Spy and other games with my sisters to pass the time. While driving, my father suddenly veered off the road into a shallow ditch to avoid a head on

We were jostled around since there were no seat belts in our vehicle. My sisters and I were thrown to the right side of the middle seat and my head banged into the window. This trauma to my head was disregarded by my parents. However, it has lingered in the back of my mind since it may have been a contributing factor to the story that follows.

A few weeks later, I began second grade. My parents and teachers both observed incidents when I stared out into the room in a trance-like state for about 30 seconds. I never had any recollection of these incidents. After referred to a pediatric neurologist, an EEG and MRI of my head revealed normal results.

Because these staring episodes neurologist diagnosed this as epilepsy. Antiseizure medication was prescribed but it took many months before finding the correct medication and dosage for my condition. In my mid-teens, the neurologist weaned me off the medication, with no further seizures during my high school and college years.

During my mid-twenties, I moved from Los Angeles to Boston for graduate school and employment as a registered dietitian. This was a stressful time with many life adjustments. Shortly after starting my job, some coworkers observed me doing a peculiar behavior while eating lunch together. I had no recollection of this but knew I needed to see a doctor.

My primary care physician expedited a referral to a neurologist. Following an EEG and MRI of my head, the results were normal. I was started on medication and instructed not to drive. Fortunately, I did not have a car and was using public transportation. Within a few months, my seizures were completely controlled.

The next twenty years were without any reported incidents of seizures. In my early forties, however, I was married, working full time, and had three children in middle school. On a busy Friday morning, the weekend of the annual school festival, I drove to the grocery store then planned to drop off some items at the festival. I was stressed from anticipation of being outside many hours that weekend in the hot September

Returning home from the grocery store, I missed the turn into the school due to loss of consciousness. I had no recollection of this happening but, apparently, ran into a truck waiting at the traffic light. The impact caused my van to veer to the right, up onto the lawn outside a medical building, instead of into oncoming traffic.

Shared Stories: Taking control of my health

After the accident, my life drastically deteriorated. my driver's license, my job was terminated, and I continued to have uncontrolled seizures. My doctor referred me to a new neurologist.

Anxious, frightened depressed, I had my first appointment. After a quick knock on the exam room door, a male doctor entered the room. Without making any eye contact with me, he announced, "I'm Dr. Indifferent." He picked up the clipboard and glanced at my completed medical

"So, you are here for seizures.

When was your last one? "I'm not sure since I don't know when I have one. My husband

said I had one last night.

when you have one?"

"No, my family says I rock back and forth with my upper body or move my right arm in and out.

The doctor verified my seizure medication and dosage. Next, he checked reflexes in my elbows, knees and ankles, arm and leg muscle strength, peripheral vision, coordination, balance, hopping, and walking.

asked basic math computations, current history questions and checked my short and long-term memory. The process was exhausting.

Without comment on my test results, he took out his prescription pad, scribbled a higher dose of the same medication and handed it to me. As he walked out the door, he told me to return in one month.

During the following weeks, I decided to keep records of the date "Do you know what happens and time of my seizures, at least

those seen by my family. Feeling proud of my efforts, I brought my notes to the doctor, but he refused to look at this information.

I felt discouraged about not having any improvement in my seizures with the higher medication dosage. He did not perform an assessment of my physical and emotional state. I felt invisible in his presence, anxious and depressed about my severely limited lifestyle.

Finally, he handed me prescription for a second medication and again told me to return in one month. Clearly, connection with his patient was low priority for this doctor.

immediately, became restless and drowsy on the new medication. I called the office but was told to continue the medication. My symptoms and seizures continued. I was losing hope about my worsening condition but refused to give up.

During appointment, the doctor interrupted me and rudely exclaimed, "You have to learn to live with these symptoms. There is nothing more I can do!"

Feeling appalled and dismissed by his comments, I left the office and vowed to myself never to return to Dr. Indifferent.

A few weeks later, my husband showed me an article he read in the Parade magazine of the Los Angeles Times newspaper entitled "Their Best Chance for a Normal Life" (9/18/2005). This article discussed medical and surgical options for people with epilepsy.

My feeling of hope returned as I explored the referral process with my medical insurance to the UCLA Seizure Disorder Center.

Several months later, I had my first consultation with an epilepsy specialist. He assured me that the medical team's goal was to find the root cause and best treatment for

follow-up my seizures.

During the next year, I npleted many tests and completed medication changes as part of the preoperative protocol for epilepsy surgery. The functional MRI test found a noncancerous lesion in my right temporal lobe which appeared to be the cause of my seizures. My case was reviewed by the department's neurophysiology

The team of doctors concluded that removal of this lesion by surgery had a high probability of ending my lifelong seizures. In December 2006, I had brain surgery at UCLA and miraculously, since then, I have never had another

Many seeking people medical care place a blind trust in doctors' opinions which may lead to substandard treatment. I learned it was imperative to do an independent medical investigation of my condition and search for a doctor who was committed to finding the root cause and best treatment of my seizures.

Not accepting the status quo in medical treatment launched my journey of becoming my own best medical advocate. That journey has no end in sight.

The left's constant need to manufacture racism

To appreciate the level of dishonesty and societal harm the media, the Democratic Party and others on the left engaged in last week regarding Congressman Ron DeSantis, one has to know exactly

tweeted, "It's disgusting that Ron DeSantis is launching his general election campaign with racist dog whistles.'

Florida Congresswoman Frederica Wilson, a Democrat who represents a district in South Florida, said: "They always find a way

to add some sort of insult to African-Americans and make it racist. 'Monkeying this up' is clearly communicating that."

The NAACP Florida State conference said that "apes" and "monkey" are "by far the best-known racist references to African-Americans in our national folklore. It's only equal in racial semantics to the 'N-word.''

Gillum himself said: "It's very clear that Mr. DeSantis is taking a page directly from the campaign manual of Donald Trump.

On CNN, Gillum told Chris Cuomo, "Well, I'll try to be articulate" sarcastically referencing DeSantis' description of him as an "articulate" advocate of the leftist policies he espouses. This is normally a compliment, but it is now deemed racist when used to describe any black. "(H)e's apparently given up the whistle," Gillum continued. "They've gone to the bullhorn with these kinds of tactics."

On the CNN website, LZ Granderson wrote: "White people linking black people to monkeys has been a racist trope for centuries. That's why when Florida Rep. Ron DeSantis, the Republican nominee for governor, used the phrase 'monkey this up' when talking about the handling of the economy by his black Democratic opponent, it was hard to believe that the word choice was an accident.

The New York Times reported, "Sharon Austin, a professor of political science at the University of Florida, said she saw Mr. DeSantis's language as a not-so-subtle racist dog whistle.

Princeton University African-American Studies professor Eddie Democrat. Glaude Jr. said on MSNBC: "That's obviously a racial dog whistle. ... here we are once again. We are right back where we've always been."

Why does the left do this? Why does it incessantly libel Republicans and conservatives as racists?

Metaphor in a government-founded church

Last week, I was intrigued by all the fanfare attendant upon the national farewell to the late Sen. John McCain. I have written in this space that McCain and I were friends who spoke many times, but generally only about the issues upon which we agreed — abortion, immigration and torture.

On those issues, he often stood at odds with most of his Republican colleagues in the Senate. They are opposed to abortion in name only (they will not lift a finger to stop or slow it), prefer judging the moral worth of individuals on the basis of where they were born, and think that torture is wrong unless the victim is a bad guy or a foreigner or has information the government wants.

Moral relativism is the coin of their realm.

On those issues, McCain stood steadfast, no matter the political or personal consequences. For that steadfastness, and with respect to those issues, his behavior was heroic. A hero does not lack fear. He or she proceeds into its face nevertheless, heedless of the consequences

For reasons he has never adequately explained, President Donald Trump rejected McCain's heroism and mocked McCain's time of torment in a North Vietnamese prison. That mockery was brought to full measure at McCain's funeral by the senator's daughter, my friend and former Fox News colleague Meghan McCain. She told the members of the Washington establishment who had gathered, sans the president, at her father's funeral at the Washington National Cathedral — why the federal government founded a cathedral is another question for another time — that her father manifested greatness and that Trump manifests cheapness.

Then the two men who each in his own way personally stopped McCain's efforts to become president — George W. Bush in the Republican primaries in 2000 and Barack Obama in the general election in 2008 — delivered similar accolades of McCain, complete with veiled rebukes of Trump.

On its face, the audience in that government-founded church, establishment to the core, was adoring McCain's memory and mourning his loss. But the establishment is filled with hypocrites.

Nearly all of the present assaults to liberty can be laid at the feet of the Republicans and Democrats who were sitting in that government-founded church in the nation's capital and listening to physically been there. the praise of John McCain.

Canada and the many conscripted veterans who came home appalled by what they had seen and done and spent the rest of their lives fighting for peace.

McCain, on the other hand, learned nothing from his experience. He never met a war — or a possible war — he didn't like. McCain voted for wars in Afghanistan and Iraq. Media accounts sanitized the myriad very bad things McCain did throughout his life. So I've been doing my part to help counter the tsunami of BS.

"Do not speak ill of the dead." This dictum, attributed to the sixth-century philosopher Chilon of Sparta, may be appropriate at your uncle's funeral; who wants to hear that the dead man's widow discovered foot fetish websites in his browser history?

Public figures are different.

In cartoons and the written word, I have attempted to counter the fulsome praise that followed the deaths of people such as Ronald Reagan. I wasn't trying to be mean to Nancy Reagan when I criticized her late husband — though I doubt she read my work.

Ronald Reagan hurt and killed a lot of people. As much as Reagan's admirers didn't enjoy my reminders that he (we believed at the time) murdered Moammar Gadhafi's daughter or that he didn't care about victims of AIDS, Americans who lost friends and relatives to the "gay plague" deserved to be acknowledged in assessments of Reagan's life and legacy. The media pretended Reagan's crimes never happened. I corrected the record.

The "too soon" and "can't you wait until the body is cold?" arguments fall flat. What better time to point out and discuss a dead leader's flaws than the time immediately after his death? That's when obituaries appear, the eulogies are said and the nation is focused on the issues and policies he affected and effected. A few weeks later,

Presumably referring to himself, former President Theodore Roosevelt argued in a 1910 speech that men of action, those "in the arena," matter and their critics do not.

"It is not the critic who counts, not the man who points out how the strong man stumbles or where the doer of deeds could have done them better," Roosevelt said. "The credit belongs to the man who is actually in the arena, whose face is marred by dust and sweat and blood, who strives valiantly, who errs, who comes short again and again, because there is no effort without error and shortcoming; but who does actually strive to do the deeds, who knows great enthusiasms, the great devotions, who spends himself in a worthy cause, who, at the best, knows in the end the triumph of high achievement and who, at the worst, if he fails, at least fails while daring greatly, so that his place shall never be with those cold and timid souls who neither know victory nor defeat."

Soaring oratory! But self-serving and obsolete.

If effort and taking chances are all that matter when assessing a person's life, the firefighter who enters a burning house to save a baby has no more worth than the serial killer who sneaks inside to kill it. Adolf Hitler, Josef Stalin and Osama bin Laden all had grand visions they strove valiantly to turn into reality. They were daring. They achieved. They counted, but so what?

These days, it's the "timid souls" who stand aside, keeping mum while the mass media wallows in sordid orgies of mawkish praise for problematic figures such as Reagan and McCain. Adding perspective and nuance to assessments of mass adulation requires courage. In this age of relentless propaganda and unmitigated BS, the critic is in the arena just as much as a dead senator.



► CULTURE IN DOWNEY: The death of Hollywood great Miriam Nelson, a dancer and choreographer who lended her talents to shows with the Downey Civic Light Opera, is another reminder of Downey's further vanishing cultural

DOWNEY - Every major newspaper in the country ran a lengthy obit on dancer/ choreographer Miriam Nelson, who died on August 12 at the age of 98 and whose seven-decade career, as The New York Times put it, "spanned the golden ages of Broadway, Hollywood and television."

worked with Judy Garland, Bette Davis, Audrey Hepburn, Ingrid Bergman and Jerry Lewis; she helped Shirley MacLaine perform a memorable striptease in "The Apartment" in which MacLaine removed nothing but her necklace; she choreographed the whole cast of "Cat Ballou" in a number; and she coaxed a terrified William Holden to dance with Kim Novak in one of Hollywood's immortal, sensually riveting scenes, in

On Broadway, as a dancer, she worked with Van Johnson, Ethel Merman and Danny Kaye, and appeared in six shows, including two by Cole Porter. As a film actress, she appeared in "Double Indemnity," and "Lady in the Dark." On TV, she worked on "The Red Skelton Show," "Father Knows Best," "The Lucy Show" and "Murder, She Wrote."

Because it's a reminder of what Downey has lost, and an indication of a city moving in the wrong direction. I can understand if local theater audiences, to whom the DCLO is already a distant memory, don't remember Nelson; she worked behind the scenes.

no one on the city council, whose job it is to know what goes on in the city, knew anything about for them. the luminary in their midst, or for that matter, the pleasure the DCLO brought audiences who drove in from as far away as Ventura. (Alex Saab would be the exception; but he, like the rest of the council members at different sort), is dressed in an the time, didn't take in DCLO

performances either, unless they were getting an award.)

A city without a cultural life is a dead zone, and as I watch architectural atrocities like the KB project on Paramount and 5th hog the landscape as they metastasize in bulk, and lament the short-sightedness that created the semi-desolate Promenade—Downey's great shot at the stuff municipal dreams are made of—I see a once-exceptional place bailing on its future.

Downey election cycles than I care to remember, and there are a few council members I'm happy to see gone for the harm they've done that lives after them. But as I've observed the more recent parade of candidates pass through public scrutiny, each trumpeting the same tune about supporting police and business, business and police (as if a robust society consisted of nothing else), I'm struck more and more by the intellectual mediocrity, the absence of thought and imagination, of knowledge of how a well-rounded city and its hosted opening night parties in rich satisfactions work, that has characterized our leadership.

> The council as a body needs to snap out of its slumber. There have been notable efforts by Saab and Rick Rodriguez to get out and around, to listen to what's going on in people's minds, to show a city presence. Sean Ashton has held a few meetings to hear what people have to say.

> the Downey arts community, such as it is, should be appalled at its own unresponsiveness to gestures Saab has made both in meetings at City Hall, where the same 15 or 20 people showed up and offered little by way of a plan to promote their work; and at the Downey Theater, where he offered discounts and non-profit incentives to theater artists to make use of the space. Except for one or two whose sole purpose seemed to complain, the majority sat in passive silence. They wanted the city to do everything

I can understand the city's reluctance to work with this bunch. Still, it has to do more. Without a cultural life, any urban locale is condemned to poverty of mind and spirit, stripped of historic continuity and the forms

that surrounds us, unrewarding to the inner lives of the people who live in it, something future generations can't wait to escape.

By cultural life I'm not just referring to visual and performing arts, literature and poetry. I'm referring to the physical landscape around us, both natural and architectural. Our political leaders have got to reverse the punishing trend of selling us out to real estate developers.

There are a number of Downey I've lived here through more civic and fraternal organizations where people come together in hearty appreciation of living here, as in the recent tributes to Mary Stauffer and the celebration of the historic McDonald's on Lakewood and Florence. But if you consider its leadership role, the city bungled the handling of the Downey Art Museum, the first in L.A. County, so that it could be destroyed by the senseless ire of one vindictive blowhard. Though the issue was complex, the city didn't protect the DCLO from a management firm that said, in effect, our way or the highway; a firm, incidentally, that acts basically as a pricey booking agency and does little to fulfill the purpose of the Downey Civic Theater as an anchor of Downey cultural identity.

> Downey needs a staff architect to help give it a look more definitive than mere branding. It needs to revive a knowledgeable arts commission consisting of energetic and figures conscientious George Redfox of the Downey Conservancy, to help advise it in fields that are clearly beyond the city council's area of expertise.

> The city should offer low rent loft and industrial space to local and L.A. artists and thereby gain entry into one of the hottest art scenes currently in the world, with no sign of cooling down. It should erase a lingering embarrassment by restoring the Downey Art Museum, and with it, an old, unmistakable source of civic pride.

The same with the Downey Theater, which, in being the largest civic structure in Downey, has dimensions superior to any other mid-size theater in Los Angeles County. Instead of the one-and-done commercial and amateur presentations we have programmed now—or in addition of expression that connect place to them--the theater should be

reconceived as a real theater, with classic and contemporary plays and theatrical performances.

Its management could offer invitations to the best college and university talents in the region to come and perform; ditto in partnership groups like the L.A. Theatre Alliance and others to cross-fertilize a regional performing arts scene. It should offer daytime performance programs for kids, who could benefit from the knowledge of some of those visiting talents. Who doesn't like kids? The theater should be buzzing fulltime, instead of looming in empty silence most days and nights like an abandoned morgue.

Who hasn't noticed the increased traffic, congestion, pollution and sheer noise that has characterized Downey life over the past decade or so? There isn't much the city can do about that. But it can find new spots here and there to put in walledoff pocket parks, which offer restorative peace and tranquility of spirit to anyone looking to get away from it all, or just catch a

All this and more could be discussed as an antidote to what we're losing, and should be addressed to our current city council, and perhaps even more crucially, the new faces competing for city leadership.

I'm a transplanted New Yorker. I first discovered the impressive Downey Theater as a theater critic for the L.A. Times; and later as a Downey resident, first became interested in local politics more than a decade ago when I went to a packed meeting at the Downey Theater hosted by city staff, who wanted to hear public opinion on how to deal with the obnoxious spread of McMansions. I was impressed by the professionalism of the staff, and by the earnest intelligence and concern of the Downey residents there.

"This city is going places," I

Neil Simon, acclaimed playwright, dies at 91

of the most popular and prolific playwrights and screenwriters of the second half of the 20th century, died Sunday, Aug. 26, of complications from pneumonia, according to his publicist Bill Evans as reported by CNN. He

Born July 4, 1927, in New York City, Simon grew up loving movies, especially comedies, and turned that love into a career when he began writing for some of TV's earliest comedy shows,

NEW YORK - Neil Simon, one including Sid Caesar's "Your the most popular and prolific Show of Shows" and "The Phil sywrights and screenwriters Silvers Show," both of which earned him Emmy awards.

> Simon spoke later of the enormous influence these jobs had on his career, particularly the opportunity to work with some of the day's finest comedy writers: "I knew when I walked into 'Your Show of Shows,' that this was the play. most talented group of writers that up until that time had ever been assembled together.'

> > The first play Simon wrote

was 1961's "Come Blow Your Horn," which ran on Broadway for more than a year to favorable reviews. It had barely closed when Simon's next play, "Little Me," opened on Broadway, starring Caesar in multiple roles and with choreography by Bob

Simon continued to write prolifically, and as his reputation grew, his plays began to become instant classics. His list of notable plays includes great favorites such as "Barefoot in the Park" (1963), "The Odd Couple" (1965), "The Sunshine Boys" (1972), "They're Playing Our Song" (1979) and "Lost in Yonkers" (1991).

Many of Simon's best-loved plays were adapted into movies, most with screenplays written by Simon: "The Odd Couple" (1968), "Only When I Laugh" (1981, based on his play "The Gingerbread Lady"), "Brighton Beach Memoirs" (1986). In other cases, the movie came first, as when he adapted his 1977 film, 'The Goodbye Girl," into a 1993

Simon also wrote screenplays that were not based on existing stage plays, such as "The Heartbreak Kid" (1972), "Murder by Death" (1976) and "The Odd Couple II" (1998).

Simon's critically acclaimed works is the are not without merit. Simon is, trilogy of autobiographical plays, "Brighton Beach Memoirs," which won the New York Drama Critics Circle Award for best play, "Biloxi Blues," which won the Tony Award for best play, and 'Broadway Bound." 1991's "Lost in Yonkers" was also greatly celebrated, winning a Drama Desk Award, a Tony Award and a Pulitzer Prize.

Simon's other honors include membership in the American Theatre Hall of Fame, the New York State Governor's Award, the Kennedy Center Honors and the Mark Twain Prize for American

Journalist Lawrence Grobel asserted that Simon "towers like a Colossus over the American theater. When Neil Simon's time comes to be judged among successful playwrights of the 20th century, he will definitely be first among equals. ...'

Broadway critic Walter Kerr also praised Simon: "Because Americans have always tended to underrate writers who make them laugh, Neil Simon's accomplishment have not gained as much serious critical praise as they deserve. His best comedies contain not only a host of funny lines, but numerous memorable

CLAIRE WINELAND: Claire Wineland, a social media star whose story about living with cystic fibrosis inspired thousands of people, died at 21.

According to a statement from her foundation Claire's Place, Wineland suffered a massive stroke caused by a blood clot on August 26 following a double lung transplant.

Wineland passed away after a week of intensive care and Leach, the debonair TV host who procedures to attempt to save her life, said the foundation.

"We know Claire was loved all over the world," said Laura McHolm, chairman of the board for the non-profit Claire's Place Foundation, in a statement. "Your prayers, support and encouraging words, have been a huge source of strength for her and her family."

Instead Wineland's family is asking for donations to be made to Claire's foundation.

"It was her greatest wish that her foundation would continue on with or without her," said Melissa Yeager, Wineland's mother, in an update on GoFundMe. "Knowing Claire, she was all about being of service to others and your donations will support her in that. A continuation of her legacy."

Wineland was born with cystic fibrosis, a genetic disease causing persistent lung infections and limiting a person's ability to breathe. According to the Cystic Fibrosis Foundation, more than 30,000 people in the U.S. live

Wineland and her family started the foundation following a routine surgery in 2010 after which she nearly lost her life, Simon is survived by his according to the organization's

> Wineland has told her story through her book "Every Breath I Take, Surviving and Thriving with Cystic Fibrosis," and on social media platforms including YouTube and Instagram, where she has hundreds of thousands of followers.

> "I will miss you more than words can say," said her father, John Wineland, in a post on Facebook. "I think its safe to say, the world will too."

> ROBIN LEACH: regaled audiences with talk of 'champagne wishes and caviar dreams," has died, his publicist confirmed to CNN.

He was 76.

John Katsilometes, a writer for the Las Vegas Review-Journal, where Leach was working as a columnist before his death, said on Twitter Leach had suffered a stroke and had been hospitalized since November.

Born in London, Leach was a veteran journalist best known for his syndicated TV show "Lifestyles of the Rich and Famous," which ran from 1984 to

Leach's family issued a statement to the Review-Journal.

"Despite the past 10 months, what a beautiful life he had. Our Dad, Grandpa, Brother, Uncle and friend Robin Leach passed away peacefully last night at 1:50 a.m.," the family said in a statement. "Everyone's support and love over the past, almost one year, has been incredible and we are so grateful."

Leach began his career in newspapers, writing for the Daily Mail, People and the New York Daily News. He moved to the U.S. in the early 1960s becoming editor of media mogul Rupert Murdoch's tabloid Star. He later helped launch "Entertainment Tonight," through Paramount Television, before co-creating and hosting "Lifestyles."

Upon news of his death, some of Leach's famous friends paid tribute to the host.

Vince Neil called Leach a "long time friend" and "an amazing person."

"He's going to be missed by me and thousands more worldwide," he wrote.

Food Network personality and chef Scott Conant said Leach was "always kind to me and a friend to Las Vegas businesses I've had over the past almost 10

years.' "I hope you're resting at your grand chalet in the sky my friend," he wrote.

In a 2016 interview with the Hollywood Reporter when he joined the Review-Journal, Leach said, "It's been a good life, and it's always been a good life. I have been rewarded very nicely.'
