Housing market begins to slow

LOS ANGELES -California housing market posted its largest year-overyear sales decline since March 2014 and remained below the 400,000-level sales benchmark for the second consecutive month in September, indicating that the market is slowing as many potential buyers put their homeownership plans on hold, the California Association of Realtors said Monday.

Closed escrow existing, single-family detached homes in California totaled a seasonally adjusted annualized rate of 382,550 units in September, according to information collected by C.A.R. from more than 90 local Realtor associations and Multiple Listing Services (MLS) statewide.

The statewide annualized sales figure represents what would be the total number of homes sold during 2018 if sales maintained the September pace throughout the year. It is adjusted to account for seasonal factors that typically influence home sales.

September's sales figure was down 4.3 percent from the revised 399,600 level in August and down 12.4 percent compared with home sales in September 2017 of 436,920.

housing market continued to deteriorate and the decline in sales worsened as interest rates remained on an upward trend. More wouldbe buyers are self-sidelining as they believe home prices will start to come down soon, making housing more affordable despite rising interest rates," said C.A.R. President Steve White. "Tax reform, which increases the cost of homeownership, also is contributing to the decline, would be used as a transitional shelter especially in high-cost areas and social services center for recentlysuch as the San Francisco Bay discharged U.S. veterans. "Price appreciations have slowed in the last few months and inventory has risen considerably since June when the statewide median price hit a new peak," said C.A.R. Senior Vice President and Chief Economist Leslie Appleton-Young. "Buyers are becoming increasingly concerned about market developments and are reluctant to purchase at the prevailing market price. As such, the deceleration in price growth will likely continue in coming

Other key points from C.A.R.'s September 2018 resale housing report include:

On a regionwide, nonseasonally adjusted basis, the Southern California region led the state's sales decline, falling 17.3 percent from a year ago. Los Angeles County experienced the largest drop in the region at 22 percent, while Orange County declined 21.8 percent. Sales in the Inland Empire were down 10.8 percent from a year ago, with Riverside and San Bernardino counties recording an annual sales decline of 9.7 percent and 12.4 percent, respectively.

Sales in the Bay Area declined 16.4 percent from September 2017, the largest decline since October 2010. Santa Clara posted the largest drop at 22.6 percent, while Marin experienced the lowest decline at 1.1 percent. Alameda (-10.4 percent), Contra Costa (-17.3 percent), Napa (-14.2 percent), San Francisco (-11.5 percent), San Mateo (-14.6 percent), Solano (-19.3 percent), and Sonoma (-19.4 percent) counties all posted double-digit declines.

Downey, South Gate clash over homeless facility

▶ Downey officials say a proposed facility on the South Gate border

County officials contend the development would provide 60-80 permanent apartment units for homeless veterans.

DOWNEY - A big question hangs over a project that may very well likely erect itself in the current American Legion 723 Hollydale location: is it just another homeless shelter?

The property, located at 11269 Garfield Ave., lies within Downey city limits and is owned by Los Angeles County.

Downey officials are eyeing the location as an opportunity to establish a temporary housing development to help honorably-discharged military veterans who find themselves in need after the conclusion of their service.

However, LA County officials have said otherwise, instead saying that the project is intended for long-term residency.

The project significant negative attention from South Gate residents near the potential project, who have voiced concerns about a homeless shelter. They fear its establishment would bring significant safety issues to their neighborhoods while not affecting Downey's residents.

However, Mayor Pro Tem Rick Rodriguez has pushed back on these claims, describing the project as a "veterans transitional housing location." acknowledged homeless veterans could be housed at the development, but insisted the proposed project is "not specifically for homeless, it's for veterans."



Preliminary plans call for a veterans facility at the American Legion's Hollydale Post No. 723, but it's not clear whether the development will provide temporary shelter or long-term housing.

"Our goal is to relaunch them into civilian life with training," proper said Rodriguez. "We give them a rifle at 18 and we train them to defend America and go around the world...We can train them to be a soldier, but we can't garnered take care of them when they get back? > Without a strong support system, returning veterans run the risk of facing other problems, such as having nowhere to go, no job, and no way to transfer their acquired skills, Rodriguez added.

The project is that of LA County and Supervisor Janice Hahn. Officials with Hahn's office said she is committed to working closely with the city of Downey, although details of the project seem to have been lost in translation between parties.

Instead, Rodriguez says communications director, Liz that veterans who would arrive Odendahl, said the supervisor would like to build 60 to 80 affordable, long-term housing apartments for formerly homeless veterans, where they could potentially live "indefinitely."

> "In this country we pride ourselves on honoring our veterans with a national holiday, by saluting them at sporting events, and allowing them to board planes early—and yet we allow thousands of veterans to sleep on our sidewalks every night," said Hahn. "There is no greater way to honor a veteran who has risked their life for our freedoms than ensuring they have a safe place to live when they return home.

> "I have seen how successful these types of projects have been in other areas of the county. When it is finally built, it will not only improve public safety, it will be a beautiful addition to this neighborhood.'

> The project is still in the planning stages with no concrete timeline, however, the county hopes to have more plans fleshed out within the coming months, officials said.



Washington's phony moves against Russian meddling

The Justice Department announced charges against Russian social media manipulator Elena Khusyaynova on Friday. She is accused of conspiring to set up fake Facebook and Twitter accounts under names such as "Bertha Malone," "Rachell Edison" and "wokeluisa" that posted "tens of thousands of messages" about gun rights, immigration, the midterm elections and other controversial topics.

No one wants to see foreign nations meddling in our politics. But don't be bamboozled by the fanfare over this criminal complaint. Federal officials claim going after Khusyaynova is part of a necessary crackdown because propaganda machines like hers "undermine confidence in our democratic institutions" and mislead voters.

Truth is, these officials are grandstanding. Their charges will go nowhere. Khusyaynova, an accountant who manages financial transactions for the conspirators, resides in St. Petersburg, Russia, and there is no extradition treaty with Russia. That means she'll never go to trial. What a waste of taxpayers' money for investigators and lawyers with no end game. It's a Justice Department vanity

operations like Khusyaynova's on voters. The impact is minuscule. Twitter's lawyer told the Senate Judiciary committee that Russian tweets "represented a very small fraction of the overall activity on Twitter in the 10-week period preceding the 2016 election." That was also true of the fake postings made by 13 Russians indicted last spring by special counsel Robert Mueller. His mandate is to look into the Trump campaign's possible collusion with Russian officials to influence the 2016 election, but so far Mueller has failed to connect any dots.

In the absence of collusion, Washington officials need to moderate Officials are wildly overstating the impact of foreign propaganda their hysteria over foreigners on social media. Foreign agents have tried to influence American elections dating back to 1796. The more urgent issue is the integrity of the vote count. Last March, Congress approved grants to the states to improve voting technology. In September, President Donald Trump authorized tougher sanctions against nations that tamper with American election equipment, not

This week, the United States Cyber Command acknowledged that it's been warning foreign operatives to stop their misinformation campaigns.

Unfortunately, liberal media outlets and Democrats in Congress, including Senator Dianne Feinstein, are urging tech companies to take on the role of speech police against social media misinformation campaigns, both domestic and foreign. Yikes. That would be devastating to our democracy. We can't trust Twitter, which recently refused to suspend Louis Farrakhan for tweeting a comparison of Jews to termites. Surely we can't trust Google, which is building a censored search engine for the Chinese market that blocks access to terms like "human rights" and "freedom of religion."

Social media should be the 21st-century version of the public square. It's true that rogue foreigners are invading it, but so far the harm is minor. What Americans cannot risk is ceding to Silicon Valley liberals — or any group — the power to limit access to opposing views. That would be far more dangerous than Russian meddling.

Much of the land was recommended for wilderness designation by pre-Trump Interior Departments.

The bills would open it to industrial uses, such as logging, mining and oil and gas development. Guess whose friends could profit handsomely.

Canada got it right when it legalized recreational marijuana

It turns out that when you legalize marijuana, a lot of people show up to buy it. That development seemed to surprise cannabis controllers in Canada, where shortages were reported almost immediately after legal recreational sales began last week.

In several other respects, however, Canada is handling the transition from prohibition to regulation better than the United States. Canadians seem to have learned a few things from American mistakes, and we in turn can learn from their successes.

by the two countries is that Canada has legalized marijuana at the national level. It is only the second country in the world (after Uruguay) to do so.

In the United States, by contrast, marijuana is still prohibited by federal law. As a result, marijuana merchants in the eight states that license them operate under a legal cloud, committing federal felonies every day. Aside from exposing cannabusinesses to the risk of prosecution and forfeiture, the federal ban complicates financing, leasing, contracting, insurance, banking and income taxes.

There is an easy fix for this problem: Congress can show its respect for the 10th Amendment by repealing the federal ban as it pertains to conduct that is permitted under state law. Even former New Jersey Gov. Chris Christie, who promised to crack down on statelegal marijuana when he ran for the 2016 Republican presidential nomination, recently conceded that "states have the right to do what they want" with cannabis.

Another important advantage of the Canadian approach is proposition.

In the U.S., most states with legal pot do not allow direct deliveries to consumers, and the continuing federal ban makes sending marijuana by mail, UPS or FedEx a risky

> The Canadian government not only has decided to stop treating cannabis consumers as criminals. It also plans to help cannabis consumers who continue to suffer from that label by eliminating fees and waiting periods for sealing conviction records related to possession of 30 grams or less of marijuana, which is now legal.

> The plan is far from perfect, but it goes further than the policies of most U.S. states with legal pot, and it invites a serious discussion of a key moral issue raised by the repeal of marijuana prohibition: When a government decides to stop punishing people for peaceful activities that violate no one's rights, what does it owe to the victims of that oppressive policy?



Home sales in L.A., Orange counties drop 2%

counties posted annual sales gains of 9.1 percent and 11.1 percent, respectively, sales for the Central Valley Region as a whole were down 15.1 percent from a year ago. Every other county of the region posted declines from a year ago.

While home prices continue to grow in the Bay Area, the rate of appreciation has slowed since the first half of the year. In September, the median price in the Bay Area increased 9.8 percent from last year, lower than the average year-over-year

Francisco Bay Area increased the most in active listings, with the market at the current sales a surge of 44 percent year over year. 

The Tell-Tale Heart

by Edgar Allen Poe



True! -- nervous -- very, very dreadfully nervous I had been and am; but why will you say that I am mad? The disease had sharpened my senses -- not destroyed -- not dulled them. Above all was the sense of hearing acute. I heard all things in the heaven and in the earth. I heard many things in hell. How, then, am I mad? Hearken! and observe how healthily --how calmly I can tell you the whole story.

It is impossible to say how first the idea entered my brain; but once conceived, it haunted

me day and night. Object there was none. Passion there was none. I loved the old man. He had never wronged me. He had never given me insult. For his gold I had no desire.

I think it was his eye! yes, it was this! He had the eye of a vulture --a pale blue eye, with a film over it. Whenever it fell upon me, my blood ran cold; and so by degrees -- very gradually -- I made up my mind to take the life of the old man, and thus rid myself of the eye forever.

Now this is the point. You fancy me mad. Madmen know nothing. But you should have seen me. You should have seen how wisely I proceeded — with what caution — with what foresight — with what dissimulation I went to work! I was never kinder to the old man than during the whole week before I killed him. And every night, about midnight, I turned the latch of his door and opened it —oh so gently! And then, when I had made an opening sufficient for my head, I put in a dark lantern, all closed, closed, that no light shone out, and then I thrust in my head. Oh, you would have laughed to see how cunningly I thrust it in!

I moved it slowly -- very, very slowly, so that I might not disturb the old man's sleep. It took me an hour to place my whole head within the opening so far that I could see him as he lay upon his bed. Ha! would a madman have been so wise as this, And then, when my head was well in the room, I undid the lantern cautiously -- oh, so cautiously -- cautiously (for the hinges creaked) --I undid it just so much that a single thin ray fell upon the vulture eye.

And this I did for seven long nights — every night just at midnight — but I found the eye always closed; and so it was impossible to do the work; for it was not the old man who vexed me, but his Evil Eye.

And every morning, when the day broke, I went boldly into the chamber, and spoke courageously to him, calling him by name in a hearty tone, and inquiring how he has passed the night. So you see he would have been a very profound old man, indeed, to suspect that every night, just at twelve, I looked in upon him while he slept

Upon the eighth night I was more than usually cautious in opening the door. A watch's minute hand moves more quickly than did mine. Never before that night had I felt the extent of my own powers --of my sagacity. I could scarcely contain my feelings of triumph. To think that there I was, opening the door, little by little, and he not even to dream of my secret deeds or thoughts.

I fairly chuckled at the idea; and perhaps he heard me; for he moved on the bed suddenly, as if startled. Now you may think that I drew back --but no. His room was as black as pitch with the thick darkness, (for the shutters were close fastened, through fear of robbers,) and so I knew that he could not see the opening of the door, and I kept pushing it on steadily, steadily.

I had my head in, and was about to open the lantern, when my thumb slipped upon the tin fastening, and the old man sprang up in bed, crying out -- "Who's there?" I kept quite still and said nothing. For a whole hour I did not move a muscle, and in the meantime I did not hear him lie down. He was still sitting up in the bed listening; --just as I have done, night after night, hearkening to the death watches in the wall.

Presently I heard a slight groan, and I knew it was the groan of mortal terror. It was not a groan of pain or of grief --oh, no! --it was the low stifled sound that arises from the bottom of the soul when overcharged with awe. I knew the sound well. Many a night, just at midnight, when all the world slept, it has welled up from my own bosom, deepening, with its dreadful echo, the terrors that distracted me. I say I knew it well. I knew what the old man felt, and pitied him, although I chuckled at heart.

I knew that he had been lying awake ever since the first slight noise, when he had turned in the bed. His fears had been ever since growing upon him. He had been trying to fancy them causeless, but could not. He had been saying to himself — "It is nothing but the wind in the chimney — it is only a mouse crossing the floor," or "It is merely a cricket which has made a single chirp."

Yes, he had been trying to comfort himself with these suppositions: but he had found all in vain. All in vain; because Death, in approaching him had stalked with his black shadow before him, and enveloped the victim. And it was the mournful influence of the unperceived shadow that caused him to feel —although he neither saw nor heard —to feel the presence of my head within the room.


When I had waited a long time, very patiently, without hearing him lie down, I resolved to open a little —a very, very little crevice in the lantern. So I opened it —you cannot imagine how stealthily, stealthily —until, at length a simple dim ray, like the thread of the spider, shot from out the crevice and fell full upon the vulture eye. It was open —wide, wide open —and I grew furious as I gazed upon it.

I saw it with perfect distinctness --all a dull blue, with a hideous veil over it that chilled the very marrow in my bones; but I could see nothing else of the old man's face or person: for I had directed the ray as if by instinct, precisely upon the damned spot. And have I not told you that what you mistake for madness is but over-acuteness of the sense? --now, I say, there came to my ears a low, dull, quick sound, such as a watch makes when enveloped in cotton.
