# Garcia introduces tampon tax repeal bill for third time

► The Assemblymember says female menstrual products should be tax exempt as other medical necessities are in California.

repeal the tax charged on menstrual health products was reintroduced Monday shortly after Assemblywoman Cristina Garcia was sworn in for her fourth term representing the 58th Assembly District.

The bill is the third attempt by Garcia (D-Bell Gardens) to create a gender neutral tax code.

In 2016, the bill (AB 1561) passed through the legislature nearly unanimously only to be vetoed by Governor Brown who cited a resulting loss of funds if the tax was removed. In 2017 Appropriations.

"When introduced this bill it started a national movement to rectify the discriminatory taxation of menstrual products. California

Currently, women NORWALK - A bill to California still pay over \$20 million annually in taxes on tampons, sanitary napkins, and menstrual cups paying on average \$7 a month for forty years of their lives. California law exempts health items like walkers, medical identification and prescription medication, including Viagra.

> Menstrual health products are not tax exempt in California even though they are deemed medical necessities by the Federal Drug Administration.

# My biggest disappointment in politics

The other day, a friend asked what surprised me most about politics. This may seem strange, but I'd never really thought about the

My response was off-the-cuff but heartfelt. The biggest surprise is also among my biggest disappointments with American political life: the ongoing effort by politicians to suppress votes.

Yes it's gone on for years. And in some respects, limiting the vote has been a feature of American politics since the beginning, when only white men with property could cast ballots. But when I began in politics, I assumed those days were past us, and everyone was on board reason that they're trying to prevent voter fraud. In other words, with the idea that the more people who vote, the better. Boy, was I

The truth is, people work hard to prevent other people from voting. To be sure, some voters do it to themselves — they're too busy, or they think their vote doesn't matter, or they encounter long lines and turn blunt: there's no tidal wave of illegal voting in the U.S. away.

minority or poor voters — from casting their ballots. How do politicians accomplish this? Here's a short, and incomplete, list:

- They require voter IDs and then limit which IDs are valid (a gun permit is fine, for instance, but not a student ID);

> needs to be guarded against. But rampant voter fraud simply doesn't exist in this country. Efforts to prove that it exists have failed. Let's be What does inarguably exist, though, is an epidemic of efforts

But there is also an active, ongoing effort to keep people — often to suppress the vote. Voting is a basic right of citizenship. It's the foundation of a democracy — people's ability to participate and engage with the issues facing their communities and their country. That ideal lies at the core of American values, and I'm always mindful of the fact that a lot of Americans gave their lives for that ideal. Moreover, excluding groups of voters encourages resentment, risking protests and potentially violence.

I've always believed that you win power by convincing people that your ideas and proposals are right — or at least that you should be given the chance to prove that they're right. Winning power by keeping people away from the polls is a perversion of what democracy is about. Our political institutions need to reflect the will of the people, and if you disenfranchise people, it means that our representative government doesn't reflect accurately the will of the people.

Because voting laws are in the hands of the states, there are plenty of counter-examples — states that have worked to make voting easier, to expand hours, to allow same-day registration, and the like. There's more to be done, especially making sure that the politicians who control elections aren't themselves running for office, as happened notably in November's elections in Georgia and Kansas. That is a conflict of interest of the most obvious sort.

This struggle, between expanding the vote and trying to limit it, is ongoing. It's not going to be resolved any time soon. I'm always distressed when I encounter efforts to suppress the vote. But I take heart from the fact that over the course of American history, the dominant trend has been to expand citizens' access to the polls, and I hope that over the long term, we continue in that direction.

# Mourning President Bush

I spent more than a year working to beat him. I thought his campaign manager was about the most unethical person I'd ever met. I knew that the fish rots from the head. I was not a big fan of George

Until I — and much of America — came face to face with a president who lacks everything we took for granted in him.

Nobody was afraid of a Bush presidency, which was one of the reasons he won. Compared with a relatively unknown liberal governor who let a black first-degree murderer out of prison and then rape a white woman, the vice president was the safe choice. And he was safe.

I don't know a single soul who told me that they were actually afraid of a Bush presidency. He appointed judges I didn't favor, gave tax cuts to the wealthy, played it cozy with the Saudis. But he was never scary. You never thought, "My God, this guy doesn't listen to everyone. He shoots from the hip, embarrasses us in the eyes of the world, creates all kinds of uncertainty, has no respect for anyone or anything, thinks he knows everything, makes everything personal and lost the House with a booming economy.'

George H.W. Bush respected the office of the presidency.

He respected the rule of law.

He surrounded himself with aides who were not chosen solely based on their loyalty to him.

He did not brag about manhandling women, did not spend his day And then the Democrat would scream and yell about questioning his watching television and actually believed in talking to Democrats.

He wrote nice notes to people ("nn") — including people he disagreed with — not Twitter posts

We were opponents, not enemies.

He cared about America more than he ever cared about himself. And, of course, we took all those things for granted.

I was on a panel at the Ronald Reagan Library during the Clinton years right after the Republicans took over the House in the midterms. peaker-to-be Newt Gingrich was riding high on a pretty harsh anti-

Clinton tide. He was on the panel. The crowd was all his. I wasn't even supposed to be there, but whichever woman was on the panel had been forced to bow out. I was doing them a favor. I got my head handed to me. The first question to me was something about President Reagan and President Roosevelt. I said something completely noncontroversial about "respect for the presidency." The

row, and she was openly appalled. She apologized and sent me flowers. Reagan respected the presidency in ways President Trump could never understand.

crowd booed me — on C-SPAN, no less. Mrs. Reagan was in the first

I remember when it was standard political fare, particularly for Republicans, to try to turn support for civil liberties, or support for requiring congressional approval to go to war, into a test of patriotism.

patriotism, because that's just not allowed.

This time is different. This time we have a president about whom nothing can be taken for granted, including respect for separation of powers, American intelligence, the independence of the judiciary and a free press. Because Donald Trump has no respect for anyone and anything, including the Constitution, which he keeps ignoring or trying to rewrite. Donald Trump is not bound by truth or by law. George Bush was a patriot and a hero, two words rarely associated with Trump.

And we have become almost used to it. Every day, Trump says or does something that none of his predecessors would have ever done, and then we forget because tomorrow will be the next outrage. We have learned to live with a president who simply lies — flat out — and then we forget because he lies every day.

George Bush had nothing in common with this president whatsoever other than his party affiliation.

May the passing of a former president who was everything Donald Trump is not remind us that patriotism and respect for the rule of law should never be partisan issues. And may our former president rest in

# Why are we still in Afghanistan?

The old peacenik slogan was, "What if they gave a war and nobody came?" Today, the question is, "What if they gave a war and nobody noticed?" The American mission in Afghanistan has borrowed a page from Harry Potter, draping itself in a cloak of invisibility.

Our war has lasted 17 years and cost upward of \$1 trillion, including \$45 billion this year. It has killed more than 2,300 Americans and wounded more than 20,000. Yet we recently completed an election campaign in which the conflict was rarely mentioned, much less debated. From a political point of view, this war is about as important as storms on Saturn.

But the spilling of American blood doesn't stop. On Tuesday, three U.S. service members were killed by a roadside bomb. Last week, an Army Ranger was fatally shot in a firefight. And for what?

When we invaded in 2001 to strike back at the Taliban, which had given safe haven to al-Qaida as it plotted the 9/11 attacks, victory seemed attainable. But the mission to eliminate a specific threat to the U.S. homeland soon gave way to a more ambitious project to make Afghanistan a stable, peaceful and democratic nation. Before long, we were stuck in the Forever War.

George W. Bush and Barack Obama each failed to find the formula for success, and each decided to leave a steaming pile of hard choices to his successor. They stayed in Afghanistan not because they knew how in Afghanistan. Donald Trump, reluctant to look weak, nearly doubled to win the war but because they didn't. They elected to keep feeding that number. "The American people are weary of war without victory,"

American troops into the meat grinder rather than admit failure.

The result has been an endless loop of futility. The latest report of the Special Inspector General for Afghanistan Reconstruction concluded that the Afghan government has control of no more than 55 percent of the country's districts — down 21 percent from the peak. Nearly 12 percent of the jurisdictions are in the grip of the Taliban, and 32 percent

The Afghan security forces now bear the brunt of the fighting, with an average of 25 deaths per day. Thanks to steady attrition, their ranks are now the smallest they've been since 2012. Civilian casualties, however, are up nearly 40 percent this year compared with 2017.

We have tried ramping up to overwhelm the insurgents. Obama started in office intending to bring the war to an end, telling his aides, "I don't want to be going to Walter Reed for another eight years." He increased our troop strength from about 30,000 to more than 100,000, with the goal of turning the tide of the war enough for us to go home.

It made a modest difference. The Kabul government gained ground, and the Taliban lost it. But a U.S. commitment on that scale was not sustainable. And the long-sought improvements in Afghan governance and military prowess failed to materialize. As soon as Obama drew down forces, things went south once again.

Rather than pull out entirely, he agreed to keep some 8,400 troops

he declared.

Wrong. The war causes no visible fatigue in the public because it requires no discernible contribution from the public. In any event, victory has eluded him, too.

For a long time, our options have fallen into two categories: bad and worse. The bad is withdrawing and letting the Afghans settle the war themselves, which could easily lead to a collapse of the government and a Taliban return to power. The worse is staying indefinitely, sacrificing American lives to preserve a stalemate.

But the enemy is sure to outlast us. The outlook recalls the comments of the prime minister of North Vietnam to a New York Times reporter early in the Vietnam War. "And how long do you Americans want to fight, Mr. Salisbury?" he asked. "One year? Two years? Three years? Five years? Ten years? Twenty years? We shall be glad to accommodate

The Taliban have shown comparable endurance. Their saying is, "The Americans have all the watches, and we have all the time.

Three American service members gave their lives Tuesday in support of an effort whose only remaining purpose is postponing the inevitable. They won't be the last to die for this mistake.

# Downey's new police chief promises to be 'tough on crime'

►A 24-year veteran of the Downey Police Department, Dean Milligan offered his commitment to the Downey community.

"We will be tough on crime and diligent in providing for your safety while being responsive to your concerns," he said.

**DOWNEY** - Former police captain Dean Milligan was officially sworn in as Downey's 11th police chief in front of a crowded City Hall chamber Wednesday morning.

Milligan has served as part of Downey's Police Department since 1994, working several assignments and moving up the ranks before being promoted to captain in December of 2012. He holds a Bachelor's Degree in Political Science from the University of Laverne and a Master's Degree in Public Safety Leadership from the University of San Diego.

He now takes over for Chief Carl Charles, whose retirement became effective Wednesday.

Charles said that he "couldn't have asked for a more hard-working, conscientious, and loyal second-in-command."

"For the past six years, Dean played a critical role in implementing a host of community-based programs and services," said Charles. "Through it all, Dean has been a confidant, an advisor, and a true friend. It is my supreme confidence in his ability that led me to choose this point in time to retire.

"I am absolutely certain that Dean is the right person to lead this department into the future with an ever-changing law enforcement landscape."

Milligan was sworn in by former Downey Police Chief Greg Caldwell. His wife, Theresa, held a bible as he took his oath.

After taking his oath, Milligan addressed the audience.

"With this chief's office comes tremendous responsibilities. It is a great honor that I am humbled by and I do not take it lightly," said Milligan.

"I offer you my commitment. We will be tough on crime and diligent in providing for your safety while being responsive to your concerns. We will always strive to be respectful while being an open, accountable, and transparent agency."

Milligan also asked for the cooperation of the community.

"We need your leadership as well as your understanding with regard to what we can and cannot do. While we will always be your first line of defense, we unfortunately are not the answer to every problem."

"It is my hope that in the event of a critical incident, you will be willing to suspend judgement until all the facts are in. Safe neighborhoods are the results of residents and their police department working together to create them...please know that the Downey Police Department is committed to working with you to make this community a safe and secure place to live and that we will continuously strive to maintain your trust"

Milligan's speech included a wide range of thanks – directed to everyone from City Council and staff to friends, loved ones and his family – as well as a few direct words to the police department staff and officers that he now will lead.

"You should feel very proud of the job you do each day. It's my hope that when you end your shift and head for the safety of your home you will truly believe that what you did today mattered," said Milligan. "I commit myself to ensure that you are properly equipped and supervised, as well as being supported entirely.

"Serving as a police officer today means facing adversity and overcoming increasing challenges. We ask more of our officers on the street today than at any time in history.

"Policing is about much more than simply investigating crime and arresting those who do harm; it's providing council to families in distress, it's getting someone suffering from mental illness help, working out civil disputes between neighbors, and working with our youth in various programs...

"I know that you all don your respective uniforms every day because you've chosen to help people and give back to the community that we serve."

Former President George H.W. Bush, the 41st president of the as a US victory, it was also viewed as a violation of international law. United States, died Friday at 94.

Bush was admitted to Houston Methodist Hospital in April after "contracting an infection that spread to his blood," according to a statement from Bush family spokesman Jim McGrath.

Bush suffered from a form of Parkinson's disease and had been hospitalized several times in recent years. The former commanderin-chief was treated for pneumonia and was temporarily placed on a

Bush served as president from 1989 to 1993. Before that, he served as vice president under Ronald Reagan from 1981 to 1989.

Bush's death follows the passing of his wife, former first lady Barbara Bush, who died on April 17. Barbara, 92, suffered from chronic obstructive pulmonary disease (COPD) and congestive heart failure. The two had been married for 73 years.

Bush, a Massachusetts native, joined the US armed forces on his 18th birthday in 1942 and eventually became the youngest naval pilot at the time. He flew a total of 58 combat missions during World War II, including one where he was shot down by Japanese forces.

"George H.W. Bush was a man of the highest character and the best dad a son or daughter could ask for," former President and son George W. Bush said in a statement. "The entire Bush family is deeply grateful for 41's life and love, for the compassion of those who have cared and prayed for dad, and for the condolences of our friends and fellow citizens.

President Donald Trump also released a statement following news of Bush's death: "Melania and I join with a grieving Nation to mourn the loss of former President George H.W. Bush, who passed away last

"Our hearts ache with his loss, and we, with the American people send our prayers to the entire Bush family, as we honor the life and legacy of 41," Trump added.

After graduating from Yale University and venturing into the oil business, Bush jumped into politics and eventually became a congressman, representing the 7th Congressional District in Texas. He made two unsuccessful runs for Senate, but would later serve in various political capacities — including as the US ambassador to the United Nations, Republican National Committee chair, and CIA

the Republican Party's nomination during the primaries. Reagan soon chose Bush as his running mate and vice presidential nominee.

He ran for president again with Sen. Dan Quayle of Indiana as his running mate, and won, in 1988.

During his time in office, Bush oversaw major foreign-policy decisions that would have lasting effects on the global stage

As one of his first major decisions, Bush decided to remove Panamanian dictator Manuel Noriega — a former US ally turned international drug lord — from power. Around 23,000 US troops took part in "Operation Just Cause" and invaded Panama. Noriega

As the sitting president during the demise of the Soviet Union, He is survived by his five children, 17 grandchildren, eight great Bush held summits with Soviet President Mikhail Gorbachev and advocated for the reduction of nuclear weapons while cultivating US-

> When the Soviet Union finally fell, Bush heralded it as a "victory for democracy and freedom" but held back on implementing a UScentric policy on the confederation of nations that emerged.

On August 2, 1990, Bush faced what was arguably his greatest test. Iraq, led by Saddam Hussein, invaded Kuwait after accusing it of stealing oil and conspiring to influence oil prices.

Bush formed a coalition of nations, including the Soviet Union, to denounce Hussein's actions and liberate Kuwait in "Operation Desert Shield" and eventually "Operation Desert Storm." Around 425,000 US troops and 118,000 coalition forces were mobilized for weeks of aerial strikes and a 100-hour ground battle.

Despite his achievements beyond the US border, Bush was less successful back home. He fell short in his bid for reelection in 1992, during a time of high unemployment rates and continued deficit spending. Bush pulled in only 168 electoral votes that year, compared to Bill Clinton — then the governor of Arkansas — who collected 370

Following his presidency, the Bushes relocated to Houston, Texas, where they settled down and became active in the community.

Bush received several accolades after his presidency, including receiving a knighthood at Buckingham Palace, and having the US Navy's nuclear-powered aircraft carrier, the USS George H.W. Bush (CVN 77), named after him.

In 2017, several women accused Bush of sexual misconduct and telling lewd jokes. Bush's representatives released a statement at the time, saying that he occasionally "patted women's rears in what he intended to be a good-natured manner."

Bush is survived by his sons, former President George W. Bush, former Florida Gov. Jeb Bush, Neil Bush, Marvin Bush, and daughter Dorothy Bush Koch.

"Some see leadership as high drama and the sound of trumpets calling, and sometimes it is that," Bush said during his inaugural address on January 20, 1989. "But I see history as a book with many pages, and each day we fill a page with acts of hopefulness and

Bush continued: "The new breeze blows, a page turns, the story Bush decided to run for president in 1980; however, failed to secure unfolds. And so, today a chapter begins, a small and stately story of unity, diversity, and generosity — shared, and written, together.'

The series, about a anthropomorphic sea sponge named SpongeBob and his various underwater-dwelling friends, airs in more than 200 countries and been translated into more than 50 languages. It has earned numerous awards during its run, including four Emmy

Hillenburg earned a special Emmy Award earlier this year for his work in the animation field.

JEAN BARKER: Baroness Trumpington, the former World War Two codebreaker and British politician, has died at the age of 96.

Her son Adam Barker broke the news on Twitter on Monday, writing that "she had a bloody good innings.'

Baroness Trumpington served for 37 years in the House of Lords, the second chamber of the British parliament, only retiring in 2017.

Prior to that she also served as a Conservative government minister and party whip, whose role is to maintain party discipline, according to the UK's Press Association.

During WWII, she was one of the so-called "Land Girls", who worked to maintain food production during the war, and also worked at the famous Bletchley Park codebreaking facility in naval intelligence.

Fluent in several languages, she helped in cracking messages from

After the war she rose through British politics and carved out a reputation as a colorful character.

In 2011 she was recorded making an obscene gesture at another member of the House of Lords.

The incident, apparently provoked by a comment about her age, only added to her reputation as something of a one of a kind.

"I thought I'd been terribly discreet," she said during a 2014 interview with CNN's Christiane Amanpour. "I've never yet discovered where the cameras are in the House of Lords.'

News of her death resulted in a wave of tributes, including a tweet from former UK Prime Minister David Cameron.

"So very sad to hear that Baroness Trumpington has passed away. She was one of a kind - they simply don't make politicians like that anymore. She will be sorely missed in Westminster but long remembered for her outstanding ability and great humour. RIP Trumpers," he wrote.

# Sears chairman offers to buy all 500 stores

**CHICAGO** - The chairman and largest investor in Sears Holdings is offering to buy the retailer out of bankruptcy — including 500 of its remaining stores — in what may amount to the chain's last hope to survive its precipitous decline.

Sears chairman and hedge fund investor Eddie Lampert, who was also CEO until the retailer's October bankruptcy filing, disclosed the offer Thursday.

"Sears is an iconic fixture in American retail and we continue to believe in the company's immense potential to evolve and operate profitably as a going concern with a new capitalization and organizational structure," Lampert said in a letter.

"Our proposed business plan envisages significant strategic initiatives and investments in a rightsized network of large format and small retail stores, digital assets and interdependent operating businesses."

Lampert said the acquisition

would keep 50,000 Sears employees working.

He said the deal would include 500 stores, which covers essentially all of the locations Sears has not identified for closure. The deal would include Sears and Kmart stores.

The deal would also include the Kenmore appliance and DieHard tool brands, key real estate and the company's inventory and receivables.

Lampert described his offer as worth about \$4.6 billion "in total consideration." He said the price would include debt to be issued by Sears, "a credit bid" of about \$1.8 billion and the assumption of certain liabilities.

In recent years, Lampert's hedge fund, ESL Investments, has loaned Sears more than \$2.4 billion in financing. So he could lose a fortune if Sears is forced to liquidate or sticks creditors with steep losses.

But critics have also accused him of structuring his deals

to ensure he gains access to key assets in the event of the retailer's demise. He was also earning hundreds of millions annually in Sears debt payments before the retailer's bankruptcy.

A committee organized to represent Sears' unsecured creditors in the case filed a motion accusing ESL of potentially structuring deals to benefit itself. ESL, which is wholly owned by Lampert, has denied those accusations, saying it should be credited for propping up Sears in recent years.

In his letter proposing the deal, dated Wednesday, Lampert also noted that his bid was conditioned on releasing ESL "from any liability related to any" deals that the hedge fund engineered before the bankruptcy.

In one key deal that's under scrutiny, Lampert helped engineer a spinoff of 235 of the most valuable Sears properties to a real estate investment trust called Seritage Growth Properties. That 2015 deal generated \$2.7 billion for Sears.

As of Sept. 30, Seritage still had 102 Sears leases, covering 12.4 million square feet and \$61.2 million in annual base rent.

Since August, the retailer has closed or announced plans to close about 228 stores. That's on top of thousands of closures since the company's peak earlier this century

Sears has suffered from the rise of Amazon, powerful retailers like Walmart and Target, a lack of investment in its stores and legacy costs, including pensions.

The company filed for Chapter 11 bankruptcy protection on Oct. 15, hoping to use the restructuring process to shed debt, escape expensive leases and reemerge as a viable company

# 'Vice' lands 6 Golden Globe nominations



HOLLYWOOD - Dick Cheney biopic "Vice" led nominations for the 76th annual Golden Globe Awards, narrowly edging Lady Gaga and Bradley Cooper's tear-jerking revival of "A Star Is Born," the interracial road-trip drama "Green Book" and period romp "The Favourite."

"Vice" topped all contenders Thursday with a surprising six nominations, including best picture and comedy. "A Star Is Born," 'Green Book" and "The Favourite" scored five nominations each.

"Vice" stars Christian Bale as the former vice president. The film is a highly critical portrait of the former VP Cheney as a powerhungry, behind-the-scenes tyrant. It arrives in theaters Dec.

The nominations were announced at the Beverly Hilton Hotel in Beverly Hills, Calif., on Thursday.

The ratings for last January's broadcast, hosted by Seth Meyers and graced with an impassioned speech by Oprah Winfrey, dipped 5 percent with approximately 19 million viewers.

As the first major award show following the Harvey Weinstein revelations and subsequent launch of the #MeToo movement, the usually more frivolous ceremony had an atypical edge of seriousness. In a demonstration organized by the then-just-founded Time's Up, many women wore black on the red carpet.

Whether this year will return the Globes to their more lighthearted celebrations will rest partly with its unexpected pairing of Andy Samberg and "Killing Eve" star Sandra Oh, who on Thursday was nominated for best actress in a TV series drama.

They were announced Wednesday as hosts to the Jan. 6 ceremony, to be broadcast live on NBC.
