Court blocks citizenship question on census

NEW YORK – A federal judge in New York has blocked the Trump Administration from adding a question about citizenship status to the 2020 Census, marking a victory for critics who have said the question is unnecessary and is intended to decrease the number of immigrants and minorities counted in the decennial survey.

The ruling is just the first in a series of cases on the issue, which has significant implications for future elections, political representation at every level and federal funding decisions for the

The Trump Administration is also facing five other lawsuits over the Census question, and the battle is expected to end up at the Supreme Court.

But U.S. District Judge Jesse Furman's decision on Tuesday was an important moment. The suit's plaintiffs — a collection of immigrant advocacy groups, states and local officials — argued that the Trump Administration tried to add the citizenship question to intentionally dissuade immigrants from responding to the survey.

The U.S. Census, which is conducted every 10 years, has not included a question about citizenship since 1950. More detailed sampling surveys have done so, but those go out to far fewer households.

Furman ruled that the way Commerce Secretary Wilbur Ross added the question was "arbitrary and capricious" and violated administrative procedures.

"He failed to consider several important aspects of the problem; alternately ignored, cherry-picked, or badly misconstrued the evidence in the record before him; acted irrationally both in light of that evidence and his own stated decisional criteria; and failed to justify significant departures from past policies and practices," Furman wrote in his 227-page decision.

The judge also ruled that Ross's explanation for the citizenship change — that the Justice Department said it was needed to help enforce the Voting Rights Act — was "pretextual."

Ross initially offered voting rights enforcement as his official explanation, but documents released as part of the ongoing lawsuits revealed that he began pushing the issue on his own soon after becoming Commerce Secretary.

The Justice Department said it was disappointed in the ruling, while advocacy groups like the ACLU cheered the decision.

"This ruling is a forceful rebuke of the Trump administration's attempt to weaponize the census for an attack on immigrant communities," Dale Ho, director of the ACLU's Voting Rights Project, said in a statement. "The evidence at trial, including from the government's own witness, exposed how adding a citizenship question would wreck the oncein-a-decade count of the nation's population. The inevitable result would have been — and the administration's clear intent was — to strip federal resources and political representation from those needing it most."

As this was the first ruling in the cases against the citizenship question, evidence that came out during the trial could encourage those pursuing similar lawsuits, said William H. Frey, a demographer and expert on the Census at the Brookings Institution.

"This is good news for people who want to have a Census that represents America," Frey told TIME. "You want to make sure that all groups are represented and it helps the proper apportionment of Congress, it helps federal spending that is allocated to different groups around the country.

Bill would take untrained teachers out of low-income schools

Teacher trainees do students a disservice at Title 1 campuses, says Assembly member Cristina Garcia.

NORWALK - Legislation that would prohibit untrained teacher trainees from teaching in low income schools was introduced by Assemblywoman Cristina Garcia (D-Bell Gardens) on Wednesday.

The bill, AB 221, seeks to prevent additional education

disparities that persist in Title (low income) funded schools and are often exacerbated by poor educator training and retention seen with trainee's placed through Teach for America (TFA), Garcia said.



1 funded school kids already face multiple disadvantages because of their ethnicity, zip code and sociocompounded when you have an inexperienced educator in the classroom," said Garcia, who taught math at the high school and college level prior to being elected to the Assembly.

"I've been that new teacher. I've seen how my own inabilities affected my students. And I saw how much my skillset and effectiveness changed once I had received the proper training and got a mentor.

"We must remove barriers to quality education for our most vulnerable students and not add problems that contribute to our achievement gap and create systemic inequities that follow kids their entire lives."

California's achievement gap, particularly with students of color, is well documented and historic particularly in math and science. Although the state has made attempts to closing the gap, policies and resources have struggled to close it significantly with vulnerable populations.

New standards and strategies, economic status, that are further such as requiring better educator training and preparation, have proven effective and practical at creating a foundation that creates an equitable education system for all of California's children.

According to Garcia, Teach for America trainees lack crucial training before entering a classroom, receiving only five weeks of training before entering the classroom and do not need to have a degree in education.

traditional teacher credentialing programs, hopeful educators take two years to complete their educational training and serve as a student teacher for another year before entering the classroom as its sole instructor as a credentialed teacher.

The left, the wall, and the truth

Democrats and others on the left offer three reasons for their opposition to building a wall on America's southern

- 1. A wall is ineffective.
- 2. A wall is too expensive.
- 3. A wall is immoral.

Each one is false, so false as to constitute lies. So, the only question is: Do Democrats and others on the left believe these lies?

This question has plagued me all my life. Leftism is built on lies — and has been since Lenin. That's why he named the Communist Party's lying newspaper "Pravda" ("truth").

Did my left-wing professors at Columbia University really believe the United States and the Soviet Union were equally responsible for the Cold War? Did they really believe one of the most genocidal regimes in history — which butchered tens of millions its own people, starved as many as 4 million Ukrainians, enslaved seven Eastern European countries under totalitarian rule and created the monstrous North Korean communist regime — was no more responsible for the Cold War than the United States, the freest country in human

Did my left-wing professors really believe men and women are the same except for body parts? And do today's leftists really believe human beings with double X chromosomes, a vagina, a uterus, ovaries, menstrual periods and lactating breasts are not necessarily female?

Do leftists really believe American universities constitute "rape cultures"? If so, why does any left-wing parent send his or her child to college? Would you send your daughter to a place you believe is permeated

Do leftists really believe that the statement "There is only one race: the human race" is a racist statement? That is the official position of the University of

Do leftists really believe that virtually every criticism of former President Barack Obama emanated from racism, that all opposition to lowering college admission standards for blacks is racist, that all attacks on George Soros are anti-Semitic?

If leftists believe any of the above, let alone all of it, they are deluded people. And the existence of tens of millions of deluded people in a society can only portend catastrophe. If leftists do not believe those claims, they are not deluded; they lie for effect and, therefore, engage in evil. The existence of tens of millions of people consciously committed to lying means society has little hope.

Now to the wall.

Do leftists believe the country cannot afford \$5.7 billion? As the Democrats have approved \$1.3 billion for border security, the difference is about one-tenth of 1 percent of U.S. federal spending (\$4.5 trillion). Democrats and the rest of the left make this argument. Yet they are the very people who, for more than half a century, have successfully pushed for unprecedented expansion of government spending; the very people who are overwhelmingly responsible for local, state and federal government debts of such magnitude that they cannot be paid without massive decreases in spending and the likely social disruption they entail. It is not possible these people believe America cannot afford to pay for a wall. They are, therefore, lying when they claim the price tag is too high.

California Democrats have allocated some \$77 billion to pay for a high-speed train between San Francisco and Los Angeles that will be ready in 2033 at the earliest. It will undoubtedly rise to more than a hundred billion dollars. And, thanks to the left and the Democrats, California is spending this money despite being an

estimated \$2 trillion in debt (between debt and pensions).

The left says a wall (or steel barrier) would be "ineffective" at preventing illegal immigration. We know it doesn't believe this, because just five years ago, Speaker Nancy Pelosi supported a bill that required the construction of 700 miles of border fencing. And Sen. Chuck Schumer was one among the "Gang of Eight" Republicans and Democrats who also supported 700 miles of fencing at the border. Every Senate Democrat voted for the Gang of Eight Bill, including 36 Democrats who serve in the Senate today.

Do Schumer and Pelosi and all these other Democrats regard fencing as effective but a wall as ineffective? Do Democrats deny that Israel's barrier has virtually ended Palestinian terrorism? Do they believe Turkey's just-built 500-mile wall across nearly its entire border with Syria will be ineffective? Do they know about the effective walls/barriers between the Turkish- and Greek-controlled areas in Cyprus; between Hungary and Serbia and Croatia; Morocco and Algeria; India and Pakistan; and elsewhere?

As for the Democrats and others on the left declaring a wall "immoral," it is difficult to know which is preferable: that they are living in delusion or lying. On what grounds is it "immoral"? They never say.

Is there a Democrat or leftist who regards walls or other physical barriers surrounding homes or communities as immoral? One doubts it. For one thing, many of them live behind a physical barrier. So, then, why isn't a physical barrier that protects America equally moral? The only possible answers are that these people don't really regard America as their home or they are lying about a wall being immoral.

So why all the lies?

Because lies are effective in achieving left-wing goals. There are people in every political, social and religious group who lie. And there are people within every one of those groups who are truth tellers. But — and this is a "but" whose significance cannot be overstated — while truth is a liberal value and truth is a conservative value, truth has never been a leftist value. For the left, there is always something more important. In this case, it is the humiliation of the president of the United States

A national emergency might backfire

If you can't stop someone from doing something you dislike, you can always hope he or she will eventually overdo it. Icarus fell out of the sky not because he flew but because he disregarded a warning not to get too close to the sun.

Donald Trump may not be familiar with the lesson of that story. He has raised the real possibility that, denied funds by Congress to build his border wall, he will declare a national emergency to do it anyway. On Thursday, he said, "If this doesn't work out, probably I will do it. I would almost say definitely.

It would represent new heights of chutzpah, even for the modern presidency and even for Trump. And it might be enough to cause some Republicans on Capitol Hill to rise up in rebellion — lest this tactic become a weapon for a Democratic president pursuing liberal ends without the consent of Congress.

It would probably not be illegal, though, thanks to a 1976 statute called the National Emergencies Act. "If President Trump wishes to state that the border is in a state of disarray or exposure such that it constitutes a national emergency under the NEA, he is pretty much free to do so," writes University of Texas law professor Robert Chesney on the website Lawfare.

The "national emergency" option sounds like something to be deployed only rarely and in exceptionally dire circumstances — such as 9/11 or a huge natural disaster. In fact, it's gotten to be as unusual as corn dogs at a county fair.

In the NEA, Congress gave the president considerable authority but placed firm restrictions on it, with the intention of keeping its use to a minimum. Things didn't work out as planned. The Brennan Center for Justice reports that 58 separate emergencies have been declared, and 30 remain in effect — several of which date back to the 20th century. Congress is supposed to regularly review each use of the law, but it never has.

That's not all. There are 123 laws granting the president emergency powers. What was supposed to be a last resort in urgent crises is now rolled out whenever it suits the convenience of the White House, and what was supposed to be temporary is often permanent.

The danger to Trump is not so much that he would be blocked by the courts on the ground that using this power to build a wall would be exceeding his legal authority. It's that his declaration might

finally induce Congress to break its habit of tamely submitting to the whims of whoever occupies the Oval Office.

Congress was not supposed to be a junior partner in governing. James Madison, the chief architect of the Constitution, wrote, "In republican government, the legislative authority necessarily predominates." Under our system, "the executive magistracy is carefully limited, both in the extent and the duration of its power."

That's why the power of the purse was placed with Congress. Presidents are not supposed to be able to spend a nickel without legislative action. Madison feared that if anything, Congress would grow too powerful.

He shouldn't have worried. Lawmakers have found that with power comes responsibility, so they've chosen, repeatedly, to surrender both to the executive branch.

Partisan solidarity is one big reason. The Framers expected each branch to jealously guard its prerogatives and repel any encroachment by the others. In our time, though, members of Congress are usually more devoted to advancing the interests of their parties than of their institution.

Only when the opposition party controls one or both houses can the president expect to be rebuffed on important issues as in the case of Trump's wall, which the Democratic House refuses to approve. Even Republicans who sometimes deplore his methods and disagree with his policies seldom vote against him.

But if Trump undertakes to spend \$5.7 billion that lawmakers have denied him, some GOP members could rebel. If a Republican president can use this trick to build a border wall, a Democratic successor might use it for some nefarious left-wing purposes. Rep. Matt Gaetz, R-Fla., said, "I don't want the next national emergency to be that some Democrat president says we have to build transgender bathrooms in every elementary school in America." And if Trump were to use it for this project, he would soon think of others.

Congress has frequently abdicated authority to presidents on the hope that it would be handled wisely. Thanks to Trump, members may finally realize that the only sure method to prevent emergency powers from being abused is to take them away.

The illogic of 'assault weapon' bans

Since 1996, Gallup has been asking Americans whether they support a ban on "assault weapons." Gallup has never explained what "assault weapons" are, and there's a good reason for that: The category is defined by politicians, so its meaning is arbitrary, mutable and

Last week, Sen. Dianne Feinstein, D-Calif., who wrote the federal "assault weapon" ban that was enacted in 1994 and expired in 2004, introduced her latest attempt to reinstate and expand it. Her bill bans "205 military-style assault weapons" by name, along with any rifle that "accepts a detachable ammunition magazine and has one or more military characteristics," such as "a pistol grip, a forward grip, a barrel shroud, a threaded barrel or a folding or telescoping stock."

The 1994 definition required two "military characteristics" instead of just one, and the list was different. Back then, Feinstein said nothing about barrel shrouds, but she was worried about bayonet mounts, which she is now willing

Now, as then, however, features that do not make a gun any more deadly in the hands of a mass shooter or an ordinary criminal, such as a folding stock or a threaded barrel, nevertheless transform it into an intolerable "assault weapon." Compounding the craziness, Feinstein's new bill also targets products that reverse this magic by removing the features that offend her.

The California company Thordsen Customs, for example, sells a kit that replaces an adjustable stock and pistol grip on a rifle that would otherwise qualify as a prohibited "assault weapon" in some states. Feinstein claims "Thordsen-type grips and stocks" are "designed to evade a ban on assault weapons," which is a bizarre way of looking at it.

"We are complying with the ban," says Alan Thordsen, the founder and CEO of Thordsen Customs. "If there's a feature that is banned, we change the feature. That's not evading. That's not skirting the law or violating the spirit of the law. We are conforming with the law and creating products that enable law-abiding people to keep their legal firearms in a

legal configuration so that they are not criminals.

By Feinstein's logic, smooth rifle barrels should be banned because they can replace threaded barrels, changing a prohibited "assault weapon" into a legal gun. The problem here is not sneaky entrepreneurs like Thordsen, but irrational legislators like Feinstein. Thordsen's real offense, one suspects, is highlighting the silliness of legislation like Feinstein's.

An "assault weapon" ban that just took effect in Boulder, Colorado, cuts Feinstein's list of "military characteristics" in half, focusing on pistol grips, adjustable stocks and "any protruding grip or other device" that 'allow(s) the weapon to be stabilized with the non-trigger hand." Unlike Feinstein, it seems, Boulder's gun controllers are not afraid of barrels with shrouds or


A ballot initiative that took effect this month in Washington goes in a different direction. While the state's ban applies only to adults younger than 21, it defines "semiautomatic assault rifles" so broadly that the category includes all semiautomatic rifles.

The seven states with general bans on "assault weapons" define them more narrowly than Washington, but the criteria vary. New York, like Feinstein circa 1994, cannot abide bayonet mounts, for example, but California, which enacted the nation's first "assault weapon" ban in 1989, is OK with them.

Once you realize that "assault weapons" are in the eye of the beholder, it's hard to take seriously the extravagant promises of legislators who want to ban them. Feinstein claims her bill would "put a stop to mass shootings." Yet, even if it eliminated the millions of "assault weapons" that Americans already own (something it does not even purport to do), would-be mass shooters would still have plenty of equally lethal alternatives.

After three decades of this nonsense, Americans may be starting to wise up. According to Gallup, support for legislation like Feinstein's fell from a peak of 59 percent in 2000 to 40 percent last year.

The Norwalk City Council, at a meeting held January 15, 2019, adopted proposed Ordinance No. 18-1706, AN ORDINANCE OF THE CITY OF NORWALK ADDING A NEW CHAPTER TO THE NORWALK MUNICIPAL CODE TO CREATE A NEW SIDEWALK VENDING PROGRAM AND DELETING THE EVISTING PAN AND DELETING THE EXISTING BAN ON THE USE OF PUSHCARTS OR OTHER NONMOTORIZED VEHICLES IN CONNECTION WITH THE SALE OF FOOD OR MERCHANDISE, which will establish a program to permit and regulate sidewalk vendors in compliance with SB 946. The proposed ordinance also repeals Section 10.08.130 of the Norwalk Municipal Code which currently prohibits the use of pushcarts, handcarts, or other nonmotorized vehicles for the sale or distribution of food

and merchandise, in conflict with SB 946.

Classrooms shouldn't be used as training grounds, lawmaker says

retention problems for the most vulnerable schools and their

California has also struggled with a teacher shortage for decades. The answer to addressing that shortage and closing the gap in low-income schools is not placing untrained educators in them. The solution must be increased support for our teacher workforce, adequate compensation and to populate our low-income schools with trained teachers.

"We can't use our kids' classrooms as training grounds when we know it has long-lasting and detrimental effects on a child's future," added Garcia. "Experience is necessary. Proper training is necessary. That's why California mandated a year of student teaching prior to credentialing our public school teachers. This is not a profession where one can just learn on the job without significant repercussions.

"And we certainly shouldn't be allowing it with our most vulnerable students who are already dealing with systemic room. challenges entirely outside their

The purpose of Title I designation is to address systemic educational challenges facing high-poverty communities by providing more resources to school districts and schools with the highest concentrations of poverty.

"The state's goals for high quality education will be undermined if it continues to supplement an inadequate teacher with underprepared teachers who leave the profession at very high rates," said Garcia.

Downey teachers clash with school board over possible magnet school

Facing declining enrollment, DUSD considers closing making Sussman Middle School a magnet secondary school and Carpenter Elementary a dual immersion campus.

Teachers and parents are protesting the idea.

DOWNEY - The strike may be in Los Angeles, but that didn't mean that Downey Unified School District was free from its own turmoil this week.

The usually quiet and calm Grace E. Horney Board Room resembled more of a gladiator's arena on Tuesday as a platoon of concerned teachers and parents packed into the School Board's regularly scheduled meeting.

Despite the crowd, the School Board attempted to operate as usual. However, the agenda's final two items - the potential reprogramming of Carpenter Elementary to a Dual Immersion / International Baccalaureate (IB) school and the possible change of Sussman Middle School to an IB / Early College magnet secondary school for grades six through 12 - sat like a giant elephant in the

Almost as if she anticipated a long and hard evening, Board Nancy Swenson President addressed the crowd before the board received presentations on transition, the school would close the controversial agenda items.

"I want to take a moment for any of the Downey Unified family members that felt disrespected with the process we have been using to roll out the information regarding the potential changes," said Swenson. "Everything being considered has been heard during our monthly meetings, and tonight the process continues... even though more ideas and possibilities will be discussed

effect until it is approved by a vote of the Board at a later date."

potential changes come at a time when DUSD is battling a statewide trend of declining enrollment. According to information presented at Tuesday's meeting, enrollment in DUSD has dropped from around 23,000 students in the 12/13 school year to about 22,000 in the 18/19 school year.

"Enrollment is a long-term challenge; it's not going to be something that all of a sudden goes away," said Superintendent Dr. John Garcia.

Because of this trend, DUSD has scrambled to come up with ways to retain and attract students to the district, including the two controversial proposals.

More than the fate of Carpenter, most in attendance seemed disenfranchised with the idea of the seemingly impending closure of Sussman. Should the Board decided to move forward with the conversion of the middle school, they would have to decide whether to make the transition at a gradual or accelerated rate.

At a gradual rate, Sussman would remain open during construction between the 19/20 school year to the 21/22 school year, while simultaneously moving the current crop of students through their normal projection and phasing into the new grade format.

> Many of those in attendance have concerns over the transition of students, staff and teachers to the three remaining middle schools during and after the transition. There are also fears that jobs may be lost in the process.

Out of the audience, four speakers came forward to address the Board.

One of those speakers, Andra Macomber, read a letter that had been submitted to the district by a representative of many of the teachers and staff in attendance and district wide.

Macomber has not only taught in DUSD for 25 years, but is also a product of the district and has a child currently attending school

The letter read by Macomber said in part,

"Our concerns are based upon the districts lack of transparency pertaining to key issues that while not violating any apparent contractual agreements, will affect our employment and morale in the immediate and sustainable future.

For several years we have been asked for input regarding how district funding should be funneled through LCFF. At the same time, we have been told the district budget needs to be cut exponentially. At this point in time, we feel that our input is no longer being considered or asked for. Decisions are hastily being made at the top without stakeholder consideration.

We believe our students deserve the best, and that is what guides our day to day decisions. accelerated approach, the district The district claims this belief too,

Staff morale is at an all-time low, and we are attempting to repair and improve the strains in this relationship for the sake of our students...

Most concerningly, district's press release stated that it had been talking with teachers since the beginning of the school year. Teachers were not informed of the new dual immersion program until after Thanksgiving, but the public was misleadingly told otherwise.

Closing a middle school to reopen a 6 - twelve grade IB school without deepened stakeholder input is not a move we currently support as we are uncertain it has our students' best interest in other stuff. A lot of times it's just mind. For the unforeseen future, the remaining three middle schools will be over-crowded... additional students will heighten overcrowding and impact class size, and again stakeholders were not adequately involved in the decision-making process...'

As Macomber read the letter, many in the room stood in solidarity.

In a statement released on Wednesday, DUSD explained that while the Board listened to each speaker, they did not offer any immediate responses due to board policy. DUSD says instead that the

comments made were noted and recorded by staff to incorporate into the stakeholder feedback for discussions at future meetings.

Visibly frustrated through most of the proceedings was Board Member Mark D. Morris, who feels as though the District is having to repeat itself.

"A lot of times they're not listening," said Morris. "We've said from the outset we will not be cutting positions; there will be no terminations. And what comes in? That's the first thing they say, 'You're going to be losing positions. Our teachers will follow the students."

Yeah I'm a little frustrated on that. I'm frustrated on some of the like a teacher in a classroom. He goes over stuff and what happens the next time? They ask questions about what has been covered. I have a little bit of problem with that.... You can't have too many meetings discussing this, but we've said in each and every meeting we will not be cutting employees, and that gets lost in the conversation."

The Board will next meet at a special meeting on Jan. 29, with a regularly scheduled meeting on Feb. 19.
