Prominent attorney killed in plane crash

Felipe Plascencia was a wellknown DUI attorney in Whittier and Downey. He and two others died in a plane crash.

Prominent WHITTIER -Felipe Plascencia perished in an airplane crash in the Tehachapi Mountains last week at the age of 53.

The La Habra Heights resident was returning from a court appearance in San Luis Obispo when the twin engine Beechcraft he was in went down. In addition to Plascencia, and the pilot, the crash killed attorney Marina Villavicencio aged 38.

Plascencia was a well respected trial attorney and political activist. Plascencia was nationally regarded as as an expert in driving under the influence cases and he was frequently asked to lecture on the subject to both the legal community and members of law enforcement.

Plascencia was born in Tepatitlan, Jalisco, Mexico in 1965. He immigrated to Santa Ana, California at the age of seven with his parents Rafael Plascencia, Maria Guadalupe Plascencia and three brothers and a sister. Plascencia attended Los Amigos High School in Fountain Valley and while at Los Amigos he distinguished himself academically.

Plascencia matriculated to California State University Fullerton where he obtained a Bachelor's degree in Psychology. While at CSUF, Plascencia actively participated in student organizations to advocate on behalf of Latino and other minority students. It was in college that Plascencia met and married his sweetheart, Yolanda Brito Plascencia who attended Santa

In 1990 Loyola Law School admitted Plascencia and he continued to be active in politics focusing on issues that impacted the working poor and underserved immigrant communities. Upon graduation from Loyola Law School in 1993, Plascencia remained a loyal alumnus and regularly donated his time and money to the institution.

Prior to opening his own practice, Plascencia served as a Los Angeles County Deputy Public Defender, and a Deputy City Attorney for the City of Compton. A graduate of the Gerry Spence Trial Lawyer's College, Plascencia regularly lectured on trial techniques and often mentored law students and new lawyers

In 2009 he was recognized as the Attorney of the Year by the Mexican American Bar Association, and he was introduced by then Los Angeles County District Attorney Steve Cooley.

Plascencia remained active in California politics and was President of the Mexican American Bar Association Political Action Committee from 2005 to present. During his presidency Plascencia raised the visibility of MABAPAC in Los Angeles county and Sacramento.

Plascencia, Democrat, encouraged MABAPAC to endorse the candidates they felt would best serve the community regardless of political affiliation.

Plascencia is survived by his wife Yolanda, and his daughters Magali and Alena. Additionally he is survived by his father Rafael and his siblings Ramon, Rosa, Moises, Rafael, Joseph, and Erika.



Man gets 4 years in prison after toddler shoots mom

NORWALK - A Norwalk man pleaded no contest Wednesday after a 4-year-old boy grabbed the man's shotgun and then shot the child's mother.

Brandon Gilbert Ambriz, 24, pleaded to one count of possession of a firearm by a felon. He was immediately sentenced to five years in prison.

Ambriz left the shotgun in a Honda in which children were regularly driven, prosecutors said. On Jan. 23, the 4-year-old shot his mother while she was in the driver's seat and the boy was in the

Three other children in the vehicle were not injured.

The shooting occurred outside Ramona Preschool in Norwalk.

The mother was shot in the upper torso but survived. The children were placed in the custody of Los Angeles County Department of Children and Family Services.

Sanchez's bill would strengthen benefits for widows and widowers

Norwalk's congressional representative is pushing a bill that would increase financial benefits after the death of a

NORWALK -Representative Linda Sánchez (CA-38) on Tuesday introduced Protecting Our Widows and Widowers in Retirement (POWR) Act, which she says would strengthen Social Security benefits for widows and widowers.

"The death of a spouse is devastating, and the financial distress of also losing their income only adds to the pain," said Sánchez. "The POWR Act ensures that in their darkest hours, those on Social Security will still be able to have some financial security and peace of

"Instead of losing half of their monthly household income, seniors will be able to keep a little more of their combined benefits. After a lifetime of hard work, seniors deserve to retire with dignity in their later years. And losing your spouse should not also lead to financial ruin."

According to the National Academy of Social Insurance, women suffer a greater financial hit following the loss of a loved one. The NASI has said, "The benefits are important to women because wives tend to earn less than their husbands and they typically outlive their husbands

both because women live longer than men, on average, and because wives tend to be a few years younger than their husbands."

The average widow sees a 33 to 50 percent reduction in Social Security benefits after the death of her spouse. However, on average, an

elderly person needs 79 percent of the income received while both were alive to maintain their standard of living. The POWR Act would create

an alternative benefit equal to 75 percent of the combined income received while both spouses were

"Among Social Security's most important protections are the monthly survivor annuities, currently paid to over four million widows and widowers,'

said Nancy Altman, founding co-director of Social Security Works. "But these benefits are very modest and often represent a drastic drop in family income. Women and men who have just lost their spouses should not also face a substantial loss of income that puts them at risk of poverty.

"The POWR act takes the important step of increasing benefits so that survivors' widows and widowers can live with dignity."

"Justice in Aging supports the Protecting Our Widows and Widowers in Retirement (POWR) Act," added Tracey Gronniger, directing attorney with Justice in Aging, a national organization that fights senior poverty.

"Losing a spouse is difficult. We should not make it more difficult by forcing men and women to take a significant cut in their income when their spouse passes away. The POWR Act keeps needed Social Security income in the hands of widows and widowers who depend on those benefits to maintain their economic security as they age."





Congress and the White House are heading for a collision course. Who will win?

With the 116th Congress up and running, President Trump is facing meaningful congressional oversight for the first time. On Monday, the House Judiciary Committee embarked on a major investigative mission, sending letters to 81 witnesses seeking documents and testimony relating to possible "obstruction of justice, public corruption and other abuses of power" by Mr. Trump and his administration.

But the White House shows no signs of rolling over. It has indicated for months that it is prepared to assert the president's executive privilege to keep congressional investigators from gathering information about Mr. Trump — including his conversations with high-level advisors

Will the White House be able to use executive privilege to successfully block investigators from getting information? When executive privilege and congressional oversight collide, who wins?

This is a complex question that federal courts, and perhaps ultimately the Supreme Court, may have to answer. If congressional investigators want to prevail, it is crucial that they keep in mind the likelihood of those court battles — and that they understand the terms on which those battles will be fought — as they proceed with their investigations.

The Constitution mentions neither congressional oversight nor executive privilege. But it is now well settled that both exist. In 1927, the Supreme Court held that each house of Congress had the power "to compel a private individual to appear before it or one of its committees and give testimony needed to enable it efficiently to exercise a legislative function belonging to it under the Constitution."

And in 1974, in United States v. Nixon, the Supreme Court confirmed the existence of a constitutionally grounded executive privilege that shields, among other things, certain communications with the president. In that case, however, the court also ruled that the privilege was not absolute and did not shield Richard Nixon's White House tape recordings from being released to the special prosecutor in the Watergate investigation.

Does this mean that Mr. Trump's communications are fair game? It is hard to say. The case of the Nixon tapes involved a judicial subpoena issued in connection with a criminal trial, not a congressional investigation. Some have argued — as Attorney General Bill Barr did, during his previous stint as attorney general, in the George H.W. Bush administration — that executive privilege is at least as strong if not stronger against congressional demands for information.

One reason there is so little clarity on this question is that the courts have not had a chance to tell us. To a remarkable extent, the courts have been silent bystanders during the frequent disputes between Congress and the executive over access to information. That is because negotiation and accommodation have long led to the resolution of these disputes outside of the courts. A give-and-take between the two political branches of government usually results in congressional requests being narrowed but ultimately complied with. Each side scores some wins and suffers some losses, and a meaningful if limited investigation occurs.

Under ordinary circumstances, the process of accommodation would start now. But this process is grounded in informal norms, such as the expectation that the political branches will proceed in good faith and with mutual acceptance of their respective roles in our

constitutional system.

The Trump White House, unfortunately, has shown little interest in respecting such norms. The prospect of a negotiated resolution thus seems unlikely. House committees, if faced with refusals from President Trump's advisers to testify or turn over documents, are likely to issue subpoenas and seek to enforce them in court through contempt proceedings.

If that happens, the courts will have to reconcile Congress's need for information with the president's need for confidentiality in his communications with advisers and when it comes to information that might implicate national security or international relations. There is no simple formula for that. In the context of the Trump investigation, then, it will matter a great deal how congressional investigators frame and perform their oversight function. Excessively broad requests might erode congressional credibility, as might requests that duplicate or overlap those of other committees, or that seek information already public or in the hands of other congressional investigators.

As this phase of congressional scrutiny begins in earnest, investigators should not only pursue their inquiries with vigilance but also keep an eye trained on the prospect of a judicial resolution of their clashes with the executive branch. Otherwise they risk losing more than particular battles with the executive branch; they jeopardize the long-term prospects of holding the president accountable.

My brother saved my life

It was my brother who saved my life.

"Get to a hospital now," he insisted over the long-distance line. "You're having a stroke."

I had just flown to Hong Kong to run an important conference and I was tempted to dismiss this big-brother, over-the-phone diagnosis (even though my brother, Jeff, is, in fact, a doctor).

I was only 49 years old, I was healthy and had none of the conditions like high blood pressure that might predict a stroke.

I imagine this is what the actor Luke Perry thought when the paramedics first reached him. A stroke? No way. Only old people get those. Mr. Perry, famous for his role in "Beverly Hills, 90210," was just 52 when he died in the aftermath of that stroke on Monday.

I'd assumed that what was happening to me was just another of my many migraines, made only slightly weirder by a slight tingle on the side of my mouth and hand, as well as very temporary dysphasia, which made my words garbled.

That morning I'd been working on a story about yet another management crisis at Yahoo. "What a goat rodeo," I had said out loud, which came out "Grrxxxx gghrtt jjjtrws." Then, when I went to eat a strawberry, it slowly dropped from the side of my useless mouth, leaving a stain first on my shirt and then on the carpet of the luxury hotel room I had just checked into.

I stared at the stain — which was a bright and beautiful red — and instead of being concerned about my numb lip, I ran to get a towel to clean up the mess. Then, as I had often done when I had a sore throat or some other minor ailment, I texted Jeff the symptoms.

By the time I'd showered and headed to the restaurant for breakfast, the symptoms were largely gone. So when Jeff called to say I was having a stroke, I think I laughed and said, "You're a bad doctor."

Besides, I had Yahoo's Jerry Yang coming to the conference, I had Alibaba's Jack Ma coming, I had Al Gore coming. I had no time.

That much was very true. Because he was actually a very good doctor, he insisted in an increasingly urgent tone that I go to the hospital right then. That's because when it comes to strokes, time is

critical. You have to get the blood flowing back to the part of the brain that is not getting it.

So I listened, for once, sidelining the obstreperous little sister, and took a car to get an emergency M.R.I.

There it was on the screen: evidence of a transient ischemic attack, often called a mini-stroke. Like the strawberry stain, it was also riveting to look at with its garish neon glow, from the angry yellow clot to the stream of red blood worming its way around it to the multicolored brain of mine full of so many ideas but also just a hunk of misfiring flesh.

As it turned out, there was a lot of that, including a small hole in my heart through which the clot traveled, as well as me having a type of blood that is more prone to clotting. All of it, combined with not hydrating or walking around enough on the long flight to Hong Kong, created what the doctor, who immediately started the treatment of anticoagulant drugs and others, called a "hole in one."

That was a good joke at a bad time. It's funny the things you remember at the critical times of your life. Like the extraordinarily bright whiteness of the surgical mask of that doctor, who also told me that had I not moved faster it would have been so much worse.

"You might have lost your abilities," he said from somewhere from behind the mask. "You might have died."

It was only then that I cried, and only because of my sons, then 6 and 9. My own father had died suddenly when I was 5. He, too, had a brain issue, but it was a more lethal one — an aneurysm that burst without warning on a sunny winter morning over 50 years ago. While he lingered for a short time, he was no longer himself. That was that and that was the rest of our lives.

And that is why the idea of death — the absolute nearness of it — has been ever-present for me. Since my dad died, I have lived my life as if I had no time at all or very little, making the kinds of choices of someone who knew that tomorrow might indeed be her last.

That was the thrust of a major speech at Stanford University in 2005 by the Apple founder and tech visionary Steve Jobs:

For the past 33 years, I have looked in the mirror every morning and

asked myself: "If today were the last day of my life, would I want to do what I am about to do today?" And whenever the answer has been no for too many days in a row, I know I need to change something.

Remembering that I'll be dead soon is the most important tool I've ever encountered to help me make the big choices in life. Because almost everything — all external expectations, all pride, all fear of embarrassment or failure — these things just fall away in the face of death, leaving only what is truly important. Remembering that you are going to die is the best way I know to avoid the trap of thinking you have something to lose. You are already naked. There is no reason not to follow your heart.

It was an unusually emotional speech from someone who was widely thought to have no heart. But, actually, I have always thought that the problem with Mr. Jobs was that he had too much heart, because he seemed to always grok that the end was always nigh. Sometimes that urgency manifested itself in inspiration, sometimes in meanness, sometimes in humor, sometimes in seriousness. But it was always urgent.

When he died on Oct. 5, 2011, I read and reread that speech to keep it in my own heart, too. That was a good thing, because my own stroke came only a few days later. I had both the privilege to live more days and the awareness that those days would be limited.

If you want to analyze my motivations for being known as pretty tough on the people I cover when they inevitably mess up, it has its roots there. Basically, you all don't have the time to be so careless in what you do and I don't have the time to not ask you about it.

You get this kind of nudge again and again from death. It is, as the Buddhist teacher Frank Ostaseski noted, "a secret teacher hiding in plain sight."

Luke Perry's death was yet another lesson from that teacher. Like many, I was a major fan of "90210" in its glory days and gave over so much of my precious time — every second worth it — to watching and then discussing the foibles of the kids of West Beverly Hills High. That definitely included the fantastic brooding of Mr. Perry's Dylan McKay, who was given to saying things like, "The only person you can trust in this world is yourself."

Well, I guess, but not if you are lucky enough to have a brother who saved your life.

How colleges and universities hoax our students

If you are an American college professor, the way you get a raise or tenure is by getting papers published in "academic journals."

The stupidity of these journals says a lot about what's taught at colleges today.

Recently, three people sent in intentionally ridiculous "research" to prominent journals of women studies, gender studies, race studies, sexuality studies, obesity studies and queer studies.

"The scholarship in these disciplines is utterly corrupted," says Dr. Peter Boghossian of Portland State University. "They have placed an agenda before the truth."

To show that, hoaxer and mathematician James Lindsay says, "We rewrote a section of 'Mein Kampf' as intersectional feminism" and got it published in Affilia: Journal of Women and Social Work.

For another paper, they claimed to have "closely" examined genitals of 10,000 dogs in dog parks to learn about "rape culture and

queer performativity."

Boghossian had assumed, "There's no way they're gonna believe that we did this!"

But the journal Gender, Place & Culture did, calling the paper "excellent scholarship."

Seven journals accepted the absurd papers, as I show in my latest video.

Hoaxers Boghossian, Lindsay and Areo Magazine editor Helen Pluckrose explain the reason for their trick.

"We think studying topics like gender, race and sexuality is worthwhile and getting it right is extremely important," says Lindsay

But researchers of these topics have gotten lazy and political, they say. "A culture has developed in which only certain conclusions are allowed — like those that make whiteness and masculinity problematic," Lindsay says.

Reach politically "correct" conclusions and you can get most anything published.

"Kind of a last straw happened," says Lindsay. "There was this paper well-funded by the National Science Foundation that studied 'feminist glaciology.' It said glacier science is sexist."

As a glaciologist giving a TED Talk put it, "the majority of glaciological knowledge that we have today stems from knowledge created by men about men within existing masculinist stories."

What upsets me most is what happened — or rather, didn't happen

No university said it would stop using those journals, and no journal editor publicly said, "We must raise our standards."

"Think about if you did this to civil engineers with bridge building," says Boghossian. "They would've thanked us, right? Because they're driving over the bridges with their families, so they don't want the bridges to collapse."

But the journal editors, instead of admitting that they sometimes publish nonsense, attacked the hoaxers. They accused them of doing "unethical research."

A dozen of Boghossian's colleagues at Portland State University criticized him anonymously in the school newspaper, which depicted him as a clown. He's become a pariah at his own school.

"I've been spat on ... physically threatened," he says.

Instead of applauding him for exposing nonsense, Portland State hreatened him.

I called the school asking for an interview, but it declined.

How can a college criticize the hoaxers but revere ridiculous journals that publish nonsense?

"When you live in these tight ecosystems, this stuff makes total sense," says Boghossian. For people in the tiny bubble of academic thinking, "there's a pervading rape culture; men are bad — the whole

ball of wax."

It's been going on for some time. A physicist once submitted a nonsense paper claiming gravity is just a "social construct." The

journal Social Text published it. That embarrassed the journal, but 20 years later, it is still going strong.

At universities, "scholarship" has gotten even crazier. The real "hoax" is on students who pay thousands of dollars for

useless degrees in fields that end in "studies."



The year was 1954. It was in

Detroit, Michigan. I remember this home with love. It was a large home directly across from the elementary school. In the basement there was a wringer washing machine. We spent many hours playing bank and passing our play money through the wringer, passing it from one person to another. There was also a laundry shoot where the dirty clothing would be dropped from upstairs, down the shoot and into a large laundry basket.

Under the staircase, my younger sister and I would drape a blanket to cover the entrance and pretend that it was our house. We would sneak upstairs and take one of the kitchen drawers and slide it perfectly into place under the bottom stair. This would be our food locker. We'd fill it with slices of bread or cookies or what ever else we could pilfer without being noticed. Oh, that basement filled our imagination.

Our kitchen was a large room that taught is about working together. My brother and two sisters and I formed an assembly line each night and did the dinner dishes. Don would wash, Sharon would dry, she'd hand the dish off to Jan, and she'd hand it to me and I'd put it on the counter. Mom would then put it up where it belonged. I have fond memories of that time we spent together learning to work as a team.

In that same kitchen I remember bobbing for apples in a big galvanized tub. I mostly remember all the laughter in that room.

Our dining room was a large room with shiny wooden floors. There were two built-in cabinets with glass doors on them, one on each side of the room. Mom kept all of her very special dishes and crystal on display. We loved to look at all the

pretty things behind glass and were taught that we were never allowed to open the doors.

There was a large wooden buffet along one wall that stored all the fancy dishes we used for holidays and special parties. A lovely white doily ran the length of the buffet. On top stood a big opened bible on a stand, surrounded by two large bunches of purple flowers from our yard. The whole middle of the room was filled with a huge table surrounded by twelve chairs. I can still see the giant turkey that sat in the middle, all golden

Grandma would come from the nursing home that she lived in and sit with us for all our holiday meals. I remember dad leading our prayers and giving thanks around that table.

Our living room had a big stone fireplace. We all loved to sit around and watch the fire burn as dad told stories. Mom would bath us after dinner and send us one by one out to dad on the sofa. We'd listen to the story as we waited for the next sibling to arrive in their pajamas.

Mom would take all the laces out of our shoes, scrub them and line them up on the window sill to dry for the next day. After that mom met us in the living room and combed our hair and tied it in rags or pin curls so we would all be nice and curly by morning. By the time she was done with all of that, the stories were about finished and it was time for bed.

This house has so many good memories. If the house itself could talk it would say that love lived here.

Robert Cormack, former two-time Downey mayor, dies at 99

Friends and family remember Robert Cormack as a straightshooter, gentleman, and proud American.

DOWNEY – Former Downey mayor Robert Cormack has died.

Cormack passed away on Feb 21.

Longtime residents of Downey may remember Cormack from when he served as mayor during two separate terms, from July 1983 to July 1984, and July 1988 to June 1989. He was also a past Downey school board member and involved with the Downey Historical Society.

Former mayor David Gafin described Cormack as "a wonderful guy."

"I didn't work with him a lot because he served a few years before me," said Gafin. "He was the old school type of councilman: stalwart, a gentleman, and an upright, honest person. He always carried himself very well. The city will sorely miss him."

Cormack carried a strong pride of Downey throughout his life, according to his daughter, Sharon Leon.

"Downey was the town he loved," she said. "He was very involved with the city, making sure the residents were taken care of right, and that they were going to keep the historical part of the

Cormack was also patriotic, having volunteered for the army in WW II. He served as a welder, and spent some time in Germany.

Leon says that he was an "All-American man."

"He loved the red, white and blue hats. He had a flag everyday flying, and it was put away by dark; if it was raining it wasn't out there," said Leon. "Every day till the end, he would put up an American flag."

Cormack was also a faithful Christian.

"He always had a bible in his car, next to his chair," said Leon. "He read the Bible; that was his favorite book."

She also describes Cormack as "the most positive man you will

"Being a religious person, I just think he knew what life was about," said Leon. "He tried so desperately to keep people focused on good things in life... we were very blessed to have him as a part of our family. We were blessed beyond anything I could

Cormack married his first wife Louise at the age of 18, and remained married for 56 years until her passing. They had three sons - Robert, Harold, and Steven - who have all preceded him in

Cormack met his second wife, Faith, at the First Baptist Church of Downey, and married her after a very quick courtship. They were married 26 years.

However, upon entering this already established family, he didn't leave the warmest of impressions.

"When he became part of our family...he was kind of a stuffy man." said Leon.

It was his newfound grandchildren that softened him

"To watch him grow into a role of a grandfather was unbelievable," said Leon. "I watched him turn from this very stout man into this gentle, loving soul; and what a role model he was to our kids."

Cormack's grandson, Darren Avery, says that "Everything he did was based around my sister and I at the time."

"He took to my sister and I right away, because from what I have been told he always wanted grandchildren," said Avery.
"Unfortunately, none of his boys had children."

"As a person, I never saw him get mad at anybody," added Avery. "He was always such a happy person...He was one of the kindest people that I had ever met."

Cormack and his wife had recently completed making the move to Northern California. However, it wasn't long after they made their final trip that Cormack became sick.

"He was very excited about that...having a relaxing life, not the hustle and bustle of the city. You know, a country life," said Leon. "We've been moving them over the last four or five months. I picked them up on a Sunday, and by Wednesday he was in the hospital."

Leon says that her father remained strong in his final days.

"This man fought and fought to stay around," said Leon. "He stayed to take care of my mom, to make sure that my mom got here and that she was going to be okay."

Cormack died at home, surrounded by family.

Through his memory, Leon hopes that people will take away a lesson of love.

"The love of his family and the love of his lord gave him a wonderful 99 years of life," said Leon. "We all should love each other the way he taught us. "There's no greater person than that man, and we're the lucky ones."

Boxing champion Eusebio Pedroza dies of cancer

Eusebio Pedroza, one of the greatest featherweight champions in boxing history, died from pancreatic cancer at home in Panama City, Panama, it was announced on Friday. He was 62.

Pedroza, who boxed professionally from 1973 to 1992 and was elected to the International Boxing Hall of Fame in 1999, had a remarkable run as world champion.

Pedroza (41-6-1, 25 KOs) held the WBA featherweight world title from 1978 to 1985 and made a 126-pound division record 19 title defenses.

Pedroza, who was 5-foot-9, which is quite tall for a featherweight, turned pro in Panama and boxed there exclusively until 1976. That is when he got a shot at thenbantamweight world champion Alfonso Zamora in Mexico and, in his 16th fight, lost by secondround knockout.

Pedroza also lost his next fight by knockout in Venezuela later in 1976, but he would not lose again until he traveled to London and lost his world title by unanimous 15-round decision to fellow future Hall of Famer Barry McGuigan.

Pedroza first won a world title by knocking out Cecilio Lastra in the 13th round on April 15, 1978, in Panama City.

From there, Pedroza, who was known for superb stamina and for taking over fights in the late rounds, embarked on a historic title reign with many of his fights shown on American television during the heyday of

weekend afternoon fights. Among his 19 successful defenses he defeated Hall of Famer Ruben Olivares by 12th-round knockout, Royal Kobayashi by 13th-round knockout and won 15-round decisions over Jorge Lujan, Rocky Lockridge (twice) and Juan Laporte.

After Pedroza, known as "The Scorpion," lost the title to McGuigan in a fight for which Pedroza earned \$1 million -- then a record purse for a featherweight -- he fought five more times,

going 3-2 and losing a 10-round split decision to Mauro Gutierrez in Detroit in his final bout on Nov. 21, 1992.

"Eusebio Pedroza authored one of the most impressive title reigns in boxing history and brought tremendous pride to his home country of Panama," International Boxing Hall of Fame executive director Edward Brophy said. "The Hall of Fame offers our condolences to his family and joins the boxing world in mourning his passing."

Amazon closing all 87 pop-up shops

Amazon will close all of its 87 pop-up locations in the U.S. in April, the company said Wednesday.

Amazon has pop-ups inside Whole Foods locations, Kohl's stores and malls around the U.S. The shops let customers try Amazon products — such as Fire tablets, Kindle e-readers, Echo smart speakers — and Amazon services, like Prime Video, Audible and Kindle Unlimited.

"Across our Amazon
network, we regularly evaluate
our businesses to ensure we're
making thoughtful decisions
around how we can best serve
our customers," an Amazon
spokesperson told CNBC. "After
much review, we came to the
decision to discontinue our
pop-up kiosk program, and are
instead expanding Amazon Books
and Amazon 4-star, where we
provide a more comprehensive
customer experience and broader

Amazon's 4-star stores let

customers browse and try some of the products that are sold on its website that have a customer rating of four stars or better. The company said it will open more 4-star locations and additional Amazon Books stores this year.

The company is also planning to open dozens of new grocery stores around the country, with the first expected in Los Angeles sometime this year, according to a separate Journal report last week.

The closures don't affect cashierless Amazon Go stores. Amazon has considered opening as many as 3,000 Amazon Go locations by 2021, according to a report from Bloomberg in September 2018.

Amazon is planning to open its own grocery stores in the U.S. at a lower price point than Whole Foods, The Wall Street Journal reported Friday. The company is planning to open dozens of the

stores, according to the Journal, with the first one opening in Los Angeles as early as the end of this

Amazon declined to comment on the report.

Amazon is reportedly getting ready to expand even further in early 2020 with two more leases already signed for other grocery locations. It's unclear whether the new stores will be branded as Amazon markets, though the Journal reported the chain will be separate from the Whole Foods brand. Amazon is reportedly in talks about opening grocery stores in shopping centers based in San Francisco, Seattle, Chicago, Washington, D.C., and Philadelphia.

The new stores would be smaller than the typical grocery store of about 60,000 square feet, according to the Journal, with Amazon seeking about 35,000 square feet of space.

Amazon is also interested

in possible acquisitions to strengthen its supermarket strategy, according to the Journal. Regional grocery chains with around a dozen operating stores would be the ideal candidates for acquisition should Amazon choose to take that route, a source told the Journal.

Amazon initially made waves in the grocery industry when it announced in 2017 its plans to buy Whole Foods, a high-end retailer that prides itself on upscale produce. Now, it reportedly hopes to offer products at a more affordable price point with its new stores, which are not meant to compete with the Whole Foods brand directly.

The move marks another shift for Amazon from the digital to the physical world. The company has had retail locations previously through efforts such as its Amazon Go cashierless convenience stores.

Zuckerberg lays out vision for new Facebook

Mark Zuckerberg wants to reposition Facebook as a privacy-focused platform.

In a Facebook (FB) post on Wednesday, the CEO and founder detailed his overarching vision for how to make the service more secure, including encrypting messages. He also teased plans to integrate its various services, including WhatsApp, Instagram and Facebook, and said there will be a bigger emphasis on ephemeral content.

"People want to be able to choose which service they use to communicate with people. However, today if you want to message people on Facebook you have to use Messenger, on Instagram you have to use Direct, and on WhatsApp you have to use WhatsApp," Zuckerberg wrote in the post. "We want to give people a choice so they can reach their friends across these networks from whichever app they prefer."

Facebook plans to make it possible for users to send messages to their contacts using any of its services and SMS. But Zuckerberg said this would be an opt-in service, and users can keep their accounts separate if they prefer.

Earlier this year, the New York Times reported that Facebook planned to integrate its messaging platforms, WhatsApp, Instagram and Messenger. The three services would remain separate apps, but the infrastructure behind the scenes would be the same, according to the Times. Following that report, Facebook received some criticism and questions, such as what kind of power that would give the company.

At the time, Senator Brian Schatz from Hawaii, tweeted: "Good for encryption but bad for competition and privacy."

In addition to convenience, Facebook on Wednesday highlighted the move's privacy and security benefits. Zuckerberg said many people use its Messenger app on Android to send and receive SMS texts and noted those texts can't be encrypted because the SMS protocol isn't encrypted. However, if its messaging services are integrated, users would be able to send an encrypted message to someone's phone number in WhatsApp from Messenger.

"I believe working towards implementing end-to-end encryption for all private communications is the right thing to do," he said.

Zuckerberg also pointed to the success of private messaging, disappearing content and small group chats, saying these are "by far the fastest growing areas of online communication." Instagram Stories, which disappear after 24 hours, recently hit 500 million daily active users.

Users may feel more comfortable communicating with one or a handful friends, and sharing content that won't stick around permanently.

"People should be comfortable being themselves, and should not have to worry about what they share coming back to hurt them later. So we won't keep messages or stories around for longer than necessary to deliver the service or longer than people want it," Zuckerberg said.

For example, Facebook could give users an option to have messages automatically delete after a year, month or even seconds after they're sent. It could also stop storing messaging metadata for a long time.

Zuckerberg also acknowledged the company's past issues with privacy. The company has faced a growing list of privacy issues, including the Cambridge Analytica data scandal and the biggest security breach in its history.

"I understand that many people don't think Facebook can or would even want to build this kind of privacy-focused platform — because frankly we don't currently have a strong reputation for building privacy protective services, and we've historically focused on tools for more open sharing," he wrote. "But we've repeatedly shown that we can evolve to build the services that people really want, including in private messaging and stories."

Charlotte Russe closing all stores

Women's clothing retailer Charlotte Russe will close all its stores just a month after filing for Chapter 11 bankruptcy protection.

Wednesday night, the company posted on its website that its online store had closed. A going out of business sale started Thursday, March 7 at all its remaining stores.

In February, the company filed for Chapter 11 and said it planned to close 94 locations. In the court filing, the company said it "suffered from a dramatic decrease in sales and in-store traffic" and struggled with "the burden of maintaining a large brick-and-mortar presence."

At the time of the Chapter 11 filing, Charlotte Russe had 500 stores in malls around the country.

According to the Wall Street Journal, the company was unable to secure a deal that would save the retailer before a deadline set by lenders.

The company is remains in negotiations to sell off its intellectual property, according to USA Today. On Wednesday, a judge approved the sale of Charlotte Russe's assets to a liquidation company. The company has more than 8,700 employees, USA Today reported.

The last day to use gift cards is March 21.

Locally, Charlotte Russe has stores inside malls in Downey, Lakewood, and Montebello.

Tesla unveils ultra-fast charging station

Tesla is turning up the juice.

The automaker flicked the switch on its fastest-ever charging station on Wednesday night.

The so-called V3 Supercharger operates at 250 kilowatts -- approximately twice that of the older stations -- and can charge some of its cars at a rate of 75 miles every five minutes, which Tesla is promoting as "1,000 miles per hour," without explaining the math.

Combined with a new feature that brings the car's battery pack to an optimal charging temperature as it is approaching the station, Tesla says total charging time will be reduced by up to 50 percent.

The higher speed was enabled, in part, by a switch to liquid-cooled charging cables, according to the Teslarati blog.

For now, the Fremont, Calif., station is in Beta mode and only compatible with Tesla Model 3s, which use a newer type of battery cell technology than the Model S and X, and is only being made available to a select group of owners in the Tesla Early Access Program.

Tesla said that the chargers would exit the beta stage in April as they are installed at additional locations, and that the battery pre-conditioning feature would reduce charge times at the slower stations by 25 percent.

The update comes ahead of the launch of Porsche and Electrify America's 350-kilowatt charging network, which the German automaker says will able to provide around 250 miles worth of charge to its upcoming Taycan sports sedan in around 15 minutes.
