### U.S. declares new sanctions against Cuba

The Trump administration also announced sanctions against Venezuela and Nicaragua.

**WASHINGTON, D.C.** – The Trump administration has announced new sanctions and penalties against Cuba, Venezuela and Nicaragua aimed at both ending the rule of Venezuelan President Nicolás Maduro and weakening Cuba's communist

One of the measures will allow lawsuits against foreign companies operating on property in Cuba that was seized from U.S. citizens during the Cuban revolution — a reversal of more than 20 years of U.S. policy.

Announcing the crackdown in Coral Gables, Fla., on Wednesday, national security adviser John Bolton called Cuba, Venezuela and Nicaragua the "troika of tyranny" and said the new measures would "end the glamorization of socialism and communism."

The measures come as the U.S. pushes for Venezuela and the international community to recognize opposition leader Juan Guaidó as interim president.

"This is just the beginning," Bolton said. "As long as the people of Cuba, Venezuela and Nicaragua stand for freedom, the United States will stand with

Earlier on Wednesday, Secretary of State Mike Pompeo announced that the U.S. would no longer suspend Title III of the Helms-Burton Act.

That provision allows U.S. citizens to file lawsuits in U.S. courts against foreign companies "trafficking" in property confiscated after the 1959 revolution in Cuba. Previous administrations had a longstanding policy of waiving the provision for six months at a time. But the Trump administration had signaled its intent to tighten the U.S. trade embargo with Cuba earlier this year when it renewed the waiver for only 45 days.

The new policies announced Wednesday also include sanctions on Venezuela's central bank and a financial services provider in Nicaragua that the administration calls a "slush fund" for President Daniel Ortega.

But Havana took the brunt of the measures, which experts say are likely to affect the country's stagnant economy.

Bolton said the U.S. would institute restrictions on "nonfamily" travel in order to decrease the amount of money Americans spend on tourism in the country, an industry that Bolton said is controlled by the regime.

Tourism is a structural factor in Cuba's economy, and a rush of visitors hit the island when President Barack Obama made it easier for U.S. citizens to make the trip. But the industry has seen a decline since President Trump took office and rolled back several Obama-era policies.

Bolton also announced a cap on remittances to Cuba of \$1,000 per person per quarter. The Obama administration had removed remittance limits, and the State Department says remittances to Cuba from the United States amounted to \$3 billion in 2016, The Associated Press reports.

One attendee of the speech told the AP he believes the measures announced by Bolton will bring down Cuban President Miguel Díaz-Canel's government.

'Today is a big day," said Rafael UsaTorres, who was a member of Brigade 2506 that worked for the CIA during the failed Bay of Pigs invasion in 1961. "But I feel very sad — too many years waiting.

As NPR's David Welna reports, ending the Title III waiver opens the door to hundreds of thousands of lawsuits seeking billions of dollars from Cuba. According to Robert Muse, a Washington attorney with expertise in Cuban expropriations, the decision will likely trigger a flood of lawsuits against the Cuban government.

The complex will also house the Student Health Center, making it a more accessible, efficient facility where students can receive quality health care services. The project is located immediately south of Falcon Gymnasium, along the western edge of the campus' athletic

The Health & Wellness Complex consists of six new buildings: Athletic Team Room,



Dance, Fitness, Conference Center, Health Services, and Physical Education.

The Athletic Team Room **Building and Health Services** Building are currently under construction and will be completed in 2020.

Cerritos College President/ Superintendent Dr. Jose Fierro announced the college received over the last year \$2.3 million in planned gifts in support of academic programs and scholarships.

# Gov. Newsom visits Downey to take stand against drug costs

On his 100th day in office, California Gov. Gavin Newsom visits Rancho Los Amigos National Rehabilitation Center.

**DOWNEY** – California Governor Gavin Newsom was in Downey on Wednesday, joining Los Angeles County leaders at Rancho Los Amigos National Rehabilitation Center to draw a hard line in the sand against expensive prescription drug and

On his 100th day in office, Newsom stood in the shadow of Rancho's new Outpatient Building and announced that the state and LA County would be partnering to in the hopes of negotiating down the often-crippling prices of pharmaceutical drugs

The high costs of prescription drugs have long been in the crosshairs of California's governor.

"I got sworn in 100 days ago, and the first thing I did was sign an executive order...quite literally moments after I walked off the stage," said Newsom. "It was remarkable to me that in the state of California, with this remarkable purchasing we already

do...we estimate now it's close to \$13 billion that the state pays into our pharmaceutical purchases

"In the executive order, there was a reference that we want to open up this purchasing pool to others, including the counties, including the private sector as well."

L.A. County is the first to partner with the state. Newsom described it as a "populous

up the imagination of others...two governors have called me saying, 'what about us? What about our state joining the state of California, said Newsom. "All that frustration and, let's be honest, all that monied interest. Big money here, and they've been buying us off. I'll say it. Politicians of all political stripes have been bought off, been threatened. They don't want to touch this; they're willful in their neglect or their content of all of you as taxpayers. They're taking care of the few, not

Newsom added that "we will save billions and billions of dollars

# Students get realistic look at drunk driving consequences

Police and student actors host a simulated car crash and funeral, ahead of prom season when teens might drink.

#### SANTA FE SPRINGS -

Santa Fe High School students received a sobering look at the real-life consequences of driving impaired as they watched a simulated car crash that claimed the lives of classmates during an "Every 15 Minutes" event held April 3-4.

Presented with staged images of classmates bloodied and motionless, Santa Fe juniors and seniors sat silently as they observed what happens in the moments after a DUI: the 9-1-1 call, the arrival of police and paramedics, a sobriety test and arrest, injured victims being taken away by ambulance and helicopter, and a deceased person loaded into a coroner's

Throughout the day, the "Grim Reaper" went to classrooms every 15 minutes to take students away from

their friends and families. The students were taken to a retreat and not allowed to communicate with the outside world.

The next day, a mock funeral was staged in the gym and included the parents whose children were taken away for the night. Students, parents and staff watched a video that showed the moments before, during and after the crash. Parents talked about the emotional toll taken by losing their child for just one day, and how tragedies like these can be prevented.

Santa Fe senior Analis Fussell - one of the students taken by the Grim Reaper - knew ahead of time she would be selected, but was still fraught

"Once I got tapped out, it was unimaginable. It made me feel like I had no concept of the outside world, like I was completely out of touch," Fussell said. "I learned that even as safe as you feel, there are things you can't control. Everybody needs to



make the right decision."

The two-day program was sponsored by the California Highway Patrol, Santa Fe Springs Department of Public Services and Health First. Among the participants were Whittier Police, Santa Fe Springs Fire Rescue, L.A. County Coroner and Guerra Gutierrez Mortuary.

"It's vitally important for

our students to know that it only takes one drink to change the trajectory of countless lives, and that they must always think and act responsibly," Santa Fe Principal Craig Campbell said.

"Thank you to our community partners and Santa Fe High staff for helping to educate our students to prevent these tragedies.'

### Woman faces new charges in immigration scam

**MONTEBELLO** – A woman accused of stealing tens of thousands of dollars by falsely offering immigration and real estate services is facing new charges.

Eblin Balver (dob 12/1/66) of Baldwin Park pleaded not guilty today to 34 felony counts filed March 19 in an amended complaint. She is now charged with a total of 75 felony counts, including 60 counts of grand theft; four counts of first-degree burglary, person present; and three counts of grand theft from an elder or dependent

The charges include allegations of taking property valued at more than \$100,000 through fraud and embezzlement and taking property valued at more than \$200,000. Deputy District Attorney Ryann Gerber Jorban of the Consumer Protection Division said Balver allegedly stole more than \$267,000 from 38 victims.

A preliminary hearing setting is scheduled on May 23 at the Foltz Criminal Justice Center.

Between September 2013 and March 2018, Balver allegedly ingratiated herself with individuals in order to lure them into business arrangements for legal services, the prosecutor said. She purportedly claimed that she worked in the legal system and could provide assistance with immigration petitions, visas and home

The defendant is accused of collecting payments from the victims but never providing the promised services. Balver also allegedly threatened some of the victims in order to prevent them from reporting the crimes to the authorities, the prosecutor said.

Additional victims were identified with the help of the District Attorney's Consumer Protection hotline after the case was filed in

Balver faces a possible maximum sentence of 63 years in state prison if convicted as charged. Bail was set at \$1 million.

Investigators encourage anyone who believes they may have been a victim to call the District Attorney's Office at 213-257-2450.



#### South Gate car dealer avoids prison for tax evasion

**SOUTH GATE** – Sam Sebuh Matioz Goncuoglu of Porter Ranch pled "no contest" this week to three felony counts of sales tax

Goncuoglu, the owner of F.A.S.T., LLC DBA Daytona Cars, which operated at multiple locations in Los Angeles and South Gate, failed to report \$8.5 million in taxable sales, resulting in \$758,495 in unreported sales tax from 2007 through 2012.

Goncuoglu was sentenced in Los Angeles County Superior Court to five years of formal probation and ordered to pay \$758,495 in restitution to the California Department of Tax and Fee Administration (CDTFA).

The case was prosecuted by Deputy District Attorney James Belna of the Los Angeles County District Attorney's Office, Major Fraud

Funds in the amount of \$300,000 have already been received and the remaining balance is to be paid in installments.

The CDTFA's investigation began in 2013 when it was discovered that Goncuoglu failed to report a large amount of sales from his retail



2. Now I understand why there were always wooden legs burning in our fireplace.

## A bright spot in California

California's plastic and paper recycling program may be struggling. And the state has made a mess of its e-waste program that is supposed to keep old televisions and computers out of the landfill.

But there is one bright spot – California's program to recycle massive amounts of metals from old appliances, cars, construction scraps, and countless other consumer products.

For nearly 50 years, California has been a leader in not just keeping this metal out of our landfills, but in converting it into valuable products. In doing so, the State has created a robust industry that touches every town, city, and county in the state.

Scrap metal recycling provides California with an estimated 51,000 jobs that represent a total of \$3.6 billion in wages. The industry's economic impact in the state is \$11.5 billion. It also generates more than \$1.5 billion in tax revenue for California governments.

At a street level, tens of thousands of people have built mom-andpop businesses collecting metals from businesses and neighborhoods. These are typically minority-owned businesses providing income for a segment of our population without much education or another opportunity for economic advancement. These scrap metal collectors

have been able to support families by collecting tons of end-of-life products that would otherwise end up in the landfill. They rightly consider themselves environmentalists who provide a valuable service that keeps their communities from blight.

These collectors load up their trucks and drop off metals at local recycling centers that pay them based on weight. These centers sort the metals before delivering them to larger regional recyclers.

In addition to receiving metal from local centers, medium and large recyclers are the collection point for old cars, trucks and buses and metals from manufacturing plants. The old vehicles come from many sources – the State of California's "cash-for-clunkers" program, auto dismantlers and non-profit organizations that receive old vehicles as donations. Before recycling, the dismantlers remove all gasoline, liquids, batteries and other potentially hazardous materials. Over a million end of life cars and over 3 million end of life appliances are recycled at these recyclers every year.

Metal recycling facilities engage in a very high-tech, sophisticated process that turns mountains of rusty, old cars and other scrap metals into raw stainless steel, iron, aluminum, steel, and copper. These products are exported and used in the manufacturing of new cars, appliances, and consumer goods, which reduces demand for natural

Over decades, the shredding and recycling process has been refined to the point where 99 percent of all metals are recovered. What is left is something known as "shredder residue." This includes shredded upholstery, plastic, glass and a minuscule amount of metal. For regulatory purposes, this end of process residue is chemically treated with a cement type mixture before being transported to a landfill as and used as daily cover.

Metal recycling has thrived as a good neighbor in part because it has excellent working relationships with its regulators - local fire departments, regional water boards, and air quality management districts. The regulators have required permits that project the environment and public health.

While household waste recycling is fraught with problems, California's metal recycling industry has been successfully delivering tremendous benefits to the state's environment and economy. It is an underappreciated effort that supports working families, diverts waste from landfills and creates value across the board.

Fire sticks are a great plant in areas where rain is limited. They grow with very little water. The branches can be cut and planted and cut and planted forever. One plant can turn into an endless garden of fire sticks. The plant can grow up to 20 feet in height if it is supported correctly.

# Can Bernie Sanders be stopped?

At the bottom of my list of the Democratic candidates I would like to see nominated in 2020 is Bernie Sanders. At the top of my list of the candidates I expect to see nominated? Same.

The presidential campaign is still young. The first actual votes will not be cast for more than nine months, when the Iowa caucuses are held on Feb. 3. In a congested race, as we know from the Kentucky Derby, the fastest contenders can find themselves hopelessly boxed in. But at the moment, it's easier to see a path for Sanders to win the Democratic nomination than it is for anyone else.

I have written before of my many objections to Sanders, which have not abated. But his political strengths are not to be underestimated.

Plenty of politicians look formidable until they actually enter the campaign. Remember Rudy Giuliani in 2008? Or Rick Perry in 2012? The jump to the major leagues is bigger than it looks.

Sanders, however, has competed at this level before, and he came close to defeating a rival who was the most admired woman in America for 17 consecutive years.

Hillary Clinton was a savvy, impeccably qualified and lavishly funded candidate who had the backing of the party establishment and the nostalgic power of her husband's presidency. Yet Sanders won 23 of the contests and 43 percent of the votes cast. He excited crowds in a way that Clinton never could.

He has raised far more money than anyone else this time around, the great majority from small donors — which suggests that a lot of people who voted for him in 2016 are eager to do it again.

Sanders' central advantage in 2016 was the blunt repetition of his signature themes: Medicare for All, taxing the rich, free college, fighting Wall Street, attacking inequality. No one can match his credentials on these issues. No one is better at communicating them in a forceful manner.

establishment credibility that remains as potent as ever. But for all his eccentricities, Sanders proved to be a sure-footed campaigner who avoided gaffes without ever sounding canned or cautious. His

appearance at a Fox News town hall Monday showed fearlessness.

Sanders has wrought a change in the Democratic Party, pushing its ideological center of gravity well to the left of where it was just four years ago. He paved the way for such firebrands as Alexandria Ocasio-Cortez and Rashida Tlaib to be elected to the House. The Congressional Progressive Caucus has 98 members, up from 69 in 2014.

Medicare for All has gained the support of many Democratic politicians, including several of those running against him. On that and other issues, the senator from Vermont could sue most of his opponents for plagiarism.

His disadvantage is that he's well to the left of most Democratic voters — half of whom say they are moderate or conservative. The New York Times noted that "perhaps 1 in 10 Democrats over all... might identify as democratic socialists, based on recent polls.

Among less liberal Democrats, the obvious alternative to Sanders is Joe Biden. But Biden has run twice for president with dismal results. His responses to women's complaints about his unwanted touching were tone deaf — and revived bitter memories of how he handled the Clarence Thomas confirmation hearings.

His past positions on abortion, criminal justice and the Iraq war will be used against him. He has a propensity for unforced errors, brought on by his garrulous nature and thirst for attention. If any candidate is a good bet to self-destruct, it's Biden.

Donald Trump got the Republican nomination not because he was the best candidate but because the better ones split up the voters who disliked him. Sanders may not be the choice of most Democrats, but he is better placed to capture consistent pluralities than anyone else.

Candidates who might outshine him in a small field, such as


Elizabeth Warren, Kamala Harris, Cory Booker and Julian Castro, will struggle to set themselves apart from each other. Fresh-faced youngsters Beto O'Rourke and Pete Buttigieg are bound to seem underprepared next to the battle-scarred Bernie.

Most Democrats would probably prefer not to risk losing the election by nominating an avowed socialist. But as Trump showed in 2016, a majority that is divided can be conquered.



#### Non-profit seeks donations for food basket program

**NORWALK** – A GoFundMe fundraiser is currently ongoing to provide food for seniors.

Care For The Children, a nonprofit corporation, created the Food Baskets for Seniors program to help solve hunger among homebound senior citizens.

Since the plan began in February 2017, Care For the Children has been providing a 30 lb. box of food each month to 365 seniors. The cost to deliver a 30 lb. box of food to each senior is \$5 but the boxes of food are provided free of charge.

food baskets The distributed to seniors in Norwalk, Whittier, Santa Fe Springs, PIco Rivera, La Mirada, La Habra, and Anaheim. There is currently a waiting list of 485 seniors waiting to be enrolled in the program.

Unlike Meals on Wheels, which receives grants to offset their cost to deliver meals to seniors, Care For the Children relies solely on donations to operate.

"We are reaching out to the public to join us in the fight against hunger among homebound senior citizens," said executive director Robert G. Henderson.

The rate of hunger among seniors aged 60 and older has increased by 45% since 2001, a lingering effect of the 2008-09 recession.

According to Feeding America, as the baby-boom generation ages, the number of seniors facing hunger is only expected to increase.
