# Norwalk upholds decision to close liquor store

Dhaka Liquor and Market had been cited for selling alcohol to minors and for operating slot machines.

NORWALK - In what could be considered as one of the most controversial votes in recent memory, the Norwalk City Council voted Tuesday to uphold the Planning Commission's decision to effectively shut down a local liquor store due to numerous violations.

Representatives of Dhaka Liquor and Market, located at 10944 Imperial Highway, pleaded its case to council members in an effort to reverse a prior Planning Commission decision to revoke its conditional use permit and zone variance, which allowed the store to sell alcohol for off-site consumption.

Norwalk officials claimed that Dhaka has been cited for multiple violations over the last several years, including the sale of alcohol to minors, the illegal sale of single cigarettes, the illegal sale of single use beers and shots, and the installation of gambling machines and illegal gambling within the

These claims were backed by research and analysis from the Department of Alcoholic Beverage Control (ABC), who reportedly conducted several decoy operations and confiscated the illegal vending

Thomas Chapin, the attorney representing the business owner, accused the city of "selective prosecution.'

"I've been throughout the city of Norwalk. I used to work for LA County Health Department...I've seen these liquor stores, I've been in these liquor stores personally, and I've seen that fact that they're all selling single use beers or

Chapin also refuted claims that Through a partnership with Dhaka had sold single cigarettes, claiming that "those are double

> He also said that the slot machines had long since been that kind of behavior.'

"Nothing has been recent," said Chapin. "The gambling machines were two years ago; they haven't been in there."

Chapin also claimed that attempts for the store owner to sell the store had been blocked as well.

Jayneshwar Gounder, the owner of Dhaka, refuted some of the city's and ABC's claims,

insisting that the mistakes that he and his business had committed had been corrected.

stopped short directly calling the situation discrimination.

"I want to work with the Norwalk city; if you guys don't want me, just let me sell the store," said Gounder. "All the liquor stores are selling the single beers, the single shots, the cigarettes...why are you targeting me for?"

"Probably they don't like my color - I'm dark - but my heart is clean."

There were also several claims against the credibility and authenticity of the ABC report made by Chapin, Gounder, and others, who suggested that they had evidence refuting the ABC report and that there may be some unknown ulterior motive on behalf

Councilmember Tony Ayala was quick to come to the defense of the government department.

'If we have a store owner that has sold liquor to minors, or had slot machines in there that they had been busted by ABC... you're oversimplifying this thing; this is a lot more serious. We are responsible for the community and making sure the community

"I've worked with ABC for a number of years...having worked with them I didn't see that kind of stuff occur. I'm saying over a couple of decades, I've never seen

Patrons of the store showed up in force to appeal to the compassion of the Council, describing the several ways how the owners had personally helped those in need. Several speakers plead to the Council to "give them second chance.'

However, these please went for naught, and with a collective groan from the audience the Council voted 3-2 to uphold the



Planning Commission's decision, with Councilmembers Jennifer Perez, Leonard Shryock, and Mayor Margarito Rios in favor.

Perez addressed the crowd before voting, said that "this isn't an easy position to be in."

"Hearing your testimony, your passion, and just hearing about the businessowners...I wish we could duplicate that feeling," said Perez. But there are reasons that have been presented to us that I have to

Rios echoed this feeling before casting her vote.

"As a council we are responsible for the entire community," said Rios. "Yes, I commend the efforts that have been demonstrated by the business and property owner in their efforts to actually help the community; that's very important."

"However, I cannot ignore the fact that on more than one occasion, alcohol was sold to minors. We have to really put that into perspective. The fact that we allow this mess to continue knowing what we know is a big risk and liability because of the potential harm to the individual residents and the community as a

# Newsom supports eliminating tax on tampons

Gov. Gavin Newsom announced his support for a repeal of sales taxes on menstrual products and also diapers.

**NORWALK** – Prior to releasing his detailed May Budget Revision, Governor Newsom on Tuesday announced he would repeal the sales tax now charged on menstrual products.

The repeal would go into effect upon his signature of the budget, which the legislature must pass by June 15.

In his remarks, Governor Newsom applauded Assemblymember Cristina Garcia's "tenacity and perseverance" at promoting the issue in California and the nation.

"I applaud the Governor's actions today in finally sending a message that our bodies are not a luxury," said Garcia (D-Bell Gardens). "Today, California joins eleven other states by removing these necessities from being charged a sales tax. Today, we finally moved California into an era with a gender neutral tax code."

In 2016, the bill (AB 1561)

passed through the legislature nearly unanimously only to be vetoed by Governor Brown who cited a resulting loss of funds if the tax was removed. In 2017 the bill was held in Assembly Appropriations.

The bill was reintroduced this year, for the third time, as AB 31 and is currently in the Assembly Appropriations Committee. It will continue to move through the legislative process until the budget is signed in June.

Currently, women in California still pay more than \$20 million annually in taxes on tampons, sanitary napkins, and menstrual cups paying on average \$7 a month for forty years of their lives.

"Women and men from around the state made their voices loud and clear taking this from a state tax measure to an international movement. I am proud of our allies and their perseverance, and most especially, of their unwavering support."

In 2017, Garcia, the self-proclaimed "Tampon Queen," was successful in expanding access to menstrual health products with the passage of AB 10. That bill provides free menstrual health products in low income school bathrooms.

Last month, her request to the Joint Legislative Committee on Rules to provide free menstrual products in the State Capitol for visitors and staff, was approved.

"I'm not done talking about our periods," added Garcia. "But today is the first day I've been able to think about what's next in the menstrual equity discussion. Our bodies are nothing to be ashamed This administration has put equality at the forefront of its efforts and California will be a better place because of it.'

### Paging Dr. Frischer...

The expression "dirty money" usually refers to illgotten gains. However, given the number of people who touch money on a regular basis, cash is actually pretty darn dirty!

If you pay for food up front, do you wash your hands immediately before sitting down to eat? A growing body of research suggests that you'd

Paper money can harbor thousands of bacterial and viral microbes, gathering them from every environment it passes through. I was quite surprised to learn that in a recent study, researchers swabbed onedollar bills from New York City and found hundreds of species of microorganisms, with pathogenic or potentially pathogenic organisms on a whopping 94% of the bills tested. The most abundant ones cause acne, and many others were harmless skin bacteria.

Also found, however, were the pathogens E. coli, salmonella, staphylococcus, hepatitis C, and others.

Of course, the presence of microbes doesn't automatically make us sick. Certain subtypes of organisms are better or worse at infecting people, and may need a different environment than the surface of a bill. But overall, currency is a great environment for germs. It is 75% cotton and 25% linen, with a porous environment that helps hold onto them. Even if microbes do rub off onto our hands, they are still unlikely to cause us harm. The skin is a good protector. However, if we then touch our eyes, nose or mouth, we increase the risk.

It also came as a great surprise to me that traces of cocaine were found on nearly 80% of dollar bills! Other illegal drugs were found as well. Rolled bills can be used to snort cocaine. Drugs are



also introduced to banknotes because the illegal drug trade is typically a cash business, so the bills may well have been handled and counted by drug users. One significant virus found on paper money is hepatitis C. The immune systems of drug users tend to be more suppressed, and they are at greater risk of infection than the general population. If someone who is infected with hepatitis handled the bills, that paper money could spread the virus and the disease.

Contamination of bills influenced Australia to switch to polymer (think plastic) banknotes starting in 1988, and other countries, including Canada, have followed. Polymers are more resistant to dirt and moisture, so fewer bacteria stick. They last longer and stay cleaner than do our U.S. bills.

What can you do to minimize your own risks? Keep your hands away from your eyes, nose and mouth, and wash your hands after handling cash. Or, you may choose to join the 21st Century, and use plastic or your cellphone to pay!

# Measles outbreak expands to L.A. landmarks and Long Beach

The number of measles cases continues to expand as a growing number of families skip vaccinations.

**LOS ANGELES** – As the measles outbreak expands, L.A. County officials issued a warning over the weekend for new locations where people may have been exposed to the contagious virus.

On Saturday, the L.A. County Department of Public Health reported that anyone who visited The Grove or the Farmer's Market in the Fairfax District on the afternoon of April 27 may have been exposed to measles.

Other nearby locations where

people may have been exposed

that same day included Paper Source, Whole Foods and the La Brea Tar Pits. People who were at Los Angeles International Airport's Terminal 2 on the evening of April 30 or the

morning May 1 may have also been

those locations at those times are at risk of developing measles up to 21 days after exposure. As of Saturday, there have been

eight confirmed measles cases among L.A. County residents so far in 2019, and another six measles cases of non-residents who traveled through L.A. The majority of the cases involved unvaccinated patients. There are another two confirmed cases in Orange County, one involving an infant.

On Saturday, Long Beach health officials announced the first confirmed case of measles in a city resident since 2015 involving an adult graduate student who attends UC Irvine and is recovering at home, according to the Long Beach Department of Health and Human Services.

Last month, UCLA and Cal State LA issued quarantine orders for hundreds of students and staff who may have been exposed to measles and either had not been vaccinated or could not verify that they have immunity.

Measles is a highly contagious

causes fever, rash, cough and red, watery eyes. Measles spreads very easily by air and by direct contact contagious. with an infected person.

People who become infected following are contagious before they have symptoms and know they are infected.

Health officials also say to self-monitor for illness with fever and/or an unexplained rash from 7 days to 21 days after exposure.

If symptoms develop, stay at home and call a health care provider immediately.

"I will work with the City of Norwalk to maintain a well operated business that serves Norwalk and its constituents. I will run a clean, well operated recycling center in Norwalk...Because it is in my vested interest to ensure safe, clean environment for my customers, I feel the need to make sure a safe, clean, and family friendly environment.

Ahmad urged the council to establish whatever conditions

Public support was a mixed bag, with several individuals speaking up against the project - citing many of the same aforementioned concerns – and those in favor claiming a community need and a willingness to give Ahmad a chance, if even just for six months to a year.

Despite this, the decision to deny the appeal came rather quickly and silently, with a unanimous 5-0 vote.

# Terrorist who lived in Downey faces deportation

Vallmoe Shqaire was admitted to the U.S. despite prior convictions in Israel on terror-related charges.

**DOWNEY** - A Jordanian national who was sentenced to prison in Israel after admitting he acted at the direction of a terrorist organization to detonate a roadside bomb in an attempt to blow up a civilian bus in Israel was ordered last week to serve a ninemonth prison sentence for lying to immigration authorities to obtain U.S. citizenship and, as a result of his conviction, will be deported to

Vallmoe Shqaire, 51, of Downey, an admitted member the Palestinian Liberation Organization, pleaded guilty Jan. 14 to unlawfully procuring U.S. citizenship.

consequence of his conviction, Shqaire was denaturalized, and he agreed to be removed to Jordan upon the completion of his prison sentence.

Shqaire was convicted in Israel of numerous violent felonies, including charges related to his role in the failed plot to bomb an Israeli bus and for assaulting persons suspected of cooperating

with the Israeli authorities.

When he pleaded guilty earlier this year, Shqaire admitted that he lied to U.S. Citizenship and Immigration Services (USCIS) in order to become a citizen. On his citizenship application and during the interview, Shqaire falsely denied under oath that he had never been arrested, convicted or sentenced for any crime, and that he was never a member of any organization or association.

Certified Israeli court records show that Shqaire was, in fact, arrested on two occasions in the late 1980s and early 1990s; was convicted of multiple, violent felonies; and served a prison sentence in Israel.

"By repeatedly lying to USCIS Officers, defendant sought to conceal his extensive and violent criminal history in Israel

and attacked the immigration safeguards that are in place to protect persons like the defendant from entering our country,' prosecutors wrote in a sentencing memo that noted Shqaire's criminal conduct continued after he fraudulently obtained U.S.

After being granted citizenship, Shqaire was prosecuted in a credit card fraud scheme that led to a state prison sentence, and he made additional false statements to law enforcement officers in an attempt to minimize his significant criminal history.

Shqaire was sentenced April 26 by United States District Judge John F. Walter, who issued the order that Shqaire be removed to Jordan once he completes his prison sentence.

# Plan would remove pepper spray from juvenile halls within 1 year

The plan comes after a report criticizing excessive use of pepper spray against incarcerated youth.

LOS ANGELES -A report released Monday laid out a roadmap for providing humane treatment and improving safety in Los Angeles County's juvenile halls and probation camps that, for the first time, includes recommendations for phasing out the use of pepper spray.

The report emerged from the Probation Reform and Implementation Team, a taskforce created after the L.A. County Board of Supervisors voted in February to eliminate pepper spray in juvenile

Last month, six detention officers at Los Padrinos Juvenile Hall were arrested on charges that they abused teenage girls with pepper spray.

After the arrests, L.A. County leaders decided to close Los Padrinos, effective this summer.

The taskforce's proposed

timeline begins with enhancing training for all staff who work with youth, particularly on deescalation techniques and nonuse of force options. Such training the year, all pepper spray will be is to start as soon as possible, and removed from juvenile halls and be ongoing.

Soon after, only supervisors not line staff - will have access to pepper spray, though only as a last

## Sierra Vista student turns his life around

Jose de Leon had a rought start to high school but he's on track to graduate next month.

WHITTIER - Sierra Vista
High School senior Jose de
Leon is looking forward to
participating in commencement
exercises in June and pursuing
a career as a probation officer.
But it wasn't very long ago that
the idea of graduating from
high school was more fantasy
than reality for de Leon.

As a freshman, de Leon spent two days at Cal High before being transferred to Sierra Vista, the District's independent study campus. There, he was placed in the Freshman Fresh Start program, which serves as a bridge for students who need additional support transitioning from middle to high school.

Unfortunately for de Leon, who was on probation, he faced additional challenges at the new school, where he was often disruptive in class and skipped school altogether at times.

Later in the school year, de Leon was placed in Sierra Vista's independent study night program, aimed at students who learn better in a quieter setting with fewer distractions. Meeting twice a week with three teachers and one tutor, the new academic plan provided de Leon the opportunity to learn at his own pace in a more focused, structured evening environment.

"The independent study evening classes don't always work for students, but sometimes magic happens, and for Jose, it worked," Sierra Vista Director Nicki Buchholz said. "We are always willing to give our students multiple chances, and Jose has accomplished so much. He matured and started to make better decisions."

For his resilience and willingness to challenge himself academically and personally, de Leon was presented with an Award of Merit by the Whittier Union Board of Trustees on April 9.



"I'd like to thank everyone, my teachers, Sierra Vista staff and my parents," de Leon said.

Though de Leon still has credits to earn, he is working hard and has begun to formulate a post-secondary education plan that includes attending Rio Hondo College and studying to become a probation officer.

"What really matters is where Jose is now, not where he was," Buchholz said. "We believe Jose will be successful and that he will reach out and help students who may be headed down the path he once took. We are very proud of him and know that going forward, he will shine."

# Juvenile halls phasing out pepper spray

sprayed as an adult, I am glad to see that L.A. County's Supervisors have decided to eliminate its use on youth under the care of the L.A. County Probation Department," said PRIT member Jose Osuna, who formerly worked with Homeboy Industries.

"I believe that the PRIT's recommendations lay out the safest path that can be taken in order to accomplish that."

Concerned about the tripling of pepper spray use in the County's juvenile halls in the last three years, the Board of Supervisors voted unanimously on February 19 to phase out pepper spray, and tapped the PRIT to conduct a special hearing after a County Inspector General (OIG) investigation found excessive and troubling uses of pepper spray.

The OIG noted cases of pepper spray being used on youth under

being pepper sprayed in the groin, and youth not being allowed to decontaminate after being pepper sprayed.

PRIT's special hearing, held March 16 in Carson, drew more than 100 people, including formerly incarcerated youth, probation staff, experts in youth justice, youth advocates, County leaders, concerned community members, and other stakeholders. Their comments informed PRIT's report, which had 15 recommendations in all.

The first 10 recommendations included developing strategies for ending the "us versus them culture" observed by the OIG in juvenile halls and probation camps and providing environments where youth can flourish.

This includes providing enhanced mental health support to youth; and expanding staff

psychotropic medication, youth support to deal with childhood being pepper sprayed in the groin, vicarious trauma.

Additionally, the PRIT recommended the Probation Department ensure robust oversight in creating a way for youth to report grievances without fear of retribution.

The last five recommendations strive to balance the urgency of phasing out pepper spray with the need to do it incrementally.

"As the author of a recent motion to eliminate pepper spray from LA County juvenile halls and camps, I applaud the Probation Reform Implementation Team for synthesizing the insights of our community stakeholders on how to eliminate pepper spray while preserving safety in our facilities," said Supervisor Sheila Kuehl, lead author of the motion to phase out pepper spray.

"Phasing out the use of pepper

spray at our probation facilities is the only way to address our serious concerns for the young people in our care—but I am also concerned for the safety of our staff," added Supervisor Janice Hahn.

"We are charting a path forward that takes into account both of these legitimate concerns equally."
