LOS ANGELES - California has filed a lawsuit against San Francisco-based electronic cigarette maker JUUL, alleging that the company targets young people through advertising and failed to give warnings about the product's chemical exposure and risks for cancer, birth defects, and reproductive harm.

"JUUL and other nicotine product makers must be held accountable when they knowingly fail to take the necessary protective measures and allow the sale of nicotine products to underage buyers. Further, as of November 13, 2019, the CDC reported 42 deaths in patients with e-cigarette or vaping product use, with a further 2,172 cases of associated lung injury reported nationwide. Four of the deaths reported were patients in California.

Monday's lawsuit, filed in the Alameda County Superior Court, alleges that JUUL's viral marketing campaigns led millions of American youth to start vaping or "JUULing" without knowing the potential harms associated with nicotine to a new front, against a new or, in many cases, that the product even contained nicotine.

Liquor store robber sought

NORWALK – Los Angeles County sheriff's officials on Wednesday released video of armed robberies that occurred last month and were asking for help from the public in identifying the man responsible.

The first incident occurred about 2:30 p.m. Oct. 19 along the 10000 block of Rosecrans Avenue in Bellflower.

About 45 minutes later, investigators believe the same man robbed a liquor store along the 10000 block of Alondra Boulevard in Norwalk, but this time brandished a gun.

In the second incident, the man allegedly pointed a gun at the cashier while customers were inside the store, Sheriff's Detective Gamielle Marshall said during a news conference Wednesday. Fearing for his life, the cashier gave the man cash, and the man ran from the scene.

Marshall called both incidents "brazen."

It is unclear how much money was taken during the robberies.

The suspect was described as being between 20 and 25 years old, between 5 feet 6 and 5 feet 9 and between 150 and 170 pounds.

Anyone with information about the incidents or about the man involved can call Marshall at 562-466-5148.

The lawsuit also alleges that JUUL unlawfully failed to verify the age of California consumers and then violated the privacy rights of minors by keeping the personal email addresses of underage individuals who failed age verification on their website and using those email addresses to send them marketing materials.

The lawsuit was announced Monday at a press conference hosted by L.A. County Supervisor Janice Hahn, California Attorney General Xavier Becerra and Los Angeles District Attorney Jackie Lacey.

"Nearly 1 in 10 high school students in LA County report using e-cigarettes. That is not by chance," said Hahn. "JUUL has systematically targeted the teen market with everything from the design of their products to their advertisements.

"With this lawsuit we are going to hold JUUL accountable for their hand in this public use health crisis and do what we e-cigarettes. can to stop this company from creating a new generation of nicotine addicts."

"We've worked too hard, committed our hard-earned money for too long combatting harmful tobacco use to stand idly by as we now lose Californians to vaping and nicotine addiction," said Becerra.

"JUUL adopted the tobacco industry's infamous playbook, employing advertisements that had no regard for public health and searching out vulnerable targets. Today we take legal action against the deceptive practices that JUUL and the e-cigarette industry employ to lure our kids into their vaping web. We will hold JUUL and any other company that fuels a public health crisis accountable.



IUUL launched its sponsored promotional events in cities across California and elsewhere to distribute free samples of JUUL devices and their flavor pods to a young, trend-setting audience. The company engaged in a targeted social media campaign by marketing flavors that appeal to youth, such as mango, cool mint, crème brûlée, and cucumber.

JUUL devices work by heating up a cartridge or "pod" containing liquids to create an aerosol, often called a vapor, that users inhale. The liquid contains nicotine, flavorings like mint or mango, and many other chemicals.

The cartridges are small, potent and convenient. They plug into a USB drive and emit a small cloud of vapor when inhaled.

Another looming threat to e-cigarettes

President Donald Trump reportedly has reconsidered a plan to ban flavored e-cigarettes, a reversal that was widely portrayed as a triumph of politics over public health. Yet that criticism more aptly describes the proposed ban, which would have sacrificed the interests — and potentially the lives — of current and former smokers in the name of curtailing underage vaping.

There were political arguments on both sides of this debate. Advocates of the flavor ban argued it would appeal to suburban women concerned about the recent rise in e-cigarette use by teenagers, while opponents warned that it would alienate vapers who were otherwise inclined to support the president, endangering his reelection.

The opponents, bolstered by rallies and polling data suggesting that vapers were highly motivated and apt to vote (or refrain from voting) based on this issue, seem to have prevailed. But they not only had the stronger political argument; they also had the stronger public health argument.

Millions of Americans have quit smoking by switching to vaping, a far less hazardous source of nicotine. Consumer surveys and sales data show they overwhelmingly prefer the products targeted by the proposed ban.

That policy, which was expressly designed to make vaping products less appealing, would have driven some former smokers

back to their old habits while deterring current smokers from making a switch that could save their lives. Even The New York Times saw the folly of this approach, warning that it "would almost certainly force people who already use these products, including roughly 11 million adults, to choose between traditional cigarettes (which remain widely available, despite being deadlier than e-cigarettes) and blackmarket vaping products."

For the time being, the vaping industry, including thousands of mom-and-pop shops across the country, seems to have dodged a bullet. But it still faces the looming threat of federal regulations that are expected to drive most businesses and products from the market.

Under a 2016 rule, manufacturers, which include vape shops that mix their own e-liquids, have to persuade the FDA that allowing sales of their products is "appropriate for the protection of public health." Although it's still not clear exactly what that means, vaping businesses must submit a "premarket tobacco application" (PMTA) for each of their products by May 12 — less than six months from now.

A PMTA is required for every product variation. The FDA puts the "average cost" at \$132,000 for e-liquids and \$467,000 for devices, although it says some applications could cost more than \$2 million.

will "exit the market" before the application deadline.

If a business manages to file adequate applications in time, it will be allowed to keep those products on the market for up to a year while the FDA decides whether to approve them. But even at this late date, the requirements for approval remain opaque, as a lawsuit filed last month by a coalition of small vaping companies points out.

The FDA, for instance, demands "sufficient information regarding the potential abuse liability" of each product and suggests it would be satisfied with "a double-blind, placebo-controlled, within-subject study comparing several doses of a new product to a comparator product with a known abuse liability." It's not clear whether anything short of that prohibitively expensive option would suffice. And while manufacturers are supposed to list "harmful or potentially harmful constituents," the FDA still has not fully specified what those are.

"Our next focus will be on ensuring that the Trump administration recognizes the need to reform the FDA's regulatory system for these products," says Gregory Conley, president of the American Vaping Association, an advocacy group that supports vaping as a harmreducing alternative to smoking. "If President Trump wants to win in 2020, mere inaction on this issue is not enough."

Elizabeth Warren's crazy healthcare plan

Sen. Elizabeth Warren, D-Mass., wants "Medicare for All," as does Sen. Bernie Sanders, D-Vt., her self-described "Democratic socialist" rival. Unlike Sanders, however, Warren claims she can finance her plan by raising taxes only on the superrich. The middle class, Warren insists, will see their health care costs go down and their taxes will not go up.

Some of her nearly equally left-wing rivals demanded specifics. Who pays? And how much? After a Democratic debate, one rival, Mayor Pete Buttigieg of South Bend, Indiana, said Warren was "more specific and forthcoming about the number of selfies she's taken" than about her plan.

Buttigieg said: "Not only is it important to have 'yes-or-no' answers to 'yes-or-no' questions at a time when people are so frustrated with Washington-speak, but also there's still been no explanation for a multitrillion-dollar hole in this plan."

Not that Democrats and their media sympathizers truly care about costs or whether promises about costs are even kept. President Barack Obama made numerous unrealized promises about his health care plan. He insisted Obamacare would save the average family \$2,500 a year, that it would "bend the cost curve" downward and that people could keep their health care plan if they wanted to. PolitiFact pronounced Obama's "if you like your health care plan, you can keep it" promise 2013's "Lie of the Year."

Democrats, of course, quickly employed their fallback position on

rising costs: blame Republicans. Sally Pipes of the Pacific Research Institute, a conservative think tank, said last year: "Despite the fact that premiums rose throughout President Barack Obama's second term, Democrats claim that the most recent rate increases are President Donald Trump's fault. In August, four liberal cities — Baltimore, Chicago, Columbus and Cincinnati — filed a lawsuit alleging that Trump is 'waging a relentless campaign to sabotage and, ultimately, to nullify the law.' That's nonsense. Obamacare is imploding under the weight of its own regulations."

A month before Warren finally revealed the cost of her plan, the Urban Institute, a center-left think tank, estimated the cost of a single-payer plan for everyone, including illegal aliens, at \$34 trillion "in additional federal spending" over 10 years. Other conservative groups, like the Heritage Foundation, put the price almost as high. Last year, Heritage estimated the cost at \$32.6 trillion. The American Enterprise Institute warns that these cost estimates don't consider the number of health care-related jobs that will be lost. According to a recent article in The Washington Post, some economists estimate the number of jobs lost at 2 million.

About Medicare for All's price tag, the center-left Atlantic magazine said: "That's more than the federal government's total cost over the coming decade for Social Security, Medicare, and Medicaid combined, according to the most recent Congressional Budget Office projections. ... Over the next decade, the plan on its own would represent a nearly 60 percent increase in total expected federal spending, from national defense to interest on the national debt."

Under pressure, Warren recently revealed the cost of her plan: \$52 trillion over 10 years, including \$20.5 trillion in new federal spending. About Warren's plan and her promise not to raise taxes on the middle class, the executive vice president of Third Way, a "centrist" Democratic organization, said: "The gap between what she says it will cost and what it will really cost is in the trillions of dollars, and the middle class will be on the hook to fill that gap. My guess is that with accurate numbers, she's somewhere between \$5 trillion and \$10 trillion short. (Her plan taps) the rich and corporations as much as possible. Who's left? The middle class."

The Kaiser Family Foundation executive vice president for health policy told The Atlantic: "The only way to make that math add up is to pay doctors and hospitals and drug companies a lot less, as Warren has proposed. The fundamental question here is: Can you lower health-care prices enough to offset the increased costs from universal coverage and very comprehensive benefits?"

The answer to that question is an unequivocal yes, provided one doesn't care who pays, how much or whether a Medicare for All plan can actually achieve its objectives of insuring everyone for less money while maintaining quality. To Democrats, this isn't even a heavy lift. They believe there is such thing as a free lunch and the Republicans are stopping them from eating it.

If you're following the presidential race, you've heard plenty of sniping about Medicare for All and whether we can afford it. But when it comes to endless war or endless profits for Pentagon contractors, we're told we simply must afford it — no questions asked.

According to one study, even if universal health insurance didn't bring health care prices down — an unlikely worst-case scenario we'd need an extra \$300 billion a year beyond our current spending to provide full insurance for everyone.


Where can we find it? In a giant pot of money that's already rampant with waste and abuse: the Pentagon.

Right now, only about one quarter of the \$738 billion Pentagon budget goes to our troops. The rest is mainly three things: the cost of maintaining 800 military installations all over the world; lucrative Pentagon contracts, which account for nearly half of the entire Pentagon budget; and, of course, our never-ending wars in the Middle East.

According to my research, if we end those wars, shut down wasteful and failing weapons programs, and close unnecessary foreign bases, we could come up with an extra \$350 billion to spend on Medicare for All — without sacrificing security.

As experts of various political stripes will tell you, the U.S. military is carrying out a costly 20th-century security vision in a 21st century world. For instance, the Pentagon still keeps tens of thousands of troops in Germany and Italy. Maybe 75 years after the end of World War II (and nearly 20 years into our ill-fated Iraq adventure) is a good time to finally bring those troops home?

Closing 60 percent of our foreign bases would save \$90 billion a

Right now, those bases enable our endless wars. Troops rotate from Germany into the Middle East and Africa, and tens of thousands are stationed in the conflict-ridden Middle East at any given time. Yet our wars have only further destabilized the region. It's time we brought our troops home for good — and saved \$66 billion each year in the bargain

Then there are those highly paid contractors. For instance, the F-35 fighter jet is projected to cost more than the entire military budget of Iran. None of this is as radical as it sounds. Today, military spending is higher than it was at the peak of the Vietnam War. Even with a \$350 billion cut, it would simply return to levels from the late 1990s.

Together with common-sense cuts to runaway overhead costs, and by rolling current Pentagon health care costs into a universal health plan, we easily get more than the \$300 billion needed for Medicare for All.

Which would make us safer: Medicare for All or endless wars? The choice is ours.

It's time to regulate CBD

One in seven Americans say they use CBD products, according to Gallup.

The rising popularity of these products — which range from oils and gummies to topical salves and most everything in between — is staggering, especially when one considers that much of the public had never even heard of CBD two or three years ago.

CBD stands for cannabidiol, one of over 100 distinct compounds found in the marijuana plant. Unlike THC, it is not significantly moodaltering. Instead, many consumers believe the compound helps treat pain, anxiousness, and other ailments.

But Americans' exuberance for CBD could well be short-lived. That's because many products currently marketed under the CBD banner are of low or variable quality.

Back in 2017, the Journal of the American Medical Association reported that only 31 percent of commercially available CBD products contained percentages of cannabidiol that accurately reflected the products' labeling. Since then, little has changed.

An October 2019 analysis of 30 leading CBD products by the watchdog group LegitScript.com reported that two-thirds possessed significant deviations in CBD content from what was advertised. Typically, these products contained far lower percentages of CBD than the manufacturer promised — a finding that is woefully consistent with prior analyses.

Investigators also reported that some of the products evaluated in the LegitScript analysis tested positive for either solvent residue or elevated levels of heavy metals — findings that are also similar to those of prior reports.

Other analyses have identified even more problematic issues. Some CBD products, for instance, have tested positive for the presence of THC, the primary psychoactive constituent in cannabis, despite being advertised as "THC-free" — an oversight that could cost customers their jobs if they fail a drug test they expected to pass.

Most concerning, some CBD products have tested positive for added psychotropic adulterants — such as dextromethorphan or synthetic

cannabinoid agonists. Exposure to these latter agents, typically found in illicit so-called "synthetic marijuana" products like Spice, can lead to serious health consequences.

All this is rapidly creating a "buyer beware" environment for consumers — and potentially placing them at risk.

This situation persists because the federal government — and the Food and Drug Administration in particular — doesn't regulate either the manufacturing or testing of these products. Despite the presumption of most Americans, the commercial CBD market is entirely unregulated by the FDA.

This is because, until recently, federal law defined all cannabisderived products as illicit. Now, the FDA and other agencies are playing catch up, with the federal regulators estimating it could take years before the FDA finalizes rules governing the commercial CBD market.

This intransigence is no longer acceptable.


Currently, the heavy burden of overseeing the CBD marketplace falls solely on state regulators in jurisdictions that have legalized cannabis use. But these regulations are not consistent from state to state, and are often far from comprehensive.

Further, state-specific regulations typically only govern CBD products that are sold in licensed dispensaries or retail outlets that exclusively sell cannabis products. They may not cover products sold online or at gas stations, which are subject to virtually no oversight.

Congress facilitated the growth of the commercial CBD market by passing legislation in 2018 that, for the first time, recognizes the production and distribution of certain hemp-derived CBD products. But without federal rules, standards, and oversight, this new market is a wild west — rife with questionable players hawking low-quality or even fraudulent products upon a largely unsuspecting public.

The tens of millions of Americans soliciting this market deserve better. It's time for federal officials to set appropriate standards to govern this industry — so consumers can be assured, once and for all, they are getting what they pay for.

Downey declines to vote on tenant protections

Citing private property rights, the City Council declined to join other cities in stopping no-fault evictions.

DOWNEY – An attempt to establish a moratorium on no-fault evictions went for naught on Wednesday, failing to convince a majority of the council to side with several frustrated renters.

Rising rental rates and nofault evictions have been one of the city's hot-button issues for the last several weeks, stemming primarily from the concerns of tenants at the Eden Roc apartment complex.
