# Thousands of jailed inmates would benefit from treatment, study finds

**LOS ANGELES -** On any given day, more than 3,300 people struggling with mental health disorders in Los Angeles County jails are legally suitable and clinically eligible for diversion to community-based treatment programs, according to a new study by the nonprofit RAND Corp.

significant proportion of this population is likely to be homeless or at risk of homelessness.

Conducted in response to a motion by Supervisors Mark Ridley-Thomas and Kathryn Barger, the independent research noted about 5,400 of the County's average daily inmate population - nearly one-third -- are in mental health housing units and/or have been prescribed psychotropic medications.

Of the jail's mental health population, RAND concluded 61 percent meet the criteria currently used by the County's Office of Diversion and Reentry (ODR) to determine whether an individual may be put forward to the courts as a candidate for diversion. An additional 7 percent are also potentially eligible for diversion, while 32 percent are not, according to the

RAND said 74 percent of women and 59 percent of men with a mental health disorder in County jail are appropriate candidates for diversion.

RAND recommended expanding diversion programs and better tracking their outcomes. It also urged the County to improve its early diversion efforts, which may be able to help people before they enter the criminal justice system. For example, some jurisdictions intervene at the point of law enforcement contact.

"Knowing how many people are appropriate for diversion is a first step toward understanding the types of programs, staff and funding that would be needed to treat those individuals in the community," the study's lead author, RAND behavioral scientist Stephanie Brooks, said.

RAND's findings echoed those of ODR, whose own recent research concluded 56 percent of the County jail's mental health population is eligible for diversion, with an additional 7 percent also potentially eligible.

Since its creation in 2016, ODR has diverted more than 4,400 people from County jails to long-term care and supportive housing, with very low rates of reoffending. Among those placed in the ODR Housing program, 90 percent have remained housed after six months.

Diversion programs cost the County about \$70 daily per person, while incarceration costs about \$600 daily per person with serious clinical needs.

"No one can get well in a cell," said Supervisor Ridley-Thomas, who authored the motion that created ODR. "With diversion, we are creating better outcomes for people and saving County resources -- without compromising public safety."

"Diversion is also breaking the cycle between jail and homelessness, enabling those with mental health disorders to get treatment instead of the costly alternative of serving additional time behind bars and then being released with no support," Supervisor Ridley-"RAND's added. Thomas research underscores the need to double down on diversion to reach all those who could benefit.'

**NORWALK -** Plans for an affordable housing apartment complex aimed for veterans were approved by Norwalk's Planning Commission on Wednesday.

The 4-story project will be located at the southwest corner of San Antonio Drive and Foster Road, and will consist of 60 units.

The project is the product of a partnership between the city and Mercy Housing, a non-profit housing corporation.

The development is intended for extremely low, very low, and low-income veteran households. Further, Mercy Housing would provide long-term supportive services to the veterans and their families living in the apartments.

According to a city staff report, the development will service 20 formerly homeless veterans, 39 veteran families, now," said Collins. "These are and one on-site manager.

to concerns of safety, privacy, country." and traffic among other issues, did not agree with the location.

Vice Chair Scott Collins approved of the project, saying that he felt the pushback was due to "NIMBYism."

"We do face a challenge right veterans. They're not people committing murder, they could be druggies, and they could be recovering from drug addiction. They're not pedophiles or rapists, or the general things you hear all of a sudden when the word 'homeless' comes up. These are people who have served our

Commissioner Victor Lujan said he approved of the concept, but was sympathetic to the residents and took issue with the area. Ultimately, Lujan abstained from the item entirely.

The final vote came to 3-0, with Lujan declining to taking a side and Chair Rosa Barragan

The apartments will still need to get approval from City Council, who is currently scheduled to see the item at their meeting on Jan.

Board and care facilities have been closing at a rapid rate due to increasing costs and stagnant reimbursement rates from the state. At \$35 a day, reimbursement rates are often not enough for operators to cover the actual costs of caring for residents.

> Tuesday's motion coincides with Supervisor Hahn's announcement that the County Department of Mental Health had identified \$11.7 million in funds for immediate relief for local board and cares. This follows her November 12th motion with Supervisor Kuehl directing the Department to do so.

> Of the \$11.7 million, \$11.2 million will be used to support the 182 board and care facilities that serve the highest number of low-income residents. The funds will help these facilities make necessary deferred maintenance improvements such as bathroom renovations, roof improvements, installing air conditioning units, replacing carpets, and more. The remaining \$500,000 will be used to create a board and care membership organization whose members serve lowincome clients, so that board and care operators have a space to collaborate on tactics to best serve their clients.

# CDC survey takes closer look at diabetes within Asian, Hispanic populations

Demographic breakdown identifies specific groups at higher risk of diabetes.

In a study published recently in JAMA, CDC researchers examined the percentage of people living with diagnosed and undiagnosed diabetes in Hispanic and non-Hispanic Asian subpopulations.

The data fills a national surveillance gap in Hispanic and Asian populations in the United States.

"This landmark diabetes provides survey essential data that will better inform public health efforts to reach more Americans with tailored, prevention effective and treatment strategies," said CDC Director Robert R. Redfield, M.D.

The percentage of adults living with diagnosed and undiagnosed diabetes varied significantly by race/ethnicity and among Hispanic and non-Hispanic Asian subgroups. Broadly, the age-sex-adjusted percentage of adults living with diagnosed or undiagnosed diabetes was 22% in Hispanics,

prevalence of diabetes among 20% in non-Hispanic blacks, 19% Hispanic and Asian demographic for non-Hispanic Asians and 12%

> The United States is an increasingly diverse nation, as Hispanics and non-Hispanic Asians collectively now account for 23% of the US population and are expected to account for 38% by 2060, according to Census

According to researchers, these groups may be at higher risk for type 2 diabetes due to genetic, lifestyle and environmental

## Paging Dr. Frischer...

Bipolar disorder can be devastating. Previously known as manic

depression, it is a mental health condition that causes extreme mood swings.

Bipolar disorder affects almost six million

adult Americans, or about 2.6% of adults in the United States,

and roughly 60 million people worldwide. It most typically starts at around the age of 25, although it can begin in early childhood or as late as the 40's and 50's. It affects both men and women, and crosses all races, ethnic groups and social classes.

There are three major symptoms: depression, mania, and hypomania.

During times of depression, victims feel sad or hopeless, lose interest or pleasure in most

activities, feel a loss of energy, experience periods of too much or too little sleep, and may have suicidal thoughts.

When the mood shifts to mania, they experience an emotional high. They can feel excited, impulsive, and euphoric, have rapid pressured speech, difficulty focusing, and be full of energy. Due to this high energy, they will sleep little. They will likely be irritable and impulsive, and use poor judgment. Behaviors may include spending sprees, unprotected and frequent sex, and drug and alcohol use.

Hypomania is generally associated with bipolar II disorder. It is similar to mania, but not as

Episodes of mood swings may occur rarely, or happen multiple times a year. Depression tends to last at least two weeks. Mania can last for several days or weeks. It is possible to feel normal in between episodes. Those with bipolar disorder may very likely have trouble managing everyday life tasks such as school or work, and maintaining relationships.

While the condition is seen in equal numbers between men and women, the symptoms may differ. Women tend to be diagnosed later in life, have milder episodes of mania, experience more depressive episodes than manic episodes, experience other conditions at the same time (such as thyroid disease, obesity, anxiety disorder and migraines), and have a higher lifetime risk of alcohol

Men with bipolar disorder are often diagnosed earlier in life, experience more severe episodes (especially mania), act out during manic episodes, have substance abuse issues, and seek medical attention less often. They are more likely to attempt suicide.

Bipolar disorder is a lifelong condition, but a treatment plan of medication and counseling can help to manage mood swings and other symptoms. Mood stabilizers, antipsychotics, antidepressants, and anxiety medications may all be used for treatment.

Bipolar disorder is common, but what causes some people to develop it and not others is still a mystery. There is a strong genetic link; those with a family history of bipolar disorder are four to six times more likely than others to develop it. Stress, traumatic experiences, and physical illness may trigger it.

If you think that you're experiencing symptoms of bipolar disorder, I urge you to see your doctor. If you feel that a friend, relative, or loved one may be suffering from it, your support and understanding are crucial. Encourage them to see a doctor to discuss any symptoms they're experiencing.

# Flu can be dangerous for diabetics

Like everyone, people with diabetes get the flu and get sick sometimes, even when you try your best to prevent it. So being prepared and knowing what to do when you get sick is important. There are several things you can do now to prepare for sick days. But also talk to your doctor and health care team about the best way to handle sick days when they occur.

The single best way to protect yourself against the flu is to get the flu shot every year. Péople with diabetes—even pregnant women should get a flu shot. Make sure you get the flu shot injection, not the nasal spray type of vaccine. The vaccine is safe and effective. It has been given safely to hundreds of millions of people. You cannot get the flu from the flu shot.

One possible complication of flu can be pneumonia. Pneumococcal (pneumonia) vaccine is recommended for people with diabetes, and should be part of your diabetes management plan. Talk to your health care provider for more information on getting both vaccines.

Diabetes can make it more difficult for you to handle an infection like the flu. You could become very sick and may even have to go to

If you get sick, prescription flu medicine can make your illness milder and make you feel better faster. The medicine can help keep you from getting serious health problems that can happen after getting the flu. Flu medicine works best when started within 2 days of getting sick, so call your doctor as soon as you begin getting flu

If you get sick and have diabetes, your blood sugar can be hard to manage. You may not be able to eat properly, which can affect blood sugar levels. Your doctor may ask you to test your blood sugar more often because you are sick.

Keep good written records of your blood sugar, medicines, temperature, and weight. You may need to test your urine for ketones if your blood sugar goes very high.





# Joe Biden's flawed foreign policy resume

as the clear Democratic primary front-runner, yet President Donald Trump just threw a wrench — or a drone — at his foreign policy record. The president's assassination of Iran's top military commander in Iraq cracked open a messy egg in the Middle East, even as he awaits a Senate impeachment trial.

Trump's New Year's resolution for 2020 seems to be: Make tomorrow worse than today. He did not even consult with Congress on striking Gen. Qassem Soleimani. Iraq now wants all Americans out of the ravaged country. This would constitute a "lost war" — just like Vietnam, only longer. All in a day's work from Mar-a-Lago.

The crisis raises questions about who in the Democratic field can quell the fury and anxiety Trump causes in our enemies and allies. At 77, Biden is perceived as a steady, experienced hand, a line he is pressing hard.

"These events put into greater relief that we need a commanderin-chief who can, from the moment they're sworn in — and without needing on the job training — start repairing the severe damage that Donald Trump has done," a campaign spokesperson told The Daily

That's malarkey.

Biden's rusty foreign policy resume is a mile long, but it's not what you'd expect from someone who passes as a statesman with 35 years of senatorial experience. In a word, it's amateur. As vice president, Biden advised President Barack Obama against the successful Pakistan raid on Osama bin Laden.

Biden's old, but he was never wise — just an average Joe, truthfully. A good fellow folks like, especially in small town Delaware.

Most central to the fix we're in now, Biden voted for the Iraq War Joe Biden is picking up speed in Iowa and New Hampshire polls in 2002, after the Sept. 11 terrorist attacks, based on the falsehood that Iraq was hiding weapons of mass destruction. Nancy Pelosi, D-Calif., later House Speaker, did not fall for that George W. Bush claim. It took courage and foresight to vote against that war of aggression. Only 23 out of 100 senators possessed that wisdom. Few

> That chain of events set the whole century off on a dark note. If the 21st century had been a Broadway show, it would have closed by now. The Iraq War was a tragedy costing trillions of dollars, hurting our good will and place in the world. It depleted the Army on a mission that soldiers came to question.

> Like it or not, Biden bears a brunt of the blame for the Obama administration's failure to bring the wars in Afghanistan and Iraq to a swift, clean close as promised. These conflicts were left hopelessly undone for over eight years.

> Note the genial, garrulous Biden was the Senate Foreign Relations committee chairman and traveled the globe for years, living the high life with world leaders. As vice president, no doubt he was an affable emissary.

> Yet he failed to tell his son Hunter that taking a plum place on a Ukraine gas company board was poor judgment  $\stackrel{\smile}{-}$  for both of them. That may be an Achilles' heel if he becomes the nominee. Trump will gnaw at that issue, which Biden has been loath to confront.

> I covered Senate Democrats as a rookie reporter and found Biden talked the longest but said little of substance in floor speeches. As a freshman senator, Obama felt trapped in a committee hearing during an endless Biden soliloquy and wrote a private note: "Shoot.

Yet rising star Obama picked Biden as his running mate in 2008.



Sen. John Kerry, who, as secretary of state, negotiated the Iran nuclear deal, would have been the best pick for his eloquence, expertise and

Don't just take my word for Biden's weak, even inept, grasp of complex foreign policy. Take it from a man who sat in the Situation Room and the Cabinet Room, side-by-side with the vice president.

Obama's secretary of defense, Robert Gates, declared publicly in his memoir that Biden has "been wrong on nearly every major foreign policy and national security issue over the past four decades.

Boom. Biden's a nice guy, but he's already done his dance with the world.

The mansion was listed in early December last year by Hudson Partners Investment Brokerage for what was described as an "aggressive" \$2.9 million.

rocky year for the property in 2019, in which plans to refurbish and convert the site into office space were given the thumbs up, including the approval a highly controversial 1,200 square foot retail café building that was to be erected in front of the Mansion.

Despite significant the property. pushback from residents, owners Arturo Concha and Erika De La Teja were able to persuade both Downey's Planning Commission and City Council to approve the café, albeit at the cost of over 100 separate conditions.

# Whittier gives 10-day notice to Parnell encampment, will enforce curfew

WHITTIER - Whittier City Council avoided a complete shutdown of Parnell Park at their emergency meeting on Monday, opting instead to give encampment residents just over a week to vacate the park before staff begins clean-up.

The city will now give 10-days notice that a curfew will be enforced at Parnell, during which HOST (Homeless Outreach Stabilization and Transition) and any other service providers can come in and assist with any of those residing in the encampment who desire assistance. When those 10 days expire, the curfew will come into effect and the park will temporarily close so that staff can begin sanitizing the encampment area. Staff will also analyze the rest of the park to determine what other locations - if any - will need similar treatment.

How long the closure will last will depend on how long staff feels they need to sanitize the area. Once completed, the park will reopen with the curfew maintained.

It was not an easy road to the decision, as council members butted heads on more than one occasion while attempting to find a reasonable solution. Even the final vote was not unanimous, only earning a seemingly begrudging 4-0 vote. Councilwoman Cathy Warner abstained, voicing that she could neither vote yay or nay due to her feeling that the motion "did not go far enough."

Warner called for discussion of the park's closure after 22-year-old Corinna Megan Ortega was found dead of a suspected overdose inside of a tent within the encampment on New Year's Day. However, matters were arguably only made more urgent after a confrontation with an older Hispanic male and one of the encampment's residents ended

in alleged gunfire over the weekend.

Councilman Josue Alvarado said that he "didn't agree with this emergency meeting.

"Has this issue been there for the last year and a half? Yes," said Alvarado. "I think we should have handled this back in October; we could have handled this many months ago."

Mayor Pro Tem Fernando Dutra said that it was "absolutely clear that there is more work to be done."

'This is a short-term way of fixing it," said Dutra. "Long term is we need to establish mental health and detox assistance."

The homeless crisis has been a sticking point for Whittier and its residents for over a year, with the city reluctant to take any action on the homeless encampment that has established itself there for fear of drawing a costly lawsuit.

Residents filled the council chambers to capacity and spilled out to the main lobby on the first floor. Before a decision could be made, Council fielded comments from residents for nearly two hours.

Amongst that crowd was an extremely emotional Betty Thorpe, Oretga's mother.

"You will never know the pain that I am feeling right now that my daughter's life was taken," said Thorpe. "I don't want anyone else to get hurt; Megan, my baby girl, wouldn't have wanted any of this to happen to anyone...There are still things going on at the park - horrible things going on at the park - that I have to listen to, and I can't grieve in peace, because people are trying to hurt others and it's not right. It's so unfair."

Thorpe went on to plead for the council and residents to show sympathy for those in the encampment.

"They're not all bad people, said Thorpe. "They have this area where they're kind of stuck at now because they don't have anywhere else to go. I understand your concerns as residents, but it doesn't make sense that the residents in the area are going around yelling at them and driving their vehicles on the grass to hurt them. They're scared now; they're victims now."

"Try and get to know them and understand where they're coming from and why. Maybe that will give you more compassion in your heart."

Although there some who mirrored Thorpe's sentiments, a vast majority of the crowd supported at least some sort of change in procedure, citing multiple instances of being approached or harassed, witnessing public defecation, and finding drug paraphernalia.

You guys want to close the park, but I feel like the park is already closed," said one resident. "In my opinion, the park is already closed to our kids, and you're opening it up to drug addicts and you're not going in there to clean them out. I call on a daily basis... When are the parks going to open up for our kids, and not for the trash that's there?'

'I'm sorry about the family that lost their daughter that lost her life, but something needs to change and it's not happening. It's getting worse, and I want the park back for our kids, not for them."

A final vote is expected at council's meeting next Tuesday.

# Larry Knight Stover January 29, 1919 - December 1, 2019 Larry Knight Stover age 100 passed awa



Larry Knight Stover age 100 passed away on December 1, 2019 at Downey Acute Care Center in Downey, CA. His ashes will be interned at Arlington National Cemetary on January 27, 2020. Larry was born in Safford, AZ on January 29, 1919 to Harold Stover and Lodemia Swanger Stover. He was raised on a farm in Hemet, CA and was the oldest of seven boys with six brothers Jack, Grant Albert, Harold, Lynn and Richard all of whom preceded him in death. In 1940 he met and married Verna Faye Franklin. They quickly had two children Patricia Lee and Kenneth Ray Stover. The family left Hemet and relocated to the southeast region of Los

Angeles County where he was hired at Joslyn Pacific Company, a metals manufacturer in Los Angeles CA. He was drafted into the Army when WWII broke out and served for 4 years in the Pacific Islands.

After his discharge from the Army he returned to work at Joslyn. He started as a line worker and while doing that took correspondence courses in mechanics and electronics. He thrived in both areas and rose up the ranks to become Maintenance Superintendent where he repaired large heavy equipment machinery. His grandson Jim recalls when he worked a summer there in high school that many workers remarked at how intelligent a man his grandfather was.

After renting in South Gate, Larry bought a new home for the family in Norwalk, CA with a VA loan. The family was the first to have a television set on the block and Larry constructed a pool in the backyard which hosted countless parties with family and friends. Always self-educated Larry developed an interest in health and nutrition eating less red meat and consuming more fruits and veggies and taking vitamins. When a channel 7 reporter asked him at his 100th birthday party last year what he attributed his longevity to, he replied healthy eating, vitamins and a little beer.

Pat and Ken had three children each and the six grandkids became a strong focus of Larry and Verna. He was also very close to his mother Lodemia "Dee Dee" who died in 1981. The Joslyn plant closed in 1981 and Larry was the last employee at the plant dismantling the plant equipment for use at other locations. In 1984, a new buyer bought the building and asked Larry to revive the building which had fallen into disrepair. So began another 25 years of employment with Pacific Coast Chemicals at the same building at 5100 District Boulevard. He worked in that building for 65 years between the two companies. He retired in 2009 at the age of 90. He lost his beloved wife Verna in 2000 and survived her for nearly 20 years. He also lost his son Kenneth Ray Stover in 2010. Ken was a chip off the old block inheriting his fathers mechanical aptitude and having a successful career in the Air Force. We all can agree that Larry was a remarkable man and everyone who met him was in awe of his abilities, work ethic and vitality. He lived very simply preparing home meals for himself and declining to go to restaurants or take vacations. Instead his retirement was filled with constant reading, listening to talk radio, watching cable television and monitoring his health markers. All of us will miss Larry, he was a rock in the Stover family and he will join his loved ones in heaven. The house on Hermes is going to be sold after 68 years and we will remember all the memories made in that home. We love you Grandpa and we'll miss you dearly.

# Suspense author Tori Eldridge 'Homing' is haunting tale of redemption and forgiveness

Author's memoir tackles **CERRITOS** - Meet suspense Dumpling," which was featured Sensitive material including mental illness, as writer comes to terms with troubled childhood.

**DOWNEY -** How easy is it to forgive those who have dealt you an immense amount of hurt and anger? Homing, a Memoir answers this question against a backdrop of 1950's Southern California.

Homing lifts the veil on the dark, turbulent life of then 14-year-old Mark Lyons.

Now 77, Lyons says that the book first came to be when his son was 14.

"Often what a lot of parents do, including myself, when you have kids and they're a certain age you think 'What was I doing when I was 6, or 14,'" said Lyons. "I started thinking about what my life was like when I was 14. The backstory is when I was 14, my mother became mentally ill and stated being institutionalized a lot. Our whole family disintegrated."

While his mother was institutionalized and being treated through methods such as electro-shock therapy, Lyons says that his father – in his focus on taking care of his ailing wife basically abandoned him and his

"It's one of those things that as a teenager filled me with a lot of rage and loneliness," said

Lyons began to try and uncover other, more pleasant elements of his life, including playing with friends in the old

orchards that used to occupy Downey and tending to his own personal pigeon coop.

"I just started writing," said Lyons. "This was like 1995. I just started writing those memories. In a way it was sort of reclaiming my childhood, because all I remembered from my childhood - which I really tried to distance myself from - was the pain and the loneliness."

"I started to build a fuller life for 14- and 15-year-old Mark."

Lyons says that he wrote for around five years, and in the process fell in love with the craft of writing. However, his newfound passion became a bit of a stumbling block in terms of his

"I realized I was starting to fudge stuff; you know, make up stuff, make it more sexy," said Lyons. "You can't do that in a memoir, so I put it away and started writing fiction. Eventually, I published a series of short stories in fiction. And then I put it away for 20 years, almost.'

Fair warning: Homing is not for the faint of heart. It, at times, deals with the dark and twisted reality that came with Lyon's mother's mental instability.

"Come to find out, there were all these secrets," said Lyons. "Two of the big secrets were that my mother had all of these sexual fantasies about me, that she made my father tell me about. The other secret was that my younger sister...was probably the daughter of our family's best friend."

"This is sort of the stuff of TV melodrama."

The book also explores the "other worlds" and "sanctuaries" that Lyons would occupy himself with in his attempt to isolate himself away from his family and miserable reality.

Lyons was eventually able to "flee home" to Berkley, and beyond that, the east coast,

escaped.'

was terrified relationships. I was convinced that the reason my mother ended up in the mental hospitals was because of me," said Lyons. "For years, I really struggled to have healthy relationships with women...and I was absolutely sure that my older son would flee me himself the way I did my

Lyons added that he "was sure that he'd go crazy" as his mother did when he turned 40.

It wasn't until much later on that Lyons was able to realize that he had "escaped the vortex of my mother's craziness."

Twenty years later after initially putting it down, Lyons was able to return to his memoir and begin adding to it once more.

More than just a reflection of

however he says he "never really his life, Homing also serves as the symbol of Lyons' forgiveness.

"It was sort of a journey...of forgiving her," said Lyons. "But in some ways, I realized this was a journey of forgiving myself for never having forgiven her."

Homing also gives a peek into the setting of the orange groves that have long since gone from

"People who have read my book have said, 'Boy, the place of Downey and Southern California was really important to you," said Lyons. "We were surrounded by orange groves, and we went through orange groves to get to school; every place I went. You have to go 60 miles south to see any orange groves now, but that was sort of the magical world that was Downey for me."
