Martin Luthern King Jr. Day: A day of service and Action

This week we remember the remarkable life of Dr. Martin Luther King, Jr. We pay tribute to his dream that one day, children would live in a nation where they would not be judged by the color of their skin, but by the content of their character. But this commemoration is not just about remembering a man who had a great impact on our nation.

It is a day to celebrate Dr. King's legacy by engaging in community service. In fact, the national theme of Martin Luther King, Jr., Day is, "Remember! Celebrate! Act! A Day on, Not a Day Off!"

It is intended to encourage everyone to dedicate the day to community service and make their communities better places. If you look around, you can see Dr. King's legacy embedded in the culture and values of our society, our military and our Army.

Every time you see nonviolent demonstrations marches aimed at focusing attention on justice, civil rights and fair treatment for every individual you can relate to Dr.

Our military, our Army is committed to the ideals endorsed by Dr. King – to treat every individual with dignity and respect.

Born as Michael King, Jr. on January 15, 1929, in Atlanta, Georgia, Martin Luther King, Jr., was the middle child of Michael King, Sr. and Alberta Williams King. His father and maternal grandfather were both preachers. King's maternal grandfather, A.D. Williams, helped found the Atlanta chapter of the National Association for the Advancement of Colored People and pastored the Ebenezer Baptist Church. Membership grew from 13 in 1893 to 400 by 1903, turning the church into a thriving congregation.

When Rev. Williams died in 1931, Michael King, Sr. became pastor of the church and adopted the name Martin Luther King, Sr., in honor of the German Protestant religious leader, Martin Luther. Michael, Jr., followed his father's lead and took the name Martin Luther King, Jr., for himself, and followed his father and maternal grandfather attending by Morehouse College. King earned a sociology degree from Morehouse College in 1948 and then went on to Crozer Theological Seminary in Chester, Pennsylvania. He graduated as valedictorian of his class in 1951.

During his time in the seminary, King was influenced by Morehouse College President Benjamin Mays, who was an outspoken advocate for racial equality. His views would shape King's own nonviolent activism. King went to Boston University for doctoral studies and while there met Coretta Scott, who was attending the New England Conservatory. They married in 1953 and had four children. In 1954, King became pastor of the Dexter Avenue Baptist Church in Montgomery, Alabama. He completed his Ph.D. the following year, at the age of 25.

On December 1, 1955, Rosa Parks boarded a Montgomery city bus to travel home from work. She sat in the middle of the bus in the first row of the "colored" section. As the bus became more crowded, the driver demanded that African Americans give up their seats to white passengers. In a decision that would change history, Rosa Parks refused and was arrested.

That night, the Montgomery NAACP chapter met with local civil rights leaders and launched a citywide bus boycott led by Dr. King. African Americans in Montgomery, Alabama, joined together to challenge and change the city's policy of racial segregation on its public transit system. The Montgomery Bus Boycott lasted over a year. During this time, police arrested and jailed Dr. King. Boycotters were physically attacked. Homes and churches were firebombed. But



The Warren Strategy

What a coincidence. With less than three weeks to go until the Iowa caucuses, we suddenly learn about a meeting that took place a year ago, with only two people in the room. She, Sen. Elizabeth Warren, told him, Sen. Bernie Sanders, she was running for president; he allegedly told her that a woman couldn't win, which is a weird thing to say to a woman who has told you that she is running, but even so. It's a fair question I've been trying to answer for a few decades.

Americans don't want to admit that they are uncomfortable. They tell pollsters in overwhelming numbers that, of course, they don't discriminate. That's not the question you need to look at. The killer is that in a recent poll, only 33% believed their neighbors would vote to elect a female president, and those numbers have been holding since I started following them 20 years ago.

Which, if you ask me, is why Hillary Clinton lost. Donald Trump was a much easier candidate to beat in 2016. A fast-talking billionaire with no claim to success in the public sector, a guy who boasted about how he had such an easy time seducing (or worse) women he should have lost. Former Presidents Bill Clinton or Barack Obama would have cleaned his clock, but in fairness, so would former Vice President Al Gore, former Secretary of State John Kerry and maybe even former Vice President Joe Biden. So why not Clinton, one of the most qualified candidates ever to run, one of the smartest and most accomplished women of the baby-boom generation?

I know. It's not a lesson about women but about this particular woman. I don't buy that. I've never heard of a male candidate being attacked because he was ambitious; of course he was ambitious,

or he wouldn't be running for president. I've never seen a man pilloried the way Sen. Amy Klobuchar was when she first announced her candidacy. Story after story quoted former staff members complaining that she was difficult to work for. Klobuchar has gotten more done in the Senate, with colleagues from both sides of the aisle, than almost anyone in the Senate. So maybe she is difficult to work for, and I know what that's like. But really, why should voters care, or care very much? She obviously plays well with others. Why hasn't Klobuchar taken off? Could it have something to do with her not being the right woman either? Exactly what would the right woman

Warren is a very good politician. Instead of getting into an onscreen debate about what Sanders said, she took on the idea that women can't win by pointing to the success of the two women on the stage with unbroken win records.

Fair enough — if it had anything to do with beating President Donald Trump. Warren has won — in Massachusetts. And Amy Klobuchar has won — in Minnesota. We're talking about states that go blue when the rest of the country is turning red.

And, sadly, there is still a big difference between being elected to a legislative position (which women have been doing very well) and being elected to govern. In fact, neither major party in Minnesota has ever nominated a woman for governor. In Massachusetts, the only woman to serve as governor was acting Gov. Jane Swift, who filled out the term of the incumbent governor when he was confirmed for an ambassadorship. California, which has sent Dianne Feinstein and Nancy Pelosi and Kamala Harris and Barbara Boxer and Maxine Waters to Washington, has never elected a woman governor. Los Angeles, where I live, has never had a woman mayor. New York City has never had a woman mayor, and New York state has never elected a woman governor, even though Hillary Clinton and Kirsten Gillibrand won cleanly for the Senate.

I understand why Warren took on Sanders. This is a campaign, and with them dividing the lefties, Biden can win, or not lose, with a much smaller percentage of voters. That's politics. But it was after the debate, when Sanders stuck out his hand to shake Warren's and she refused to shake back, that I felt bad for Sanders. He was trying to rise above it, and she very visibly would not, and the post-debate brush-off was much discussed by all the pundits and noticed by

Whatever he said, or didn't, a year ago, it's no reason not to shake hands. That's not very gentlemanly, and it's certainly not very ladylike. Everyone else on the stage was shaking hands. In the vise in which a woman must operate, neither wimpy nor nasty, tough but not too tough, strong but not mean, Warren's decision not to shake Sanders' hand says more about her electability than anything that was said onstage.

A tangled web of deception

When witnesses testify in a courtroom and offer varying, contradictory or even unlawful explanations of the events under scrutiny, juries tend not to believe them. The same is now happening with the Trump administration's defense of its killing Iranian Maj. Gen. Qassem Soleimani by the use of an unmanned drone while he was being driven peacefully along a public highway in Iraq two weeks ago. Why the shifting justifications?

Here is the backstory.

The general was the commander of Iran's elite military and intelligence forces. He was a fierce opponent of ISIS and the American military presence in Iraq. Iraq and Iran were belligerents for generations owing to, among other factors, ancient disputes between the two main branches of Islam, Shiite and Sunni. For generations, Iran's elites were predominantly Shiite and Iraq's were predominantly Sunni.

When the U.S., under President George W. Bush, invaded Iraq in 2002, pursuant to a congressional Authorization for Use of Military Force, the government did so by deceiving the American public and Congress into believing it was searching for weapons of mass destruction. Since none was there, none was found.

But it did destroy the Sunni government and its true target, the Iraqi dictator Saddam Hussein. That created a power vacuum, which was soon filled by Shiite politicians. Slowly but inexorably, Iran's and Iraq's governments became friendly and they jointly sponsored militias against ISIS. Soleimani even consulted with President Barack Obama in the Oval Office about using these militias to topple ISIS

The general's assassination was odd, out of place, untimely and unlawful. Odd, because the general's folks had worked with our intelligence folks in Iraq against ISIS. Out of place, because the Iranian general was welcomed by the Iraqi government and was not engaged in any violence or war crimes at the time he was killed. Untimely, because whatever he may have been planning to do was not an imminent attack on the U.S. or on Americans. We know this because Trump administration officials revealed that the president gave the kill order seven months ago, in June 2019. How imminent could an attack have been in June if it had not occurred by January?

And unlawful, because we are not at war with Iran, and political assassinations have been prohibited by still valid executive orders signed by Presidents Gerald R. Ford and Ronald Reagan. The U.S. Constitution limits the federal government's lawful power to kill to foreign troops in wartime and after due process, neither of which abides here. Moreover, international treaties to which the U.S. is party, as well as the laws of war to which the U.S. subscribes, prohibit preemptive killings except when the target is just about — "certainty" is the standard — to strike.

Now, back to the shifting sands of justification.

Shortly after the general's death, Secretary of State Mike Pompeo argued that Soleimani's attacks on Americans were imminent. President Donald Trump himself claimed Soleimani was planning to attack four U.S. embassies in the Middle East. When Secretary of Defense Mark Esper was asked if he saw any intelligence data about attacking four embassies, he said he had not. When Pompeo was pressed for his understanding of Trump's four embassies claim, he offered that the intelligence data did not reveal when or where or how, but he knew Soleimani was "probably" up to no good.

When the State Department spokesperson was asked if any alerts of likely attacks had been sent to any American embassies in the region, she said that none had.

Then the White House sent CIA Director Gina Haspel, Joint Chiefs of Staff Chair General Mark Milley, and Pompeo and Esper, to brief members of Congress on the administration's intelligence, moral and legal justifications for killing the general. None of the briefers mentioned four embassies or any data showing where or when or how he might strike — just probabilities. When Republican Senators Mike Lee and Rand Paul challenged the briefers, the president weighed in with a startling tweet on Monday:

"The Fake News Media and their Democrat Partners are working hard to determine whether or not the future attack by terrorist Soleimani was "eminent" or not, and was my team in agreement. The answer to both is a strong YES, but it doesn't really matter because of

That boast of killing the general "because of his horrible past" sent off bells and whistles in the Department of Justice. Trump's retribution argument does not legally justify killing a person who is not engaged in violence at the time of the killing, and, arguably, is a war crime

Thereupon, Attorney General Bill Barr revealed that the DOJ had been consulted on the lawfulness of the killing and signed off on it if the general's attacks on Americans were imminent. Now that the imminence argument had been undermined by the administration's own folks — including the president himself — the attorney general argued that Soleimani needed to die as a deterrence to others pursuant to the old 2002 AUMF.

These shifting justifications are contrary to reason and cannot survive a simple cross-examination. When did we start killing generals from countries with which we are not at war? Never in our history. When did we start killing foreign generals because of their "horrible past"? Never in our history. How can the government use the 2002 AUMF, whose stated target was Iraqi WMDs, but whose true target was Saddam Hussein, as a legal justification to kill a non-Iraqi general 18 years later? Except in the minds of extreme administration loyalists, it cannot legally or rationally do so.

Why is truth always the first casualty of government violence?

The passage of Assembly Bill 5 (AB 5) has had ripple effects across the state - and the country - likely far bigger than the bill's sponsor, Assemblywoman Lorena Gonzalez-Fletcher, could have ever imagined. The working-class families impacted across the state may never be the same, and sadly, this is not the first time that Gonzalez-Fletcher's support for a particular policy has negatively affected the lives of workers. But, hopefully with proper public pressure, this will

The public outcry regarding AB 5 started almost immediately. The bill was signed into law on September 18, 2019. A week later, the Los Angeleno reported that Uber drivers would rather quit than be classified as employees. Within a month, Forbes posted about 3093, and 3094. This legislative package would have decertified a how this bill would have a major impact on the current franchise union (like the UFW) if they abandoned farm workers for more than model, given how franchisees have long operated as independent

The law was also panned by some journalists, and this is after the press received a carve out in the bill that allowed them to do 35 assignments per news outlet each year while still being classified as an independent contractor.

The backlash to AB 5 was immediate, severe, and came from different sectors all across our economy. Due to the public and frequent outcry by working-class people throughout the state, action is already being taken to minimize the negative impacts of the law, with "tens of thousands" of app-based drivers hoping to secure an exemption to AB 5 through a ballot measure and a California court recently ruling that truck drivers are excluded from AB 5.

Hopefully, the same type of public attention will also be put towards Gonzalez-Fletcher's anti-farm worker record.

What many Californians might not know is that despite Gonzalez-Fletcher boasting about how she is on the side of workers, like she has with AB 5, she took several votes over the past few years that have put her on the exact opposite side of farm workers.

During the last legislative session, Assemblyman Jim Patterson introduced a set of bills that would provide farm workers with more is now legal protections and rights, which were sorely needed after an incident in Fresno that Gonzalez-Fletcher was abundantly aware of.

The United Farm Workers (UFW) union had entered into

discussion session the union disappeared and was not heard from for

Once the UFW did return, they tried to force a contract on workers that was government-written and would have lowered the workers' take home pay, without giving the farm workers a chance to negotiate. When the farm workers organized and held a vote to decertify the union, the union alongside the CA Agricultural Labor Relations Board tried to throw out the farm workers' votes. Thankfully, due to a California court order, the votes were counted and the farm workers successfully decertified the UFW.

As a response, Rep. Patterson introduced Assembly Bills 3092 3 years, given workers a say in contracts before they can be imposed upon them, and would have required a judicial review before farm workers union election votes could be thrown out.

Not only did Gonzalez-Fletcher oppose this legislative package, she spoke out against the policies during the Assembly Committee hearing on the bills.

Gonzalez-Fletcher deserves all the negative attention she is receiving as a result of the consequences of her bill, AB 5. But we should not forget about the farm workers, who don't have expensive lobbyists like Über or extensive platforms like journalists. Gonzalez-Fletcher had an opportunity to fight on behalf of them, and be their champion, but decided to side with union bosses instead. Thankfully, organizations like Pick Justice Action are working hard to highlight her record and are being the real champion that farm workers

The time to fight climate change

Dear Editor:

Martha Morrissy ("Fix the Homeless Crisis before Worrying About Climate Change," Letters to the Editor, 1/9/20) has a point, we need to spend more to address the homelessness crisis; however, we should not take it from fire prevention, water and sea-level protection, and other measures to mitigate the effects of climate change.

The cost of climate change already impacts all of us. Ms. Morrissy said that she read that with one volcanic eruption, 5 years of manmade efforts to protect changes in the climate would be wiped out. This is backward. Volcanoes emit sulfur dioxide into the atmosphere which reflects solar radiation and cools the climate. When the Philippines' Mt. Pinatubo erupted in 1991, it spewed 20 million tons of sulfur dioxide into the atmosphere, which had a measurable impact: global average temperatures dropped by nearly a degree Fahrenheit during the next two years.

The Paris Climate Accord aims to hold global warming on Earth to 2 degrees Celsius (3.6 degrees Fahrenheit) warming above the average temperature at the beginning of the Industrial Revolution in 1750. However, 1.5 C (1.7 F) warming is really the safer limit, and we have already exceeded 1 C (1.8 F). Even if all nations followed their Paris pledges we would still be headed for over 2 C (3.6 F) increase; unfortunately, most countries, including the U.S., have not kept their pledges, so we are headed for a 3 C (5.4 F) or more temperature rise, which will be catastrophic for future generations.

The last time the climate was 2 degrees C. hotter, 120,000 years ago, the oceans were 20-30 feet higher than today. Do we really want to have oceans 20 feet or more higher when most of the human population lives in cities near the coasts? Where will the people who live there move to, and won't this worsen the homeless problem that justifiably concerns Ms. Morrissy? This is not a far-off concern, as local beach cities are already planning to raise sea walls to protect their residential and commercial properties: who will pay for this? And what will this do to our local economies?

The Energy Innovation and Carbon Dividend Act (HR 763),


legislation supported by Citizens Climate Lobby and 76 members of Congress, proposes a carbon fee which is returned to American families equally via a monthly dividend. Economists feel that such a fee is the fastest way to reduce greenhouse gas emissions to safe levels. Helen Burns (No Such Thing as Free Money, 1/9/20)) is concerned that the money collected from raising the price of fossil fuels won't come back to us and that administrative costs will be too high. But HR 763 requires all the money collected to go back to people's pockets as a monthly dividend check; it also limits administrative expenses to 2.6% after a five-year startup period when the limit is 8.6%. In 2018, the Social Security Administration reported administrative fees of 1.9% of total revenue, so HR 763's limits are reasonable; and, as we know, Social Security is a very popular program.



Downey approves 90-day pilot scooter program

By Alex Dominguez **Staff Writer**

DOWNEY - Downey residents will have another option to cruise around the city, thanks to a 90day pilot electric scooter program approved by the city council on Tuesday night.

Shared scooters first entered the conversation back in September last year, when Downey Councilmember Alex Saab pitched the idea after utilizing similar programs in other cities.

This comes after the Zagster bike program – which was implemented earlier in 2019 – received mixed reviews.

Fifty scooters will now be deployed starting Feb. 28. An additional 50 scooters would be deployed after, completing phase two by mid-March.

The Sun Scooter Company will move each scooter into the designated area every morning and make them available between 5 a.m. and 2 a.m. each day. During off hours, scooters will be collected and stored at a

Riders 18 and older (and with a valid driver's license) can rent a scooter for one dollar, and ride for 15 cents per minute. Upon conclusion of their ride, renters will be required to take a photo that the bike is correctly parked. Failure to do so will result in contact by the Sun operation

Scooters max out at 15 mph.

Scooter reservations can be made using an app available on iOS and Android devices.

The city will also benefit from scooter usage, receiving 20 cents per ride. Based on an average of

six rides per day per scooter, the staff estimates that the city could receive \$9,780 during the 90day program, and by extension, potentially \$43,800 per year.

The program received a thumbs up from four of the five council members, only failing to persuade Mayor Pro Tem Claudia

"I definitely like this idea... we've seen these in many parts of the country," said Frometa. "When we look at Washington, D.C., and they have the National Mall, and they have a very large area to ride this. Here in the city of Downey, there are those limitations; we don't have such large areas where we can ride

Frometa added that there seemed to be too many liabilities involved for such limited use, and thus the program was not a good fit for Downey.

"We've been dealing with excessive speed in those main thoroughfares Lakewood, Paramount, Gallatin we see it in some portions," said Frometa.
"My tendency is - while I definitely appreciate, and I like this idea - I have more concerns about bringing this into our community because of all of the risks and all of the problems it can represent..."

However, her colleagues figured the program to at least be worth a try.

"It may not work; the community may not embrace it, it may not make financial sense, said Saab. "I've used the scooters many times when I travel, I look forward to using it.

"When I proposed it, I thought let's try it out...if it doesn't work,

Empty county building to become emergency shelter

SAN PEDRO — The Los this endeavor." Angeles County Board Supervisors unanimously approved a plan today proposed by Supervisor Janice Hahn to use a vacant county building in San Pedro as an emergency homeless shelter for three years.

The shelter will have 40 beds for 20 men and 20 women, 24/7 security. medical staff on-site. mental health services, and housing navigators who will connect residents with long-term housing that meets their needs. The shelter will operate for three years after which construction will begin to transform the site into a proposed mixed-use housing development.

"This is an empty county building and there are people sleeping in tents on the sidewalk outside. It makes sense to turn this building into a shelter for three years, bring people inside, and get them the services they need," said Hahn.

The shelter plan has recently gotten the unanimous support of both the San Pedro Chamber of Commerce and the Central San Pedro Neighborhood Council Committee. Homelessness Members of both organizations attended Tuesday's board meeting to speak in favor of the project.

"When the Supervisor established a plan to tackle the most difficult instances of homelessness in the Harbor Area, our members stood up and got behind it," said Lee Williams, Chairman of the San Pedro Chamber of Commerce. "We know what this won't be easy, but we are offering our full support in

The county has awarded the contract to operate the shelter to local service provider Harbor Interfaith. The Los Angeles County Department of Health Services will serve as contract

"This is the correct location and the correct service provider to make this project a success," said San Pedro resident and longtime advocate Amber Sheikh Ginsberg. "I've said before that beds don't bring people inside, relationships do - that coupled together is what really solves (homelessness). Harbor Interfaith has the best relationships with our homeless individuals on the street and is absolutely the best option to be providing the services for this temporary shelter."

The vacant site is located at 122 W. 8th street in San Pedro and was previously used by the Los Angeles County Department of Public Health. There is a large homeless encampment on the sidewalk outside of the building and outreach efforts will focus on bringing the residents of these local encampments into this shelter.

The building is in good condition and needs minimal work before it can be opened to shelter residents. The Board authorized the Department of Public Works to do any necessary repairs, refurbishments, or remodel for an initial \$200,000 and any additional work not to exceed \$100,000.

The shelter's operations will be funded using available Measure

"In the Cart Containment plan, what we are suggesting is that we require the grocery stores and department stores to insert disabling devices on all the carts...or they can use the method that Aldi's uses, and that's a security deposit,' said Community Development Director Aldo Schindler during his presentation to council.

Regardless of which direction they choose, all relevant businesses will also be required to train their staff in regard to the new containment plan, as well as maintain any lock systems that they may utilize.

in the end, the perseverance of the boycotters resulted in the Supreme Court's decision that the laws requiring segregated buses were unconstitutional, and spurred the national Civil Rights Movement.

Following the Montgomery Bus Boycott, King invited African American ministers and leaders to Ebenezer Baptist Church in Atlanta to organize, coordinate and support nonviolent actions to end segregation. They formed the Southern Christian Leadership Conference, or SCLC, with Dr. King as its president.

King said, "Nonviolence means avoiding not only external physical violence but also internal violence of spirit. You not only refuse to shoot a man, but you refuse to hate him.'

After the Birmingham demonstration, King and his supporters planned a massive demonstration in the nation's capital to ask for and embrace peaceful change.

The March on Washington on August 28, 1963, brought more than 200,000 people to D.C. Here, in the shadow of the Lincoln Memorial, King gave his famous "I Have a Dream" speech. "I have a dream that my four children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character." The Civil Rights Movement continued as more and more people began to question Jim Crow laws and the unequal treatment of African American citizens.

The Civil Rights Act of 1964 authorized the Federal Government desegregation accommodations and outlawed discrimination in publicly owned facilities. In 1964, at the age of 35, Martin Luther King, Jr. received the Nobel Peace Prize. In his acceptance speech, he said, "I refuse to accept the view that mankind is so tragically bound to the starless midnight of racism and war that the bright daybreak of peace and brotherhood can never become a reality."

King continued his fight for Civil Rights until his assassination on August 4, 1968. Today his legacy lives on, inspiring men and women of all races to seek equality, tolerance and justice.
