### Reporter urges **Americans** to subscribe to local newspapers

The shrinking presence of local news across the United States may be dividing the country, Miami Herald reporter Julie K. Brown said Sunday on CNN's Reliable Sources.

"With these smaller newspapers drying up across the country, it is creating a collapse of local newspapers and local news and the kind of information (they provide) around the country," said Brown, who is known for her reporting on accused sex trafficker Jeffrey Epstein. "Because there isn't the number of voices and the number of local newspapers, (that) has contributed to the divisions that we're experiencing around the

Brown's comments come just days after the Herald's owner, McClatchy (MNI), filed for bankruptcy, throwing the future of her paper and 29 others across the country into question.

It's the latest in a yearslong decline of local news. Late last year, US newspaper giants Gatehouse and Gannett merged, leading to job cuts and consolidating hundreds of the country's daily newspapers under one company. Around the same time, hedge fund Alden Global Capital became the biggest shareholder in Tribune Publishing, which owns the Chicago Tribune, the Baltimore Sun and the Hartford Courant, among others. Staffers protested decision and Tribune Publishing has already offered a round of buyouts to employees

Labor Department data show that jobs at newspapers have fallen every year since 1998, a net loss of nearly 300,000 jobs during that period. That represents a nearly 70% drop in employment.

McClatchy said it plans to stay in business and emerge from bankruptcy in the next few months. The company had been trying to reduce operating expenses, but it wasn't enough. It posted a net loss in the hundreds of millions and a revenue decline of 11% in the first nine months of 2019. It plans to use bankruptcy to reduce legacy debt and pension obligations, and that the process will help it transform more quickly into a digital news company.

Brown said that while staffers at the Herald — a Pulitzer Prize winning newspaper regarded for its investigative reporting — are staying hopeful, the future of the paper is "an unknown."

"I don't think we know what the impact is going to be," Brown said. "We've seen this around the country where some of these other chains have been bought up by hedge funds and, in some cases, they've dismantled some of these local newspapers. So of course we're hoping that won't happen to our paper and the papers that are owned by McClatchy.'

Media industry analyst Ken Doctor said the trend of hedge fund ownership could be troubling for the long term success of local news.

"Clearly, reader habits have changed, but this isn't news, it's 2020. This has been a transition that has not worked, these companies are dependent on print," Doctor said Sunday. Still, he said there is money to be made from owning newspapers — at least in the short term.

"The people who are making it are the people who are willing to make those tough decisions and cut into the product knowing that they're not building a product for tomorrow, but taking the money in the short term,' Doctor said.

# The Astros' apology? Not accepted

The Houston Astros have gotten a lot of criticism lately, but they may also have a business opportunity. They could work out a marketing promotion with Reese's, maker of those peanut butter cups, whose ad slogan is: "Not sorry."

Oh, they say they're sorry, just as losing Academy Award nominees force themselves to smile and applaud for the winners. But their contrition is about as convincing as Pete Rose's hair dye. When Jose Altuve and Alex Bregman stepped forward to apologize at a Thursday press conference, they looked as though they were making a hostage video.

"I'm really sorry about the choices that were made by my team, by the organization and by me," said Bregman. "I've learned from this and I hope to regain the trust of baseball fans." Altuve assured the audience that everyone in the organization "feels bad about what happened in 2017."

You gotta love their phrasing: "The choices that were made" and "what happened in 2017." The systematic, extended use of electronic surveillance and communication to sabotage opposing teams — well, they made it sound like an unfortunate rain shower that happened to fall on them. "We cheated every chance we got, and the cheating won us a World Series" would have been a more honest formulation.

"I've learned from this" and "feels bad" have a charming vagueness. Did Bregman learn the importance of greater secrecy in foul play? Is Altuve pained that everyone now regards him as a thief? Neither player appeared to be wracked by conscience.

Owner Jim Crane minimized the crime as irrelevant. "Our opinion is, you know, that this didn't impact the game," he said with serene calm. "We won the World Series and we'll leave it at that."

Yes, we were at the bank wielding guns when it was robbed, and yes, we have bags filled with bundles of cash, but we don't think we owe our wealth to the robbery. And we'll leave it at that.

The cheating involved a mix of modern video and primitive

communication, with a TV monitor near the dugout showing the catcher's signs and a guy banging on a trash can to indicate to the batter what pitch was coming. The commissioner's report said the scheme was "player-driven," but an investigation by The Wall Street Journal found widespread guilt: "The Astros' rule-breaking permeated the entire organization, involving executives, coaches and players."

Professional sports teams are results-oriented, so it's safe to say that if this program didn't "impact" games, it would have been scrapped. The obvious reason players were so happy to make use of it is that it made a difference.

The Journal notes that one internal email commended Marwin Gonzalez for doing "the best job with getting this info." The utility player had his best season in 2017. His reward was a \$21 million contract with the Minnesota Twins, who might have paid less had they known more.

But don't worry: Gonzalez apologized. "I'm remorseful for everything that happened in 2017," he said Tuesday — though not, perhaps, for what happened in 2019, when the Brink's truck arrived to unload his windfall.

It's plain that if they had the chance to do it over, the Astros would behave differently. They would try much, much harder to avoid getting caught. Since they were caught, they can bring themselves to utter a few banal words of feigned regret. But nothing indicates a willingness to take true responsibility for their transgressions.

Those transgressions rank among the most outrageous and disgraceful in major league history, with immeasurable consequences. They damaged the careers of opposing pitchers whose failures were mistakenly attributed to their inadequacies. They brought hits and money to hitters who were complicit in the crime. And they cost other teams victories they would have had in the absence of the cheating.

So, if the Astros are sorry, let them show it. First, by providing a complete account of everything they did. Second, by admitting the obvious fact that they owed much of their success to it. Third, by

surrendering the rings and the bonuses they got for winning the Series and renouncing their title.

If the Astros players and staff aren't willing to do any of these, they should take their apologies and throw them in the trash can. I know they have one.

# If Duterte Wants Us Out, Let's Go

Philippines President Rodrigo Duterte has just given us notice he will be terminating the Visiting Forces Agreement that governs U.S. military personnel in the islands.

His notification starts the clock running on a six-month deadline. If no new agreement is negotiated, the VFA is dissolved.

What triggered the decision?

Duterte was offended that one of his political allies who led his antidrug campaign in the islands, which involves extrajudicial killings of drug dealers, had been denied a U.S. visa.

Yet, Duterte has never been an enthusiast of the U.S. presence. In 2016, he told his Chinese hosts in Beijing: "I want, maybe in the next two years, my country free of the presence of foreign military troops. I want them out."

The Pentagon is shaken. If there is no VFA, how do we continue to move forces in and out to guarantee our ability to honor the 1951 Mutual Defense Treaty? Defense Secretary Mark Esper called Duterte's action "a step in the wrong direction."

President Donald Trump openly disagreed: "If they would like to do that, that's fine. We'll save a lot of money."

The Philippine Islands are among the largest recipients of foreign aid in East Asia, and we've provided \$1.3 billion in military assistance over the last two decades. But money shouldn't be the largest consideration here.

Trump has been given a historic opportunity to reshape U.S. and Asia policy along the lines he ran on in 2016.

He should tell Duterte that we accept his decision and that we, too, are giving notice of our decision to let the 1951 treaty lapse. And following expiration of that treaty, the U.S. will be absolved of any legal obligation to come to the defense of the Philippines.

Time for Manila to take charge of its own defense. Indeed, what is the argument for a treaty that virtually dictates U.S. involvement in any future war in 7,600 islands 8,000 miles from the United States?

When we negotiated the 1951 treaty, it was a different world.

We had entered a Cold War with Stalin's USSR. We were in a hot war in Korea that would cost 37,000 U.S. lives. Gen. Douglas MacArthur

had just been relieved of his command of U.S. forces in Korea by Harry Truman. A disarmed Japan had not fully recovered from World War II.

The Communist armies of Chairman Mao had overrun China and driven our Nationalist allies off the mainland. The Viet Minh were five years into a guerrilla war to drive the French out of Indochina.

Today, the Cold War is long over. Vladimir Putin's Russia is no threat to the Philippines. Nor is China, though Xi Jinping has occupied and fortified islets like Mischief Reef in the South China Sea that are within the exclusive economic zone of the Philippines.

There is no U.S. vital interest at risk in these islands to justify an eternal war guarantee or treaty commitment to fight Beijing over rocks and reefs in the South China Sea.

Trump should seize this opportunity to tell Duterte that when the VFA, which guarantees immunity for U.S. forces in the Philippines, is dissolved, the 1951 Mutual Defense Treaty is dissolved.

A message would be sent to Asia, and the world, that Trump was serious when he said that he intends to revisit and review all the defense alliances and war guarantees entered into 60 and 70 years ago, to address threats that no longer exist in a world that no longer exists.

The U.S. has a long history with the Philippines, beginning in the War of 1898 with Spain, when Admiral George's Dewey's Asian squadron sank a Spanish fleet in Manila harbor, and we invaded, occupied and colonized the islands, thus emulating Europe's imperial powers and abandoning the anti-colonial legacy of the Founding Fathers.

"Take up the White Man's burden," Rudyard Kipling admonished us.

After Filipino patriots fought for nearly four years to liberate their islands from the Americans, as they had from the Spanish, inflicting on U.S. soldiers and Marines thousands of casualties, the New York Herald replied to the Poet of Empire:

"We've taken up the white man's burden/Of ebony and brown/Now, will you tell, Rudyard/How we may put it down."

After Pearl Harbor in December 1941, the Japanese invaded and occupied the islands, until Gen. MacArthur made good in on his famous pledge on leaving Corregidor, "I shall return."

In 1944, we liberated the islands.

A year after Japan's surrender, on July 4, 1946, we granted the Philippines full independence. And that nation and people, far more populous and prosperous than in 1946, should take full custody of the defense of their own sovereignty and independence.

At the end of the Cold War, nationalists in Manila ordered the U.S. to vacate the great naval base we had built at Subic Bay. We should have used that expulsion to let the 1951 security treaty lapse.

Trump should not miss this opportunity.

# Coronavirus Epidemic Tests the World's Economic Vigor

China's coronavirus disease 2019 (Covid-19) continues to take human lives. The Chinese people have suffered the most in terms of total cases and lives lost. The epidemic began in Wuhan, capital of the Hubei province. As I write this column, Hubei has had 60,000

confirmed cases and almost 1,800 deaths.

Covid-19, however, has escaped China's political borders. The World Health Organization's Feb. 18 Covid-19 "Situation Report 29" declared that 25 countries have clinically diagnosed Covid-19 cases, and many are laboratory-confirmed. As of Feb. 17, WHO had sent virus laboratory testing kits to 34 countries. Eventually, 56 countries will receive them.

WHO's Risk Assessment index rated the virus' global health threat level as "High."

Though it is no economy killer, Covid-19 does threaten the world's economic vigor. That is not a surprise. The current trade war between the U.S. and China has only begun to decouple their economies.

China's communist government must import natural resources (oil and minerals) to keep its industry humming. It also imports some foodstuffs that have domestic political impact. Since a swine virus devastated its pig farms, China relies on U.S. pork to appease the palates of its oppressed but increasingly restless citizens.

In the last three weeks, a spate of corporate and governmental announcements shows the U.S. and Chinese economies remain entwined.

For example, Apple warned investors that the coronavirus epidemic will prevent it from meeting first-quarter profit expectations. Domestic Chinese demand for Apple products has declined sharply. The epidemic has also disrupted iPhone production in China. Apple remains a blue chip company, but it faces demand and supply chain problems.

The epidemic has also disrupted the world's largest mobile phone industry trade show, the Mobile World Congress. On Feb. 12, the MWC decided to cancel its annual Barcelona conference. Fear the disease may spread is one reason, but travel restrictions from East Asia would have reduced attendance.

On Feb. 14, The Wall Street Journal examined the epidemic's effect

on auto industry manufacturing. Once again the big factor is supply chain disruption. Hyundai and Renault have slowed production on selected assembly lines in South Korea. Fiat-Chrysler is halting car production at its factory in Kragujevac, Serbia, because the facility relies on Chinese-made parts. North America is not decoupled. The Journal quoted a United Automobile Workers source who warned that General Motors' Arlington, Texas, assembly plant may face a shortage of Chinese-made components.

The Chinese National Immigration Agency has reported that 133 countries have imposed entry restrictions on Chinese citizens or individuals who have visited China. For health reasons, the quarantines are mandatory and must be enforced. But they exact economic costs, obvious and hidden. For example, Chinese companies operate several globally important mines in the Democratic Republic of Congo. Typically, Chinese nationals fill the critical skilled-worker positions. Movement restrictions could "extend the timelines" for manufacturing projects relying on Congolese minerals from Chinese-operated mines.

A recent Reuters report provided a superb example of economic disruption attributable to a quarantine. The state-owned China Railway International Group's high-speed rail project in Indonesia is one of Beijing's marquee Belt and Road Initiative megaventures. Key managers and technical workers who went to China for the Chinese New Year cannot return to Indonesia. The project now faces major delays.

The virus bugs the oil business, with Iran a definite loser. China has been Iran's biggest buyer, importing roughly 300,000 barrels a day in 2019. Reduced economic activity lowers China's demand for oil. According to The Wall Street Journal, U.S. government officials attribute some of China's decline in demand to the domestic transit restrictions. People can't travel.

Thus, Covid-19 exacerbates Iran's economic maladies. Are the ayatollahs blaming their best customer? No, they will find a way to blame America for the disease.







# Eagle Scout brings "Little Libraries" to city



Resident Keith Aguilar of Boy Scout Troop 438 was required to plan, develop, and give leadership to others in a service project helpful to any religious institution, school, or community.

Aguilar reached out to the city back in May of last year and has been in continued discussions with City staff for the past several months, all while continuing to fundraise the project.

Aguilar's efforts culminated

on Tuesday, when he approached city council for approval.

The libraries will be installed in three locations - Hermosillo and Holifield Parks, and inside the courtyard near the Cultural Arts Center - which staff says are frequently visited by children.

Aguilar has already been in contact with hearby school prin cipals concerning keeping each library stocked should there be a need. Maintenance of the Library structures would be the responsibility of the city.

Once built, local artists selected by the City will paint a design on each box, followed by an anti-ngraffiti coating over the paint applied by Public Services

The Little Free Libraries program was created in 2009 to inspire reading and make books more available to the public through book sharing throughout communities. The Little Free Library organization indicates that there are over 90,000 Little Free Libraries worldwide.

There is currently only one existing Little Free Library in Norwalk, which was donated to Sanchez Elementary School by Chick-fil-a during their grand opening.

# Joseph Thee Baker: finding passion while on parole

Joseph Maez spent close to 19 years in and out of trouble before finding his niche in baking.

WHITTIER - You wouldn't be too far off to describe Joseph Maez as a self-made success story; it just took a few years in and out of trouble to get him there.

His story is one of whipped cream and cake. It's also one of drug abuse and prison bars.

"In 2009 I did parole for the last time," said Maez, 51. "I have a total of 14 years invested in the men's prison system, in and out of prison; five different prison terms, three different prison

numbers all for manufacturing - the club life, you get to hanging methamphetamine and drug

Adding in other jail time, Maez estimates that he has a combined 19 years incarcerated.

"I wasn't a bad person; I just lived a very reckless life," he said.

Maez says that he was a "functional drug addict."

We were the kind of people that made house payments, car payments, and blended in with society," said Maez.

Having been a foster child that was born and raised in the church, Maez says that he was sheltered from a lot of the harsh realities of

"Once I turned 18, you start getting your first little sip of life

out with different kinds of friends the weed, the alcohol, different things lead to different drugs."

"I mixed up with the wrong people, and next thing I knew I was hustling...most of my charges were possession and sales.

'People don't realize there's a lot of really good money into it. Even every time I got locked up, I didn't care about changing, because the money was really good. I had the same mentality of not to get busted, how can I be a little more slick...that's how clouded my mind was."

His last stint in prison came with eight years and a stern warning from the judge; "I better not see you in here again.'

"I knew I had to change," said Maez. "I made promises to God; I said, 'God, I've tried everything else. Í need vour help...if vou take me from the revolving door of the prison system, I'll change."

It was in that very prison system where Maez would find the answer to his escape: baking.

"All my experience comes from cooking and restaurants, stuff like that; any time I've gotten out, I went right to the restaurants," said Maez. "My points dropped, and I got to go from a level four prison facility to one of those fire camps that you

"I was out there fighting fires for a year, but then the opportunity came where I could go in to work in the kitchen."

During Maez's time in the kitchen, another inmate - who was responsible for the baking was preparing to parole.

said Maez. "Every camp wants enough. a good baker. No one wants a piece of crap baker; life sucks for everyone when there's a garbage

Ultimately, Maez stepped up and volunteered to be trained. It was a decision that would have a much more lasting impact than he originally anticipated.

"Who knew that that four months of training was going to be some of the best free school I've gotten in my life," said Maez. "And what better test dummies than inmates? It just worked out."

Maez found that he had a knack for baking, and would carry those talents past his last term in prison and back into the restaurant industry, eventually bringing him to help create many of the pastries sold front-of-

However, Maez found that "They said we need a baker," even that wasn't satisfying him

"My last job was at Costco Bakery; I worked there for five months," said Maez. "When I punched out for the last time, I had no clue things would end up the way they did. I perfected my skill; I baked, I learned I watched YouTube. I never went to school for any of this in my life."

Now, Maez, more commonly known as Joseph Thee Baker, runs his own business out of his Whittier apartment.

"That hustle gene that I put into everything I used to do for the wrong reasons, I now do it for the right reasons," said Maez. "Your work is your number one

"You have to learn how to network; you have to learn to market yourself. If not, you're

Maez has already accumulated

an impressive social media following, and racked up celebrity endorsements from the likes of Snoop Dog, the KTLA 5 news team, and Christine Devine.

Now, Maez is using his vigor and talent for the betterment of others, having taught over 1,500

"For so many years, I used my platform for the wrong reasons, said Maez. "I get so many private messages from people who I am connecting with...If I can use my platform in a positive way to inspire, that's all I ask."

"That comes as part as being a success, is being able to show somebody. Part of me being a success is being a successful teacher...I want to make sure I'm using my platform in a positive way to inspire."

its emergency care, the Downey Fire Department launched new. hands-free CPR equipment this

DFD recently showed off it's new AutoPulse system to city staff, demonstrating how the apparatus could administer chest compressions more effectively than manual CPR.

CPR doesn't do is increase blood flow," said DFD Captain Ivan deployed. Orloff. "Manual CPR, for instance, only produces 30% blood flow, where this AutoPulse will produce near-normal blood to a patient's heart, brain, and vital organs."

> Once applied to a patient, AutoPulse will provide continuous compressions throughout the entirety of ambulance loading and travel to the hospital. This will free up paramedic hands to delegate to other necessary tasks, while also allowing for easier transport and safer conditions for paramedics while riding in the back of an ambulance.

> "Our paramedics can delegate responsibilities to other important areas. That could be starting IV's, defibrillating, intubating a patient," said Orloff. "It will allow us to focus on other areas which is very, very nice."

> The device is intended for adult application, though bigger children or adult-sized teenagers may be able to benefit from its use

> Each AutoPulse unit costs The department currently owns two, which have been deployed with the busiest ambulances in the department. According to Orloff, the goal is to hopefully secure funding within the next year to outfit the
