Beware crisis scams, warns IRS

The Internal Revenue Service (IRS) will begin to distribute COVID-19 Economic Impact Payments in a matter of weeks. For most Americans, this will be a direct deposit into your bank account. For the unbanked, elderly or other groups that have traditionally received tax refunds via paper check, they will receive their economic impact payments in this manner as well.

With any good news story from the IRS, comes an opportunity for criminals and scammers to take advantage of the American public.

• Scammers may try to get you to sign over your check to them.

• Scammers may use this as an opportunity to get you to "verify" your filing information in order to receive your money, using your personal information to file false tax returns in an identity theft scheme

Between these two schemes, everyone receiving an economic impact payment is at risk.

The Internal Revenue Service - Criminal Investigation (IRS-CI) is working tirelessly alongside our civil counterparts and law enforcement partners to identify scams and halt wrongdoers from taking advantage of the American people. Special Agent in Charge Ryan L. Korner warns, "unfortunately criminals are unprecedented this taking pandemic as an opportunity to exploit the public. It is critical now more than ever to remain vigilant for scams that are attempting to steal your personal information and your money. All Americans

NORWALK - Costco is once again temporarily changing its policy in response to the global coronavirus pandemic, which has caused store traffic to spike and in-demand items to sell out across the country.

Beginning April 3, members will only be allowed to bring one guest inside the store with them. Previously, Costco members could bring two guests per membership card, as well as their children.

The big-box chain explained the decision on its website, saying the move is designed to control the amount of people in the warehouse at one time.

"This temporary change is for your safety and the safety of our employees and other members, and to further assist with our social distancing efforts," the website reads.

Costco has been routinely updating procedures in an effort to better protect its employees and customers.

Over the past few weeks, Costco has altered its hours, increased sanitization its

of high-touch surfaces like shopping cart handles and merchandise shelves, and placed limits on in-demand items. The warehouses also stopped offering food sampling and are no longer accepting returns on certain merchandise.

In a letter from CEO and President Craig Jelinek, he said the brand is "closely monitoring the situation" and complying with guidance from public health officials.

"As

information new

becomes available, management is keeping warehouse staff well informed so they can respond swiftly and appropriately,' the letter reads. "While the circumstances continue to change and we modify our operations as necessary, we thank you for your patience and cooperation. As new developments occur, be assured we are committed to taking care of our members and employees and to our mission of providing low prices, quality merchandise and exceptional service."



should specifically be on the lookout for scammers trying to directly steal their COVID-19 Economic Impact Payment, as well as fraudsters trying to trick them into providing sensitive information by convincing them it is required to receive their payment from the IRS."

"While much of the country is working from home, scammers and con artists are also working on schemes to steal your money,' said United States Attorney Nick Hanna. "Criminals are taking advantage of the health emergency, so I urge everyone to heed the warnings to protect your personal information, your bank account and anything potentially valuable to a fraudster. The Justice Department will vigorously investigate and prosecute criminals, but we need everyone to be extra careful so they can avoid becoming a victim."

The IRS will deposit your economic impact payment into the direct deposit account you previously provided on your tax return (or, in the alternative, send you a paper check). The IRS will not call and ask you to verify your payment details. Do not give out your bank account, debit account, or PayPal account information - even if someone claims it is necessary to get your economic impact payment. Beware of this scam.

If you receive a call, do not engage with scammers or thieves. Just hang up. If you receive texts or emails claiming that you can get your money faster by sending personal information or clicking on links, delete them. Do not click on any links in those emails.

Reports are also swirling about bogus checks. If you receive a "check" in the mail now, it's a fraud -- it will take the Treasury Department a few weeks to distribute the payments. If you receive a "check" for an odd amount (especially one with cents), or a check that requires that you verify the check online or by calling a number, it's fraud.

Coronavirus cases climb every day

Coronavirus numbers continue to surge in Southern California.

NORWALK — The number of confirmed coronavirus cases in Norwalk continues to swell daily, with the city hosting nearly two dozen patients as of Thursday.

Officials with the L.A. County Department of Health said Wednesday that Norwalk has 21 confirmed COVID-19 cases. The number is expected to rise as testing becomes more prevalent.

Health officials did not say if the 21 cases were Norwalk residents, hospital patients, or both.

To date, authorities have identified 3,518 coronavirus cases across all areas of LA County, including 65 deaths.

Of those who were sick, 733

have been hospitalized at some continue to do our part to slow point during their illness.

Emerging evidence suggests that there may be a significant number of people infected with COVID-19 who are asymptomatic and capable of spreading the virus to others.

New guidance from the Centers for Disease Control and Prevention (CDC) suggests that people should consider using universal precautions all the time - assuming that each of us can infect others even when we aren't sick.

"Our sadness is not diminished by the daily frequency of announced deaths related to COVID-19, and reminds us of our need to work together to protect each other," said Barbara Ferrer, Los Angeles County Public Health Director.

"The hard truth is we have some difficult days ahead as we work tirelessly to flatten the curve of this horrible virus. Though the end may not be as close as we'd like, if we all

the spread by staying home, social distancing, self-isolating when we are positive or presumed positive, and self-quarantining if we are close contacts of a positive case, we will get to the end of the COVID-19 crisis more quickly, together."

Public Health has issued the following guidance for people with mild illness during this time of increased spread:

If you are mildly sick, stay home for at least seven days and until 72 hours after being fever and symptom free. Call your doctor if you are concerned and/or your symptoms worsen. Individuals who are elderly, have underlying health conditions or pregnant should consider contacting their providers earlier when they are sick.

Surrounding cities have also received confirmed coronavirus cases, including Downey (37), Whittier (15), Pico Rivera (14), South Gate (25) and Paramount (10).

Andrew Cuomo reminds us how it's done

In "The Splendid and the Vile," his new book about former Prime Minister Winston Churchill's stewardship of Britain through the desperate early months of World War II, Erik Larson details the seemingly hopeless circumstances confronting the country. Germany had overrun Europe and was poised to begin a bombing campaign aimed at obliterating British cities and, if that didn't force England's surrender, to invade England. By late 1941, 45,000 Britons had been killed and 52,000 injured. Three hundred thousand British soldiers were trapped at Dunkirk, certain to be captured or annihilated. German submarines were preventing supplies from reaching Britain, which was effectively on its own.

Churchill was defiant. "We shall not fail or falter," he proclaimed. "We shall not weaken or tire. Neither the sudden shock of battle nor the long-drawn trails of vigilance and exertion will wear us down." His people knew that he was as tireless as he was asking them to be. "Papa has served them with his heart (and) his mind," Churchill's daughter wrote in her diary, "and they have given him in his finest and darkest hour their love and confidence."

It is fair to say that Americans have not been similarly blessed during the current crisis. The Daily Dissemble, the White House "briefings" on the novel coronavirus, are substantially mixtures of misrepresentation and nonsense. The president has two signature specialties. One is making claims demonstrated within 24 hours to be misleading or simply false. The other is settling upon a truly meaningless banality ("It's very important that our economy be strong. A strong economy is very, very important. Really important.") and just repeating it endlessly, as though doing so makes it less meaningless. Both have been on full display during these briefings.

One bright spot has been New York Gov. Andrew Cuomo, who, like Churchill, has had to deliver continuously dreadful news while inspiring confidence. Americans confined to their homes have taken to tuning in to the governor's daily press conferences not only to hear about the state of things in New York but also to get reminded of what leadership looks like.

It has been 90 years since Americans made it a regular point to listen to what a leader had to say. Our grandparents and greatgrandparents gathered to listen to then-President Franklin Roosevelt's fireside chats during the Great Depression because they felt they could trust him: to tell the truth, to know what he was doing, to have a plan of action, to empathize with them. Cuomo brings these qualities to his briefings, and Americans living nowhere near New York tune in because of it.

In truth, even a leader merely playing with the proverbial full deck of cards would be a sight for sore eyes for Americans, who have been deprived of this for three years. But Cuomo has been just what the doctor ordered. In contrast to the president's profound unreliability, Cuomo exudes command: Here is Plan A. Here is why it is urgent that Plan A work. Here are the problems that we face making Plan A work. Here is what we are doing to solve those problems. Here is Plan B.

Cuomo, a tough political gut fighter, has provided both humanity and inspiration while showcasing hands-on management.

"This is going to be a long day, and it's going to be a hard day, and it's going to be an ugly day, and it's going to be a sad day," Cuomo told the National Guard before deploying it to assist reeling New Yorkers.

He reaffirmed the words of his late father and predecessor, Gov. Mario Cuomo, on what a democratic government is supposed to



mean. It is, he reiterated, "family, mutuality, the sharing of benefits and burdens for the good of all, feeling one another's pain, sharing one another's blessings — reasonably, honestly, fairly, without respect to race or sex or geography or political affiliation."

Cuomo's management and words have reassured a deeply anxious nation, one that is grateful to him for his finest hour.

Why did the U.S. put China first?

A little less than two months ago, the U.S. State Department made a curious announcement that suggests President Trump's "America First" administration put "China First" at a critical moment during the burgeoning Wuhan pandemic.

I asked the State Department about the controversy this week — and the vague and nonresponsive responses I received on background from a Foggy Bottom spokesperson raise more questions than they answer.

The Feb. 7, 2020 press statement attributed to Secretary of State Mike Pompeo is headlined: "The United States Announces Assistance to Combat the Novel Coronavirus." That week, we are told, the State Department "facilitated the transportation of nearly 17.8 tons of donated medical supplies to the Chinese people, including masks, gowns, gauze, respirators, and other vital materials. These donations are a testament to the generosity of the American people."

Whoa, whoa, whoa. Nearly 18 tons of critical medical supplies went to the Communist government whose country unleashed COVID-19 on the world, downplayed it, punished whistleblowers who warned about it and attacked critics worldwide as racist? Whose idea was this "generosity?" Which "American people" approved this plan? Was the aid solicited or unsolicited? I asked our government.

The answer: "We have no additional details at this time."

The press statement elaborated further that "the United States government is announcing it is prepared to spend up to \$100 million in existing funds to assist China and other impacted countries... to contain and combat the novel coronavirus. This commitment — along with the hundreds of millions generously donated by the American private sector — demonstrates strong U.S. leadership in response to the outbreak."

How much of the "up to \$100 million" has been spent to assist

government.

The answer: No reply.

By what means were the 18 tons of medical goods transported: Air or sea? If by sea, on what ships were the goods transported to China and when and where did they arrive? If by air, which carriers transported the goods and when and where did they arrive?

(I asked about shipping because U.S. Department of Transportation Secretary Elaine Chao's family owns the New York-based multinational shipping behemoth, Foremost Group. The mega-fleet was built in China, subsidized with loans from the ChiComs' Export-Import bank and conducts nearly three-quarters of its freight business in China. Secretary Chao was designated an "international consultant" of the Wuhan government in 2009. Her sister, Angela Chao, is CEO of Foremost and organized a humanitarian shipment of masks, gloves and gowns from New York to Wuhan in partnership with the "Hubei Charity Foundation" a week after the State Department's press statement.)

I also asked whether any of the precious medical supply items shipped to China in February were sent back to the U.S. as part of White House adviser Jared Kushner's "Project Airbridge" transfer of personal protective equipment last weekend from China to New York — including 130,000 N95 masks, 1.8 million face masks and gowns, more than 10.3 million gloves and more than 70,000 thermometers?

Here's the full answer I received from the State Department spokesperson:

"In early February the American people demonstrated their characteristic generosity by donating 17.8 tons of medical supplies to help the Chinese people contain the impact and stem the spread of COVID-19 from Wuhan to other parts of China and the world. These donations were provided by Samaritan's Purse, The Church of Jesus Christ of Latter Day Saints, Intermountain Healthcare, and Boeing. The State Department facilitated the delivery of these medical **Michelle**

home over 800 American citizens back from Wuhan at the outbreak of the pandemic."

Odd. Very odd. Boeing's huge shipment of 250,000 medical masks was reported on Jan. 29, more than a week before the State Department's announcement. Side note: Was it "characteristic generosity" or self-serving corporate relations? The troubled aircraft company has been desperately seeking business after China's de facto boycott the past couple of years and stands to benefit most from the China trade deal signed in January. Also: Did the multinational company's purported goodwill gesture deprive the American people of scarce PPE resources? Sure seems so.

LDS's own press statement about its donations to China was also released Jan. 29 and made no mention of the State Department's role in facilitating delivery of "220,000 respirator masks, 870 protective goggles and more than 6,500 protective coveralls." It appears LDS has its very own special relationship with "Project Hope," a nongovernmental organization that works closely with the Chinese Ministry of Health. The church chartered flights from Salt Lake City and Atlanta to Shanghai at the behest of its president, Dr. Russell Nelson, who had performed heart surgeries in China. Photos of the LDS church's PPE drop show LDS volunteers in Shanghai smiling in front of a massive wall of 3M boxes full of medical equipment on Feb. 4.

Finally, the State Department's red-flag mention that some of the planes used to deliver these resources to China brought back 800 Americans from Wuhan deserves more probing. Was this entire "charitable" exercise — which sent abroad 18 tons of the very items Americans are now desperately scraping to manufacture out of paper towels, pillow fabric and bandanas — cover for some sort of COVIDpro-quo?

Inquiring minds ought to want to know.

Although Venezuela has more oil in the ground than any other country, once the socialists nationalized the oil industry, production declined. Today, Venezuelans struggle to buy gasoline.

When government orders companies to do things, companies don't innovate. They're less able to adjust quickly to market demand. That's the topic of my new video.

Today, hospitals need more ventilators. But the government doesn't need to order companies to make more. The private sector is already on it.

Automakers slowed car production and are gearing up their factories to produce ventilators. Other businesses are, too. That's what businesses do when conditions change; they pivot.

Distillers that once made gin and vodka now make hand sanitizer. The federal government had to waive regulations to allow them to sell it.

Some give it away. It's not just charity; it's "goodwill." They hope customers will remember the good deed, and that'll lead to profit in the future.

The best catalyst to spur production is simple pursuit of profit. It's what gets companies to produce new things instantly. Unlike governments, businesses have no guaranteed income. To survive, let alone grow, they must constantly innovate to make sure more money comes in than goes out.

The socialists call that "greed."

Without question, some tycoons are greedy. They pursue profit to the point that they have more money than they will ever need.

That's fine. That greed for success drives them to get me what I need.

I assume it's what inspired Ford to start using 3D printers to make face masks.

The profit motive delivers the goods. Higher prices tell companies what products are most urgently needed.

When our government failed to produce enough coronavirus test kits, private companies filled the gap. Some offered convenient tests you could use at home.

But the government didn't like it, saying the test hadn't been approved. The tests were withdrawn.

Government's rules often make it harder for private actors to help people. In a crisis, America's unsung heroes are people who overcome that.

Many truck drivers wanted to work overtime to help, but federal law said they must not work more than 11 hours a day. Finally, the government suspended the regulation.

We ought to suspend a lot of these rules permanently. Allow Americans to make our own choices about when we want to work.

In this crisis, businesses are trying all sorts of new things. Supermarkets started offering special "senior hours" so older people can safely get supplies we need.

Musicians are livestreaming concerts.

Restaurants are switching to takeout and delivery.

People have lost jobs, but if businesses are free to adapt, they'll create many new jobs.

Because demand for deliveries has increased. Amazon is hiring 100,000 new workers. Walmart is hiring 150,000.

The free market adjusts. We don't need "production acts" to tell us what to do.

Beware Scams and Schemes

aggressive and An sophisticated phone scam targeting taxpayers, including recent immigrants, has been making the rounds throughout the country. Callers claim to be employees of the IRS, but are not. Victims are told they owe money to the IRS and it must be paid promptly through a pre-loaded debit card or wire transfer. If the victim refuses to cooperate, they are then threatened with arrest, deportation or suspension of a business or driver's license. Or, victims may be told they have a refund due to try to trick them into sharing private information.

With COVID-19 scams, they impact check. For those who

receive an actual check, they may ask you to endorse it and forward to them for "payment of past debts.'

Remember: Scammers Change Tactics -- Variations of the IRS impersonation scam continue year-round and they tend to peak when scammers find prime opportunities to strikelike a new economic impact check being sent.

Surge in Email, Phishing and **Malware Schemes**

Scam emails are designed to trick taxpayers into thinking these are official communications from the IRS, tax industry professionals or tax software companies. These phishing emails ask taxpayers about a wide range of topics -- related may urge you to pay this fake to refunds, filing status, ordering 'debt" with your economic transcripts and verifying PIN information - in order to steal

your personal information or file false tax returns.

When people click on links from these phishing emails, they are taken to sites designed to imitate an official-looking website, such as IRS.gov. The sites may also carry malware, which can infect people's computers to steal their files or record their kevstrokes.

Also be aware of email phishing scams that appear to be from the IRS and include a link to a bogus websites intended to mirror the official IRS website. These emails contain the direction "you are to update your IRS e-file immediately." The emails mention USA.gov and IRSgov (without a dot between "IRŠ" and "gov"). Don't get scammed. These emails are not from the IRS.

Price gouging FAQs

Courtesy California Attorney General

What is price gouging?

Price gouging refers to sellers trying to take unfair advantage of consumers during an emergency or disaster by greatly increasing prices for essential consumer goods and services.

Is price gouging illegal in California?

Yes, in certain circumstances. California's anti-price gouging statute, Penal Code Section 396, prohibits raising the price of many consumer goods and services by more than 10% after an emergency has been declared.

Local laws may also contain their own prohibitions on price gouging.

When does California's antiprice gouging statute apply?

The statute applies immediately after the President

reconstruction services.

The goods and services listed above are just examples; the statute's protections are not strictly limited to these items.

How long do the restrictions of the statute apply?

The statute generally applies for 30 days after a declaration of emergency, although for reconstruction services and emergency cleanup services, it applies for 180 days after a declaration of emergency. State and local officials may extend the effective period of the statute beyond these timeframes.

What if I experienced price increases outside of the city or county where the emergency or disaster is occurring or occurred?

The statute does not restrict its protection to a city or county the evicted tenant under the where the emergency or disaster price gouging statute. is located. In addition to applying in the city or county covered by the declaration, it is intended to prevent price gouging elsewhere in the state where there is increased consumer demand as a result of the declared emergency. For example, if a fire in San Diego County causes residents to evacuate to neighboring Imperial County, hotels in Imperial County may not raise rates by more than 10% to take advantage of the increase in demand for lodging. What if a seller increased the price of a good or service because the seller's costs of providing the good or service increased? If the seller can prove that the increased price is directly attributable to increases in the cost of labor or materials needed to provide the good or service, the seller may not be liable under the statute. It's important to note that manufacturers, wholesalers, and distributors must also comply with the statute when selling covered goods or services to a retailer.

but offered on a full-time or monthly basis following a declaration of emergency, the price may not exceed 160% of the fair market value of the rental housing as established by the U.S. Department of Housing and Urban Development.

A landlord may not justify an otherwise unlawful price increase by providing additional services such as gardening, cleaning, or utilities, or because they are now offering a shorter lease term. Similarly, a landlord may not charge more than the allowable price because an insurance company offered to pay a higher price.

Finally, the statute also makes it a separate misdemeanor for a landlord to evict a tenant and then re-rent the property at a rate that the landlord would have been prohibited from charging

How can I find out if a declaration of emergency is in effect?

declarations Emergency issued by the Governor are generally available on the Governor's website at gov. ca.gov. For information about local declarations of emergency, please contact your local city or county emergency authority or sheriff's office.

Who is subject to the statute?

Individuals, businesses, and other entities must comply with the statute. The statute applies to all sellers, including wholesalers, manufacturers, distributors, and retailers. It also covers all sales, including sales to individuals and families, businesses and other organizations, and government agencies.

What goods and services are covered by the statute?

The statute applies to the following major necessities: lodging (including permanent or temporary rental housing, hotels, motels, and mobile homes); food and drink (including food and drink for animals); emergency supplies such as water, flashlights, radios, batteries, blankets, candles, soaps, temporary shelters, diapers, tape, toiletries, plywood, nails, and hammers; and medical supplies such as prescription and nonprescription medications, bandages, gauze, isopropyl alcohol, antibacterial and products.

goods and services including: home heating oil; building materials, including lumber, construction tools, and windows; transportation; freight; storage services; gasoline and other rented on a daily basis prior motor fuels; and repair and to a declaration of emergency

How does the statute affect rental housing?

As with all other covered goods and services, following a declaration of emergency, the statute generally prohibits landlords from increasing the price of rental housing by more than 10% of the previously charged or advertised price. For rental housing that was not rented or advertised for rent prior to a declaration of emergency, the price cannot exceed 160% of the fair market value of the rental housing as established by the U.S. Department of Housing and Urban Development.

It also applies to other or rented on a daily basis, such as an AirBnB or VRBO listing, the daily price may not be increased by more than 10% following a declaration of emergency. For rental housing advertised or

violating the statute

Violations of the price gouging statute are subject to criminal prosecution that can result in one-year imprisonment in county jail and/or a fine of up to \$10,000. Violations are also subject to civil enforcement actions including civil penalties of up to \$5,000 per violation, injunctive relief and mandatory restitution.

The Attorney General, local district attorneys, and private individuals can bring actions for violations of the statute.

Can the Attorney General's office assist me with a claim against someone who price gouged me?

Our office cannot give you legal advice or represent you. If you believe that you might have a claim for price gouging, you might consider contacting an attorney to explore your options. For referral to a lawyer, you may contact the State Bar at (866) 442-2529 (toll-free in California) or (415) 538-2250 (from outside California), or through its website at: http://www.calbar. ca.gov. If you cannot afford to pay an attorney, you may consider contacting your local legal aid office. For a referral, visit http:// www.lsc.gov and click on the Find Legal Assistance tab, or go to http://lawhelpca.org.

Should I report price gouging to the Attorney General's office?

Even though our office cannot represent individuals, the Attorney General may, on behalf of the public, investigate or prosecute someone who has engaged in price gouging. Anyone who has been the victim of price gouging, or who has information regarding potential price gouging, is encouraged to immediately file a complaint with the Attorney General's Office by going to the Attorney General's website or by calling (800) 952-5225.
