We are in our third week staying "Safer at Home" here in LA County and I just wanted to take a minute to thank you for doing your part so far. Your decision to stay indoors, keep your distance, and change your routine for the sake of our neighbors is saving lives.

If you're still going in to work at an essential job — caring for the sick, working at a grocery store, delivering food or supplies — thank you for risking your own health and safety to keep our County running. We owe you more than we can say.

There are now 6910 COVID-19 cases in LA County and 169 deaths. This is certainly an unprecedented crisis — but we are working around the clock to keep communities safe and lend a helping hand to those hit hardest by COVID-19.

Below I've outlined some of the actions that we have taken as well as what you and your loved ones need to know about getting a COVID-19 test, wearing a mask in public, having a meal delivered for a senior loved one, getting assistance for a small business,

Drive-Thru Testing Available in LA County

Testing is one of the most important tools we have to track and then slow the spread of COVID-19. Across the 4th District and the County we're ramping up efforts to test especially our most vulnerable residents.

Many drive-thru testing sites are now open across the County. Two of these are in the 4th District, one at the parking lot of the South Bay Galleria in Redondo Beach and another at Long Beach City College.

Same or next-day appointment priority is still being given to those who are 65 or older or who have chronic health conditions.

Please book an appointment online before going. If you do not have an appointment, they will not be able to test you.

Recommendations

Because it is possible to spread COVID-19 days before a person is symptomatic, wearing a face covering while you are out of your home will help reduce the spread of this virus.

federal government has now recommended the use of these masks by the general public, but our LA County Public Health Department stresses that you SHOULD NOT purchase or use an N95 or other similar medical-grade mask. Those are in limited supply and must be reserved for our healthcare workers only. Wearing a mask is also not a substitute for safe social and physical distancing.

Fortunately it is easy to make a face mask or covering at home with materials from around your house. Here is a sample guide on how you and your family can make your own masks — this one does not even require sewing.


Meal Options for Seniors

Norwalk nears 60 cases of COVID-19



Officials say this could be a critical week during the coronavirus emergency.

NORWALK - As of Wednesday evening, there are 58 confirmed cases of COVID-19 in Norwalk.

At the time of writing, there have been 7530 cases across Los Angeles County, including 198

Neighboring Downey continues to have one of the higher counts in the local area, at 84 with at least one confirmed fatality.

California Governor Gavin Newsome gave an update to the state's coronavirus numbers on Wednesday, saying that there were 16,957 cases, 442 deaths, 2,714 hospitalized and 1,154 people in ICU state-wide, 30% of which who were identified as Hispanic, according to data related to race compiled by the

New Guidance for LA County Restaurants

Last Tuesday I directed our Public Health Department to quickly issue guidelines allowing these restaurants to continue selling groceries via delivery and takeout. These guidelines are now in place to help keep these

Feeding the 4th District

My office is funding several especially organizations across the 4th District that are getting vulnerable residents food and groceries during this crisis.

Some of our grants include:

\$30,000 to the Diamond Bar Evergreen Club so they can deliver make and deliver meals to Diamond Bar seniors who are disabled and/or lack resources.

\$23,000 for the Torrance-Lomita Meals on Wheels so they can add more participants to their meal delivery program.

\$10,000 to the City of La

Mirada so they can partner with Grocery Outlet to provide meal boxes to seniors in the community.

\$5,000 to Industry Meals on Wheels so they can serve more participants in Rowland Heights, Hacienda Heights, and Diamond

\$10,000 to the Long Beach Salvation Army so they can make more meals for local residents,

\$18,000 to the City of Whittier and PIH Health so they can provide more meals for seniors and gravely ill individuals.

How to end the shutdown

President Donald Trump is hinting at a second task force responsible for getting Americans back to work. Appoint it now, Mr. President. Don't wait until the virus peaks. This second task force should prepare the country to reopen, with new tools to fight the

The president's top epidemiologist, the esteemed Anthony Fauci, insists "the best tool we have" is "physical separation." But mandating that people stay home is costing Americans their jobs and will force businesses into bankruptcy. The nation needs an

A chorus of government health officials and academics, like Harvard's Marc Lipsitch, want the shutdown continued until the virus is gone or a vaccine is developed. They're well-meaning but out of touch. No wonder. Their paychecks continue to roll in, even during a shutdown.

Meanwhile, blue-collar workers and business owners are hammered. It's possible the virus will stay with us, and become seasonal, Fauci warns. And a vaccine will take at least 18 months.

This second task force needs to cut red tape and speed approvals for new drugs, making coronavirus a treatable disease by summer. That's a real possibility, not wishful thinking.

Several drugs are already being tested on patients, including antiviral medicines. As former Food and Drug Administration Commissioner Scott Gottlieb explains, the key is getting the FDA to review how patients are responding in real time, rather than waiting

Since taking office, Trump has worked to speed up the FDA's bureaucratic, risk-averse and slow drug approval process. He's pushing even harder now.

Trump's under attack for pressuring the FDA to allow doctors to try hydroxychloroquine combined with the antibiotic azithromycin, although both drugs are already in use for other maladies. In a French clinical trial, the combo worked on coronavirus, but critics object that

study wasn't large enough. That's a legitimate concern in ordinary

"The president is short-circuiting the process," protests Jeffrey Flier, former Harvard Medical School dean. The process? In a pandemic, patients can't wait.

State Rep. Tavia Galonski, D-Ohio, wants to charge Trump with "crimes against humanity" for pushing a drug that hasn't been tested for coronavirus patients. Patients think he deserves a medal.

A second task force also needs to ramp up production and distribution of rapid tests. It's key to reopening workplaces, including assembly lines and office settings. Walmart is taking employees temperatures, but that is hit or miss because many infected people have no fever. Broad distribution of the Abbott five-minute test could be a game changer. So could the new Ortho Clinical Diagnostics blood test, already in mass production, which will tell people if they have antibodies to the virus and are probably immune.

The new task force's third job is to shrink the shutdown to where it's actually needed. Not every part of America is enduring the medical carnage of New York. But shutdown pain is everywhere. On Friday, first-time unemployment benefit applications hit an all-

University of Texas professor Lauren Ancel Meyers is urging all counties in the nation to shutdown. Meyers' approach is typical, ignoring the human cost of closing the economy. She warns that in counties with no reported cases, there's still a 9% chance of an outbreak. Maybe so, but shutting down comes with a 100% chance of destroying Main Street and costing people their livelihoods, and some even their lives.

Likewise, Fauci is urging Americans to stick with the shutdown. "It's inconvenient," he says, but it's "the answer to our problems." "Inconvenient" is the wrong word. The shutdown is a killer.

In Sweden, government leaders have avoided shutting the economy down, instead letting individuals decide what precautions to take. A major rationale for that approach, explains Anders Tegnell, 98 and is chairman of the Committee to Reduce Infection Deaths.

Trump's Task Force deserves enormous thanks for marshaling resources to equip our hospitals and man the front lines. Now it's time for a second task force to rescue America from the shutdown.

Selective social distancing is futile

This week in Colorado, our statewide stay-at-home order was extended until April 26. Gov. Jared Polis urged everyone to wear a mask of any kind while outdoors. Local groceries are limiting customers to one every 120 square feet of the store. For the first time, my neighborhood playground on Tuesday was wrapped in bright yellow "CAUTION" tape. And in Brighton, Colorado, a father was handcuffed in an empty park by three police officers for playing T-ball with his 6-year-old daughter and wife.

We are not a serious country. America's "social distancing" campaign has gone both too far and not far enough. The restrictions and guidelines are arbitrary, irrational and unevenly applied.

While children's swings and slides are now crime scenes, golf courses and pickleball courts in my city are wide open.

Weed and booze stores are considered "essential." Ice cream, dessert joints and fast-food outlets with takeout and delivery services are still operating. But family-owned, sit-down restaurants that have been staples in our community have been forced to shut their doors after decades in business.

Barbershops and hair salons here were ordered to close three weeks ago, but government employees on landscaping crews who cut grass — like the ones I've seen all crammed together in a city truck are still earning paychecks subsidized by the taxpayers sidelined from their jobs in the name of safety and public health.

In my state, and across the country, private gyms have been forbidden spaces for the masses for weeks. But if you're a celebrity or Beltway elitist, you can still stay in shape while sanctimoniously taping public service announcements telling everyone else to stay at and bicep curls with their jugs of laundry detergent.

media clicks by sharing cozy family quarantine videos and coping tips from their multi-million-dollar Florida mansion. "We all need to take care of ourselves, mentally and physically, and also be respectful of the health and well-being of others. At a time when people need to stay apart, we can still find other ways to feel togetherness. Stay connected, and most importantly, stay safe," Rodriguez tweeted to his 1.2 million fans. Early failures by the CDC and FDA has lasting consequences

Public officials across the United States are flying blind against the COVID-19 epidemic. Because of a government-engineered testing fiasco, they do not know how fast the virus is spreading, how many people have been infected by it, how many will die as a result or how many have developed immunity to it.

The failure to implement early and wide testing, which was caused by a combination of short-sightedness, ineptitude and bureaucratic intransigence, left politicians scrambling to avoid a hospital crisis by imposing broad business closures and stay-at-home orders. It foreclosed the possibility of a more proactive and targeted approach, focused on identifying carriers, tracing their contacts and protecting the public through isolation and quarantines.

The initial outbreak of COVID-19 in Wuhan, China, was reported at the end of December. The first confirmed case in the United States was reported on Jan. 20, by which time it seems likely that many other Americans were already infected.

At first, the U.S. Centers for Disease Control and Prevention monopolized COVID-19 tests. When the CDC began shipping test kits to state laboratories in early February, they turned out to be defective.

The CDC and the Food and Drug Administration initially blocked efforts by universities and businesses to develop and conduct tests before relaxing the restrictions that made it impossible to assess the progress of the epidemic. Making a false virtue of necessity, the CDC set irrationally narrow criteria for testing, which meant that carriers without severe symptoms or obvious risk factors escaped detection.

The CDC still insists that "not everyone needs to be tested for COVID-19." But without testing everyone — or at least representative samples — for both the virus itself and the antibodies to it, we can do little better than guess its prevalence, its lethality and the extent of immunity among the general public.

Even now, months after the Wuhan outbreak and the first reported case in the U.S., we have managed to test less than 1% of the population, and those tests have been limited mainly to people with symptoms severe enough for them to seek treatment. Since people infected by the COVID-19 virus typically experience mild symptoms or no symptoms at all, that's a real problem.

Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, estimates that "somewhere between 25 percent and 50 percent" of COVID-19 carriers are asymptomatic. But he

cautions that "right now we are just guessing," saying the issue would be clarified by wide antibody testing, which would identify people who had the virus and recovered, many of whom may never have realized they were infected.

Iceland — which has tested more than 8% of its population for the virus, 14 times the U.S. rate — has been screening the general public as well as people who think they might have COVID-19. About 1% of those volunteers have tested positive and half of them reported no

Iceland's response to COVID-19, which features aggressive testing, contact tracing and quarantines of infected people but no general lockdown, seems to be working. Its crude case fatality rate known deaths as a share of confirmed cases — is much lower than the rates in other developed countries, including places where the disease emerged around the same time.

Other countries that are doing mass testing, including South Korea, Singapore, Austria and Germany, also seem to have a better handle on their epidemics, whether measured by their crude CFRs or by the number of new cases. Because of the ongoing test shortage, the United States has been unable to mount a similar response.

Our ignorance about COVID-19 will have profound consequences, potentially leading to an overreaction that wrecks the economy while saving relatively few lives or (less likely, given the current political climate) an underreaction that costs many lives and allows hospitals to be overwhelmed by COVID-19 cases. You can thank the same agencies on which we are relying to guide us through this crisis.

Epidemiologist answers common questions on Covid-19

By Iqbal Pittalwala

Brandon epidemiologist at the UC Riverside School of Medicine, has given numerous media interviews the novel coronavirus, COVID-19, and related topics. An associate professor in the Center for Healthy Communities, he answers several common questions about the virus and its

Who should wear a mask?

Centers for Disease Prevention Control and recommends that we wear cloth face coverings — homemade masks, scarves, bandanas in public settings, such as the grocery store or a pharmacy, where other social distancing measures are difficult to maintain and when other masks are not available. This prevents us from touching our face and prevents asymptomatic or symptomatic people from spreading the virus.

If people suspect they have the new coronavirus, what should their course of action be?

If someone suspects they may have coronavirus, and have symptoms that are indicative of it, including temperature above 100.4 F, they should call their primary care physician, the local public health department, or the local coronavirus hotline if one has been established. They should not go directly to urgent care since they will need to be treated as a person under investigation rather than a regular patient. We don't want people who have coronavirus to possibly expose other patients and health care providers or front desk workers to it in the hospital Any nonessential setting. doctor's appointments should be deferred at this time.

Why is your best bet to stay home with mild to moderate symptoms?

Staying home if you have symptoms similar to a common cold is best, because hospitals cold that can be treated with free from COVID-19. home remedies in many cases, including plenty of rest and nutrition. Is it true that the virus can only live on your hands for five to 10 minutes?

How long the virus can live on hands is not as important as what you do with your hands. If you are washing your hands regularly, the virus will not live on your hands for a long time. The virus can live on surfaces for days, and we are constantly using our hands and touching surfaces. More important than thinking how long the virus lives on your hands is to avoid touching your eyes, nose, and mouth with unwashed hands. Wash your hands!

What are the best ways to contain the pandemic at this

Social distancing is the best way to contain the spread at this point, along with vigorous and frequent handwashing, and making testing more available to identify positive cases and get them isolated. Aggressive social distancing, meaning going outside for food and medications only, would help decrease the spread of infection.

Should people be taking precautions like changing their clothes after going to the grocery store?

Washing your hands and avoiding touching your face are more important prevention methods than washing clothes. If we do that, along with staying home and physical distancing, we can dramatically decrease our likelihood of getting infected.

People should indeed be changing their clothes after going to places that are currently attended by hundreds of people every day such as grocery stores. Once you head home after the grocery store, first step is to use a sanitizer before touching your car door and steering wheel. For many people who have a home and a closet to keep their cold, and go to the hospital, you clothes, going to a laundromat may be their only option to wash their clothing. Why aren't gloves being recommended to the general public even though doctors use them to help prevent the spread of germs?

Medical exam gloves don't deter people in general from touching their faces because touching our faces is something natural that we do, with gloves or not. If we were kept in an experiment for a few hours wearing boxing gloves, we would likely still try to touch or scratch our face. Doctors use medical exam gloves for medical exams, touching people's skin and bodies, and they change the gloves between patients. They are experts at using gloves. If you are not a doctor, then there is no reason why you would wear medical gloves. Instead, wash your hands frequently with soap and water and avoid touching your face.

Do you have any rules/ recommendations around not touching your face while traveling, or not touching certain areas?

The only way to get around from the norm of touching your face is to be intentional. It is very difficult. The recommendation to not touch your eyes/nose/ mouth is not only limited to mass transit, but for our everyday life. We usually interact with people on a regular basis and can have potential exposure during that time. Touching your face with hands that you just cleaned and washed with soap and water is OK. That's when you scratch and itch. The problem is when we touch surfaces, hands, or other things that may have virus on them, and then we touch our face. That is how we can get infected.

Why should "flattening the curve" be a goal during outbreaks?

Flattening the curve is always a goal, because it just means limiting the number of infections. In phase two of an epidemic, you want to have as low a number of new cases as possible, particularly now that we have community transmission. We can achieve this with frequent and proper handwashing, staying home when possible if you are sick (or wearing a mask, washing hands and preventing the spread of infection when it's not possible to stay home), social distancing, self-quarantine when indicated, and contact tracing for those who test positive.

Hospitals agree to reopen and operate closed St. **Vincent Medical Center**

establishment of the Los Angeles Surge Hospital, a temporary facility in Los Angeles that will expand access to additional beds and expand ICU capacity for patients who contract COVID-19.

Dignity Health and Kaiser Permanente will partner with the State of California and the County of Los Angeles to open the facility, which will be located on the campus of the former St. Vincent Medical Center in central Los Angeles.

Last month, under his Declaration of State Emergency and Executive Order, Governor Newsom authorized the leasing of facilities to respond to the COVID-19 pandemic, including the recently closed St. Vincent Medical Center. The hospital will create additional inpatient capacity in the community to treat the expected surge of patients with COVID-19 in the coming weeks. The facility will operate as a dedicated referral hospital and will not have an emergency room or accept walkin patients. The County of Los Angeles' Department of Health Services will play a critical role in coordinating intake and transfer requests from hospitals across the County.

The Los Angeles Surge Hospital is expected to open April 13. It will open in phases, ramping up to accept more patients as physicians and staff are hired and supplies and equipment are secured, up to a projected capacity of 266 beds when fully operational.

The State of California will fund the hospital and its operations and will be responsible for obtaining all federal and state permits, licenses, and waivers to operate. The State is also responsible for procuring critical equipment and supplies, such as personal protective equipment and ventilators.

"It has never been easier to respond on your own, whether online at 2020census.gov, over the phone, or by mail — all without having to meet a census taker. It's something everyone can do while practicing social distancing at home to make a difference today, tomorrow and the next 10 years.

While nearly half of all households have responded online to the 2020 Census, some may prefer to receive a paper questionnaire. About 22% of the the beginning of the census.



Q: The skies look very clear right now. What's the best way to stargaze from my backyard?

pollution is horrendous - but even with that, a good pair of binoculars is a good place to start, look for 15x70 as the size, that'll get you amazing views of the Moon's surface and even Saturn's rings. Brands like Celestron make good stuff. Grab an app or two as well! I use Sky Safari, and it can help you learn what stars and constellations you can see. I highly recommend learning the sky first before you get a

Right now in the evening sky you've got a very bright point of light, and that's the planet Venus! In the coming weeks, as Venus catches up to the Earth in its own orbit around the Sun, in a good pair of binoculars you can see that Venus has phases, just like the Moon.

The only bad time to look at the Moon is when it's full, as there's no shadows being cast relative to our viewing here on Earth, so you lose surface detail.

In the morning, you've got Jupiter, Mars, and Saturn greeting you before sunrise. Sometimes I'll step out and share a coffee with them. But as the Earth continues in its own orbit around the Sun, we'll catch up and pass all three, so their positions will change so that prime viewing for Jupiter and Saturn will be July into August, and Mars' best will be around September.

Q: Do I need an expensive telescope?

A: You don't! Eyes work! As mentioned before, binoculars too! But if you want a telescope, start small, make sure you want to do astronomy as a hobby. I know folks who have entrylevel telescopes that cost them \$60 new, I know folks who moved to the desert, built a house around their own private observatory, then dropped a million dollars on equipment for it. Like any hobby, it's limited

to spend. I always recommend start with a reflector telescope, and look for something in the 4" range.

Q: Our newspaper has a couple of readers who insist that the Moon Landings were staged. Can you address this once and for all?

A: The ability to stage the Moon Landing was just not possible in the late-1960s. The Soviet Union and China both had the motivation to embarrass the United States on as big a stage as possible, and they certainly had the technology to know Apollo was actually happening. You're telling me all of that machinery that was made is perfectly hidden somewhere? In addition, you're telling me the 400,000 people who worked on Apollo have maintained over half a century of silence on the matter? Get real, they were real. Watch 2001: A Space Odyssey, that was Stanley Kubrick's perfection of the best special effects of the time Apollo happened, and it just doesn't cut the mustard. As the joke about Stanley Kubrick faking the Moon landing goes: When hired to fake the Moon landings, Kubrick was such a perfectionist that he shot on-location.

Q: Not to get too political, but what are your thoughts on the Space Force?

A: I think the Space Force is an okay thing actually. It's really been in the works since 2001 when the US DoD had a panel on US-aerospace challenges, and one of those recommendations was to have a space-specific set of operations and capabilities. It's just been a matter of moving the right bureaucracy to make the newer, shinier bureaucracy. I feel like in addition to its role of being a standalone version of the Air Force Space Command, it should also track and mitigate

only by how much you're willing space debris from rockets and satellites in orbit around the Earth, and should also hunt for and track asteroids, because preventing your extinction is important, especially if you have the technology to do so.

Q: Do you believe there is life out in the universe besides Earth?


A: Absolutely. From my point-of-view, knowing just how many planets are in the Milky Way by itself [about 1 trillion, yeah, 1,000,000,000,000 planets then think about how many galaxies there are in the Universe and multiply those two numbers...], it's almost arrogant to think that Earth is alone in having life.

I would be very surprised if we didn't find other life or evidence for past life in our own Solar System. Mars at one time had all of the right ingredients to be habitable. We know several moons in our Solar System, like Europa orbiting Jupiter, or Enceladus orbiting Saturn, have multiple parts of what it takes for life to occur, and may have that complete set that makes the survival of life

I would be surprised if it was anything beyond bacteria though, and I would also be surprised if it had the same kind of genetic makeup we do. For all we know, life on Earth could be the weird ones in the Universe.
