

# Letter from a Birmingham Jail

#### 16 April 1963

#### My Dear Fellow Clergymen:

While confined here in the Birmingham city jail, I came across your recent statement calling my present activities "unwise and untimely." Seldom do I pause to answer criticism of my work and ideas. If I sought to answer all the criticisms that cross my desk, my secretaries would have little time for anything other than such correspondence in the course of the day, and I would have no time for constructive work. But since I feel that you are men of genuine good will and that your criticisms are sincerely set forth, I want to try to answer your statement in what I hope will be patient and reasonable terms.

I think I should indicate why I am here in Birmingham, since you have been influenced by the view which argues against "outsiders coming in." I have the honor of serving as president of the Southern Christian Leadership Conference, an organization operating in every southern state, with headquarters in Atlanta, Georgia. We have some eighty five affiliated organizations across the South, and one of them is the Alabama Christian Movement for Human Rights. Frequently we share staff, educational and financial resources with our affiliates. Several months ago the affiliate here in Birmingham asked us to be on call to engage in a nonviolent direct action program if such were deemed necessary. We readily consented, and when the hour came we lived up to our promise. So I, along with several members of my staff, am here because I was invited here. I am here because I have organizational ties here.

You deplore the demonstrations taking place in Birmingham. But your statement, I am sorry to say, fails to express a similar concern for the conditions that brought about the demonstrations. am sure that none of you would want to rest content with the superficial kind of social analysis that deals merely with effects and does not grapple with underlying causes. It is unfortunate that demonstrations are taking place in Birmingham, but it is even more unfortunate that the city's white power structure left the Negro community with no alternative.


# Maria Teresa Farfán Blamey June 24, 1929 - May 4, 2020

Widowed twice, she became an American citizen in 1984, and took great pride in her citizenship. Her legacy continues with her six children,

There have been more unsolved bombings of Negro homes and churches in Birmingham than in any other city in the nation. These are the hard, brutal facts of the case. On the basis of these conditions, Negro leaders sought to negotiate with the city fathers. But the latter consistently refused to engage in good faith negotiation.

> Then, last September, came the opportunity to talk with leaders of Birmingham's course of the negotiations, certain promises were made by the merchants--for example, to remove the stores' humiliating racial signs. On the basis of these promises, the Reverend Fred Shuttlesworth and the leaders of the Alabama Christian Movement for Human Rights agreed to a moratorium on all demonstrations. As the weeks and months went by, we realized that we were the victims of a broken promise. A few signs, briefly removed, returned; the others remained. As in so many past experiences, our hopes had been blasted, and the shadow of deep disappointment settled upon us. We had no alternative except to prepare for direct action, whereby we would present our very bodies as a means of laying our case before the conscience of the local and the national community. Mindful of the difficulties involved, we decided to undertake a process of self purification. We began a series of workshops on nonviolence, and



we repeatedly asked ourselves: "Are you able to accept blows without retaliating?" "Are you direct action? Why sit

able to endure the ordeal of jail?" We decided to schedule our direct action program for the Easter season, realizing that except for Christmas, this is the main shopping period of the year. Knowing that a strong economic-withdrawal program would be the by product of direct action, we felt that this would be the best time to bring pressure to bear on the merchants for the needed change.

While Mr. Boutwell is a much more gentle person than Mr. Connor, they are both segregationists, dedicated to maintenance of the status quo. I have hope that Mr. Boutwell will be reasonable enough to see the futility of massive resistance to desegregation. But he will not see this without pressure from devotees of civil rights. My friends, I must say to you that we have not made a single gain in civil rights without determined legal and nonviolent pressure. Lamentably, it is an historical fact that privileged groups

# A case of negligent homicide

A normal president of either political party would have read by now the dark milestone that the country passed this week, when American deaths from coronavirus passed 100,000 in a space of three months. A normal president would have felt compelled to face up to this terrible reality in a spirit of unity and compassion, speaking to us from the Oval Office or a house of worship. A normal president would not brush aside those deaths with a perfunctory tweet, wedged with minimal sincerity into his daily outpouring of poison.

But Donald Trump isn't a normal president. He is a perpetrator. And he cannot respond appropriately to this monumental tragedy he must instead do anything he can to distract us — because he is conscious of his own guilt.

The definition of negligent homicide is the killing of another person through gross negligence, which is exactly what Trump has inflicted, on a scale that was once unimaginable.

So, whatever Trump says about China or the World Health Organization or Joe Scarborough or Barack Obama or Twitter, he knows the pandemic in America is a massive case of manslaughter perhaps the largest such instance in American history and certainly the worst in the world today.

On Friday, Trump withdrew the United States from the WHO, yet another action among many White House missteps that will prolong the pandemic, endanger Americans and others, and damage our global position. It is nothing but another attempt to blame others for the stunning ineptitude of Trump's government.

Whatever WHO officials may have said or done to maintain cooperation with Beijing, the inescapable fact is that its warnings were delivered at the same time to every member state — including nations like South Korea, New Zealand and Germany, which managed to protect their populations with far greater success than the United States.

And whatever the political shortcomings of the WHO, Trump repeatedly received flashing-red briefings about the looming coronavirus pandemic from our own intelligence agencies, which, of course, he ignored. His trade adviser Peter Navarro tried to tell him in January that this new coronavirus could kill hundreds of thousands of Americans.

Indeed, Obama administration officials had tried to make Trump aware of the likelihood of a pandemic during the 2017 transition and then watched in horror as his vandals dismantled the global health apparatus in the National Security Council and withdrew the teams monitoring potential disease threats around the world — including Wuhan, China.

Even Joe Biden tried to warn Trump last fall, when the first traces of an ominous zoonotic illness were detected. On October 24, 2019, the former vice president posted a prophetic tweet: "We are not prepared for a pandemic. Trump has rolled back progress President Obama and I made to strengthen global health security. We need leadership that builds public trust, focuses on real threats, and mobilizes the world to stop outbreaks before they reach our shores."

But rather than absorb and act on any of those crucial admonitions, Trump listened as he always does to quacks and imbeciles talking on

Whatever WHO officials may have said or done to maintain cable television, who assured him this virus was no more threatening than the flu. That was what he wanted to believe, and he acted — or, more precisely, failed to act — accordingly.

So, he told us that China had "everything under control." He said that warm weather would get rid of the virus. He promised that the virus would go away "like a miracle." He uttered many idiotic pronouncements about the virus, none of them based on fact or science. With his usual preference for isolationist stupidity, he closed our airports to travelers from China — except for Americans and travelers who had visited another country on their way from China. He still boasts about this travel ban, which we now know achieved nothing and likely made matters worse when he extended it to Europe (which unwittingly sent the virus to New York and set off the epidemic here).

The latest estimate is that Trump might have prevented nearly half of 100,000 deaths suffered here over the past few months if he had acted swiftly and wisely in late February. He must know now that his dithering incompetence cost an additional 40,000 lives, at a minimum. And yet he recklessly continues to inflict new mayhem, making false claims for nonexistent cures, encouraging premature reopenings and sending a fatally false message about face masks.

The numbers make the indictment: With roughly 4% of the world's population, the U.S. has tolled nearly 25% of the world's coronavirus deaths. There will be thousands more people who didn't have to die. Trump's feckless failure doomed them.

# Twitter's left wing bias

It's ironic that Democrats and their mouthpieces in media have been pounding the table the past few years about Russia, Russia, Russia and the importance of preserving the integrity of our elections while overlooking the fox in the henhouse of Silicon Valley.

A powerful tech sector, run by ultra-liberal political activists at Twitter and other social media networks, routinely censor conservatives and any voices that stray from its left-wing ideology. This includes Senate Majority Leader Mitch McConnell, R-Ky., whose Twitter account was suspended last August. This week, ranking member of the House Judiciary Committee Rep. Jim Jordan, R-Ohio, tweeted: "Two years ago, Twitter shadow bans @RepMattGaetz @ MarkMeadows @DevinNunes and myself. Now they've decided to censor @realDonaldTrump What's next, @jack?"

Of course, Jack Dorsey, Twitter's CEO, denies any foul play while the rest of us see pervasive evidence of alarming political bias — and de facto election meddling.

Take Twitter's latest attempt to humiliate President Donald Trump by fact-checking some of his tweets expressing concern about mail-in voter fraud. This week, Twitter singularly targeted the president — in the midst of a presidential election cycle — effectively labeling his tweets as "fake news" despite ample evidence that mailin voter fraud exists. Had Twitter administrators bothered to do a simple internet search, they would've found that federal prosecutors charged Thomas Cooper, a 47-year-old postal carrier, on Tuesday for fraudulently altering mail-in ballots from one political party to another.

Or Twitter's content monitors could've easily gone to WhiteHouse.gov and found a comprehensive study done by the

Heritage Foundation which details scores of examples of voter fraud surrounding absentee ballots. Or, heck, Twitter could've watched a 2004 video available on YouTube by Rep. Jerry Nadler, D-N.Y., who warned: "Paper ballots are EXTREMELY susceptible to fraud... I can show you experience which would make your head spin."

This is precisely what the president was warning us about in his tweets, but alas, Twitter's "fact-checkers" either didn't bother to do basic research or, worse, deliberately chose not to.

If you suspect it's the latter, then you are correct given the politically charged, anti-Trump tweets recently uncovered and outlined in an eye-opening piece by Gregg Re at Fox News. Yoel Roth, Twitter's Head of Site Integrity has tweeted his disdain for our commander in chief and the millions of patriotic, law-abiding Americans who support him. In November 2016, Roth tweeted "I'm just saying, we fly over those states that voted for a racist tangerine for a reason."

Translation: If you live in "fly-over" states and voted for Trump, then your voice doesn't count.

Or how about this missive? In September 2016, Roth tweeted: "I've never donated to a presidential campaign before, but I just gave \$100 to Hillary for America. We can't f—- around anymore." Roth has also compared the Trump administration to "ACTUAL NAZIS."

This is who Twitter wants us to trust as a "neutral" fact-checker.

Now also consider that when Twitter "fact-checked" the president, it linked to selectively chosen information that attempts to counter the accuracy of the president's tweets. Articles that were — you guessed it — created by anti-Trump left-wing media.

No bias there right?

But that's not all. What's also glaringly obvious and warranting the executive action by the president we're told is forthcoming is that Twitter hasn't fact-checked any Democratic lawmakers, media outlets or blue check-marked "journalists" who've spent the past four years spreading malicious lies and misinformation about the Russia collusion conspiracy theory and propaganda campaign that was waged against President Trump and his 2016 campaign since debunked by a special counsel probe.

Twitter is "fact-checking" the president — while turning a blind eye to his past and present political opponents who've spread malicious misinformation on its platform in an attempt to stop Trump from getting elected in 2016 and to block him from getting re-elected this November.

This stacked deck has sparked a widespread backlash against Twitter and a historic warning by the president via tweet Thursday morning: "This will be a Big Day for Social Media and FAIRNESS!" The president is expected to announce an executive order addressing the matter in the near future.

Not a minute too soon! Twitter has not only demonstrated rampant political bias for far too long — it's also crossed the line into election meddling — as studies have shown most voters get their news online. So if Conservative candidates like the president are being censored but not his Democrat opponent, Joe Biden, it's a rigged system that jeopardizes the integrity of our elections.

It's high time to right the ship.

In 1960, the last Gallup poll before the election showed John F. Kennedy leading Republican candidate Richard Nixon 78% to 22% among Catholics.

Kennedy became the first Catholic president.

In 12 of the 14 elections since then, the candidate who won the Catholic vote also won the White House.

And Republicans Richard Nixon and George W. Bush — the two candidates who initially won while losing the Catholic vote — both came back and won reelection while winning the Catholic vote.

Nixon trailed Hubert Humphrey 33% to 59% among Catholics in the last Gallup poll before the 1968 election. But in the last Gallup poll before the 1972 election, he led George McGovern by 52% to 48% among Catholics.

In 2000, George W. Bush lost the Catholic vote to Al Gore by 50% to 47%, according to the exit poll published by the Pew Research

But in 2004, according to the exit poll, Bush won the Catholic vote over Catholic candidate John Kerry by 52% to 47%.

George H.W. Bush had the opposite experience. In 1988, according to the exit poll published by The New York Times, the senior Bush beat Michael Dukakis 52% to 47% among Catholics. But in 1992, the senior Bush trailed Bill Clinton 47% to 35% among Catholics (with Ross Perot at 18%) in the last Gallup poll before he lost the presidency.

In 2008 and 2012, Barack Obama won the Catholic vote over John McCain (54% to 45%) and Mitt Romney (50% to 48%), according to the exit polls published by Pew.

In 2016, Donald Trump won the Catholic vote over Hillary Clinton by 52% to 45%.

This pattern raises an interesting question about this year's election: Will Joe Biden win the Catholic vote and become America's second Catholic president?

Or will he suffer the fate of John Kerry?

Biden often talks of his Catholicism in political settings.

"I'm a practicing Catholic, which, I guess, as a Democrat, is getting harder to be," Biden said at a Jan. 19, 2005 confirmation hearing for Secretary of State nominee Condoleeza Rice.

On April 29, 2007, Biden made a similar statement on NBC's "Meet the Press."

Tim Russert asked him: "You have changed your position on abortion. When you came to the Senate, you believed that Roe v. Wade was not correctly decided, and that you also believe that a right of abortion was not secured by the Constitution. Why did you change your mind?"

"Well, I was 29 years old when I came to the United States Senate, and I have learned a lot," Biden said in response.

"Look, Tim," he continued, "I'm a practicing Catholic, and it is the biggest dilemma for me in terms of comporting my religious and cultural views with my political responsibility."

In other words, Biden had come to believe by 2007 that it was his "political responsibility" to support the legalized killing of an unborn child. Biden also plans to give me they are women (and vice versa). "Biden believes every transg

"I still am opposed to public funding of abortion," Biden told Russert in that same 2007 interview.

On his current campaign website, Biden has a page entitled, "Joe Biden's Vision for America."

"I'm a practicing Catholic," Biden says at the top of this page. "I believe faith is a gift. And the first obligation we all have is, 'Love your God,' the second one is, 'Love your neighbor as yourself.' ... 'Treat people with dignity.' Everyone's entitled to dignity, that's a basic tenet in my household."

Elsewhere on his webpage, Biden explains how he is going to treat unborn children.

"As president," it says, "Biden will work to codify Roe v. Wade, and his Justice Department will do everything in its power to stop the rash of state laws that so blatantly violate the constitutional right to an abortion."



Biden, says his website, will restore "federal funding for Planned Parenthood" and "supports repealing the Hyde Amendment," which prohibits federal funding of abortion except in cases of rape, incest or when the life of the mother is endangered.

Biden also plans to give men government documents that say they are women (and vice versa).


"Biden believes every transgender or non-binary person should have the option of changing their gender marker to 'M,' 'F,' or 'X' on government identifications, passports, and other documentation," says his website.

He also hopes to "restore transgender students' access to sports, bathrooms, and locker rooms in accordance with their gender identity."

And his plan for health care "includes covering care related to transitioning — including gender confirmation surgery."

Whether Joe Biden becomes America's second Catholic president may depend on his ability to persuade fellow Catholics they should vote for a president who supports codifying a right to abortion, forcing taxpayers to fund abortion, letting men declare they are women and providing them with government documentation — or surgery — to establish that "fact."

# Letter from a Birmingham Jail

"Wait" has almost always meant "Never." We must come to see, with one of our distinguished jurists, that "justice too long delayed is justice denied."

We have waited for more than 340 years for our constitutional and God given rights. The nations of Asia and Africa are moving with jetlike speed toward gaining political independence, but we still creep at horse and buggy pace toward gaining a cup of coffee at a lunch counter. Perhaps it is easy for those who have never felt the stinging darts of segregation to say, "Wait." But when you have seen vicious mobs lynch your mothers and fathers at will and drown your sisters and brothers at whim; when you have seen hate filled policemen curse, kick and even kill your black brothers and sisters; when you see the vast majority of your twenty million Negro brothers smothering in an airtight cage of poverty in the midst of an affluent society; when you suddenly find your tongue twisted and your speech stammering as you seek to explain to your six year old daughter why she can't go to the public amusement park that has just been advertised on television, and see tears welling up in her eyes when she is told that Funtown is closed to colored children, and see ominous clouds of inferiority beginning to form in her little mental sky, and see her beginning to distort her personality by developing an unconscious bitterness toward white people; when you have to concoct an answer for a five year old son who is asking: "Daddy, why do white people treat colored people so mean?"; when you take a cross county drive and find it necessary to sleep night after night in the uncomfortable corners of your automobile because no motel will accept you; when you are humiliated day in and day out by nagging signs reading "white" and "colored"; when your first name becomes "nigger," your middle name becomes "boy" (however old you are) and your last name becomes "John," and vour wife and mother are never given the respected title "Mrs."; when you are harried by day and haunted by night by the fact that you are a Negro, living constantly at tiptoe stance, never quite knowing what to expect next, and are plagued with inner fears and outer resentments; when you are forever fighting a degenerating sense of "nobodiness"--then you will understand why we find it difficult to wait. There comes a time when the cup of endurance runs over, and men are no longer willing to be plunged into the abyss of despair. I hope, sirs, you can understand our legitimate and unavoidable impatience. You express a great deal of anxiety over our willingness to break laws. This is certainly a legitimate concern. Since we so diligently urge people to obey the Supreme Court's decision of 1954 outlawing segregation in the public schools, at first glance it may seem rather paradoxical for us consciously to break laws. One may well ask: "How can you advocate breaking some laws and obeying others?" The answer lies in the fact that there are two types of laws: just and unjust. I would be the first to advocate obeying just laws. One has not only a legal but a moral responsibility to obey just laws. Conversely, one has a moral responsibility to disobey unjust laws. I would agree with St. Augustine that "an unjust law is no law at all." Now, what is the difference between the two? How does one determine whether a law is just or unjust? A just law is a man made code that squares with the moral law or the law of God. An unjust law is a code that is out of harmony with the moral law. To put it in the terms of St. Thomas Aquinas: An unjust law is a human law that is not rooted in eternal law and natural law. Any law that uplifts human personality is just. Any law that degrades human personality is unjust. All segregation statutes are unjust because segregation distorts the soul and damages the personality. It gives the segregator a false sense of superiority and the segregated a false sense of Segregation, to inferiority. use the terminology of the Jewish philosopher Martin Buber, substitutes an "I it" relationship for an "I thou" relationship and ends up relegating persons to the status

of things. Hence segregation is a negative peace which is the not only politically, economically absence of tension to a positive and sociologically unsound, it is morally wrong and sinful. Let us consider a more concrete example of just and unjust laws. An unjust law is a code that a numerical or power majority group compels a minority group to obey but does not make binding on itself. This is difference made legal. By the same token, a just law is a code that a majority compels a minority to follow and that it is willing to follow itself. This is sameness made legal. Let me give another explanation. A law is unjust if it is inflicted on a minority that, as a result of being denied the right to vote, had no part in enacting or devising negative peace, in which the the law. Who can say that the Negro passively accepted his legislature of Alabama which set up that state's segregation and positive peace, in which all laws was democratically elected? Throughout Alabama all sorts of devious methods are used to Actually, we who engage in prevent Negroes from becoming nonviolent direct action are registered voters, and there are not the creators of tension. We some counties in which, even though Negroes constitute a majority of the population, not a single Negro is registered. Can any law enacted under such circumstances be considered democratically structured?

Sometimes a law is just on its face and unjust in its application. For instance, I have been arrested on a charge of parading without a permit. Now, there is nothing wrong in having an ordinance which requires a permit for a parade. But such an ordinance becomes unjust when it is used to maintain segregation and to deny citizens the First-Amendment privilege of peaceful assembly and protest.

I hope you are able to see the distinction I am trying to point out. In no sense do I advocate evading or defying the law, as would the rabid segregationist. That would lead to anarchy. One who breaks an unjust law must do so openly, lovingly, and with a willingness to accept the penalty. I submit that an individual who breaks a law that conscience tells him is unjust, and who willingly accepts the penalty of imprisonment in order to arouse the conscience of the community over its injustice, is in reality expressing the highest respect for law. Of course, there is nothing new about this kind of civil disobedience. It was evidenced sublimely in the refusal of Meshach Shadrach, and Abednego to obey the laws of Nebuchadnezzar, on the ground that a higher moral law was at stake. It was practiced superbly by the early Christians, who were willing to face hungry lions and the excruciating pain of chopping blocks rather than submit to certain unjust laws of the Roman Empire. To a degree, academic freedom is a reality today because Socrates practiced civil disobedience. In our own nation, the Boston Tea Party represented a massive act of civil disobedience. We should never forget that everything Adolf Hitler did in Germany was "legal" and everything the Hungarian freedom fighters did in Hungary was "illegal." It was "illegal" to aid and comfort a Jew in Hitler's Germany. Even so, I am sure that, had I lived in Germany at the time, I would have aided and comforted my Jewish brothers. If today I lived in a Communist country where certain principles dear to the Christian faith are suppressed, I would openly disobeying advocate that country's antireligious laws. I must make two honest confessions to you, my Christian and Jewish brothers. First, I must confess that over the past few years I have been gravely disappointed with the white moderate. I have almost reached the regrettable conclusion that the Negro's great stumbling block in his stride toward freedom is not the White Citizen's Counciler or the Ku Klux Klanner, but the white moderate, who is more devoted to "order" than to justice; who prefers

peace which is the presence of justice; who constantly says: "I your methods of direct action"; man's freedom; who lives by a mythical concept of time and who constantly advises the Negro to wait for a "more convenient season." Shallow understanding more frustrating than absolute misunderstanding from people of ill will. Lukewarm acceptance is much more bewildering than outright rejection.

I had hoped that the white moderate would understand that law and order exist for the purpose of establishing justice and that when they fail in this purpose they become the dangerously structured dams that block the flow of social progress. I had hoped that the white moderate would understand that the present tension in the South is a necessary phase of the transition from an obnoxious unjust plight, to a substantive men will respect the dignity and worth of human personality. merely bring to the surface the hidden tension that is already alive. We bring it out in the open, where it can be seen and dealt with. Like a boil that can never be cured so long as it is covered up but must be opened with all its ugliness to the natural medicines of air and light, injustice must be exposed, with all the tension its exposure creates, to the light of human conscience and the air of national opinion before it can be cured.

In your statement you assert that our actions, even though peaceful, must be they condemned because they precipitate violence. But is this a logical assertion? Isn't this like condemning a robbed man because his possession of money precipitated the evil act of robbery? Isn't this like condemning Socrates because his unswerving commitment to truth and his philosophical inquiries precipitated the act by the misguided populace in which they made him drink hemlock? Isn't this like condemning Jesus because his unique God consciousness and never ceasing devotion to God's will precipitated the evil act of crucifixion? We must come to see that, as the federal courts have consistently affirmed, it is wrong to urge an individual to cease his efforts to gain his basic constitutional rights because the quest may precipitate violence. Society must protect the robbed and punish the robber. I had also hoped that the white moderate would reject the myth concerning time in relation to the struggle for freedom. I have just received a letter from a white brother in Texas. He writes: "All Christians know that the colored people will receive equal rights eventually, but it is possible that you are in too great a religious hurry. It has taken Christianity almost two thousand years to accomplish what it has. The teachings of Christ take time to come to earth." Such an attitude stems from a tragic misconception of time, from the strangely irrational notion that there is something in the very flow of time that will inevitably cure all ills. Actually, time itself is neutral; it can be used either destructively or constructively. More and more I feel that the people of ill will have used time much more effectively than have the people of good will. We will have to repent in this generation not merely for the hateful words and actions of the bad people but for the appalling silence of the good people. Human progress never rolls in on wheels of inevitability; it comes through the tireless efforts of men willing to be co workers with God, and without this hard work, time itself becomes an ally of the forces of social stagnation. We must use time creatively, in the knowledge that the time is always ripe to do right. Now is the time to make real the promise of democracy and transform our pending national elegy into a creative psalm of brotherhood. Now is the time to lift our national policy from the quicksand of racial injustice to

the solid rock of human dignity.

You speak of our activity in Birmingham as extreme. At first I was rather disappointed that fellow clergymen would see my nonviolent efforts as those of an extremist. I began thinking about the fact that I stand in the middle of two opposing forces in the Negro community. One is a force of complacency, made up in part of Negroes who, as a result of long years of oppression, are so drained of self respect and a sense of "somebodiness" that they have adjusted to segregation; and in part of a few middleclass Negroes who, because of a degree of academic and economic security and because in some ways they profit by segregation, have become insensitive to the problems of the masses. The other force is one of bitterness and hatred, and it comes perilously close to advocating violence. It is expressed in the various black nationalist groups that are springing up across the nation, the largest and best known being Elijah Muhammad's Muslim movement. Nourished by the Negro's frustration over the continued existence of racial discrimination, this movement is made up of people who have lost faith in America, who have absolutely repudiated Christianity, and who have concluded that the white man is an incorrigible "devil."

I have tried to stand between these two forces, saying that we need emulate neither the "do or for the extension of justice? In religious leadership of this nothingism" of the complacent that dramatic scene on Calvary's community would see the justice nor the hatred and despair of the black nationalist. For there is the more excellent way of love and nonviolent protest. I am grateful to God that, through the influence of the Negro church, the way of nonviolence became an integral part of our struggle. If this philosophy had not emerged, by now many streets of the South would, I am convinced, be flowing with blood. And I am further convinced that if our white brothers dismiss as "rabble rousers" and "outside agitators" those of us who employ nonviolent direct action, and if they refuse to support our nonviolent efforts, millions of Negroes will, out of frustration and despair, seek solace and security in black nationalist ideologies--a development that would inevitably lead to a frightening racial nightmare. Oppressed people cannot remain oppressed forever. The yearning for freedom eventually manifests itself, and that is what has happened to the American Negro. Something within has reminded him of his birthright of freedom, and something are big in quality. Some -such without has reminded him that it can be gained. Consciously or unconsciously, he has been caught up by the Zeitgeist, and with his black brothers of Africa and his brown and yellow brothers of Asia, South America and the Caribbean, the United States Negro is moving with a sense of great urgency toward the promised land of racial justice. If one recognizes this vital urge that has engulfed the Negro community, one should readily understand why public demonstrations are taking place. The Negro has many pent up resentments and latent frustrations, and he must release them. So let him march; let him make prayer pilgrimages to the city hall; let him go on freedom rides - and try to understand why he must do so. If his repressed emotions are not released in nonviolent ways, they will seek expression through violence; this is not a threat but a fact of history.

Rather, I have tried to say that this normal and healthy discontent can be channeled into the creative outlet of nonviolent direct action. And now this approach is being termed extremist. But though I was initially disappointed at being categorized as an extremist, as I continued to think about the matter I gradually gained a measure of satisfaction from the label. Was not Jesus an extremist for love: "Love your enemies, bless them that curse you, do good to them that hate you, and pray for them which despitefully use you, and persecute you.' Was not Amos an extremist for justice: "Let justice roll down like waters and righteousness like an ever flowing stream." Was not Paul an extremist for the Christian gospel: "I bear in my body the marks of the Lord Jesus." Was not Martin Luther an extremist: "Here I stand; I cannot do otherwise, so help me God." And John Bunyan: "I will stay in jail to the end of my days before I make a butchery of my conscience." And Abraham Lincoln: "This nation cannot survive half slave and half free.' And Thomas Jefferson: "We hold these truths to be self evident, that all men are created equal . . So the question is not whether we will be extremists, but what kind of extremists we will be. Will we be extremists for hate or for love? Will we be extremists for the preservation of injustice with the hope that the white

Christian stand on this past Sunday, in welcoming Negroes to your worship service on a nonsegregated basis. I commend the Catholic leaders of this state for integrating Spring Hill College several years ago.

But despite these notable exceptions, I must honestly reiterate that I have been disappointed with the church. I do not say this as one of those negative critics who can always find something wrong with the church. I say this as a minister of the gospel, who loves the church; who was nurtured in its bosom; who has been sustained by its spiritual blessings and who will remain true to it as long as the cord of life shall lengthen.

When I was suddenly catapulted into the leadership of the bus protest in Montgomery, Alabama, a few years ago, I felt we would be supported by the white church. I felt that the white ministers, priests and rabbis of the South would be among our strongest allies. Instead, some have been outright opponents, refusing to understand the freedom movement and misrepresenting its leaders; all too many others have been more cautious than courageous and have remained silent behind the anesthetizing security of stained glass windows.

In spite of my shattered dreams, I came to Birmingham of our cause and, with deep moral concern, would serve as the channel through which our just grievances could reach the power structure. I had hoped that each of you would understand. But again I have been disappointed. I have heard numerous southern religious leaders admonish their worshipers to comply with a desegregation decision because it is the law, but I have longed to hear white ministers declare: "Follow this because integration decree is morally right and because the Negro is your brother." In the midst of blatant injustices inflicted upon the Negro, I have watched white churchmen stand on the sideline and mouth pious irrelevancies and sanctimonious trivialities. In the midst of a mighty struggle to rid our nation of racial and economic injustice, I have heard many ministers say: "Those are social issues, with which the gospel has no real concern." And I have watched many churches commit themselves to a completely other worldly religion which makes a strange, un-Biblical distinction between body and soul, between the sacred and the secular. I have traveled the length and breadth of Alabama, Mississippi and all the other southern states. On sweltering summer days and crisp autumn mornings I have looked at the South's beautiful churches with their lofty spires pointing heavenward. I have beheld the impressive outlines of her massive religious education buildings. Over and over I have found myself asking: "What kind of people worship here? Who is their God? Where were their voices when the lips of Governor Barnett dripped with words of interposition and nullification? Where were they when Governor Wallace gave a clarion call for defiance and hatred? Where were their voices of support when bruised and weary Negro men and women decided to rise from the dark dungeons of

hill three men were crucified. We must never forget that all three were crucified for the same crime--the crime of extremism. Two were extremists for immorality, and thus fell below their environment. The other, Jesus Christ, was an extremist for love, truth and goodness, and thereby rose above his environment. Perhaps the South, the nation and the world are in dire need of creative extremists.

I had hoped that the white moderate would see this need. Perhaps I was too optimistic; perhaps I expected too much. I suppose I should have realized that few members of the oppressor race can understand the deep groans and passionate yearnings of the oppressed race, and still fewer have the vision to see that injustice must be rooted out by strong, persistent and determined action. I am thankful, however, that some of our white brothers in the South have grasped the meaning of this social revolution and committed themselves to it. They are still all too few in quantity, but they as Ralph McGill, Lillian Smith, Harry Golden, James McBride Dabbs, Ann Braden and Sarah Patton Boyle--have written about our struggle in eloquent and prophetic terms. Others have marched with us down nameless streets of the South. They have languished in filthy, roach infested jails, suffering the abuse and brutality of policemen who view them as "dirty niggerlovers." Unlike so many of their moderate brothers and sisters, they have recognized the urgency of the moment and sensed the need for powerful "action" antidotes to combat the disease of segregation. Let me take note of my other major disappointment. I have been so greatly disappointed with the white church and its leadership. Of course, there are some notable exceptions. I am not unmindful of the fact that each of you has taken some significant stands on this issue. I commend you, So I have not said to my people: Reverend Stallings, for your

complacency to the bright hills of creative protest?"

Yes, these questions are still in my mind. In deep disappointment I have wept over the laxity of the church. But be assured that my tears have been tears of love. There can be no deep disappointment where there is not deep love. Yes, I love the church. How could I do otherwise? I am in the rather unique position of being the son, the grandson and the great grandson of preachers. Yes, I see the church as the body of Christ. But, oh! How we have blemished and scarred that body through social neglect and through fear of being nonconformists.

There was a time when the church was very powerful--in the time when the early Christians rejoiced at being deemed worthy to suffer for what they believed. In those days the church was not merely a thermometer that recorded the ideas and principles of popular opinion; it was a thermostat that transformed the mores of society. Whenever the early Christians entered a town, the people in power became disturbed and immediately sought to convict the Christians for being "disturbers of the peace" and "outside agitators." But the Christians pressed on, in the conviction that they were "a colony of heaven," called to obey God rather than man. Small in number, they were big in commitment. They were too God-intoxicated to be "astronomically intimidated." By their effort and example they brought an end to such ancient evils as infanticide and gladiatorial contests. Things are different now. So often the contemporary church is a weak, ineffectual voice with an uncertain sound. So often it is an archdefender of the status quo. Far from being disturbed by the presence of the church, the power structure of the average community is consoled by the church's silent--and often even vocal--sanction of things as they are.

But the judgment of God is upon the church as never before. If today's church does not recapture the sacrificial spirit of the early church, it will lose its authenticity, forfeit the loyalty as an irrelevant social club with commended the Birmingham profundity to one who inquired

within the church, as the true unarmed, nonviolent Negroes. I ekklesia and the hope of the doubt that you would so quickly world. But again I am thankful commend the policemen if you to God that some noble souls were to observe their ugly and from the ranks of organized religion have broken loose here in the city jail; if you were to from the paralyzing chains of conformity and joined us as active partners in the struggle for freedom. They have left their secure congregations and walked the streets of Albany, Georgia, with us. They have gone down the highways of the South on tortuous rides for freedom. Yes, they have gone to jail with us. Some have been dismissed from their churches, have lost the support of their bishops and fellow ministers. But they have acted in the faith that right defeated is stronger than evil triumphant. Their witness has been the spiritual salt that has preserved the true meaning of the gospel in these troubled times. They have carved a tunnel of hope through the dark mountain of disappointment. I hope the church as a whole will meet the challenge of this decisive hour. But even if the church does not come to the aid of justice, I have no despair about the future. I have no fear about the outcome of our struggle in Birmingham, even if our motives are at present misunderstood. Before the pen of Jefferson etched the majestic words of the Declaration of Independence across the pages of history, we the Negro sit inners and were here. For more than two centuries our forebears labored in this country without wages; they made cotton king; they built the homes of their masters while suffering gross injustice and shameful humiliation - and yet out of a bottomless vitality they continued to thrive and develop. If the inexpressible cruelties of slavery could not stop us, the opposition we now face will surely fail. We will win our freedom because the sacred heritage of our nation and the Negro women, symbolized in a eternal will of God are embodied in our echoing demands. > It is true that the police have exercised a degree of discipline in handling the demonstrators. In this sense they have conducted themselves rather nonviolently" in public. But for what purpose? To preserve the evil system of segregation. Over the past few years I have consistently preached that nonviolence demands that the means we use must be as pure as the ends we seek. I have tried to make clear that it is wrong to use immoral means to attain moral ends. But now I must affirm that it is just as wrong, or perhaps even more so, to use moral means to preserve immoral ends. Perhaps Mr. Connor and his policemen have been rather nonviolent in public, as was Chief Pritchett in Albany, Georgia, but they have used the moral means of nonviolence to maintain the immoral end of racial injustice. As T. S. Eliot has said: "The last temptation is the greatest treason: To do the right deed for the wrong reason."

I wish you had commended demonstrators of Birmingham for their sublime courage, their willingness to suffer and their amazing discipline in the midst of great provocation. One day the South will recognize its real heroes. They will be the James Merediths, with the noble sense of purpose that enables them to face jeering and hostile mobs, and with the agonizing loneliness that characterizes the life of the pioneer. They will be old, oppressed, battered seventy two year old woman in Montgomery, Alabama, who rose up with a sense of dignity and ride segregated buses, and who about her weariness: "My feets

gospel and a host of their elders, courageously and nonviolently sitting in at lunch counters and willingly going to jail for conscience' sake. One day the South will know that when these disinherited children of God sat down at lunch counters, they were in reality standing up for what is best in the American dream and for the most sacred values in our Judaeo Christian heritage, thereby bringing our nation back to those great wells of democracy which were dug deep by the founding fathers in their formulation of the Constitution and the Declaration of Independence.

Never before have I written so long a letter. I'm afraid it is much too long to take your precious time. I can assure you that it would have been much shorter if I had been writing from a comfortable desk, but what else can one do when he is alone in a narrow jail cell, other than write long letters, think long thoughts and pray long prayers?

If I have said anything in this letter that overstates the truth and indicates an unreasonable impatience, I beg you to forgive me. If I have said anything that understates the truth and indicates my having a patience that allows me to settle for anything less than brotherhood, I beg God to forgive me.

I hope this letter finds you strong in the faith. I also hope that circumstances will soon make it possible for me to meet each of you, not as an integrationist or a civil-rights leader but as a fellow clergyman and a Christian brother. Let us all hope that the dark clouds of racial prejudice will soon pass away and the deep fog of misunderstanding will be lifted from our fear drenched communities, and in some not too distant tomorrow the radiant stars of love and brotherhood will shine over our great nation with all their scintillating beauty.

# Protect your eyes while staying at home

At a time when we are spending more time sheltering at home as part of efforts to protect public health as we combat the COVID-19 pandemic, many of us are glued to our smartphones, tablets and laptops for work, school, information and entertainment.

But, did you know spending too much time staring at such devices can cause eye strain that can actually lead to pain, discomfort and, for young children, may actually result in near-sightedness?

John Shan, chief of optometry, Kaiser Permanente Panorama City Medical Center, has some advice.

"What's important is to give your eyes some rest from prolonged staring at electronic devices," he said. "Just like any other muscle in the body, if you overexert your eyes, you're likely to experience a strain. When your eyes get strained, you'll likely start to get headaches, blink less and eventually dry out your eyes. As a result, they may excessively tear, turn red and lead to discomfort and increase more risk for infection.

That is why for adults and children alike, it's important to take regular breaks from staring at devices such as laptops and smartphones.

In order to protect your eyesight, Shan recommends abiding by the 20/20/20 rule.

"Every 20 minutes, as a general rule of thumb, take a 20-second break, and look out 20 feet," he explained. "We want you to look far away, because then your eye muscle gets a chance to relax. It gives your eye muscle a little time to recoup and avoid problems later on."

Shan cautioned that prolonged close-up staring at electronic can be especially devices harmful for young children ages 5-11. Because they are still developing, it can increase their risk of developing myopia, or near sightedness, he warned.

"Take good care of your eyes, and they will take good care of you," Shan said. "Don't' take your vision for granted!"

# **Medical clinic settles** discrimination charges

RIVERSIDE Riverside Riverside County, has agreed to resolve allegations that it violated the Americans with Disabilities Act (ADA) by failing to provide effective communication to deaf and hard-of-hearing patients.

The settlement resolves allegations that Riverside Medical Clinic failed to provide a qualified sign language interpreter or other appropriate form of auxiliary aid or service to a patient who is deaf and her family, instead relying on a video remote interpretation system that often failed to work.

The ADA requires medical hard of hearing; Medical Clinic, a company that providers to ensure effective operates seven medical offices in communication for patients who are deaf or hard of hearing. The settlement requires the company to provide appropriate auxiliary aids and services free of charge so that people who are deaf or hard of hearing have full and equal access to treatment at its offices.

> Under the settlement Clinic must:

> > provide appropriate

auxiliary aids and services necessary for effective communication to patients and their companions who are deaf or

advertise the availability of auxiliary aids and services;

conduct individualized assessments for patients who are deaf or hard of hearing to determine what auxiliary aids and services are best suited for their needs; and

pay \$5,000 in agreement, Riverside Medical compensation to the complainant and a \$1,000 civil penalty to the United States.
