Yes, I still wear a mask.

■ Fifteen months into the pandemic, not everyone is ready to ditch the mask.

Last week, the US Centers for Disease Control and Prevention announced that those of us who are fully vaccinated could remove our masks in most situations. After over a year of living in a Covid-19 world, I thought that I would have been ecstatic.

Instead, I greeted the news with a nervous chuckle.

I received my second shot of the Pfizer vaccine back in April and have been considered "fully vaccinated" for just about a month. As such, I have started to venture back out into the wide-open world again with a little bit more confidence in my stride.

Even still, I wore my mask; sometimes two.

While California still has strict mandates in place and is not anticipated to reopen completely until June 15, the CDC's latest rollback seems to have left many -myself included - with more questions than answers.

As such, there are a few reasons why I am not so sure I am ready to take my mask off just yet.

The ability to unmask comes with a significant caveat: "Those who are fully vaccinated."

While the concept of "fully vaccinated" sounds simple enough, I have yet to hear any compelling or convincing argument on how governments, stores, restaurants, and the like can or will be able to enforce that particular provision.

Everything I have seen to this point seems to depend on the highly undependable "honor system."

At the time of writing, Los Angeles County is reporting that just over 59% of residents have been administered at least one dose of a Covid-19 vaccine, with over 43% being considered fully vaccinated. While promising, that leaves a significant number of the population without a shot in their arm.

Some cannot be vaccinated for health concerns. Some kids are not eligible yet. Some will ultimately choose not to receive the vaccine, and that is their right.

Who is to say if the person next to you in the grocery store has been vaccinated or not and why?

While we seem to be in the final stretch of the pandemic, we have certainly not crossed the finish line yet. While numbers are low, we cannot neglect that they still do represent a life affected.

Speaking of numbers, while writing this piece I desperately searched for a key bit of evidence or statistics that I could wave around and put on a pedestal; something to say that wearing a mask is still extremely relevant.

The fact is, I couldn't find any.

Covid rates are continuing to decline. On Tuesday, the county reported only 159 new cases and 12 deaths, which is a far cry from the numbers that we were seeing back in November and December.

Those worried about "breakthrough cases" should take comfort in the fact that they are extremely rare.

As of this writing, the CDC's website shows only 1,359 hospitalized or fatal vaccine breakthrough cases reported with only 223 deaths, compared to the over 115 million in the United States who it says are fully vaccinated.

Everything points to us being on the precipice of normality.

However, mentally - for me at least - it is not so simple as data.

Retired LAPD deputy chief hired as public safety director

NORWALK - The City of Norwalk made immediate efforts to recruit a replacement for former Director of Public Safety, Grissel Chavez, who has moved on to a position with the City of Bell Gardens.

Former Los Angeles Police Department (LAPD) Deputy Chief Dennis Kato is the new Interim Director of Public Safety. He officially commenced with the city on May 13.

The Public Safety Department is an essential service provided by the city, so an immediate replacement was crucial, which led to the recruitment of Kato. He brings with him 32 years of veteran experience with the LAPD.

He has worked a variety of assignments such as patrol, gangs, vice, narcotics, burglaries, major assault crimes, and Asian Crimes homicides. He has supervised law enforcement personnel for over 19 years and has been a command officer (captain and above) for over 11 years.

As a Deputy Chief, Kato oversaw a workforce of approximately 1,500 officers and 500 civilian personnel.

Norwalk Mayor Jennifer Perez stated, "We are grateful for the work performed by Grissel Chavez, our former Director. She was instrumental in the many efforts

performed by the department, including work in combatting homelessness in Norwalk.

As a result, it is important that the City recruit a replacement that will be ready to run the Department and hit the ground running from day one. Mr. Kato has both extensive leadership skills and experience in community policing to continue the work that had been done by the Department of Public Safety while the City seeks a permanent replacement for director."

As the new Interim Director of Public Safety, Kato now leads and manages day-to-day operations of the Norwalk Public Safety Department and its staff of 52 employees.

Kato expressed his enthusiasm for the new task when he stated, "I'm grateful and excited for this opportunity. My experience with the LAPD along with my training has provided me with the foundation to lead the many efforts here and to expand on the duties of community policing efforts for Norwalk's growing community."

Kato has dealt with many intense policing efforts including several experiences of community unrest during his tenure with the LAPD and this has molded and shaped his view of policing and solidified his commitment to the tenets of community policing. This involves fostering trust between the police and the community, while aligning policies with community values and prioritizing community engagement.

The City of Norwalk's Department of Public Safety was established in March of 1989 and has since evolved into a model for



other cities and law enforcement agencies throughout the nation.

The Department was created with the intention of establishing the concept of community-based law enforcement services. The City's goal was to find effective solutions to neighborhood concerns of crime, gang activity, juvenile delinquency, narcotics activity, vandalism, and in general

the "quality of life" issues in the Norwalk community. The Department regularly resolves many neighborhood issues before they require a law enforcement response through a unique and progressive mix of services, inter-agency partnerships, and community support and cooperation.

Norwalk-La Mirada's Anna Apoian receives national award

■ The food service director was honored this month for her dedication to Norwalk-La Mirada students.

NORWALK - The national, non-profit School Nutrition Association (SNA) has named Anna Apoian, food service director for Norwalk-La Mirada Unified School District, the National Director of the Year.

The award recognizes the extraordinary contributions of school nutrition directors who manage effective school meal programs providing healthy, appetizing meals to students.

A little more than a year since COVID-19 created new logistical challenges for school nutrition directors, SNA continues to applaud the dedication, ingenuity and compassion shown by its members who have excelled in keeping students fed during the pandemic.

When the pandemic hit, Apoian led her team in re-opening schools for meal distribution as the county guidelines changed. She was first to start pantry style meal distribution with assistance from the superintendents, executive board administrators, board members, local churches, and police in distributing meals at two drive-up locations.

More than 5,000 households in the area benefited from this outreach. As the county slowly reopened, the nutrition services team also began to reopen the school kitchens for non-congregate meal service, three times a week, to keep the community connected to the schools. The meal programs began with two schools, to six, to eight, and 25 by the end of the first school year.

Apoian started an "Extra Eats" program, which included food for suppers and snacks. This helped the community when supermarket shelves were sparse and assisted in preventing future lay offs for her staff by securing more federal and state revenue for the budget.

Prior to the pandemic at a

previous district, she and her team installed deli bars for made-to-order sandwiches and salads, a panini room for hot sandwiches and a pizza oven where students see the pizza being baked. Her students also enjoy scratch-made signature salsas and dressings for produce bars.

She also directed a Breakfast-in-the-Classroom program, which continues to serve 90 percent of students. At her current district, freshly prepared burritos, breakfast sandwiches and smoothie bowls have helped increase participation by 20 percent. Apoian creates new recipes to be more inclusive of students' special dietary restrictions, including no-bake energy bites for a vegan meal entrée and the Green Monster smoothie. Her menu focus is on plant-forward, while continuing to serve 100 percent USDA beef and antibiotic free poultry, in healthful portions.

In her tenure, Apoian has been committed to improving communication and general wellness in her community. She hired parent-to-parent nutrition educators, created a sustaining employee wellness program, provided physical activity training for elementary teachers by professional trainers, began Active Recess at eight elementary school sites, updated wellness policies and has been in charge of the Wellness Committees since 2004.

She also started "Your Chew," a monthly newsletter for employees. To keep parents involved and updated, Apoian attends district level parent meetings quarterly and uses feedback to make adjustments to menu options.

Apoian has dedicated many hours to volunteering for California SNA and local chapters, helping to restart the defunct local chapter that supports nine



area districts. Over the summer of 2020, she created the Summer Series-Friday Fun to keep local chapter members connected and provide support and a sense of community for professionals during an uncertain time. She has been a member on the state SNA board of directors, president elect of the regional SNA chapter, and served in numerous other state and local SNA leadership roles.

Committed to professional development, Apoian continues to promote the benefits of being a member of state and national SNA, attending and presenting at various conferences and workshops. She has also conducted trainings at 28 neighboring districts and in 2019, she presented team building to 300 frontline workers at an annual workshop.

"It's inspiring to see directors like Anna Apoian, who strategically incorporate invaluable feedback from students, parents and district administration into bettering her program," said SNA President Reginald Ross, SNS. "Her outside-the-box thinking has helped make her program a true success for students. We congratulate her on

this deserved national award."

The regional Director of the Year Award was created to recognize school nutrition directors who exhibit an extraordinary commitment to their school meal programs. The directors are responsible for maintaining the quality of the program through student interaction, menu planning and a commitment to serving nutritious, tasty and well-balanced school meals.

Through effective oversight of all aspects of foodservice operations, including budgeting, staffing, training, marketing and community outreach, school nutrition directors ensure the overall success of school meal programs.

On May 5, Apoian was honored during the first-ever "Our Heroes: Celebrating the 2021 SNA Award Winners" virtual event. Nominees, nominators, state leaders, Board of Directors, Leadership Development Committee and Back to School Summit attendees will be invited to celebrate the accomplishments of this year's SNA award winners.

If you decide that now is the time to take off your masks (whether vaccinated or not), I hope that you act responsibly, safely, and courteously to your neighbors and the community around you.

As for me, I think I will hold on for just a little while longer.

Sanchez reintroduces federal hazard pay

NORWALK – Reps. Linda T. Sánchez (CA-38) and Matt Cartwright (PA-08) this week re-introduced the Coronavirus Frontline Workers Fair Pay Act, legislation to establish a hazard pay program for healthcare professionals and other essential workers on the frontlines of the coronavirus pandemic.

Specifically, the bill would create a dedicated fund within the U.S. Treasury Department to provide hazard pay funds to employers. Healthcare workers would receive a hazard pay increase of \$18.50 per hour, and other essential workers would receive an increase to \$13 per hour. Pay would be capped at \$35,000 and \$25,000, respectfully.

"For over a year now, our nation's essential workers in hospitals, grocery stores, warehouses, and emergency services have kept this country running," said Sánchez. "Many have no choice but to go to work, despite the risk of bringing the virus home to their loved ones, and we would not have gotten through this past year without them. The pandemic is not over and America's workers continue to show up for us.

Providing them with hazard pay is the least we can do."

"Nurses, grocery store staff, garbage collection workers – these are roles we too often take for granted, but these workers maintained critical services throughout uncertain times in this pandemic. That's why I continue to fight for hazard pay for frontline workers like them," Cartwright said. "Although nothing can fully compensate them for the risks they've faced and the sacrifices they've made, enacting this bill would be an important step to paying the heroes of this pandemic more fairly for their critical work."

This legislation was originally filed by Sánchez and Cartwright in May of 2020. The updated bill would allow the benefit to run through the end of the employment designated COVID-19 Public Health Emergency or until Sept. 30, 2021.

The new legislation also expands the definition of "high-risk health care worker" to include all of the occupations listed in our 2020 Congressional Record Statement.

Happy 80th, Bob Dylan

Bob Dylan made me break into silent tears once, in concert on Nov. 11, 2001. Two months from the Sept. 11 attacks, people were still shattered.

The song was “Tangled up in Blue.” Pitch-perfect for the moment in time, from the album “Blood on the Tracks.” Try it sometime and you shall be released.

The greatest American bard (Sorry, Walt and Bruce) turns 80 on Monday, May 24. Dylan has serenaded generations since the early '60s, when he rose from Greenwich Village folk music haunts.

The young man from Minnesota seized a breeze in the bright JFK era. The nation had an ear for the utterly new, true and fresh songs spinning off his guitar.

“Blowin’ in the Wind,” “A Hard Rain’s A-Gonna Fall” and “Chimes of Freedom” set the sound stage for social protests and marches of that decade.

In the '70s, a young girl played Dylan songs on the piano. Always crowd-pleasers, among them “Don’t Think Twice, It’s All Right” (“Goodbye is too good a word, babe.”)

His eyes were bluer than robin’s eggs, as singer Joan Baez wrote in bittersweet lyrics about their love affair.

With his raspy voice, sulky charm and matchless harmonica, Dylan enchants the world over.

Given the 2016 Nobel Prize for his music and literary memoir, Dylan didn’t go to Sweden for the honor.

So let the songbook speak for itself. Dylan recently sold it for about \$300 million. Laced in every line, the restless artist remains a mystery to be solved.

“Mr. Tambourine Man” is my favorite for dazzling wordplay. It seems a self-portrait — keeping time with a wandering troubadour who plays in the jingle jangle morning mists (“Yes, to dance beneath the diamond sky with one hand waving free / Silhouetted by the sea”).

To be fair, “Like a Rolling Stone” that ode of scorn, was ranked as Dylan’s best song — by Rolling Stone magazine, no kidding. That came soon after Dylan went electric at the Newport Folk Festival.

The song “Mississippi” captured me, from the record “Love and Theft.” Don’t we all know the feeling: “Only one thing I did wrong / Stayed in Mississippi a day too long.”

Dylan’s love songs are unbelievably tender under his shiny hard shell.

When sung by Judy Collins or old muse Baez (“Visions of Johanna”), their beauty truly rocks. Collins sings “Farewell” and “Tomorrow is a Long Time” in her piercing golden voice.

One exception is the plaintive song “Sara” written for his then-wife, “So easy to look at / So hard to define / ... sweet love of my life.” Only Dylan could sing that song.

On the same album, “Desire,” is an arresting song no writer can resist: “One More Cup of Coffee.”

No other singer-songwriter possesses his psychic grasp of the country’s soul, captivating over miles, tears and years. Dylan’s life is the road.

The man from the Midwest wrote vividly about the South, from beloved New Orleans to Mobile, Alabama, to Memphis, Tennessee, to the Nashville skyline.

Baez’s haunting ballad “Diamonds and Rust” shows just how easy — and how hard — it would be to love Dylan. (“My poetry was lousy, you said.”)

In song, Baez addresses Dylan in memories that travel back in time to standing in Washington Square, where their breath comes out as white clouds, mingles and hangs in the air.

At a concert while Bruce Springsteen played, a historian who knows Dylan told me about this scene in her song.

I answered with Baez’s line: “Speaking strictly for me, we both could have died then and there.”

Nailed it, history repeating itself.

Baez’s 80th birthday was in January. A couple of Aprils ago, I went to a farewell concert. Boy, did she sing a lot of searing Dylan songs.

In 2020, Dylan released a major work, a montage titled “Murder Most Foul,” on JFK’s assassination as a tragic point of no return for America.

Innocence, optimism and common dreams were dashed by the shots that blasted a young vibrant leader. It’s an apt coda, for Dylan launched in that promising period.

But he was so much older then.

Remaking the ocean of experience, seeing and feeling things as if for the first time — isn’t that what it takes to be forever young?

Play it, Bob.

2020’s startling numbers

We’re a statistics-happy society. We obsess over the latest numbers on just about everything — birthrates, jobs and population changes — mining them for trends.

Some stats are really obscure, such as the shocking amount of electricity Bitcoin uses. The digital currency’s complex computing process devours 143 terawatt-hours a year — more than the country of Norway! Can you believe?

Anyhow, the commonly quoted stats are dribbling in, but because they are being compared to those of the wildly abnormal pandemic year of 2020, what should we do with them? The answer may be to marvel at the dramatic shifts but with asterisks attached.

Take changes in state and city populations. California reported a net loss in population last year, the first time since 1900, when the state started counting. The effects of the pandemic, says Hans Johnson of the Public Policy Institute of California, should put an asterisk on last year’s shrinkage.

Two big reasons for the falloff were the large number of COVID-19 deaths and a sharp decline in international immigration. But as shots in Californian arms curb the disease and more normal immigration patterns return, the state should resume growing slowly, as it has in recent years, Johnson adds.

New York state also lost people last year. Some of it resulted from COVID lockdowns sending people out of its cities to less crowded parts of the country. As with California, however, more of it reflects a decline in foreign immigration, according to the Empire Center.

The country as a whole last year grew at its slowest pace since 1918 — by only 700,000 residents, or 0.2 percent. Some of that low count reflects deaths from COVID and a lower birthrate. The number of babies born in the U.S. hit a 4 million high in 2015 and has fallen every year since.

The pandemic may have accelerated the process. Last December, when babies conceived early in the health crisis would have been born, the U.S. birthrate posted its sharpest decline in history. Was a drop-off this severe a temporary phenomenon reflecting health and economic fears of those strange times? We will see.

Cities are reporting significant spikes in shootings. Experts have

offered some pandemic-related explanations for that as well. Lost jobs, closed schools and suspended after-school activities have left vulnerable young people on the streets where violent youth gangs do their recruiting.

COVID knocked the economy on its rear, so a large jump to more normal levels of consumer spending is producing price numbers that just reflect a return to normal. Gasoline prices, for example, soared 50 percent in April compared with the same month of 2020. For perspective, though, they actually decreased 1.4 percent from March 2021.

Economists surveyed by the Wall Street Journal expect the economy to grow in the second quarter at an annual rate of 8.1 percent over the same time a year earlier. This would be the most torrid growth in about 40 years. Then again, consider the pathetic base we’re starting at — the annus horribilis of 2020.

The U.S. Centers for Disease Control and Prevention says the number of new COVID cases — almost 350,000 a week early this month — could drop to below 10,000 by August if vaccinations continue apace. The scourge seems to be ending, and barring some other astounding turn of events, the trend lines could start becoming less dramatic.

Clearly, 2021 is turning into a whole new ballgame. Making comparisons to the sick, sick year of 2020 may offer opportunities to exclaim over the biggest year-to-year surge or drop in this or that since the nation’s founding. We can have fun with that, but, hey, remember the asterisks.

Government debt

Dear Editor:

In his opinion piece (Patriot, May 6, 2021), Steve Chapman argues that the \$4 trillion in relief doled out under the Trump administration was justified, but that the \$6 trillion proposed by the Biden administration is not, because “the emergency has subsided.”

Has it? Millions of Americans are still out of work. Moreover, the climate emergency shows no signs of easing.

Mr. Chapman referenced the Penn Wharton Budget Model that found that increasing the tax rate on capital gains would reduce revenue. That reminds me of Reagan’s (and more recently Trump’s) claim that lowering taxes would increase revenue and balance the budget. History shows otherwise.

Moreover, the claim that “over the first decade, Biden’s infrastructure package would cost \$600 billion more than it would bring in” must be put in context. That works out to \$60 billion a year, compared to the \$628.6 billion spent on national defense.

Mr. Chapman claims that “piling more federal debt...is bound to divert funds that would have gone to private investment, to the detriment of the economy.” Where does Mr. Chapman believe that the money is being diverted? Spending on infrastructure, etc., does not leave the economy; it stimulates the economy, hence the term “investment.”

More wisdom from Mr. Chapman: “The budgetary binge may also lift inflation to levels that Americans have not seen since the 1980’s.” Really? Wasn’t Mr. Chapman just arguing that more federal debt was going to divert funds from private investment, slowing the economy?

Paul Krugman recently argued that government debt tends to lower inflation. He offers as evidence not only recent U.S. experience, but also that of Japan, whose accumulated debt equals over 266% of its GDP. Far from experiencing inflation, the central bank in Japan has been fighting deflation for the past 30 years.

So whom to believe—Mr. Chapman, or the guy with a Nobel Prize in economics?

What labor shortage?

America has a record 8.1 million job openings.

The media call it a “labor shortage.”

But it’s not a labor shortage; it’s an incentive shortage.

“No one wants to work,” says a sign on a restaurant drive-thru speaker in Albuquerque, New Mexico. “Please be patient with the staff that did show up.”

I never wanted to work. I got a job because I had to support myself. That was good for me. It forced me out of my comfort zone. It made me a better person.

Had government offered me almost equal money not to work, I never would have applied.

Today, government takes away that incentive.

The American Rescue Plan, passed in March, increased unemployment payments by hundreds of dollars and extended them for up to 73 weeks. Given the cost of commuting, etc., many people find they are better off financially not working.

Denmark once offered workers five years of unemployment. Then they noticed that workers found work after exactly five years. So, Denmark cut the benefit to four years. Then most workers found jobs after four years. Now Denmark, wisely, has cut benefits in half.

Incentives matter.

America’s unemployment handouts began during the Great Depression when desperate people really needed help. Still, you could collect for only 16 weeks.

Barack Obama extended unemployment benefits to up to 99 weeks.

“There are no jobs!” people I interviewed waiting in line for benefits in New York City once told me.

But that wasn’t true. There were lots of entry-level jobs within walking distance.

My staff visited 79 nearby stores. Forty said they wanted to hire. Twenty-four said they’d hire people with no experience.

People in the unemployment line also said that the government should do more to train them for jobs. But New York already offered “job training” centers, so I sent an intern out to see what they did. The first offered to help her get welfare. A second told her to apply for unemployment. Neither place suggested looking for a job.

When she insisted that she wanted work, not handouts, they directed her to yet another building. There she was told she could not receive help because she didn’t have a college degree.

Finally, a fourth office offered her an interview at the sandwich chain Pret a Manger. The boss there told her she’d wasted her time going to the government Jobs Center because she could have gotten that same interview using Craigslist.

Some politicians understand that handouts encourage dependence. Sixteen states are now ending extra unemployment benefits early. Montana and Arizona replaced extra unemployment benefits with a bonus for people who find work.

Even President Joe Biden has noticed the unintended consequences of his party’s benefits. “If you’re ... offered a suitable job, you can’t refuse that job and just keep getting unemployment,” he said.

Seems more than reasonable. Yet a New York Times headline says, “Some say it presents an undue hardship.”

The reporter interviewed a “Mx. San Martin, 27, who uses the pronouns they and them.”

Mx. Martin wants to work with pets. They complained that “there simply weren’t enough jobs that I would actually want.” Restaurant work “is not in my field of interest.”

Too bad.

Bad for all of us when people think they’re entitled to our tax money if bureaucrats don’t get them the exact job they want.

According to mega-yacht sellers, the main draw of these ostentatious purchases is that they reinforce inequality, literally letting the rich float in leisure and luxury, oceans apart from even having to see hoi polloi like us.

The wailing by those who run corporate America is not for the plight of the great majority of workaday families who’ve seen their incomes stagnate and even plummet to zero during the past months of the coronavirus pandemic. Rather, this chorus of woe is arising from powerful plutocratic interests that have been enjoying windfall profits but now want us to feel sorry for them. Why? Because, they cry, that meanie in the White House, Joe Biden, intends to jack up their corporate tax rate up from 21% to 28%.

But wait. Didn’t former President Trump and the GOP Congress slash the corporate share of our nation’s upkeep nearly in half just four years ago, from 35% to 21%, shifting the burden to the middle class and poor? Yes. And didn’t they promise that those cuts would create millions of new jobs and raise the incomes of the working class? Yes, again. Yet corporations got richer and working stiffs got shafted.

La Mirada girls soccer returns to CIF semifinals

■ Amarissa Alvizo scores two goals as Matadores defeat South Torrance, 4-0, in quarterfinals.

NORWALK – After two close games to start the post season, the La Mirada High School Girls Soccer team is on a major roll.

That roll began at the CIF-Southern Section Division 2 playoffs, as the Matadores defeated visiting South Torrance, 4-0, Tuesday afternoon in the quarterfinals at John Glenn High.

La Mirada has been on a three-year road trip, as the football stadium on campus has been unplayable and is due to be remodeled soon.

In the first round, the Matadores defeated Palos Verde, 1-0, in the first overtime period with a golden goal by senior defender Marissa Marquez and in another scoreless regulation game in the second round, defeated Mission Viejo, 3-1 on PK's.

The three Matadores that scored penalty kicks were Marquez, senior defender Emma Viayra and senior midfielder Ryley Candelario.

The Matadores, with the win, improved to 13-0-2 and have allowed only one goal all season. The win also guarantees a second consecutive trip to the CIF State playoffs that begin after the CIF-SS championships.

They will play Claremont (14-3), who won in the quarterfinals on PK's, 3-1, in the semifinals Saturday (May 23) at John Glenn at 5:00 pm.

The winner of Saturday's semifinal will travel to either Saugas (8-1-4) or Downey (16-3-3) for the CIF Championship next weekend, May 28 or 29.

La Mirada lost in last years' semifinals to eventual CIF Champion Mira Costa.

This will mark the third time in the last four years that the Matadores have advanced to the CIF semifinals and sixth in the

last seven years.

"We just keep playing," La Mirada Girls Soccer coach Dave Christensen said. "That's really the secret to our lasting success. We've had a good run."

We go out and we know our opportunities and we know people who have done it before and why not us and why not keep going. This is a dog fight. This is to go to the semis, to go to state. It's great."

Junior forward Amarissa Alvizo led the way for La Mirada with two goals, which now gives her a team-leading 15 for the season. Also scoring was Marquez with a penalty shot.

The game was a defensive battle in the first half with both teams not being able to capitalize on a few scoring opportunities.

La Mirada's best chance in the first half came on a left-footed shot by sophomore midfielder Kyra Hamilton in the 34th minute as South Torrance goal keeper Sophia Keel jumped to knock the ball out on the right side of the goal.

Six minutes prior to that attempt, Candelario took a corner kick that was bending right to Keel, who knocked the shot away with her hand.

South had its best chance in the 36th minute as Alexi Anaya, from 30 yards out, hit the right post.

Neither goalie had any real tough saves, but La Mirada's Sage Strohmman, who is headed to Army's West Point next fall, recorded her 15th shutout in regulation.

"Our defense has been strong all year," Strohmman said. "It's a cliché, but defense wins championships. Teams don't get any easy (shots on us); it's got to be a good one.

"I didn't have really anything the whole game. The second half I had one with my foot, but it was very easy for me."

Strohmman knew that the first goal by the Matadores in the second half was huge.

"That goal really inspired

us and got us going and from there we scored three more," Strohmman added. "It's nice for us because we have been going overtime and PK's, so it's nice to get one in regular time."

Strohmman, however, had her biggest save in the second round in the PK portion of the game against Mission Viejo. The senior stopped the shot that sent the Matadores to the quarterfinals against South.

"Sage just makes everything look simple," said Christensen, of his keeper. "We take a lot of pride in the fact that in soccer you call it clean sheets (shutouts)."

In the South Torrance game in the second half, Strohmman kept her scoreless streak in regulation alive with a save off of a corner kick by Nicolette Wyrick that saw the ball land in front of the goal, but Strohmman jumped to make the save.

The first goal came in the 43rd minute as senior midfielder Caitlyn Hickman had a throw-in that went all the way to the far

side of the goal and was an own goal by South. Hickman gets credit for the first goal of the game.

"Caitlyn Hickman does special things for us," Christensen added. "She is fearless in front of the net."

That was evident in the first-round win on the winning goal by Marquez, as she was right in front of the Palos Verde goalie.

"When the ball was chipped into the box, she ran in and the goal keeper saw her and she wanted none of that," said Christensen, of Hickman's presence in front of the keeper.

As for her long throw-in, Christensen again knew of Hickman's importance to the team.

"Her (Hickman) throw was big and she just has a presence," Christensen said. "She's super athletic and she does athletic things that a lot of other soccer girls don't do.

"Hickman is like a sledge hammer and Kat (Cassandra

Villanueva) is like a surgical instrument."

Christensen was also referring to Villanueva, who is a nonstop forward that has accounted for 10 goals this season and is in constant motion with amazing footwork in the attacking third of the field.

"We're blessed to have that speed up top," Christensen added.

Christensen believes in his defense as they have only given up one goal this season.

"I believe defense wins championships," he said.

Just three minutes later in the 46th minute, Alvizo scored the first of her two goals to give the Matadores a 2-0 lead.

Alvizo picked up the ball, turned and in between two South defenders put the ball in the right corner.

"It was really awesome," said Alvizo, who broke her knee in last years' quarterfinals. "The past two games we won in

overtime and now we won 4-0. "I never thought I would have scored two goals. That's just crazy.

"I think (Caitlyn) Hickman was on the ground, her and Milan (Nimeh), and I just intercepted it and touched it forward and shot. We're just really hyped right now."

The third goal came by way of a penalty shot by Marquez in the 73rd minute for the 3-0 lead.

"I was very confident going into it, very focused and shut everybody out and shot the ball into the left corner," Marquez said. "That was pretty much the game."

The icing on the cake was a late goal in the 88th minute by Alvizo for her second of the game and the 4-0 lead.

"Scoring these goals is huge for us with the momentum going into the CIF semi's," Christensen concluded.

Obituaries

Chuck Hicks, actor and stuntman

Chuck Hicks, an actor and stuntman with notable roles in many Clint Eastwood films, as well as in "Dick Tracy," died May 4 in Las Vegas after suffering a stroke at the age of 93.

Hicks was a boxer before he got his first break in Hollywood, playing a football player in the Ronald Reagan movie "She's Working Her Way Through College" (1952). He had roles in "Gentlemen Prefer Blondes" (1953), "Rebel Without a Cause" (1955), and the first season of the TV show "The Untouchables."

Hicks began working with Eastwood on an episode of TV's "Rawhide" and went on to appear with him in movies including "Paint Your Wagon" (1969), "Dirty Harry" (1971), "Magnum Force" (1973), "Every Which Way but Loose" (1978), and "City Heat" (1984). He played Chief in "Cool Hand Luke" (1967) and The Brow in "Dick Tracy" (1990).

Hicks was known for playing tough-guy characters, drawing on his skill as a boxer as he frequently appeared in fight scenes.

Damon Weaver, aspiring journalist

Damon Weaver, an aspiring journalist who became the youngest person to interview a sitting president when he interviewed President Barack Obama at age 11, died May 1 of natural causes at the age of 23.

Weaver was a reporter for the TV newscast at his elementary school, Florida's Kathryn E. Cunningham/Canal Point Elementary School, when he had his opportunity to interview the president.

He had previously had a chance to ask a question of Vice President Joe Biden at a 2008 campaign event, and after he sent in several requests to interview the president, he got his chance in 2009.

Weaver asked Obama questions including "As president, you get bullied a lot. How do you handle

it?" and "Do you have the power to make school lunches better?"

Later, Weaver interviewed other notable people, such as Oprah Winfrey, Samuel L. Jackson, and Dwayne Wade.

He graduated from Royal Palm Beach Community High School in 2016 and received his degree in communications from Albany State University in 2020. He intended to become a sports journalist and hoped to cover the NFL.

"I like being a reporter because you get to learn a lot of things, you get to meet nice people and you get to travel a lot," he told the Associated Press in 2009.

Spencer Silver, creator of Post-it Notes

Spencer Silver, a chemist who invented the adhesive used in Post-it Notes, died May 8 at his home in St. Paul, Minnesota of ventricular tachycardia at the age of 80.

Silver worked at 3M for 30 years, from 1966 until his retirement in 1996, but it was early in his career there that he developed his most memorable invention.

In 1968, Silver was working to create a powerful adhesive to be used in building airplanes. What he came up with wasn't strong enough for that - but it had interesting properties. It stuck well to surfaces but could easily be peeled off and repositioned.

3M patented the adhesive and marketed it as a spray, but it wasn't until several years later that Silver's adhesive found its true purpose.

3M chemical engineer Art Fry learned of Silver's adhesive in 1974, and he immediately had an idea for its use. He thought it could be ideal for securing bookmarks to his hymnal while he sang at church.

He used Silver's adhesive to develop the first Post-it Notes, which 3M began marketing nationwide in 1980. The product quickly took off and became ubiquitous in offices, schools, and homes.

In his years at 3M, Silver was a part of more than 20 patented products. His adhesive found other uses in addition to Post-it Notes, including medical bandages and interior decorating. He was inducted into the National Inventors Hall of Fame in 2010 and was honored with the American Chemical Society's 1988 Award for Creative Invention.

Pervis Staples, founder of the Staple Singers

Pervis Staples, a co-founder of the legendary gospel and R&B group the Staple Singers, along with his father and sisters, died May 6 at his home in Dolton, Illinois at the age of 85.

The Staple Singers began performing in churches around Chicago in the early 1950s, when Staples and his sisters were still in their teens. They soon began recording their music and had early success with gospel songs including "Will the Circle Be Unbroken?" and "Uncloudy Day," which Bob Dylan has cited as an influence on his career.

It was Staples who urged his father and sisters to begin recording more secular and protest music as well as gospel, and he occasionally sang lead vocals, as on "A Hard Rain's Gonna Fall."

The Staple Singers found crossover success with hit singles in the early 1970s including "I'll Take You There," "Let's Do it Again," and "Respect Yourself," though Staples was no longer singing with the group at the time of their release, having left in 1968.

Staples was also a U.S. Army veteran, singing with the U.S. Army Choral Group while he served.

Along with his family, Staples was inducted into the Rock and Roll Hall of Fame in 1999.

Norman Lloyd, prolific actor

Norman Lloyd, a centenarian actor whose career spanned nine decades and included roles in Alfred Hitchcock films, "Dead Poets Society," and the soap opera "St. Elsewhere," died May 11 at his home in Los Angeles at the age of 106.

Lloyd's impressively long career in Hollywood led many to marvel over the history he carried in his head. He could reminisce about playing tennis with Charlie Chaplin and had the privilege of calling Alfred Hitchcock a friend (and calling him "Hitch," as his friends did).

He worked with Orson Welles when he was a pre-"Citizen Kane" boy wonder and fractured a rib playing basketball with Karl Malden.

But his fascinating memories didn't end with the deaths of his fellow stars of Hollywood's golden age - he also had stories to tell about Judd Apatow and the Coen Brothers. That's because of the staying power that made him Hollywood's oldest working actor.

It all began in 1932. Lloyd left New York University at 17, after two years of study, because he already knew he wanted to act. He spent the first decade of his career in the theater, with emphasis on social theater collectives including the Theatre of Action and the Federal Theatre Project. With the latter, he appeared in a number of "Living Newspapers" productions, dramatizing current events.

It was as a theater actor that Lloyd crossed paths with Welles, who put on a 1937-'38 adaptation of William Shakespeare's "Julius Caesar," renamed simply "Caesar," with his critically acclaimed Mercury Theatre in New York City. Lloyd played Cinna the Poet, bringing to the role his show-stopping interpretation of the character.

Lloyd suspected that his celebrated performance may have annoyed Welles a bit - the director, playing Marcus Brutus, would have preferred to be the star of the show. Several years later, Lloyd told the AV Club in a 2015 interview, the men met again. "Orson embraced me in this tremendous embrace and whispered in my ear, 'You son of a bitch.' And that was the last time I saw him! I took it as a mark of affection."

Welles hoped to assemble the actors of the Mercury Theatre, including Lloyd, to star in a film adaptation of "Heart of Darkness." The whole troupe traveled to California and began preparations to make the movie. But when the production stalled and then entirely stopped, Lloyd and a few others went back to New York to resume their onstage work. Had he stayed, Lloyd later realized, he would have been cast in the project that soon followed the aborted "Heart of Darkness" - 1941's "Citizen Kane."

Another year would pass before Lloyd returned to Hollywood and resumed his stalled movie career, and it would be another legendary director who lured him there for the second time. Hitchcock cast Lloyd in his 1942 spy thriller, "Saboteur." Lloyd remained in Hollywood and took a role in a second Hitchcock film, "Spellbound," in 1945.

He would work with his friend again on the TV series "Alfred Hitchcock Presents" in the 1950s and '60s - both in front of the camera and behind it.

Lloyd continued to act and direct throughout the 1960s and '70s, but his next high-profile role wouldn't come until 1982. It was then that he agreed to do a short arc on the award-winning TV drama "St. Elsewhere."

It wasn't long after the end of "St. Elsewhere" that Lloyd took another part that made him highly recognizable to younger audiences. In 1989's "Dead Poets Society," Lloyd played Mr. Nolan, the strict headmaster who became a villain as he administered corporal punishment to a student and fired a beloved teacher, played by Robin Williams.

In the 1990s and beyond, Lloyd largely worked on television. One notable role came in 1993 on "Star Trek: The Next Generation." In the episode "The Chase," Lloyd played Captain Picard's former mentor, Professor Richard Galen. Before his death, Lloyd was the oldest living actor to have appeared in the "Star Trek" franchise. Lloyd also had guest-star spots on "Modern Family" and "Murder, She Wrote," as well as a recurring role on "The Practice."

Lloyd returned to the big screen in 2015 for the raunchy comedy hit "Trainwreck."
